1. Reviews of Academic Programs and Units

a. <u>Semi-Annual Reports of Academic Programs (October 2014 – March 2015)</u>

Professor Smyth said that three Reviews were considered by the Committee on Academic Policy and Programs (AP&P). Of these, the review for the Factor-Inwentash Faculty of Social Work had been commissioned by the Office of the Provost, while reviews for the Christianity and Culture Programs and the programs of the Department of Slavic Languages and Literatures had been commissioned the Dean of the Faculty of Arts and Science.

Professor Smyth added that the AP&P had a thorough discussion of each of the reviews. In some cases, members had asked for clarification of points raised in the reviews. Representatives of the units and programs that had been reviewed had been available to answer questions.

AP&P had requested a one-year follow-up report from the Christianity and Culture Programs (Faculty of Arts and Science – St. Michael's College) on curriculum renewal, faculty complement, student recruitment and the outcome of their Programs retreats.

b. Follow-up Reports on Reviews

Professor Smyth said that AP&P had received the following five follow-up reports:

- Department of Biochemistry and its graduate programs (Faculty of Medicine) a twoyear report regarding time-to-completion for the M.Sc. and Ph.D. programs, budget modelling, and strategic planning.
- Department of Psychology and its undergraduate programs (Faculty of Arts and Science) – a two-year report about the Department's progress in managing over-enrolment through increased complement and decreased numbers of students enrolled in the major and specialist programs.
- John H. Daniels Faculty of Architecture, Landscape and Design and its undergraduate and graduate programs a one-year report on the progress of the Faculty's reorganization and the cultivation of new faculty leadership.
- Leslie Dan Faculty of Pharmacy and it its undergraduate and graduate programs - a one-year Follow-up Report on the reorganization of the Faculty's administrative structure.
- University of Toronto Scarborough joint programs with Centennial College: Specialist in Journalism Major in New Media Studies; and Specialist in Paramedicine - a one-year report on the programs' learning outcomes and an update on the integration of the UTSC and Centennial College teaching schedules for the New Media Studies program.
