1. Election of the 2013-2014 Executive Committee

At the invitation of the Chair, Mr. John Richardson, a member of the 2012-2013 Nominating Committee for the Executive Committee (NC-EC), presented the Committee's report.

The Chair congratulated the members of the 2013-2014 Executive Committee. On behalf of the College, the Chair extended thanks to the Nominating Committee for the care they exercised in identifying members of the Executive Committee.

2. Selection of the 2013-2014 Nominating Committee for the Executive Committee

The Chair outlined the role of the NC-EC, which was composed of three individuals chosen by election or formed of volunteers from among members in their final year on the College. As the College just had seen, the NC-EC was responsible for recommending the Vice-Chair and three other members of the Executive Committee of the College. The NC-EC normally met once a year following the close of the Executive Committee nomination period to review the applications received and to develop its recommendations to the College. Dr. Alexandra Berezowskyj, Rev. David Harrison and Ms Sadia Mahmood volunteered to serve on the 2013-2014 NC-EC.

The College returned to open session.

3. Minutes of the Previous Meeting

The minutes of the meeting of March 6, 2013, were approved.

4. Business Arising from the Minutes

There was no business arising from the minutes of the previous meeting.

5. 2013-2014 Meeting Schedule
