PURSUANT TO SECTION 44 OF BY-LAW NUMBER 2, THE GOVERNING COUNCIL CONSIDERED THE RECOMMENDATION OF THE PRESIDENTIAL SEARCH COMMITTEE IN CAMERA, WITH MEMBERS OF THE PRESIDENTIAL SEARCH COMMITTEE INVITED TO ATTEND.

1. Senior Appointment

Following discussion in camera

On motion duly made, seconded and carried unanimously,

It was Resolved

- (1) THAT Professor Meric S. Gertler be appointed President of the University of Toronto, effective on a date to be determined but not later than December 31, 2013, and continuing to June 30, 2018 and for up to an additional five years, subject to a review not later than the fall of 2017 by the Executive Committee of the Governing Council and a subsequent determination by the Governing Council and by Professor Gertler that continuation of the term is mutually agreeable.
- (2) THAT the Senior Appointments and Compensation Committee be authorized to complete negotiations with Professor Gertler and to finalize the full terms and conditions of his contract

THE GOVERNING COUNCIL MOVED TO OPEN SESSION.

The Chair and the Secretary escorted Dean Gertler into the Council Chamber. Members stood and applauded Dean Gertler.

The Chair welcomed members and guests to the meeting. He announced that the Council had approved the appointment of Professor Meric S. Gertler as the sixteenth President of the University of Toronto effective on a date to be determined but not later than December 31, 2013, and continuing to June 30, 2018 and for up to an additional five years.

On behalf of all governors he congratulated Dean Gertler.

The Chair repeated, for the public record, a summary of Dean Gertler's significant talents, proven by his extraordinary track record and assessed by the Presidential Search Committee as meeting and exceeding the standards required to lead the University of Toronto in this next decade. He noted that the University was very fortunate to have had Dean Gertler in its midst to lead the University as its next President at this important point in time.

He informed members that, against the Position Specification, developed following extensive consultation with the University community, Dean Gertler's track record demonstrated:

- outstanding academic scholarship and leadership;
- excellent administrative and executive leadership;
- a deep dedication to the University and to its excellence;
- commitment to students and quality of their educational experience;

- an ability to articulate a clear vision and to make difficult decisions and to learn from successful and unsuccessful outcomes;
- a clear and deep understanding of the key issues facing universities in general and the University of Toronto in particular in the current environment and an ability to articulate a path forward.
- an understanding of and commitment to engagement in Canadian public life, locally, provincially and nationally;
- an enthusiasm for and demonstrated success in fundraising, coupled with an unwavering commitment to the University's essential values respecting academic freedom;
- a passion for city-building, integrating his academic interests and highly-respected scholarship on urban life with advancing the University's partnerships and engagement across the Greater Toronto Area;
- a record of successful international relationships and initiatives;
- excellent skills in building and leading a team and maintaining strong relationships;
- a leadership approach characterized as selfless, calm, deliberate and consultative;
- a record of and reputation for integrity; and
- a commitment to equity, diversity and fairness.

He noted that all of this was combined with evidence of courage, resolve, decisiveness, successful problem-solving, sound judgment and humour.

The Chair acknowledged how well the University had been served - and would continue to be served in coming months - by President Naylor. He remarked that through two terms, President Naylor had led the University to ever greater successes and international prominence – and he had ensured that the University would continue to be ambitious in its vision and bold in its execution. He noted that at the outset, the Committee had recognized that it had an enormous challenge in finding his successor – President Naylor had set exceptionally high standards for leadership and for our University. The Chair offered his thanks to President Naylor. Members applauded President Naylor for his service.

The Chair then invited Dean Gertler to address the Council.

President-Designate Gertler addressed the Governing Council. His remarks are attached hereto as Appendix 'A'.

Following the President-Designate's remarks the Chair invited President Naylor to address the Governing Council. His remarks are attached hereto as Appendix 'B'.

President Naylor advised members that the Chancellor was out of the country but that he had passed on his warmest congratulations to Dean Gertler.

The Chair concluded by noting that, for the remainder of the day, various groups of faculty, staff and student groups would be invited to join him and the President in informal meetings to introduce the President-Designate. The following day brief visits would be arranged to meet the communities at the University of Toronto Mississauga (UTM) and the University of Toronto Scarborough (UTSC).

He invited members and guests to an informal reception that he and the President were
hosting the following day at Noon in the Great Hall at Hart House.

Finally, he thanked those present for coming to the special meeting and for their dedication to the University.

APPENDIX A

President-Designate Meric Gertler's Remarks to the Governing Council

March 4, 2013

Mr. Chair, Mr. President, members of the Presidential Search Committee, members of the Governing Council:

I am truly thrilled to have been chosen to be the next President of U of T – but also deeply honoured and humbled. As the news began to sink in over the past few days, I have felt a mixture of emotions (as you can imagine), but mostly excitement, and pride at the prospect of leading this great institution. The University of Toronto has rightfully taken its place as one of the world's great public universities – and indeed, one of the best anywhere – full stop. It occupies a unique niche amongst institutions of higher education (in Ontario, in Canada, and around the world). It is world-renowned for its leading-edge scholarship and graduate programs in fields that span the humanities, sciences, social sciences, medicine, engineering, law, management, and many other professional faculties. At the same time, we are a large, accessible, urban university: deeply embedded in the economic and social fabric of the GTA; and providing a portal of opportunity for thousands of undergraduates – many of whom are the first in their family to attend university. We should all be justly proud of the way the University has managed to advance both parts of this mission so successfully.

While we live in challenging times – thanks to economic uncertainty, public sector austerity, and rising expectations from taxpayers, politicians, and our students – it is also a time of unparalleled opportunity. We are reinventing the university in a variety of ways. We are rethinking undergraduate education by emphasizing core competencies, breadth, research opportunities and internationalization. We have rolled out a set of distinctive new 'One' programs emphasizing small-group learning in 1st year. We are exploring the brave new world of online learning, looking for ways to complement the in-class experience. We are developing new professional masters programs in a range of innovative fields. And we have implemented a fundamentally new way of managing our budget – a profound organizational change that continues to attract accolades – and imitators – from across Canada. In all of these endeavours, the University of Toronto is demonstrating yet again its astounding capacity for innovation and creativity.

We all owe a huge debt of gratitude to David Naylor for his outstanding leadership of the University during some very challenging times. He would be the first to point out that one person cannot singlehandedly bring about substantial change in an organization as large and complex as this one – and he is absolutely right. Our faculty, staff, students, alumni, donors, friends, hospital partners and government partners have all played critically important roles in this process. Our cadre of Vice-Presidents, Principals and Deans, led ably by our remarkable and multi-talented Provost Cheryl Misak, have also played a very big part. But there is no doubt that, on David's watch, this University has not only met many important challenges but has become much stronger in the process. Its reputation and regard around the world have reached new highs. There is a pervasive sense of energy, excitement, and

possibility about this place. David deserves full credit for leading this transformation process. When the time comes for me to take over the reins, I know that I shall be inheriting an institution that is in very good shape, despite the challenges. My goal is to build on the excellent achievements and maintain the momentum established under David's leadership. I know that, with the help of everyone in this room, we will be able to succeed in this mission. I want to thank the search committee and Governing Council for their confidence in me – and thanks in advance to all of you for the help you'll be providing me as we meet our challenges and seize the opportunities before us together. President Naylor's Remarks to the Governing Council
