## ITEM IDENTIFICATION:

Category 6, Administrative User Fees and Fines, 2005-2006 Items for information

## JURISDICTIONAL INFORMATION:

The University's Policy on Ancillary Fees makes provision in category 6 for a University Schedule of User Fees and Fines. A copy of the policy is attached (Attachment A).

Under the policy, the fees and fines shown on the Schedule may be adjusted annually by administrative authority of the Vice-Provost, Planning and Budget, provided that the adjustments relate to the cost of the services provided. These adjustments are to be reported annually to the business board for information.

A new University Schedule of Administrative User Fees and Fines for 2005-2006 (Attachment B) is attached to item 8 for the Business Board's information.

## **PREVIOUS ACTION TAKEN:**

The Schedule comes forward annually.

#### **HIGHLIGHTS**:

These fees include fees for special registration arrangements, optional copies of records, special arrangements relating to examinations, placement fees, library fines, application fees and other services. None of these fees is subject to the MTCU policy on ancillary fee protocols.

Details of the changes to the schedule are given on the following pages.

## FINANCIAL AND/OR PLANNING IMPLICATIONS:

In 2003-2004, these fees produced \$9,884,612 in income for the University's academic divisions, which closely matched the costs of providing the relevant services.

## FOR INFORMATION

The University's policy permits administrative user fees to increase annually to reflect the cost of services provided. The following divisions are proposing increases to existing fees:

#### Request 1 6.2 Records and Documents

SGS is requesting the binding of doctoral thesis be increased to \$20. Reports from Robarts Library indicate that vendor's prices for commercial binding have increased by approximately 40% over the past 10 years. Local commercial binders in Toronto now charge \$30 per thesis. The present funding does not cover the in-house costs associated with processing and an increase to \$20 is recommended.

#### Request 2 6.2 Records and Documents

The University Registrar is requesting that the diploma mailing fee be increased to \$20 to destinations in Canada, \$40 to the U.S.A., and \$60 to International destinations. The current fee of \$10 has not kept pace with the increases in postal rates. This fee structure is comparable to other public research institutions in Ontario. Please not this new fee does not take into account the approximately 300 diplomas mailed free of charge for degrees conferred 'in absentia' in March.

## Request 9 6.7 Application Fees

The Faculty of Law tentatively requests a change to their application fee. The Faculty participates in a centralized application process in Guelph with the other Ontario law schools (OLSAS). Currently the OLSAS application fee is \$225 which includes an application to one law school. An application to an additional law school costs \$50.

This year, the Faculty understands that other law schools would like to raise the "per school" application fee from \$50 to \$75. They will confirm whether this was approved by the other law schools by mid-February.
