(1) Start Time

The starting time for the Thursday June 22 meeting has been restored to the usual 5:00 p.m. The scheduling problem that had required that the starting time for be delayed until 5:30 p.m. has been resolved. I do regret any confusion or inconvenience.

(2) Parking

If members are driving onto campus, they should be aware that, because of the Convocation ceremony being held on the afternoon of June 22, there is some possibility that the parking places near Simcoe Hall may not be available. (My hope and expectation is that the Convocation will be well over by the time you arrive.)

Members with Governing Council parking permits will, in any event, be able to park in spaces on the outside perimeter of the northwest corner of campus, near the Croft Chapter House and 21 King's College Circle.
