Committee for Honorary Degrees Nomination Form, 2009

By awarding honorary degrees the University of Toronto seeks to recognize extraordinary achievement, in Canada or abroad, in community, national or international involvement, and to honour those individuals whose accomplishments are of such generally perceived excellence that they provide, through example, inspiration and leadership to the graduates of the University. Their esteem should be such that, by virtue of accepting an honorary degree, their presence will bring honour and distinction to the University of Toronto.

The Committee defines as broad a range of categories for achievement as possible in obtaining and considering nominations. Extraordinary achievement in scholarship is the predominant category, but categories will, among other areas, include the arts, business, health services, professional and voluntary service in the community at large, and exemplary service of long-standing and unusual merit to the University. The Committee also considers the association nominees may have with the University of Toronto or with higher education more broadly.

Canadians and non-Canadians are considered. It is a requirement that honorary graduands attend Convocation for the conferral of their degrees. Nominees who are currently active in political life will normally not be considered for honorary degrees until a minimum of two years following their retirement from political life. As well, it is a general principle that nominations for serving members of the Governing Council or of the University staff are not normally considered until a minimum of two years following their retirement or departure from the University.

It would be appreciated if nominations could be submitted by Friday, August 14, 2009 in order to allow their consideration by the Committee in September. Please ensure that this form is completed as fully as possible, and that all relevant supplementary information is attached.
