Item Identification

Allocation of resources for Phase I capital projects at the University of Toronto at Scarborough (UTSC)

Sponsor

Ron Venter, Vice-Provost, Space and Facilities Planning

Jurisdictional Information

The Committee is responsible for reviewing and making recommendations concerning a broad range of planning issues and priorities and for the use of University resources, including space and facilities.

Highlights

Extensive planning is on-going at the University of Toronto at Scarborough [UTSC] to address the necessary capital projects for the construction of appropriate physical facilities to accommodate the projected increase in student enrolment. The first projects will be built within the envelope of the Phase I funding which is to be derived from the anticipated enrolment growth income at the UTSC campus. The total funding identified available in Phase I is \$28.98 million. Details of all on-going and /or anticipated projects on the UTSC campus are identified in the Sector 1 University of Toronto at Scarborough attachment. All UTSC projects are identified and the specific funding available and tentatively assigned for support for each project with Phase I funding tabulated. The current Phase I projects and the tentatively assigned allocation of financial support are as follows:

The projected cost of these Phase I projects totals \$28.98 million.

Resource Implications

Each project requires careful consideration. At the present time the ARC project is well underway and \$11.99 million from the Phase I funds will be allocated to this project which has been approved by Governing Council. A second significant project, currently submitted to Planning & Budget for approval, is the Management Building. This building requires an allocation of \$14.37 million from the Phase I funds.

Four other smaller projects are currently under consideration at UTSC. Each being valued less than \$2 million, they will require approval by the Accommodation & Facilities Directorate [AFD] as detailed plans are firmed up.

Funding Sources

The funding for all projects to be undertaken within the Phase 1 enrolment expansion will be derived from the Phase I enrolment growth income. These funds will be available to the University of Toronto at Scarborough for targeted capital projects to support the increased enrolment.

Recommendations

It is recommended that subject to Governing Council approval of any individual project costing over \$2 million and approval by the Accommodation and Facilities Directorate of individual projects costing less than \$2 million, and subject to quarterly reports by the Vice-Provost, Space and Facilities Planning, on the progress of the Phase I plan to expand the University of Toronto at Scarborough,

- 1 THAT funding of \$28.98 million plus interest, from the Enrolment Growth Fund allocation(s) to UTSC be approved for the following capital projects for the Phase I expansion of the University of Toronto at Scarborough, [the projects to be financed, with principal and interest to be repaid over time by the University of Toronto at Scarborough from its Enrolment Growth Fund allocations, deriving from its enrolment expansion]:
 - Phase 1: Academic Resource Centre [ARC]
 - Phase 1: Management Building
 - Phase 1: Renovation to Arts & Science Facilities
 - Phase 1: Infills for Offices and other Facilities
 - Phase 1: Renovations: Delivery Services
 - Phase 1: Roads, Landscaping and Bridge
- 2. THAT authority be delegated to the Vice-President and Provost and the Principal of the University of Toronto at Scarborough to allocate this funding to individual projects costing less than \$2-million.
