On December 12, 2014, the Governing Council approved the appointment of Professor Bruce Kidd as Vice-President, University of Toronto and Principal, University of Toronto Scarborough (UTSC), for a three and a half-year term, effective January 1, 2015 to June 30, 2018. Professor Kidd has indicated that he will not be seeking a re-appointment.
