Section III: Definitions

For elections to the UTSC Campus Affairs Committee, the candidate and nominators must be registered at the University of Toronto Scarborough.

The definition of “**Graduate Student**” and “**Student**” below is an extract from the *Election Guidelines 2019*. It is your responsibility to ensure that you are eligible by consulting the *Election Guidelines 2019*, which provides more details for this definition and the eligibility criteria.

“Graduate Student” means a Student registered in the School of Graduate Studies.

“Student” means any person registered at the University for full-time or part-time study in a program that leads to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University. The Transitional Year Program and the Millie Rotman Shime Academic Bridging Program have been designated by the Governing Council as programs of post-secondary study at the University, and, accordingly, a student in either of these programs is considered a “Student” in these *Guidelines*.

Section IV: Candidate Statement

The nominee may submit a typed biographical statement or other comments, up to a limit of 100 words. The candidate's name will not be counted in the 100-word total if placed at the beginning of the statement. Abbreviations and acronyms will be counted as one word. The nominee’s URL will not be counted in the 100-word limit and should be placed at the end of the statement. **This statement may be published in the campus media and will be linked to the ballot on the web. If a statement exceeds 100 words, only the first 100 words will be printed.**
