**(a) Agenda Package**

**(b) Parking**

Members who plan to drive onto campus should be aware that, because of the Convocation ceremony being held on the afternoon of June 16 (beginning at 2:30 p.m.), the usual parking places near Simcoe Hall might not be available. Members with Governing Council parking permits will, however, be able to park in spaces on the outside perimeter of the northwest corner of campus, near the Croft Chapter House and 21 King's College Circle.

Members are advised to enter the campus from the east entrance, beneath the Queen's Park Crescent overpass from Wellesley Street. Point out your Governing Council parking permit and let the police officer or parking attendant know that you will be attending the Business Board meeting. The attendant will direct you to the appropriate parking places.
