- University College

• operates under provincial statute -- The University of Toronto Act, 1971

autonomous, self-governing

- 3 campuses
- 80 graduate departments and 30 interdisciplinary programs
- 28 academic divisions
- Over 70,000 undergraduate and graduate students
- 11,000 faculty and staff
- 434, 000 living graduates, including 6 Nobel laureates

Academic divisions:

- \$1.7 billion annual budget
- \$375 million in research funding
- 10 fully affiliated hospitals

- defines the system of governance and specifies:
 - the composition of Governing Council
 - its powers and duties: "government, management and control of the University and of the property, revenues, business and affairs thereof are vested in the Governing Council"
 - how its members are to be chosen
 - that Council can determine the remainder of its structure

University Administration

President

- duties specified in University of Toronto Act
 - chief executive officer
 - appointed by the Governing Council

Vice-President and Provost

- chief academic officer and chief budget officer
- appointed by the Governing Council

Deans and Principals

- duties specified in Policy on the Appointment of Academic Administrators
- chief executive officer of the Faculty/College

Statement of Institutional Purpose

The University of Toronto is committed to being an internationally significant research university, with undergraduate, graduate and professional programs of excellent quality.

President's Mandate

- Increasing the University's capacity for creating knowledge, and advancing research and scholarship that is recognized internationally as outstanding among its peer institutions
- Enhancing the quality of student experience
- Fostering a culture that attracts, motivates, recognizes and retains excellent faculty

President's Mandate

- Building effective relationships that will advance the University's interests and those of post-secondary education in general; and
- Being a strong external representative and a champion of the University as a force for public good.

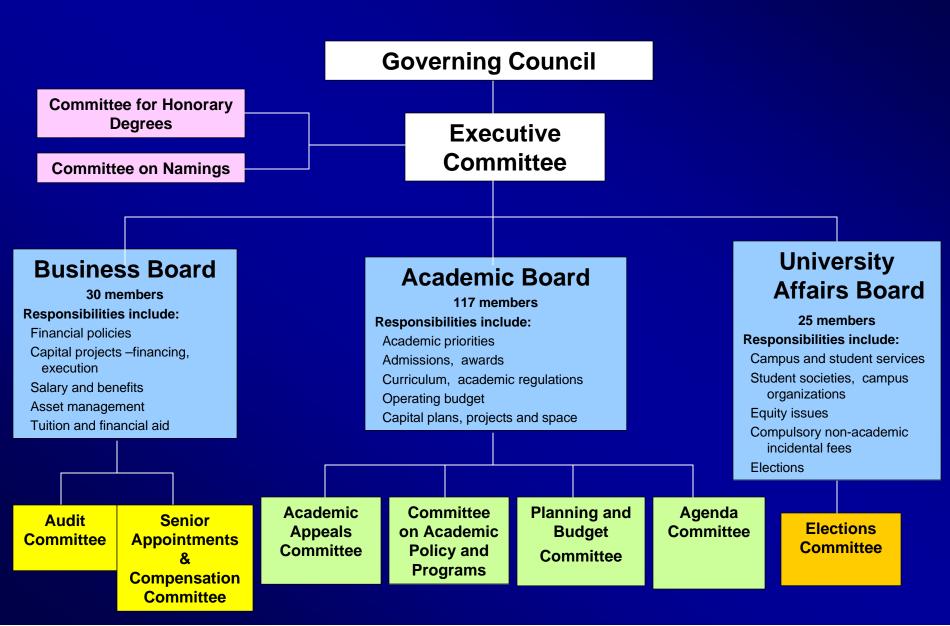

Being an Effective Member of Governing Council

- Act in the best interests of the University of Toronto as a whole
- Take a broad and long-range view when participating in collective decision-making
- Consider how the Council's decisions will affect the University, not just a particular constituency
- Engage in dialogue about policy, especially at level where matters are first introduced

Governing Council



Election of Alumni Governors

- Three of eight seats will be open as of July 1, 2008
- Two of the three incumbents are eligible for reelection
- Three-year terms, maximum term of nine years
- Nomination form will reflect advice given by the Chair of the Governing Council and the President on important qualities of candidates

Election Process

- Nominations open Friday, January 11, 2008 at noon
- Nominations close Monday, February 25, 2008 at 4:00 p.m.
 - College reviews nominations March 10, 2008
- Alumni Governors elected by College April 3, 2008

Alumni Governors' Assignments

- Each spring, members of the Governing Council are canvassed about their preferences for standing committee and board assignments for the coming year
- Balance of skills, experience, and interest among members is considered
- The Governing Council makes appointments of members to its Boards/Committees by end of June
