Re:	Governing Council Meeting – Thursday, April 3, 2003 at 4:30 pm

(a) Agenda Package Attached - Request to Bring Forward Documentation

The Agenda package for the April 3, 2003 Council meeting is attached.

(b) Consideration of Tuition Fee Schedule

One of the items for approval on April 3, 2003 is the tuition fee schedule for publicly funded programs for 2003-04. The Chair is proposing the following time allocation for the item, after the motion has been moved and seconded:

- <u>10 minutes</u>: Presentation of background by Provost
- <u>20 minutes</u>: External Speakers
- <u>60 minutes</u>: Discussion by members

It is the intention of the Chair, supported by the Executive Committee, to ensure that there is a minimum period of time protected for governors to debate the matter and to hear one another's views.

At its meeting on March 24, 2003, the Executive Committee considered eighteen speaking requests from nonmembers. After taking into account whether the individual or group had addressed either AP&P or the Business Board, as well as whether the individual would speak on behalf of a representative group, it was decided to allow six speaking requests – three from the campus-wide student groups and three from the requests that had been received. It was the decision of the Executive Committee that any additional requests would be declined. An additional eight requests have been received to date. A complete list of speakers is attached as Appendix "A".

If there is an indication that members wish to hear additional external speakers on this item, a decision can be made by Council after debate and before the vote. There would be a vote on each additional three-minute speaking opportunity, requiring a 2/3 majority, with the name to be chosen after the vote by lot by the Chair.

A total of fifteen non-member speakers have addressed the Committee on Academic Policy and Programs (AP&P) on February 27 and the Business Board on March 3. Their remarks are available in the Reports of these meetings. In addition, a number of written submissions have been received, and are included in the agenda package for the Governing Council meeting.
