Re: Election Guidelines 2008

Attached is the draft *Election Guidelines 2008*. The proposed minor revisions listed below include changes issuing from experience with the *Election Guidelines 2007*, as well as changes intended to provide clarity of language.

I would be happy to provide additional information on any of the proposed changes.
