PREVIOUS ACTION TAKEN:

At the May 31, 2014 Business Board meeting, the Chair of the Audit Committee reported that the Audit Committee had completed its review of Audit Committee governance activities. As part of this process, the University tendered its external auditor services for the 2014-15 financial statements and recommended the appointment of Ernst & Young.

HIGHLIGHTS:

Ernst & Young are completely independent, perform excellent work, have extensive expertise in both accounting for not-for-profit generally and for the university sector, are proactive in bringing issues and new developments forward, meets the University very tight deadlines and heavy workload requirements for the various audits, and therefore should be retained for the upcoming fiscal year (2015-16).
