ITEM IDENTIFICATION:

Policy on Scheduling of Classes and Examinations and Other Accommodations for Religious Observances

JURISDICTIONAL INFORMATION:

The terms of reference of the Committee on Academic Policy and Programs provide that the Committee is responsible for the consideration of University-wide policy on academic matters including the establishment of policy with respect to examinations.

PREVIOUS ACTION TAKEN:

The religious observances of the major Christian denominations are recognized through ordinary University scheduling and statutory holidays. An existing Governing Council resolution, approved by the Academic Affairs Committee on February 4, 1974, provides the following:

- (1) THAT the first day of classes in the fall term in all teaching divisions should not be scheduled on the first and second days of Rosh Hashanah or on Yom Kippur.
- (2) THAT examinations in all teaching divisions should not be scheduled on the first and second days of Rosh Hashanah or on Yom Kippur or on the first two days and the last two days of Passover, which normally fall in April.

The first resolution is interpreted to apply to the first day of classes in any given course and not only to the first day of the autumn term.

In recent years, other holy days have been accommodated pursuant to a memorandum issued annually by the Vice-President & Provost. However, there is no provision for the accommodation of holy days, other than those noted above, in University policy.

HIGHLIGHTS:

The proposed policy articulates the University's commitment and expectations with respect to reasonable accommodation of the needs of students who observe religious holy days other than those already accommodated by ordinary scheduling and statutory holidays.

As provided in the proposed policy, the Office of the Vice-President & Provost shall, on an annual basis, publish information concerning the anticipated dates of a number of holy days over the subsequent two academic years. This list is currently based upon the dates published in the *Multifaith Calendar* by the Ontario Multifaith Council on Spiritual and Religious Care. This calendar can be ordered at the Council's web site at http://www.omc.ca.

The policy provides that while every reasonable effort should be made to provide accommodation, the publishing of these dates should not necessarily be interpreted to mean that no important academic activities can be scheduled on these dates. The published dates will be provided in the interest of assisting instructors and those planning academic activities in anticipating when students might choose to seek accommodations for religious observances. It is also important to note that there are many holy days associated with many faiths and that the absence of such dates on the published list should not be interpreted to mean that there should be no accommodation for students who observe those holy days. Finally, some observances are based on an interpretation of the lunar calendar, and thus may vary by one or two days depending upon the interpretation relevant to a student's faith tradition.

FINANCIAL AND/OR PLANNING IMPLICATIONS:

There are no implications for the University's operating budget.

RECOMMENDATION:

It is recommended that the Committee on Academic Policy & Programs recommend to the Governing Council:

THAT the Policy on Scheduling of Classes and Examinations and Other Accommodations for Religious Observances be approved, effective immediately.

On an annual basis, the Office of the Vice-President & Provost shall publish information concerning the anticipated dates of a number of holy days over the subsequent two academic years. While every reasonable effort should be made to provide accommodation, the publishing of these dates should not necessarily be interpreted to mean that no important academic activities can be scheduled on these dates.
