Re: Election Guidelines 2008

Attached is the draft *Election Guidelines 2008*. The proposed minor revisions listed below include changes issuing from experience with the *Election Guidelines 2007*, as well as changes intended to provide clarity of language.

I would be happy to provide additional information on any of the proposed changes.

Chapter I - Interpretation	Chapter I - Interpretation
"Full-Time Undergraduate Student" means all students (except students registered in the Toronto School of Theology) registered at the University in a program of full-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University who are not registered in the School of Graduate Studies. The status of a student as full-time will be determined by the definition used in the student's academic division. For purposes of the Governing Council elections, students at the University of Toronto at Scarborough who are registered in a work term will be considered to be full-time students; (p. 4)	"Full-Time Undergraduate Student" means a student registered at the University in a program of full-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University who is not registered in the School of Graduate Studies or the Toronto School of Theology. The status of a student as full-time will be determined by the definition used in the student's academic division. For purposes of the Governing Council elections, students at the University of Toronto at Scarborough who are registered in a work term will be considered to be full-time students;
"Graduate Student" means all students registered in programs of part-time or full-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University in the School of Graduate Studies; (p. 4)	"Graduate Student" means a student registered in the School of Graduate Studies;

"Part-Time Undergraduate Student" means all students (except students registered in the Toronto School of Theology) registered at the University in a program of part-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University who are not registered in the School of Graduate Studies. The status of a student as part time will be determined by the definition used in the student's academic division; (p. 4)

Constituency IB - 1 seat FOR WHICH AN ELECTION IS REQUIRED

all teaching staff members in the Faculty of Arts and Science who hold their major appointments in the Departments of Anthropology, Economics, Geography, History, Philosophy, Political Science, Psychology, Sociology and The Study of Religion (excluding those who are members of Constituency II or III) (p. 8)

Constituency VI - 1 seat

all teaching staff members of the Faculty of Dentistry, Faculty of Nursing, Leslie Dan Faculty of Pharmacy and the Faculty of Physical Education and Health (p. 9)

Constituency VII - 1 seat FOR WHICH AN ELECTION IS REQUIRED

all teaching staff members in the Faculty of Architecture, Landscape, and Design, Rotman School of Management, Faculty of Forestry, Faculty of Information Studies, Faculty of Law, Faculty of Music and the Faculty of Social Work (p. 9)

"Graduate Student" means all students registered in the School of Graduate Studies in programs of parttime or full-time study leading to a degree or postsecondary diploma or certificate of the University, or in a program designated by the Governing Council as a program of post-secondary study at the University. (p. 10) "Part-Time Undergraduate Student" means a student registered at the University in a program of part-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University who is not registered in the School of Graduate Studies or the Toronto School of Theology. The status of a student as part time will be determined by the definition used in the student's academic division;

Constituency IB - 1 seat FOR WHICH AN ELECTION IS REQUIRED

all teaching staff members in the Faculty of Arts and Science who hold their major appointments in the Departments of Anthropology, Economics, Geography, History, Philosophy, Political Science, Psychology, Sociology, and **Centre for** The Study of Religion (excluding those who are members of Constituency II or III)

Constituency VI - 1 seat

all teaching staff members of the Faculty of Dentistry, **Lawrence S. Bloomberg** Faculty of Nursing, Leslie Dan Faculty of Pharmacy and the Faculty of Physical Education and Health

Constituency VII - 1 seat FOR WHICH AN ELECTION IS REQUIRED

all teaching staff members in the Faculty of Architecture, Landscape, and Design, Rotman School of Management, Faculty of Forestry, Faculty of Information Studies, Faculty of Law, Faculty of Music and the **Factor-Inwentash** Faculty of Social Work

"Graduate Student" means a student registered in the School of Graduate Studies. "Full-Time Undergraduate Student" means all students (except students registered in the Toronto School of Theology) registered at the University in a program of full-time study leading to a degree or post-secondary diploma or certificate of the University, or in a program designated by the Governing Council as a program of post-secondary study at the University, who are not registered in the School of Graduate Studies. The status of a student as full-time will be determined by the definition used in the student's academic division. For purposes of the Governing Council elections, students at the University of Toronto at Scarborough who are registered in a work term will be considered to be full-time students. (p. 10)

Constituency II - 2 seats FOR WHICH AN ELECTION IS REQUIRED

all full-time undergraduate students registered in the Faculty of Applied Science and Engineering, Faculty of Dentistry, Faculty of Law, Faculty of Medicine, Faculty of Music, Faculty of Nursing, OISE/UT, Leslie Dan Faculty of Pharmacy, and Faculty of Physical Education and Health (with the proviso that both members elected in Constituency II not be registered in the same faculty, and that in the event that a member elected while registered in one faculty or school later registers in the faculty or school in which the other elected member is registered, the transferring member shall resign his or her seat) (p. 11)

"Part-Time Undergraduate Student" means all students (except students registered in the Toronto School of Theology) registered at the University in a program of part-time study leading to a degree or post-secondary diploma or certificate of the University, or in a program designated by the Governing Council as a program of post-secondary study at the University, who are not registered in the School of Graduate Studies. The status of a student as part-time will be determined by the definition used in the student's academic division. (p. 11)

Chapter V - Election Schedule 2008

Nominations (same for both elections) (p. 13)

"Full-Time Undergraduate Student" means a student registered at the University in a program of full-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University who is not registered in the School of Graduate Studies or the Toronto School of Theology. The status of a student as full-time will be determined by the definition used in the student's academic division. For purposes of the Governing Council elections, students at the University of Toronto at Scarborough who are registered in a work term will be considered to be full-time students.

Constituency II - 2 seats FOR WHICH AN ELECTION IS REQUIRED

all full-time undergraduate students registered in the Faculty of Applied Science and Engineering, Faculty of Dentistry, Faculty of Law, Faculty of Medicine, Faculty of Music, Lawrence S. Bloomberg Faculty of Nursing, OISE/UT, Leslie Dan Faculty of Pharmacy, and Faculty of Physical Education and Health (with the proviso that both members elected in Constituency II not be registered in the same faculty, and that in the event that a member elected while registered in one faculty or school later registers in the faculty or school in which the other elected member is registered, the transferring member shall resign his or her seat)

"Part-Time Undergraduate Student" means a student registered at the University in a program of part-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University who is not registered in the School of Graduate Studies or the Toronto School of Theology. The status of a student as part time will be determined by the definition used in the student's academic division.

- a) Nominations
- ix) Verification process
- In the event that one or more of a nominee's nominators cannot be verified, they may be replaced by the nominee if, in the judgment of the CRO, the error was made in good faith.
 - The deadline for this process will be the end of the verification period. (p. 17)

xvii) Names of candidates

- The names of candidates nominated for election will be public information as they are received, once the nomination has been validated.
- The **names of nominators will <u>not</u> be released** by the Chief Returning Officer to the public or the other candidates. (p. 18)

b) Campaign period

- ii) Campaigning
 - Campaigning for elections held by mail ballot in teaching staff and administrative staff constituencies may not begin until all candidates have been announced. (p. 19)

Guidelines for Campaigning

3. Campaigning for web-based elections may not start before 12:01 a.m. February 25, 2008 and will cease at the end of the voting period. (p. 31)

k) (ii)

- (ii) Severe violations might include, but are not limited to:
- spending grossly over the maximum spending limit as set by the *Election Guidelines*;
- · intentionally misrepresenting campaign expenditures;
- attempting to interfere in the election process as regulated by these *Guidelines*;
- soliciting Student Information System (SIS) and/or Personal Identity Number (PIN) numbers. (p. 34)

Chapter VI – Regulations

- a) Nominations
- ix) Verification process
- In the event that one or more of a nominee's nominators cannot be verified, they may be replaced by the nominee if, in the judgment of the CRO, the error was made in good faith.
 - The deadline for this process will be the time of announcement of candidates (Thursday, January 31, 1:00 p.m.)

xvii) Names of candidates

- The names of candidates nominated for election will be made public on Thursday, January 31, 1:00 p.m.
- The names of nominators will <u>not</u> be released by the Chief Returning Officer to the public or the other candidates.

b) Campaign period

- ii) Campaigning
 - Campaigning for elections held by mail ballot in teaching staff and administrative staff constituencies may not begin until all candidates have been announced 5:01 p.m. on Friday, February 8, 2008, and will end at 5:00 p.m. Friday, March 14, 2008.

3. Campaigning for web-based elections may not start before 12:01 a.m., **Monday**, February 25, 2008 and will cease at the end of the voting period (6:00 p.m. Friday, March 7, 2008).
