ITEM IDENTIFICATION:

Compulsory Non-Academic Incidental Fees – Student Society Fees: Student Society Proposals for Fee Increases

JURISDICTIONAL INFORMATION:

The terms of reference of the University Affairs Board provide that the Board approves the establishment of and changes to compulsory non-academic incidental fees including those collected on behalf of student societies.

The administrative procedures are outlined in the *Policy on Compulsory Non-Academic Incidental Fees* and the *Handbook for Student Societies* (published by the Office of the Vice-Provost, Students). Pursuant to the *Policy*, requests for increases to fees must be supported by due constitutional and fair processes within student societies.

Requests for increases are brought forward to the Board by the administration on the assurances of the student societies that due constitutional procedures have been followed.

Increases which are greater than the cost of living must be supported by a positive result in a recent referendum. Requests for increases which are less than or equal to the cost of living must be supported by a previous referendum approving annual increases by the cost of living or an explicit inflation factor. When such a provision is approved by referendum, annual increases, no greater than the Ontario Consumer Price Index of the previous December (or no greater than a specific inflation factor approved by referendum), may be requested upon approval of the board or council of the organization.

PREVIOUS ACTION TAKEN:

Requests for changes to existing fees and/or the establishment of new fees are brought forward to the Board on one or more occasions each year. This is the third set of requests on behalf of student societies brought forward this year.

The requests have been reviewed by the Office of the Vice-Provost, Students in light of the requirements of the *Policy for Compulsory Non-Academic Incidental Fees* and are found to be in compliance. Therefore, the requests are recommended for approval.

FINANCIAL AND/OR PLANNING IMPLICATIONS:

There are no significant implications for the University's operating budget.

RECOMMENDATION:

It is recommended that the University Affairs Board approve the following:

THAT beginning in the fall 2011 session, the **89 Chestnut Residence Council** fee be increased as follows: (a) an increase of \$0.30 per session in the society portion of the fee. If approved, the total 89 Chestnut Residence Council fee will be increased to \$9.47 per session, charged to all residents of the 89 Chestnut Residence.

THAT beginning in the fall 2011 session, the **Association of Part-time Undergraduate Students** (APUS) fee be increased as follows: (a) by \$0.11 per session in the Canadian Federation of Students (CFS) / CFS-Ontario portion of the fee; (b) by \$3.39 per session in the Accident & Prescription Drug Plan portion of the fee; and (c) by \$2.83 per session in the Dental Plan portion of the fee. If approved, the total APUS fee will be \$86.12 per session, charged to all part-time undergraduate students on all campuses.

THAT beginning in the fall 2011 session, the **Engineering Society** fee be increased as follows: (a) an increase of \$0.74 (\$0.69 part-time) per session in the society portion of the fee; (b) continuation of, and an increase of \$0.50 (\$0.00 part-time) per session in the Formula SAE Racing Team portion of the fee through 2012-13; (c) continuation of the Special Projects Levy portion of the fee through 2012-13; (d) continuation of the Human Power Vehicle Design portion of the fee through 2012-13; (e) continuation of the Engineers Without Borders portion of the fee through 2012-13; (f) the establishment of an Endowment Fund portion of the fee of \$50.00 (\$0.00 part-time) through 2012-13; (g) the establishment of a Robotics Association portion of the fee of \$1.25 (\$0.00 part-time) through 2012-13; and (f) the elimination of the Engineering Career Centre portion of the fee. If approved, the total Engineering Society fee will be increased to \$163.44 (\$21.68 part-time) per session, charged to all Faculty of Applied Science and Engineering students.

THAT beginning in the fall 2011 session, the **Erindale College Student Union** (operating as the University of Toronto Mississauga Students' Union; UTMSU) fee be increased as follows: (a) an increase of \$0.42 per session in the society portion of the fee; (b) an increase of \$0.30 per session in the On-Campus First Aid Emergency Response portion of the fee; (c) an increase of \$0.03 per session in the Academic Societies portion of the fee; (d) an increase of \$0.02 per session in the Food Bank portion of the fee; and (e) an increase of \$0.03 per session in the Student Refugee Program portion of the fee. If approved, the total UTMSU fee will be increased to \$99.07 per session, charged to all full-time undergraduate University of Toronto at Mississauga students.

THAT, beginning in the fall 2011 session, the **Graduate Students' Union** (GSU) fee be increased as follows: (a) an increase of \$0.96 (\$0.48 part-time) per session in the society portion of the fee; (b) an increase of \$0.13 (\$0.07 part-time) per session in the Canadian Federation of Students (CFS) – CFS-Ontario portion of the fee; (c) a decrease of \$0.07 (full-time students only) per session (including an administration fee and sales tax) in the Supplementary Health Coverage portion of the fee; and (d) an increase of \$6.55 (\$6.55 part-time) per session (including an administration fee and sales tax) in the Dental Plan portion of the fee. If approved, the total GSU fee will be increased to \$222.98 per session (\$94.81part-time), charged to all graduate students.

THAT beginning in the fall 2011 session, the **Master of Information Student Council** (MISC) fee be continued as follows: (a) continuation of the Technology Upgrade Fund portion of the fee through 2012-13. If approved, the total MISC fee will continue to be \$62.50 (\$31.25 part-time) per session, charged to all Master of Information students.

THAT, on the condition that Faculty of Information doctoral students support this proposal by referendum on April 15, 2011, beginning in the fall 2011 session, the **Faculty of Information Doctoral Student Association** (FIDSA) fee be continued as follows: (a) continuation of the Technology Upgrade Fund portion of the fee through 2012-13. If approved, the total FIDSA fee will continue to be \$50.00 (\$25.00 part-time) per session, charged to all Master of Information students.

THAT beginning in the fall 2011 session, a **Museum Studies Graduate Students' Association** (MSGSA) fee be established as follows: (a) establishment of a Technology Upgrade Fund portion of the fee through 2012-13. If approved, the total MSGSA fee will continue to be \$50.00 (\$25.00 part-time) per session, charged to all Faculty of Information doctoral students.

THAT beginning in the fall 2011 session, the **Innis College Student Society** (ICSS) fee be increased as follows: (a) an increase of \$8.03 per session in the society portion of the fee; and (b) the establishment of the designated portion of the fee of \$100.00 per session for Orientation (first year students only). If approved, the total ICSS fee will be \$130.00 per session for first year students and \$30.00 per session for all other students, charged to all full-time and part-time Innis College students.

THAT beginning in the fall 2011 session, the **Nursing Undergraduate Society** (NUS) fee be increased as follows: (a) an increase of \$2.50 per session (full-time only) in the Canadian Nursing Students Association portion of the fee. If approved, the total NUS fee will be \$22.00 (\$1.00 part-time) per session, charged to all undergraduate Faculty of Nursing students.

THAT beginning in the fall 2011 session, the **Scarborough Campus Community Radio** (SCCR) fee be increased as follows: (a) an increase of \$1.26 in the society portion of the fee. If approved, the total SCCR fee will be increased to \$4.85 per session, charged to all full-time University of Toronto Scarborough students.

THAT, on the condition that the Scarborough Campus Students Union board approves the requests for increases at its meeting on April 11, 2011, beginning in the fall 2011 session, the **Scarborough Campus Students' Union** (SCSU) fee be increased as follows: (a) the continuation of the Student Refugee Program portion of the fee; (b) an increase of \$0.73 (\$0.34 part-time) per session in the Student Centre portion of the fee; (c) an increase of \$0.23 (full-time only) per session in the CFS/CFS-O portion of the fee; (d) an increase of \$1.60 (\$0.32 part-time) per session in the Sports and Recreation Centre portion of the fee; and (e) an increase of \$4.74 (full-time only) per session (including an administration fee and sales tax) in the Dental Plan portion of the fee. If approved, the

total SCSU fee will be \$217.39 (\$20.66 part-time) per session, charged to all undergraduate University of Toronto Scarborough students.

THAT beginning in the fall 2011 session, the **Students' Administrative Council** (operating as the University of Toronto Students' Union; UTSU) fees be increased as follows: (a) an increase of \$0.54 per session in the society portion of the fee; (b) an increase of \$0.02 per session in the Student Refugee Program portion of the fee; (c) an increase of \$0.23 per session in the Canadian Federation of Students (CFS) – CFS-Ontario portion of the fee; (d) an increase of \$3.02 per session (including an administration fee and sales tax) in the Accident & Prescription Drug Plan portion of fee; and (e) an increase of \$2.57 per session for the Dental Plan portion (including an administration fee and sales tax); and (f) for full-time undergraduates on the St. George Campus only, an increase of the fee for the Student Common Project of \$0.56 per session. If approved, the total UTSU-St. George fee will increase to \$156.56, charged to all full-time undergraduate students on the St. George Campus; and the total UTSU-UTM fee will increase to \$148.16, charged to all full-time undergraduate students on the University of Toronto Mississauga campus.

THAT beginning in the fall 2011 session, the **University College Literary and Athletic Society** (UC Lit) fee be decreased as follows: (a) an increase of \$0.34 (\$0.12 part-time) per session in the society portion of the fee; and (b) the elimination of the Student Aid Fund Portion of the Fee. If approved, the total UC Lit fee will be \$16.94 (\$7.62 part-time) per session, charged to all University College students.

THAT beginning in the fall 2011 session, **The Varsity** fee be increased as follows: (a) an increase of \$0.04 per session in the society portion of the fee. If approved, the total Varsity fee will be \$1.33 per session, charged to all full-time undergraduate University of Toronto students.

Subject: Student Society Proposals for Fee Increases

Requests from a number of student societies for the fee changes listed below have been received by the Office of the Vice-Provost, Students. The applications have been reviewed in light of the requirements of the *Policy for Compulsory Non-Academic Incidental Fees*, are found to be in compliance with these requirements, and are recommended for approval.

Requests for fee increases from student societies must meet a number of requirements. Section 2 of the *Policy for Compulsory Non-Academic Incidental Fees* outlines the University's general expectations:

Requests to change the fee collected on behalf of a student society and requests for new fees shall be approved only when evidence has been presented that the request has been authorized by due constitutional process in the organization.

Where the amount of an increase in the fee charged is not greater than the year-over-year change in consumer prices for Ontario as measured by Statistics Canada (December-over-December) as of December 31 of the previous year, the request must be supported by the results of a previous referendum approving the principle of a cost-of-living adjustment. Where the amount of an increase in the fee charged is greater than the year-over-year change in consumer prices, the request must be supported by the majority of the society's members voting in a recent referendum.

The procedures for handling fee change requests (from the *Handbook for Student Societies* published by this office) also provide that requests for a fee increase must be supplied with the following:

Evidence that the request to change the existing fee (or to institute a new charge) has been authorized by due constitutional process of the organization. This evidence should include a copy of or specific reference to the section of the society's constitution which relates to the mechanism for fee changes, minutes of the meeting at

which the resolution to request the change was passed, details and results of any referenda related to the subject which may have been held within the division, and publicity given the matter to ensure that those who may be affected by the change are aware of the proposal, including size and purpose of the increase, and have had the opportunity to make their views known.

Normally, the administration intersects with these processes at two points. Initially, we ask student societies to seek advice from this office on the wording of referendum questions (with respect to clarity and technical language). The second point occurs after the referendum when the student society makes the formal request for a fee increase. The recommendation for approval is derived from the assessment of whether or not the society has met the requirements established in the *Policy* and the relevant procedures.

Occasionally, the Office is asked to look into complaints about referendum procedures and compliance with relevant portions of the society's constitution and/or by-laws. The results of these investigations play a significant role in the assessment of the request and the recommendation for approval.

The assessment of requests for fee increases is normally based upon the following expectations:

- 1) The student society must make the request in a manner consistent with the *Policy for Compulsory Non-Academic Incidental Fees* and the University's procedures for increases to student society fees;
- 2) When required, there must be a positive result in a referendum for a fee increase (special conditions established by the society, such as quorum, must also be met);
- 3) The referendum question itself should be clear and provide enough information to students in order to gain a full understanding of the implications of the question and proposed fee for them;
- 4) The referendum must be held in a fair manner, advertised and promoted in a reasonable manner, and the members of each organization should be given a reasonable opportunity to vote; and
- 5) Each organization must comply with the provisions of its own by-laws, rules of procedure, and specific policies and procedures approved by the society's board or council.

Societies which have previously received approval (by referendum) from their members for an annual cost of living increase in the society's portion of the fee may request increases, upon approval by the society's board or council, of up to the previous Ontario December to December cost of living increase (consumer price index) calculated by Statistics Canada. The December 2010 consumer price index for Ontario was 3.3%.

Where members of a society have given consent (through a previous referendum) to the concept of inflationary increases according to a specific inflation factor or measure, this factor or measure may be used in place of CPI. For example, the Students' Administrative Council (SAC)¹, the Graduate Students' Union (GSU), the Association of Part-time Undergraduate Students (APUS), and the Scarborough Campus Students' Union (SCSU) may request increases in the designated portions of their fees for health and dental plans at a rate established by approval of a previous referendum. SAC, APUS and SCSU may request increases in their health and dental plan fees of up to 10%. The GSU may request increases in its health and dental plan fees of an amount less than or equal to a health industry index.

It is important to note that when dealing with a student society request for a fee change, it is the society's own constitution, by-laws or established policies that set the standards for acceptable results in referenda. In some cases, society constitutions establish a minimum voter turnout in order to consider a referendum result to be valid. The University has not established additional criteria with respect to valid referendum voter turnout.

In addition, the administration relies heavily on the assurances of student societies that due constitutional and fair procedures have been followed.

89 Chestnut Residence Council

Background

In fall/winter 2010-11, the total 89 Chestnut Residence Council fee was \$9.17 per session for all residents of the 89 Chestnut Residence. The entire fee is designated for the society.

Requests

1) A cost of living increase in the society portion of the fee.

At its meeting held on March 14, 2011 the 89 Chestnut Residence Council approved a resolution for a cost of living increase.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

Summary of Changes

Recommendation

THAT beginning in the fall 2011 session, the **89 Chestnut Residence Council** fee be increased as follows: (a) an increase of \$0.30 per session in the society portion of the fee. If approved, the total 89 Chestnut Residence Council fee will be increased to \$9.47 per session, charged to all residents of the 89 Chestnut Residence.

Association of Part-time Undergraduate Students (APUS)

Background

In fall/winter 2010-11, the APUS fee was \$79.79 per session charged to all part-time undergraduate students on all campuses. The fee includes \$3.47 per session for membership in the Canadian Federation of Students (CFS) and CFS-Ontario (CFS-O), \$33.89 (including sales tax) per session for an Accident & Prescription Drug Insurance Plan, and \$28.28 (including sales tax) for a Dental Plan.

Requests

1) A cost of living increase in the CFS/CFS-O portion of the fee.

At its meeting held on March 1, 2011, the APUS Assembly of Class Representatives approved a resolution to request a cost of living increase to the CFS/CFS-O portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

2) An inflationary increase in the Accident & Prescription Drug Insurance Plan portion of the fee.

At its meeting held on March 1, 2011, the APUS Assembly of Class Representatives approved a resolution to request a cost of living increase to the Accident & Prescription Drug Insurance Plan portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

3) An inflationary increase in the Dental Plan portion of the fee.

At its meeting held on March 1, 2011, the APUS Assembly of Class Representatives approved a resolution to request a cost of living increase to the Dental Plan portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

THAT beginning in the fall 2011 session, the **Association of Part-time Undergraduate Students** (APUS) fee be increased as follows: (a) by \$0.11 per session in the Canadian Federation of Students (CFS) / CFS-Ontario portion of the fee; (b) by \$3.39 per session in the Accident & Prescription Drug Plan portion of the fee; and (c) by \$2.83 per session in the Dental Plan portion of the fee. If approved, the total APUS fee will be \$86.12 per session, charged to all part-time undergraduate students on all campuses.

Engineering Society

Background

In fall/winter 2010-11, the total Engineering Society fee was \$123.45 per session for full-time Faculty of Applied Science & Engineering students (\$20.99 per session for part-time students and Professional Experience Year (PEY) students). The fee includes \$22.32 per session (\$20.99 part-time) for the society, \$12.50 per session (\$0.00 part-time) for the Engineering Career Centre; \$2.25 per session (\$0.00 part-time) for the Formula SAE Racing Team; \$75.00 per session (\$0.00 part-time) for a Special Projects Levy; \$1.25 per session (\$0.00 part-time) for a Human Powered Vehicle Design project; and \$1.25 per session (\$0.00 part-time) for Engineers Without Borders. The mandates to continue to charge the Engineering Career Centre, Formula SAE Racing Team, Special Projects Levy, Human Powered Vehicle Design, and Engineers Without Borders portions of the fee end this year.

Requests

1) A cost of living increase to the society portion of the fee.

At its meeting held on March 8, 2011 the University of Toronto Engineering Society Council approved a resolution for a cost of living increase in the society portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

2) The continuation of, and an increase to, the Formula SAE Racing Team portion of the fee.

A referendum was held March 16-18, 2011, in which Applied Science & Engineering students were asked to support the increase and the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

The University of Toronto Formula SAE Racing Team was founded in 1997 by a small group of undergraduate engineering students. Today, it has grown to become an award winning design team comprised of students from a variety of engineering disciplines. The team's mandate is to design, build and race an open-wheel, open-cockpit high performance vehicle to compete internationally in the Formula SAE/Formula Student Collegiate Design Competitions.

In its short history the UofT team has won 3 European Championships, and is currently one of the top ranking Canadian teams worldwide. We are one of the most successful and celebrated Formula Racing teams in the 26 year history of the series, and our success

continues to represent the quality that employers associate with engineering students from *UofT*.

On campus, our team is a hub of academic activity that provides all engineering students with technical workshops, guest lectures and team projects that each help to develop skills that complement the academic studies of our team members. Every September, we organize and host the largest student-run competition in the world, the UofT Shootout at Mosport International Raceway. Each year our team also actively promotes the University of Toronto and Engineering Faculties at on-campus events as well as at dozens of major public events such as the Canadian International Autoshow.

Our past and present success has been made possible through the funding from our Engineering Society Levy and from you, the students. As we look forward towards the future, we hope that you will continue to support our team through the renewal and increase of the Formula SAE Levy; a \$5.50 fee per academic term (\$2.75 per fall/winter semester) for all full-time engineering undergraduate students. The money raised from this levy is crucial for our team to exist. Our transportation costs alone of our vehicle shipping to competitions exceed the amount currently provided by the Engineering Society Levy. These funds are essential to remain competitive in this series and to continue representing U of T as one of the top-ranking Engineering institutions worldwide.

3) The continuation of the Special Projects Levy portion of the fee through the 2012-13 fall/winter academic period.

A referendum was held March 16-18, 2011, in which Applied Science & Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

On behalf of all full-time students registered in the Faculty of Applied Science and Engineering, the University of Toronto Engineering Society proposes that the Temporary Special Levy is renewed at \$150 per academic term (\$70 per semester).

The fund has been crucial to the improvement of the undergraduate academic experience since its creation in 1983. The fund has been used to benefit all departments, paying for new computers for the ECF labs, for experiment set ups and tutorial demonstrations for all departments, and for tutor training for the Engineering Society tutoring service. The purpose of the fund is the purchase of equipment or services, such as laboratory setups, computer lab updates, and tutoring services that will directly enhance the engineering undergraduate education.

4) The continuation of the Human Powered Vehicle Design project portion of the fee through the 2012-13 fall/winter academic period.

A referendum was held March 16-18, 2011, in which Applied Science & Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Pre-Amble

The University of Toronto Human Powered Vehicle Design Team (HPVDT) was established in 2006, and has since had great success due in large part to the support of you, undergraduate engineering students. The team's first technical project was a human-powered ornithoper (HPO), a flapping-wing aircraft. After 4 years of dedicated work and support from students like you, the HPO became the world's first successful human-powered flapping-wing aircraft, a 500 year-old dream first set down by DaVinci. The HPO has brought international

attention to U of T Engineering through media outlets such as Popular Science and CNN, as far away as Germany, Australia, and Japan.

The team's current project, renewed annually, is a streamlined recumbent bicycle, designed to compete in the ASME HPV Challenge held in the U.S. each year. This competition features speed, endurance, and utility challenges, and involves more than 25 teams from all over the world. In 2010, at the U of T HPVDT's first entry into the competition, the team took 3rd place overall. In September of 2010, the team also traveled to the World Human-Powered Speed Challenge in Battle Mountain, Nevada, and came away with the World Collegiate Speed Record, at an amazing 101 Km/h!

A primary objective of HPVDT is to promote hands-on and practical learning as a supplement to the theoretical teachings of the classroom. This experience provides unique preparation for a career as an engineer through emphasis on elegant and sustainable design. Team members utilize advanced optimization and design techniques including aerodynamic (CFD) and structural (FEM) analysis. Design meets implementation through construction using advanced composites and other state-of-the-art materials.

Both projects will continue to highlight the role of the Engineering Faculty as an innovator and environmental leader. The HPVDT has become an active member of the university community, hosting seminars on human-powered flight, participating in the Sustainable Energy Fair, and partnering with other engineering design teams to mutually enhance technical capabilities. Further, we hope to encourage the use of alternative energies in transportation, while promoting self-improvement and environmental stewardship. Human power in particular remains an untapped yet viable means of long-distance transportation.

The HPVDT Levy accounts for about 15% of the team's budget. This funding will be vital to the team and used to purchase equipment, software, and construction materials. The team is committed to actively pursuing outside sponsorship and donations from local and international companies, while at the same time marketing you, U of T Engineering Students. On campus, EWB-UT hosts regular opportunities for students to understand the complexity behind international development and practice their leadership capabilities in leading our numerous outreach events in the community. Off campus, EWB-UT members also visit 40-50 high schools each year to conduct workshops on world water resources and energy issues, promoting the Engineering Profession and global citizenship in tandem. EWB-UT has grown in capacity and was named Canada's "Chapter of the Year" in January 2010. This proposed levy will allow EWB-UT to advance its core activities that provide engineering students with the best opportunities to create impact in the developing world.

We ask for your support in continuing the levy in the amount of \$2.50 per academic term (\$1.25 per student) for each full-time undergraduate student. This funding will focus on enhancing the activities of EWB-UT, in all aspects of our projects and outreach to engineering students. Most importantly, this funding will enable EWB-UT's events to be more financially accessible to engineering students. 6) The establishment of an Endowment Fund portion of the fee through the 2012-13 fall/winter academic period.

A referendum was held March 16-18, 2011, in which Applied Science & Engineering students were asked to support the establishment of the levy for the next two years. The wording of the question is as follows:

Preamble

Currently, each undergraduate student at the Faculty of Applied Science and Engineering pays a \$150 mandatory fee for the "Students' Temporary Special Levy" for the improvement of academic facilities at the University. This money is held in trust by the University of Toronto Engineering Society each year and is matched 50% by the Faculty. Distribution of such money is decided upon by a committee of student representatives based on proposals from each Department of the Faculty.

Although the levy is temporary, it has been in effect since 1983 (renewed bi-annually), and no effort has been made to establish a permanent fund to remove the need for the "temporary" levy.

The proposed SkuleTM Endowment Fund will consist of a \$100 levy to each undergraduate student, and students will have the opportunity to opt-out of the levy at each academic year if they do not wish to participate in the endowment fund.

Interest earned from the principal collected through the levy will be used each year to fund academic and student life improvements following the same procedure as the existing Temporary Special Levy. For the first two years of the fund, no withdrawals will be made to maximize its earnings. Following that, withdrawals from the fund will be made according to interest earned in the previous year. The levy for the Endowment Fund will be renewed by referendum every two years.

In addition, the principal of the fund can be spent on capital projects such as building renovations and student space construction in the future when the need arises. Such decisions will be made by student representatives with the Engineering Society.

The goals of the SkuleTM Endowment Fund are:

- Establish a permanent endowment for improvement of student facilities, academic facilities, and student club funding
- In the short term, reduce the cost of the Temporary Special Levy by offsets made with the Endowment Fund

- In the long term, replace the Temporary Special Levy with the associated gains of the Endowment Fund
- Create a long-term financial plan for provision of capital projects such as building renovations and construction of new student space

An example of such a student-run Endowment Fund has been in place at the University of Waterloo since 1990. The Waterloo Engineering Education Foundation (WEEF) has collected more than \$9 million to date and distributes up to \$400,000 per year to student clubs, departments, and special projects.

A referendum was held March 16-18, 2011, in which Applied Science & Engineering students were asked to support the establishment of the levy for the next two years. The wording of the question is as follows:

Preamble

The University of Toronto Robotics Association (UTRA) was formed in the winter of 2002 with an objective to design, build and maintain robots to compete in internationally recognized robotics competitions.

Since then UTRA has expanded to an organization of 200 University of Toronto undergraduate and graduate students, alumni and faculty. Graduate students, alumni and faculty merely advise the team; UTRA is run by undergraduate engineering students, and all robots are designed and built by undergraduates. Since 2006, UTRA has begun rapidly expanding the scope of its activities to include Sumo Robots, Robot Fire Fighting, Robot Soccer, Autonomous Robot Racing, 3D Printers, and the UT-FIRST mentorship program. In

2007, UTRA began traveling to California to compete in RoboGames. RoboGames is the largest robotics competition in the world, with a large number of international competitors.

UTRA has been most successful in combat robotics, which compete annually at RoboGames. UTRA won the bronze medal in 2008 and 2009, and topped it off with the gold medal in the 120-lbs weight class in 2010. We currently have the best 120-lbs combat robot in the world!! Being the only Canadian university team who won a gold medal at RoboGames 2010, UTRA was invited to an interview by the Toronto Star and made a live appearance on CTV. Furthermore, our latest project, known as Autonomous Rover Team (ART), has successfully built our very first fully autonomous robot and participated in RobotRacing competition in Windsor, Ontario, in July 2010. This project is the milestone of various other international competitions, and it is a well-respected field amongst the robotics experts.

In addition, UTRA has been increasing its involvement in outreach initiatives. While continuing to support the UT-FIRST Robotics program, this year UTRA attended the TEDx Youth event which was a great opportunity to promote our vision and raise awareness of what UTRA has accomplished in the recent years.

UTRA has long been a multi-disciplinary student club where members of various engineering backgrounds work together on supplementing their technical skills with practical experience. UTRA is committed to providing students with team building and hands-on technical experience regardless of their background and experience in robotics. All the aforementioned projects require substantial funding, and the members of the club always propose new ideas which are only possible given sufficient funding. As the club has continued to expand, so have its funding requirements. We would like to kindly ask for the support of the full-time engineering undergraduate students to help us further expand and improve the leading robotics club at the University of Toronto. UTRA has never before asked for a student levy; all of our numerous projects have been funded by rigorous fundraising - which we will continue to do. A levy of \$2.50 levy per academic year (\$1.25 per fall/winter semester) will give UTRA the necessary funds to be competitive in the numerous international competitions that we attend. The American schools that we often compete against easily have five to ten times the budget that we do!

Currently, an increase to the fee is not automatically implemented, but rather requires a referendum of the membership prior to approval by the Nursing Undergraduate Society and the University Affairs Board of the Governing Council as defined in the Policy on Compulsory Non-Academic Incidental Fees.

Based on the current Consumer Price Index of 3.3% for 2011, the fee increase for September 2011 would be \$0.56 per session (Fall/Winter). The Nursing Undergraduate Society would retain the ability to implement this increase until 2015 and the total increase per session will not exceed \$2.00.

The purpose of the requested increase is:

- a) To allow Fusion Radio to meet minimum wage laws
- b) Provide additional involvement opportunities to students
- c) To fund new staff positions necessary to improve the quality of programming
- d) To contribute to realizing our dream of a functional FM radio station at the University of Toronto Scarborough

Fusion radio currently receives no funds for the summer session, despite that it is active and broadcasting 12 months per year and it employs its staff (primarily students) year-round. To maintain this service and these opportunities, summer funds are necessary.

The fee on both campuses includes \$16.46 per session designated for the society; \$0.63 per session for a Student Refugee Program; \$6.91 per session for membership in the Canadian Federation of Students (CFS) and CFS-Ontario (CFS-O); \$60.32 (including an administration fee and sales tax) for an Accident and Prescription Drug Plan; and \$51.38 (including an administration fee and sales tax) for a Dental Plan. In addition, full-time undergraduate St. George Campus students are charged \$5.59 per session for the Student Commons.
