Dear Mr. Delaney,

As chair of the UTM Quality Services to Students Council, I am writing to confirm the decisions of the Council with respect to UTM's Student Affairs and Services operating plans and fees. The resolutions that were considered by the Council along with the record of voting are reported here. The relevant documentation for each resolution is attached.

## **RESOLUTION #1 – Considered by the QSS Council on March 1, 2012**

That the 2012-13 operating plans and budget for **Health Services**, as presented by Allison Burnett, Director of the UTM Health & Counselling Centre, be approved by UTM's Quality Service to Students Council; and

That the sessional fee for a UTM-registered or UTM-affiliated full-time student remain at \$28.67 (\$5.73 for a UTM-registered or UTM-affiliated part-time student) which represents a year over year increase of \$0 (0%) (resulting from the expiration of a 2009-10 three-year temporary increase, and a permanent increase of \$1.47).

That the sessional fee for a UTM-registered or UTM-affiliated full-time student increase to \$8.39 (\$1.68 for a UTM-registered or UTM-affiliated part-time student) which represents a year over year increase of \$0.26 (3.2%).

That the 2012-13 operating plans and budget for the **UTM International Centre**, as presented by Dale Mullings, Director of Student and Residence Life, be approved by UTM's Quality Service to Students Council; and

That the sessional fee for a UTM-registered or UTM-affiliated full-time student increase to \$3.97 (\$0.79 for a UTM-registered or UTM-affiliated part-time student) which represents a year over year increase of \$1.79 (82.1%).

# **RESOLUTION #6 – Considered by the QSS Council on March 1, 2012**

That the proposed 2012-13 consolidated **UTM Student Services Fee** (including the Student Shuttle Service, Career Centre, Child Care Support, Handbook & Communications, Space Occupied by Student Societies, Alcohol Education & Monitoring, Family Care, and amended International Students Centre), as presented by Mark Overton, Dean of Student Affairs, be approved by UTM's Quality Service to Students Council; and



That the sessional **UTM Student Services Fee** for a UTM-registered or UTMaffiliated full-time **undergraduate** student be increased to \$133.02 (\$26.60 for a UTM-registered or UTM-affiliated part-time undergraduate student), which represents a year over year permanent increase of \$1.94 (1.5%); and

That the sessional **UTM Student Services Fee** for a UTM-registered or UTMaffiliated full-time **graduate** student be increased to \$120.90, (\$24.18 for a UTMregistered or UTM-affiliated part-time graduate student) which represents a year over year permanent increase of \$2.59 (2.2%); and

That the sessional **UTM Summer Shuttle Service Fee** for a UTM-registered or UTM-affiliated full-time graduate student, assessed in the fall and winter sessions only, be increased to \$4.45, which represents a year over year permanent increase of \$0.26 (6.1%); and

That the sessional **UTM Summer U-Pass Fee** for a UTM-registered or UTMaffiliated full-time graduate student, assessed in the fall and winter sessions only, be introduced to \$47.58; and

That the sessional **UTM Fall/Winter U-Pass Fee** for a UTM-registered or UTMaffiliated full-time graduate student, assessed in the fall and winter sessions only, be increased to \$72.10, which represents a year over year permanent increase of \$6.35 (9.7%); and

That the sessional **UTM Summer Shuttle Service Fee** for a full-time undergraduate Mississauga Academy of Medicine student, assessed in the fall and winter sessions only, be increased to \$4.45, which represents a year over year permanent increase of \$0.26 (6.1%).

Be it further resolved that this motion be verified for accuracy by ensuring it is in line and consistent with preceding motions.
