Subject: Student Society Proposals for Fee Increases

Requests from a number of student societies for the fee changes listed below have been received by the Office of the Vice-Provost, Students. The applications have been reviewed in light of the requirements of the *Policy for Compulsory Non-Academic Incidental Fees*, are found to be in compliance with these requirements, and are recommended for approval.

Requests for fee increases from student societies must meet a number of requirements. Section 2 of the *Policy for Compulsory Non-Academic Incidental Fees* outlines the University's general expectations:

Requests to change the fee collected on behalf of a student society and requests for new fees shall be approved only when evidence has been presented that the request has been authorized by due constitutional process in the organization.

Where the amount of an increase in the fee charged is not greater than the year-over-year change in consumer prices for Ontario as measured by Statistics Canada (December-over-December) as of December 31 of the previous year, the request must be supported by the results of a previous referendum approving the principle of a cost-of-living adjustment. Where the amount of an increase in the fee charged is greater than the year-over-year change in consumer prices, the request must be supported by the majority of the society's members voting in a recent referendum.

The procedures for handling fee change requests (from the *Handbook for Student Societies* published by this office) also provide that requests for a fee increase must be supplied with the following:

Evidence that the request to change the existing fee (or to institute a new charge) has been authorized by due constitutional process of the organization. This evidence should include a copy of or specific reference to the section of the society's constitution which relates to the mechanism for fee changes, minutes of the meeting at

which the resolution to request the change was passed, details and results of any referenda related to the subject which may have been held within the division, and publicity given the matter to ensure that those who may be affected by the change are aware of the proposal, including size and purpose of the increase, and have had the opportunity to make their views known.

Normally, the administration intersects with these processes at two points. Initially, we ask student societies to seek advice from this office on the wording of referendum questions (with respect to clarity and technical language). The second point occurs after the referendum when the student society makes the formal request for a fee increase. The recommendation for approval is derived from the assessment of whether or not the society has met the requirements established in the *Policy* and the relevant procedures.

Occasionally, the Office is asked to look into complaints about referendum procedures and compliance with relevant portions of the society's constitution and/or by-laws. The results of these investigations play a significant role in the assessment of the request and the recommendation for approval.

The assessment of requests for fee increases is normally based upon the following expectations:

- 1) The student society must make the request in a manner consistent with the *Policy for Compulsory Non-Academic Incidental Fees* and the University's procedures for increases to student society fees;
- 2) When required, there must be a positive result in a referendum for a fee increase (special conditions established by the society, such as quorum, must also be met);
- 3) The referendum question itself should be clear and provide enough information to students in order to gain a full understanding of the implications of the question and proposed fee for them;
- 4) The referendum must be held in a fair manner, advertised and promoted in a reasonable manner, and the members of each organization should be given a reasonable opportunity to vote; and
- Each organization must comply with the provisions of its own by-laws, rules of procedure, and specific policies and procedures approved by the society's board or council.

Societies which have previously received approval (by referendum) from their members for an annual cost of living increase in the society's portion of the fee may request increases, upon approval by the society's board or council, of up to the previous Ontario December to December cost of living increase (consumer price index) calculated by Statistics Canada. The December 2012 consumer price index for Ontario was 0.8%.

Where members of a society have given consent (through a previous referendum) to the concept of inflationary increases according to a specific inflation factor or measure, this factor or measure may be used in place of CPI. For example, the Students' Administrative Council (SAC)¹, the Graduate Students' Union (GSU), the Association of Part-time Undergraduate Students (APUS), and the Scarborough Campus Students' Union (SCSU) may request increases in the designated portions of their fees for health and dental plans at a rate established by approval of a previous referendum. SAC, APUS and SCSU may request increases in their health and dental plan fees of up to 10%. The GSU may request increases in its health and dental plan fees of an amount less than or equal to a health industry index.

It is important to note that when dealing with a student society request for a fee change, it is the society's own constitution, by-laws or established policies that set the standards for acceptable results in referenda. In some cases, society constitutions establish a minimum voter turnout in order to consider a referendum result to be valid. The University has not established additional criteria with respect to valid referendum voter turnout.

In addition, the administration relies heavily on the assurances of student societies that due constitutional and fair procedures have been followed.

Association of Part-time Undergraduate Students (APUS)

Background

In fall/winter 2012-13, the APUS fee was \$92.55 per session charged to all part-time undergraduate students on all campuses. The fee includes \$3.65 per session for membership in the Canadian Federation of Students (CFS) and CFS-Ontario (CFS-O).

Requests

1) A cost of living increase in the CFS/CFS-O portion of the fee.

At its meeting held on April 3, 2013, the APUS Assembly of Class Representatives approved a resolution to request a cost of living increase to the CFS/CFS-O portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

Summary of Changes

Recommendation

THAT beginning in the fall 2013 session, the **Association of Part-time Undergraduate Students** (APUS) fee be increased as follows: (a) by \$0.06 per session in the Canadian Federation of Students (CFS) / CFS-Ontario portion of the fee. If approved, the total APUS fee will be \$92.61 per session, charged to all part-time undergraduate students on all campuses.

Engineering Society

Background

In fall/winter 2012-13, the total Engineering Society fee was \$161.47 per session for full-time Faculty of Applied Science & Engineering students (\$22.11 per session for part-time students and Professional Experience Year (PEY) students). The fee includes \$23.52 per session (\$22.11 part-time) for the society; \$2.75 per session (\$0.00 part-time) for the Formula SAE Racing Team; \$75.00 per session (\$0.00 part-time) for a Special Projects Levy; \$1.25 per session (\$0.00) for a Human Powered Vehicle Design project; \$1.25 per session (\$0.00 part-time) for Engineers Without Borders; \$50.00 per session (\$0.00 part-time)

time) for An Endowment Fund; and \$1.25 per session (\$0.00 part-time) for the Robotics Association. The mandates to continue to charge the Formula SAE Racing Team, Special Projects Levy, Human Powered Vehicle Design, Engineers Without Borders, and the Robotics Association portions of the fee end this year.

Requests

1) A cost of living increase to the society portion of the fee.

At its meeting held on February 20th, 2013 the University of Toronto Engineering Society Council approved a resolution for a cost of living increase in the society portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

2) The continuation of the Formula SAE Racing Team portion of the fee through the 2014-15 fall/winter academic period.

A referendum was held From March 28-April 3, 2013, in which Applied Science & Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

The Engineering Society is seeking consent from its members to continue the levy for the Formula SAE team. The levy will be \$5.50 per session per student (\$2.75 per Fall & Winter academic sessions).

If the levy is approved, it will continue to be charged to all full-time undergraduate Applied Science and Engineering students in fall 2013 and fall 2014. Subsequent referendum approval will be required to continue the fee after the 2014/15 session.

3) The continuation and decrease of the Special Projects Levy portion of the fee through the 2014-15 fall/winter academic period.

A referendum was held from March 6-8, 2013 in which Applied Science & Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

The Engineering Society is proposing that the Temporary Special Levy be continued and decreased from \$150 per year (\$75 per session) to \$125 per year (\$62.50 per session) for the years 2013-14 and 2014-15.

The fund has been crucial to the improvement of the undergraduate academic experience since its creation in 1983. The fund has been used to benefit all departments, paying for new computers for the ECF labs, for experiment set ups and tutorial demonstrations for all departments, and for tutor training for the Engineering Society tutoring service. The purpose of the fund is the purchase of equipment or services, such as laboratory setups, computer lab updates, and tutoring services that will directly enhance the engineering undergraduate education. In 2012-13, the fund enabled the creation of new study spaces in the Engineering and Computer Science Library and in the Bahen Centre

At the end of each fiscal year, the leftover funds that have not been spent due to lack of qualifying submissions may be transferred to the SkuleTM Endowment Fund if approved by the elected Engineering Society board of Directors, which includes representatives from each discipline.

Preamble

The Engineering Society is seeking consent from its members to continue the levy for the Human Powered Vehicle Design Team (HPVDT). The levy will be \$1.25 per session per student (\$2.50 per fall & winter academic sessions).

If the levy is approved, it will continue to be charged to all full-time undergraduate Applied Science and Engineering students in fall 2013 and fall 2014. Subsequent referendum approval will be required to continue the fee after the 2014/2015 session.

5) The continuation of the Engineers Without Borders portion of the fee through the 2014-15 fall/winter academic period.

A referendum was held March 28 - April 3, 2013 in which Applied Science & Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

The Engineering Society is seeking consent from its members to continue the levy for the Engineers Without Borders – University of Toronto Chapter (EWB). The levy will be \$1.25 per session per student (\$2.50 per Fall & Winter academic sessions).

If the levy is approved, it will continue to be charged to all full-time undergraduate Applied Science and Engineering students in fall 2013 and fall 2014. Subsequent referendum approval will be required to continue the fee after the 2014/2015 session.

6) The continuation of the Endowment Fund portion of the fee through the 2014-15 fall/winter academic period.

A referendum was held from March 6-8, 2013, in which Applied Science & Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

The Engineering Society is proposing continuation of the SkuleTM Endowment Fund levy of \$100 per year (\$50 per session) for the years 2013-2014 and 2014-2015.

The Skule™ Endowment Fund was established by referendum in the spring of 2011. Since then a total of \$857,038 has been collected. Since 1983, engineering students have paid into the Temporary Special Levy, initially \$100 per year until 2009 when it was increased to \$150. This fund is expended annually by engineering departments to pay for laboratory equipment, academic facilities and computer labs. The Endowment Fund is intended to gradually eliminate the need for future students to pay this levy.

*The goals of the Skule*TM *Endowment Fund are:*

- Establish a permanent endowment for improvement of student facilities, academic facilities, and student club funding
- In the short term, reduce the cost of the Temporary Special Levy by offsetting it with income from the Endowment Fund
- In the long term, replace the Temporary Special Levy with the associated gains of the Endowment Fund

• Create a long-term financial plan for provision of capital projects such as building renovations and construction of new student space

The Engineering Society has reached an agreement with the University of Toronto that allows the funds to be held and invested by the University in trust while elected student representatives retain control over the use of any income or principal.

Interest earned from the principal collected through the levy may be used each year to fund academic and student life improvements following the same procedure as the existing Temporary Special Levy. Capital improvements previously funded through similar student levies include the renovation of the Sandford Fleming Atrium and the Engineering and Computer Science library. The levy for the Endowment Fund will be renewed by referendum every two years.

In addition, the principal of the fund can be spent on capital projects such as building renovations and student space construction in the future when the need arises. Such decisions will be made by elected student representatives with the Engineering Society. The Faculty of Applied Science and Engineering is currently in the process of fundraising for the construction of an entirely new engineering building on St. George St. adjacent to the Galbraith Building. At this early stage, capital contributions from students through the Endowment Fund may be able to provide substantially superior student facilities in this new building, thereby improving student experience in the Faculty for decades to come.

An example of such a student-run Endowment Fund has been in place at the University of Waterloo since 1990. The Waterloo Engineering Education Foundation (WEEF) has collected more than \$9 million to date and distributes up to \$400,000 per year to student clubs, departments, and special projects.

Students will be able to opt out by November 1 of each year, and a cheque for the amount paid will be cut, payable to them, by the Engineering Society.

The Engineering Society is seeking consent from its members to continue and increase the levy for the University of Toronto Robotics Association (UTRA). The levy will be \$1.50 per session per student (\$3.00 per Fall & Winter academic sessions).

If the levy is approved, it will continue to be charged to all full-time undergraduate Applied Science and Engineering students in fall 2013 and fall 2014. Subsequent referendum approval will be required to continue the fee after the 2014/2015 session.

Recommendations

THAT beginning in the fall 2013 session, the **Engineering Society** fee be increased as follows: (a) an increase of \$0.19 (\$0.18 part-time) per session in the society portion of the fee; (b) continuation of the Formula SAE Racing Team portion of the fee through 2014-15; (c) continuation of and decrease of the Special Projects Levy portion of the fee of \$62.50 (\$0.00 part-time) through 2014-15; (d) continuation of the Human Power Vehicle Design portion of the fee through 2014-15; (e) continuation of the Engineers Without Borders portion of the fee through 2014-15; (f) the continuation of the Endowment Fund portion of the fee through 2014-15; (g) the continuation and increase of the Robotics Association portion of the fee \$1.50 (\$0.00 part-time) through 2014-15; (h) the establishment of a Concrete Canoe Team portion of the fee \$0.90 (\$0.00 part-time) through 2014-15; (i) the establishment of a Blue Sky Solar Racing Team portion of the fee \$2.75 (\$0.00 part-time) through 2014-15. If approved, the total Engineering Society fee will be decreased to \$153.06 (\$22.29 part-time) per session, charged to all Faculty of Applied Science and Engineering students.

Association of Erindale Part-time Undergraduate Students (EPUS)

Background

At present, the EPUS fee includes an \$88.20 per session fee in the summer for a Mississauga Transit U-Pass for all part-time undergraduate University of Toronto Mississauga students.

Requests

1) An inflationary increase in the summer Mississauga Transit U-Pass portion of the fee.

In accordance with the original referendum question, EPUS may request increases to the Mississauga Transit U-Pass portion of the fee of up to 9.0% upon approval of a resolution by the Executive Committee of EPUS.

At its meeting held on October 19, 2012, the EPUS Board approved the resolution to request inflationary increases to the summer Mississauga Transit U-Pass portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

2) The cancellation of fee collection on behalf of EPUS effective in the Fall 2013 session.

A referendum was held from March 26-28, 2013, in which UTM part-time undergraduate students were asked to support the permanent folding of the EPUS organization into the Erindale College Students Union (UTMSU). Part-time Students at UTM would continue to also be members of the Association of Part-time Undergraduate Students (APUS). The wording of the question is as follows:

Preamble

The University of Toronto Mississauga Students Union (UTMSU) [legally operating as the Erindale College Student Union, Inc] and the Association of Erindale Part-time Undergraduate Students (EPUS) are seeking consent from Part-Time Undergraduate Students at UTM to:

- (1) Dissolve the Association Of Erindale Part-Time Undergraduate Students' (EPUS) effective August 31, 2013.
- (2) Obtain part-time undergraduate membership in and representation by UTMSU effective September 1, 2013.

If these changes are approved,

- (1) the EPUS Membership Fee* of \$76.35 per Fall and Winter session and \$93.95 per Summer session will cease to be collected as of August 31, 2013;
- (2) A total UTMSU Membership Fee** of \$90.49 per Fall and Winter session and \$107.84 per Summer session will be charged to all part-time undergraduate students at UTM effective the Fall 2013 and Summer 2014 sessions respectively;

- (3) Annual cost of living and inflationary increaseds (determined as per the Statistics Canada's Consumer Price Index for Ontario, except where expressly indicated otherwise on the back of this ballot) will be applied to the relevant designated portions of the UTMSU Membership Fee effective the Fall 2013 and Summer 2014 sessions respectively;
- (4) Effective June 1st, 2013 the EPUS Membership Fee for summer 2013 will be administered in trust by the UTMSU.

Erindale College Student Union (operating as the University of Toronto Mississauga Students' Union; UTMSU)

Background

In fall/winter 2012-13, the total UTMSU fee was \$105.31 per session for full-time University of Toronto Mississauga (UTM) students. The fee includes \$0.98 per session for Academic Societies, \$71.67 per session for the Mississauga Transit UPass and \$1.06 per session for a Student Refugee Program.

Requests

1) A cost of living increase in the society portion of the fee.

At its meeting held on February 28, 2013 the UTMSU Board approved a resolution to request a cost of living increase to the society portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

2) A cost of living increase in the Academic Societies portion of the fee.

At its meeting held on February 28, 2013 the UTMSU Board approved a resolution to request a cost of living increase to the Academic Societies portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

3) A cost of living increase in the Student Refugee Program portion of the fee.

At its meeting held on February 28, 2013 the UTMSU Board approved a resolution to request a cost of living increase to the Student Refugee Program portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

4) An inflationary increase in the Mississauga Transit UPass portion of the fee.

In accordance with the original referendum question, ECSU may request increases to the Mississauga Transit U-Pass portion of the fee of up to 9.0% upon approval of a resolution by the ECSU Board of Directors.

At its meeting held on February 28, 2013 the UTMSU Board approved a resolution to request a cost of living increase to the 8-month U-Pass program portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

An inflationary increase in the Food Bank and the Erindale College Special Response Team (ECSPERT) portions of the fee.

At its meeting held on February 28, 2013 the UTMSU Board approved a resolution to request a cost of living increase to the Food Bank and the Erindale College Special Response Team (ECSPERT) portion of the fee.

* Please note that the CPI increase for 2013 was not significant enough to alter the dollar value of these two fees. The increase will however be taken into account as the base number for the calculation of next year's CPI increase.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

The establishment of fees for part-time students as per the 2013 EPUS Referendum question portion of the fee.

At its meeting held on April 11, 2013 the UTMSU Board approved resolutions to adopt a fee schedule for part-time students as dictated by the results of the 2013 EPUS Referendum.

At its meeting held on March 28, 2013 the UTSU Board approved a resolution to request a cost of living increase to the levy.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

3) A cost of living increase in the CFS/CFS-O portion of the fee.

In accordance with the original referendum question, the UTSU may request increases to the CFS/CFS-O levy by an amount identified by CFS/CFS-O upon approval of a resolution by the Board of Directors of the UTSU.

At its meeting held on March 28, 2013 the UTSU Board approved a resolution to request a cost of living increase to the levy.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

4) An inflationary increase in the Student Commons portion of the fee (St. George Students only).

At its meeting held on March 28, 2013 the UTSU Board approved a resolution to request an inflationary increase to the levy.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

5) An inflationary increase in the Accident and Prescription Drug Plan portion of the fee.

At its meeting held on March 28, 2013 the UTSU Board approved a resolution to request an inflationary increase to the levy.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

6) An inflationary increase in the Dental Plan portion of the fee.

At its meeting held on March 28, 2013 the UTSU Board approved a resolution to request an inflationary increase to the levy.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

7) An increase to the Bike Chain (formerly BikeShare) portion of the fee (St. George Students only).

A referendum was held from March 12-14, 2013, in which St. George undergraduate students were asked to support an increase to the Bike Chain levy. The wording of the question is as follows:

Preamble

Bike Chain (formerly Bike Share) is the on-campus bicycle repair facility, which offers the use of tools and the advice of trained mechanics for free to the University community. Bike Chain also operates a bike lending program that is free to students, as well as various events and seminars through the course of the school year.

Currently, Bike Chain receives a levy of \$0.25 per student per semester as a refundable part of the University of Toronto Students' Union fee as per a Winter 2004 referendum. This funding is split equally between the do-it-yourself repair space and the bike lending program. Bike Chain has grown in their capacity to service the University community every year. Bike Chain currently hires 3 mechanics during the summer and 15 work-study positions during the

year. In 2010, more than 3900 service visits were logged at Bike Chain, and that number continues to grow. Bike Chain needs additional funding to expand its services.

The University of Toronto Students' Union is asking its members whether they consent to a proposed increase of \$0.25 per semester to the Bike Share refundable levy collected (for a total of \$0.50 per semester per student) for the purpose of funding Bike Chain, as described in the preamble. U.T.S.U. is also requesting that the total levy be indexed annually to the Statistics Canada Ontario consumer price index rate for the previous year pending the approval of the UTSU board.

THAT beginning in the fall 2013 session, the **Students' Administrative Council** (operating as the University of Toronto Students' Union; UTSU) fees be increased as follows: (a) an increase of \$0.14 per session in the society portion of the fee; (b) an increase of \$0.01 per session in the Student Refugee Program portion of the fee; (c) an increase of \$0.11 per session in the Canadian Federation of Students (CFS) – CFS-Ontario portion of the fee; (d) an increase of \$6.27 per session (including an administration fee and sales tax) in the Accident & Prescription Drug Plan portion of fee; and (e) an increase of \$5.65 per session for the Dental Plan portion (including an administration fee and sales tax); (f) for full-time undergraduates on the St. George Campus only, an increase of the fee for the Bike Chain (formerly BikeShare) levy of \$0.25 per session; and (g) for full-time undergraduates on the St. George Campus only, an increase of the fee for the Student Common Project of \$0.68 per session. If approved, the total UTSU-St. George fee will increase to \$172.74, charged to all full-time

undergraduate students on the St. George Campus; and the total UTSU-UTM fee will increase to \$162.79, charged to all full-time undergraduate students on the University of Toronto Mississauga campus.

University College Literary and Athletic Society (UC Lit)

Background

In fall/winter 2012-13, the UC Lit fee was \$16.94 per session for full-time undergraduate University College students (\$7.62 for part-time students). The fee includes \$10.76 (\$3.61 part-time) per session designated for the society.

Requests

1) A cost of living increase in the society portion of the fee.

At its meeting held on May 27, 2012, the UC Lit Council approved a resolution to request a cost of living increase to the society portion of the fee.

In course of considering this request, the Office of the Vice-Provost, Students has not received any complaints concerning the process leading up to the request.

2) The establishment of a UC Follies Theatre Troupe portion of the fee.

A referendum was held on September 20, 2012, in which University College students were asked to support the establishment of a UC Follies Theatre Troupe levy. The wording of the question is as follows:

Preamble

The University College Literary & Athletic Society is seeking consent from its members for the creation of a new portion of the University College Literary & Athletic Society fee. The proposed increase is \$0.50 per session.

The new portion of the fee will be used to ensure financial stability to [sic] the UC Follies, the College's own theatre troupe founded in the 1890s. Unlike the Gargoyle or the UC Review, the UC Follies do no currently rely on a fixed student levy to support its theatrical productions. The Council of the UC Lit would like to remedy to this situation and provide the Follies with their own levy.

If the increase is approved, the total fee for the University College Literary & Athletic Society will be \$18.60 per session and will be charged to all full-time and part-time University College students beginning in the fall 2013 session.

Varsity Publications Inc. (The Varsity)

Background

In fall/winter 2012-13, The Varsity fee was \$1.36 per session for full-time undergraduate University of Toronto students.

Requests

1) An increase to the society portion of the fee.

A referendum was held from January 28-30, 2013, in which all full-time undergraduate students (all 3 campuses) were asked to support an increase to the society portion of the fee. The wording of the question is as follows:

Preamble

The Varsity is the University of Toronto's largest student newspaper, with a print circulation of 20,000 across all three campuses and one of the most visited websites of any student publication in Canada. The Varsity is a voice for University of Toronto Students, covering issues and events that matter to the community.

The Varsity receives a student levy of \$1.36 per semester from full-time undergraduates at the University of Toronto. The levy is four times less than the average for Canadian university newspapers.

The Varsity is seeking to increase its student levy by \$0.50 per semester from the current fee of \$1.36 per semester to \$1.86 per semester. The annual cost of living increase approved in the spring 2007 referendum would continue to apply to this fee.
