ITEM IDENTIFICATION:

Student Societies: Requests for Fee Increases – University of Toronto St. George and Multi-Campus

JURISDICTIONAL INFORMATION:

Section 5 of the University Affairs Board Terms of Reference list student societies and compulsory non-academic incidental fees among the Board's areas of responsibility.

Sections 5.2.1 and 5.2.2 provide that compulsory non-academic incidental fees for representative student committees and divisional student societies "are approved by the Board."

Student society fees are subject to the terms and conditions of the *Policy on Ancillary Fees* (Category 2.0, "Student organizations and services provided by such organizations," and Category 3.0, "Student levies for specific, limited projects"), and the *Policy for Compulsory Non-Academic Incidental Fees* (Preamble, Section A., and in particular, Section B.).

Section B.4. of the *Policy for Compulsory Non-Academic Incidental Fees* outlines the general expectations with respect to increases of student society fees:

Requests to change the fee collected on behalf of a student society and requests for new fees shall be approved only when evidence has been presented that the request has been authorized by due constitutional process in the organization. The procedures to request approval of a new fee or an increase to an existing fee shall be published in the Handbook for Student Societies. Cost of Living Increases

(a) Where the amount of an increase in the fee charged is not greater than the year-over-year change in consumer prices for Ontario as measured by

Statistics Canada (December-over-December) as of December 31 of the previous year, the request must be supported by the results of a previous referendum approving the principle of a cost-of-living adjustment. In special circumstances (e.g., when a portion of a student society fee is designated for a health plan or capital project), other inflation indexes or predetermined inflation factors may be used, provided that the request is supported by the results of a previous referendum approving the use of the specific inflation index or predetermined inflation factor.

Referendum Requirement

(b) Where the amount of an increase in the fee charged is greater than the year-over-year change in consumer prices, the request must be supported by the majority of the society's members voting in a recent referendum.

In summary, increases that are greater than the cost of living must be supported by a referendum. Other increases must be supported by a previous referendum approving the concept of annual increases by the cost of living or an explicit inflation factor. When such a provision is approved by a referendum, annual increases, no greater than the Ontario Consumer Price Index of the previous December, or no greater than a specific inflation factor approved by referendum, may be requested upon approval of the board or council of the organization.

The administrative procedures are outlined in the *Policy on Compulsory Non-Academic Incidental* Fees and the *Handbook for Student Societies* (published by the Office of the Vice-Provost, Students & First-Entry Divisions). Pursuant to the *Policy*, requests for increases to fees must be supported by due constitutional and fair processes within student societies.

Requests for increases are brought forward to the Board by the administration on the assurances of the student societies that due constitutional procedures have been followed. If a complaint is received about the process related to a fee request from a student society, the Office of the Vice-Provost, Students & First-Entry Divisions makes inquiries about the issue and, if necessary, investigates the matter further as part of the assessment of the request.

RECOMMENDATION:

It is recommended that the University Affairs Board approve the following:

BE IT RESOLVED

THAT beginning in the fall 2015 session, a new fee of \$10.00 (\$5.00 part-time) per fall and winter session be established for the newly-formed **Architecture and Visual Studies Students' Union (AVSSU)**, and be charged to all AVSSU members (undergraduate students in the John H. Daniels Faculty of Architecture, Landscape and Design).

THAT beginning in the fall 2015 session, the **Association of Part-time Undergraduate Students** fee be increased as follows: (a) an increase of \$0.07 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee; (b) an increase of \$4.48 per fall and winter session in the Accident & Prescription Drug Insurance Plan portion of the fee; and (c) an increase of \$3.74 per fall and winter session in the Dental Plan portion of the fee.

THAT beginning in the fall 2015 session, the **Engineering Society** fee be increased as follows: (a) the establishment of a new designated portion of the fee for the University of Toronto Aerospace Team at \$3.25 per fall and winter session through 2016-17; (b) an increase of \$0.36 (\$0.34 part-time) per fall and winter session in the society portion of the fee; (c) the continuation of the Robotics Association portion of the fee through 2016-17; (d) the continuation of the Concrete Canoe Team portion of the fee through 2016-17; (e) the continuation of the Human Powered Vehicle Design portion of the fee through 2016-17; (g) the continuation of the Blue Sky Solar Racing Team portion of the fee through 2016-17; (h) the continuation of the Formula SAE Racing portion of the fee through 2016-17; (i) the continuation and decrease of \$5.00 per fall and winter session in the

Special Projects Levy portion of the fee through 2016-17; and (j) the continuation of the Endowment Fund portion of the fee through 2016-17. [Note: fees (b) through (j) apply to full-time students only.]

THAT beginning in the fall 2015 session, the **Graduate Students' Union** fee be increased as follows: (a) the establishment of a new portion of the fee of \$0.50 (\$0.25 part time) per fall and winter session for the Sexual Education Centre; (b) the establishment of a new portion of the fee of \$2.00 (\$1.00 part-time) per fall and winter session for the Students for Barrier-free Access; (c) an increase of \$0.58 (\$0.29 part-time) per session in the society portion of the fee; (d) an increase of \$4.16 (full-time only) per fall and winter session in the Supplementary Health Coverage portion of the fee; (e) an increase of \$10.73 (\$10.73 part-time) per fall and winter session in the Dental Plan portion of the fee; (f) an increase of \$0.15 (\$0.07 part-time) per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee; (g) an increase of \$0.05 (\$0.02 part-time) per session in the OPIRG portion of the fee; and (h) an increase of \$0.01 (\$0.00 part-time) per session in the Bikechain portion of the fee.

THAT beginning in the fall 2015 session, the **Innis Residence Council** fee be increased as follows: (a) an increase of \$0.57 per fall and winter session in the society portion of the fee.

THAT beginning in the fall 2015 session, the **Nursing Undergraduate Society** fee be increased as follows: (a) an increase of \$0.33 per fall and winter session in the society portion of the fee.

THAT beginning in the fall 2015 session, the **University of Toronto Students' Union** (UTSU, legally the Students' Administrative Council) fees be increased as follows: (a) an increase of \$0.34 per session in the society portion of the fee; (b) an increase of \$0.01 per session in the Student Refugee Program portion of the fee; (c) an increase of \$0.14 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee; (d) an increase of \$3.24 per fall and winter session in the Accident & Prescription Drug Plan portion of the fee; (e) an increase of \$2.92 per fall and winter session in the Dental Plan portion of the fee; (f) for full-time undergraduates on the St. George Campus only, an increase of \$0.82 per session in the Student Commons portion of the fee; (g) for full-time undergraduates on the St. George Campus only, an increase of \$1.56 per session in the Downtown Legal Services portion of the fee; and (h) for full-time undergraduates on the UTM Campus only, an increase of \$0.52 per session in the Downtown Legal Services portion of the fee.

THAT beginning in the fall 2015 session, the **Varsity Publications Inc.** society fee be increased as follows: (a) an increase of \$0.04 per session in the society portion of the fee.

Re: Student Society Proposals for Fee Increases

The Office of the Vice-Provost, Students & First-Entry Divisions has received a number of fee change requests from student societies. The applications have been reviewed in light of the requirements of the *Policy for Compulsory Non-Academic Incidental Fees*, are found to be in compliance with these requirements, and are recommended for approval.

Requests for fee increases from student societies must meet a number of requirements. Section B.4 of the *Policy for Compulsory Non-Academic Incidental Fees* outlines the University's general expectations:

Requests to change the fee collected on behalf of a student society and requests for new fees shall be approved only when evidence has been presented that the request has been authorized by due constitutional process in the organization. The procedures to request approval of a new fee or an increase to an existing fee shall be published in the Handbook for Student Societies.

Cost of Living Increases

(a) Where the amount of an increase in the fee charged is not greater than the year-over-year change in consumer prices for Ontario as measured by Statistics Canada (December-over-December) as of December 31 of the previous year, the request must be supported by the results of a previous referendum approving the principle of a cost-of-living adjustment. In special circumstances (e.g., when a portion of a student society fee is designated for a health plan or capital project), other inflation indexes or predetermined inflation factors may be used, provided that the request is supported by the results of a previous referendum approving the use of the specific inflation index or predetermined inflation factor.

Referendum Requirement

(b) Where the amount of an increase in the fee charged is greater than the year-over-year change in consumer prices, the request must be supported by the majority of the society's members voting in a recent referendum.

The procedures for handling fee change requests (from the *Handbook for Student Societies* published by the Office of the Vice-Provost, Students & First-Entry Divisions) also provide that requests for a fee increase must be supplied with the following:

Evidence that the request to change the existing fee (or to institute a new charge) has been authorized by due constitutional process of the organization. This evidence should include a copy of or specific reference to the section of the society's constitution which relates to the mechanism for fee changes, minutes of the meeting at which the resolution to request the change was passed, details and results of any referenda related to the subject which may have been held within the division, and publicity given the matter to ensure that those who may be affected by the change are aware of the proposal, including size and purpose of the increase, and have had the opportunity to make their views known.

Normally, the administration intersects with these processes at two points. Initially, it is recommended that student societies seek advice from the Office of the Vice-Provost, Students & First-Entry Divisions on the wording of referendum questions (with respect to clarity and technical language). The second point occurs after the referendum when the student society makes the formal request for a fee increase. The recommendation for approval is derived from the assessment of whether or not the society has met the requirements articulated in the *Policy* and the relevant procedures.

Occasionally, the Office is asked to look into complaints about referendum procedures and compliance with relevant portions of the society's constitution and/or by-laws. The results of these investigations play a significant role in the assessment of the request and the recommendation for approval.

The assessment of requests for fee increases is normally based upon the following expectations:

- 1) The student society must make the request in a manner consistent with the *Policy for Compulsory Non-Academic Incidental Fees* and the University's procedures for increases to student society fees;
- 2) When required, there must be a positive result in a referendum for a fee increase (special conditions established by the society, such as quorum, must also be met);
- 3) The referendum question itself should be clear and provide enough information to students in order to gain a full understanding of the implications of the question and proposed fee for them;
- 4) The referendum must be held in a fair manner, advertised and promoted in a reasonable manner, and the members of each organization should be given a reasonable opportunity to vote; and

 Each organization must comply with the provisions of its own by-laws, rules of procedure, and specific policies and procedures approved by the society's board or council.

Societies which have previously received approval (by referendum) from their members for an annual cost of living increase in the society's portion of the fee may request increases, upon approval by the society's board or council, of up to the previous Ontario December to December cost of living increase (consumer price index) calculated by Statistics Canada. The December 2014 consumer price index for Ontario was 1.9%.

As outlined in the excerpt from the *Policy* above, where members of a society have given consent (through a previous referendum) to the concept of inflationary increases according to a specific inflation factor or measure, this factor or measure may be used in place of CPI. For example, the University of Toronto Students' Union (the UTSU, or legally the Students' Administrative Council), the Graduate Students' Union (the GSU), and the Association of Part-Time Undergraduate Students (APUS) may request increases in the designated portions of their fees for health and dental plans at a rate established by approval of a previous referendum. UTSU and APUS may request increases in their health and dental plan fees of up to 10%. The GSU may request increases in its health and dental plan fees of an amount less than or equal to a health industry index.

It is important to note that when dealing with a student society request for a fee change, it is the society's own constitution, by-laws or established policies that set the standards for acceptable results in referenda. In some cases, society constitutions establish a minimum voter turnout in order to consider a referendum result to be valid. The University has not established additional criteria with respect to valid referendum voter turnout.

In addition, with respect to both requests for increases based upon the results of a referendum, and increases which require only the approval of the society's board or council, the administration relies on the assurances of student societies that due constitutional processes and fair procedures have been followed.

The session in which a student society's fee is applied is at the society's discretion. While not all societies charge summer fees, others have chosen to have their fees apply for all academic terms. Additionally, some societies have elected to have only certain portion of their fee charged in the summer term. For example, student societies that provide health and dental insurance plans only collect those portions of the fee in the fall and winter terms. For specific details of which fees are assessed in each term, please refer to the summary of changes document.

Architecture and Visual Studies Student Union

Background

At present, there is no fee for the Architecture and Visual Studies Student Union, which formally established itself at an inaugural Annual General Meeting on March 9, 2015.

Requests

1) The establishment of a new fee for a new student society of the University of Toronto.

On March 9, 2015, the Architecture and Visual Studies Student Union (AVSSU) held its inaugural Annual General Meeting, in which undergraduate students in the John H. Daniels Faculty of Architecture, Landscape and Design were asked to ratify the proposed AVSSU constitution, which included a provision on the collection of a fee.

The wording of the provision is as follows:

Article 3: AVSSU Membership and Fees

Section 1:

- 1. All undergraduate students enrolled in the Faculty of Architecture, Landscape, and Design at the University of Toronto shall be members of AVSSU.
- 2. AVSSU maintains a Membership fee of \$20.00 per year for all full time Honors [sic] Bachelor of Arts in Architectural Studies and Honors Bachelor of Arts in Visual Studies students to be paid with tuition.
- 3. AVSSU maintains a Membership fee of \$10.00 per year for all part-time Honors Bachelor of Arts in Architectural Studies and Honors Bachelor of Arts in Visual Studies students to be paid with tuition.
- 4. AVSSU maintains the right to raise this fee in accordance with official Cost of Living increases.
- 5. Only students enrolled in the Daniels Faculty of Architecture, Landscape, and Design and current members of AVSSU have rights to vote, nominate, stand for elections and pass the motion of constitutional amendments.
- 6. AVSSU Membership is open and inclusive to all undergraduate students studying under the faculty of Daniels.

7. Members must not be discriminated against due to age, gender, sexual orientation, race etc.

The results of the vote on the constitution, including the above provisions, are as follows:

Association of Part-time Undergraduate Students (APUS)

Background

In fall/winter of 2014-15, the APUS fee was \$100.15 per session charged to all part-time undergraduate students on all campuses. The fee included \$3.77 per session for the Canadian Federation of Students (CFS)/CFS-Ontario; \$44.83 (including an administration fee and sales tax) per session for Accident & Prescription Drug Insurance Plan; and \$37.40 (including an administration fee and sales tax) per session for a Dental Plan.

Requests

1) A cost of living increase in the Canadian Federation of Students (CFS) & CFS-Ontario portion of the fee.

At its meeting held on April 17, 2015, the APUS Board of Directors approved a resolution to request a cost of living increase to the Canadian Federation of Students (CFS) & CFO-Ontario portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

2) An inflationary increase in the Accident & Prescription Drug Insurance portion of the fee.

At its meeting held on April 17, 2015, the APUS Board of Directors approved a resolution to request an inflationary increase to the Accident & Prescription Drug Insurance Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

3) An inflationary increase in the Dental Plan portion of the fee.

At its meeting held on April 17, 2015, the APUS Board of Directors approved a resolution to request an inflationary increase to the Dental Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

Recommendations

THAT beginning in the fall 2015 session, the **Association of Part-time Undergraduate Students** fee be increased as follows: (a) an increase of \$0.07 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee; (b) an increase of \$4.48 per fall and winter session in the Accident & Prescription Drug Insurance Plan portion of the fee; and (c) an increase of \$3.74 per fall and winter session in the Dental Plan portion of the fee.

If approved, the total APUS fee will be \$108.44 per fall and winter session, charged to all part-time undergraduate students on all campuses.

University of Toronto Engineering Society

Background

In the fall/winter 2014-15, the University of Toronto Engineering Society fee was \$153.42 per session, charged to all full-time Faculty of Applied Science & Engineering students (\$22.62 per session for part-time students and Professional Experience Year [PEY] students). The fee included \$24.07 per session (\$22.62 part-time) for the society portion of the fee; \$1.50 for the Robotics Association portion of the fee; \$0.90 for the Concrete Canoe portion of the fee; \$1.25 for the Engineers Without Borders portion of the fee; \$1.25 for the Human Powered Vehicle Design Team portion of the fee; \$2.75 for the Blue Sky Solar Racing Team portion of the fee; \$2.75 for the U of T Formula SAE Racing Team portion of the fee; \$62.50 for the Special Projects Levy portion of the fee; and \$50.00 for the Endowment Fund portion of the fee.

Requests

1) A cost of living increase in the society portion of the fee.

At its meeting held on March 21, 2015, the University of Toronto Engineering Society Council approved a resolution to seek a cost of living increase in the society portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

2) The continuation of the Robotics Association portion of the fee through the 2016-17 fall/winter academic period.

A referendum was held from March 18, 2015 to March 23, 2015, in which Applied Science and Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

The Engineering Society is seeking consent from its members to continue and increase the levy for the University of Toronto Robotics Association (UTRA). The level will be \$1.50 per session per student (\$3.00 per Fall & Winter academic sessions) (As it was per session last year).

If the levy is approved, it will continue to be charged to all full-time undergraduate Applied Science and Engineering students in Fall 2015 and Spring 2016. Subsequent referendum approval will be required to continue the fee after the 2015/16 session.

A referendum was held from March 18, 2015 to March 23, 2015, in which Applied Science and Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

Concrete Canoe is one of the University of Toronto's oldest design teams having been founded in the 80's competed annually since 1995. We are a multi-disciplinary team with members from all disciplines. We are currently seeking to renew our levy of \$0.90 per session (\$1.80 per fall/winter academic sessions).

Question

Are you in favor of continuing the UofT Concrete Canoe levy of \$0.90/session (\$1.80 per academic year) for the academic years of 2015-16 and 2016-17?

4) The continuation of the Engineers Without Borders portion of the fee through the 2016-17 fall/winter academic period.

A referendum was held from March 18, 2015 to March 23, 2015, in which Applied Science and Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

The University of Toronto Chapter of Engineers Without Borders (EWB) is a student organization focused on engaging engineering students in the fight against global poverty. It believes that systemic solutions, when they appropriately take into account each community's social, cultural, economic and political context, can improve the lives of people living in extreme poverty. Since 2001, it has raised funds to send volunteer students to represent the University of Toronto in countries such as Ghana and Malawi, to partner with local organizations to improve the livelihoods of those in developing communities. On our campus, EWB hosts regular opportunities for students to understand the complexity behind international development and improve their leadership capabilities in leading our numerous outreach events in the community. Off campus, EWB members visit high schools each year to conduct workshops, promoting the Engineering Profession and global citizenship in tandem. EWB members also meet with Canadian members of parliament to push for change in Canada's part in aid & development. This proposed levy will allow EWB to advance its core activities that provide engineering students with the best opportunities to create impact in the developing world.

The proposed levy is in the amount of \$1.25 per term (\$2.50 per year) for each full-time undergraduate student. This funding will focus on enhancing the activities of EWB. For example, it will allow the purchase of additional workshop materials for high school outreach activities and improved display materials for more effective outreach events. Most importantly, this funding will enable EWB's opportunities to be more financially accessible to engineering students. These include the junior fellowship program, where two UofT students can participate in EWB ventures in Canada and Africa every summer, and the Annual EWB National Conference, where students from all Canadian EWB chapters meet to share experiences and contribute to solving global problems.

Preamble

The Human-Powered Vehicle Design Team (HPVDT) is a student club at the University of Toronto that is focused on the design and construction of innovative, high-performance, human-powered vehicles. Our goal is to provide students with practical, hands-on experience in engineering design while promoting efficiency, sustainability and the use of human power as a means of reducing society's impact on the environment. We are constantly pushing the limits of engineering, technology, and human achievement, with the goal of being no less than the best in the world.

Our current focus is the design of a new high-speed, aerodynamic bicycle, capable of reaching speeds well in excess of 100 km/hr, while still having the utility necessary for carrying groceries and travelling safely within the city. The bike will compete in the annual American Society of Mechanical Engineers (ASME) Human-Powered Vehicle Challenge, a race specifically focused on the utilitarian aspects of the bike. As well, we will compete in the World Human-Powered Speed Challenge, where teams from around the globe attempt to set land speed records on a 5- mile stretch of road near Battle Mountain, Nevada.

In the past, HPVDT ranked 1st and 3rd amongst the 30+ student teams at the ASME HPVC. Also, in 2013, team member Trefor Evans shattered the collegiate land speed record by reaching 123.7 km/hr in Battle Mountain, Nevada. Together with our partner team AeroVelo Inc., we've set multiple records in human-powered aviation, including the first-ever flight of a human-powered ornithopter and the longest flight of a human-powered helicopter. We hope to achieve new heights in the next two years, and thus we are asking for your continual support

through the student levy. We invite you to visit our website, hpvdt.skule.ca for more information, and join us at one of our team meetings if you are interested in participating.

The student levy is our main financial resource, and thus has been a crucial part in our accomplishments. We are sincerely grateful for the support that it has provided us. Funding for our team is used for two purposes: 1) components, materials, and tools to build our vehicles, and 2) to cover the costs of attending competitions and conferences (transportation, registration fees, etc.).

6) The continuation of the Blue Sky Solar Racing Team portion of the fee through the 2016-17 fall/winter academic period.

A referendum was held from March 18, 2015 to March 23, 2015, in which Applied Science and Engineering students were asked to support the continuation of the levy for the next year. The wording of the question is as follows:

Preamble

To Undergraduate Engineering Student Body: The University of Toronto Blue Sky Solar Racing is an entirely student-run initiative that aims to educate future environmentalists through the design, construction, and competition of world-class solar-powered vehicles. The team currently seeks to renew its engineering student levy of \$2.75 per student per semester, for the academic years between Fall 2015 and Spring 2017.

The successful completion of a solar car project is a tremendously difficult task that requires extreme passion and dedication from the team members. The

challenges are real and the stakes are high. Two years are required for each new group of students to work through the whole project, and each student must actively learn and grow at every step along the way, or risk failure and disappointment.

During the 2011-2013 race cycle, the team designed and built B-7, our seventh and newest car, with the help of over 120 undergraduate students. At the 2013 World Solar Challenge, Blue Sky Solar Racing represented the University of Toronto on the international stage, competing against 22 other teams from institutions from around the world. B-7 successfully completed the Challenge in 8th place overall, 2nd from North America, with a top speed of 102kph. This was the team's most successful race ever!

As an undergraduate student in engineering, you are already a member of the Blue Sky Solar Racing team. We are always eager to have you visit our shop, discover where your interests lie, and get you involved with our activities. However, even if you are not interested in being part of this exciting project directly, by voting yes, you are supporting your classmates, friends, and fellow aspiring engineers to take part in this learning experience. We also actively participate in the Faculty of Applied Sciences and Engineering by making parts of the project available to various design project courses that you might take in the near future. Our extensive family of industry sponsors also provides team members very promising career opportunities.

This year is a race year, and we are currently working hard to make the car we have been designing since the last race a reality. Manufacturing will take place between January and May, testing between May and July, and the team will head to Australia again in September for the 2015 World Solar Challenge. Our goal is to place in the top 5.

Due to budget constraints resulting from unexpected events on the 2013 race, the team members have agreed to pay for their own trips to Australia. This is a testament to the team members' commitment to the project and the value of the race experience. Despite this commitment, the team still needs to raise funds to bring the most important item, the car itself, to the competition. This is what the 2015-2016 levy funds would go toward.

Beyond the current cycle, Blue Sky Solar Racing aspires to continue to develop as one of the world's top solar car teams. Discussions have already started on pursuing a more practical solar car – one that might become a common sight on public roads sometime in the distant future. This is the initiative that will be made possible by the 2016-2017 levy funds.

In the big picture, the aim of Blue Sky Solar Racing is to promote innovative sustainable energy technologies. The truth is, solar cars are not a viable transportation option at this moment in time. However, the underlying design philosophy of a solar car: optimization of the mechanical and electrical systems

to achieve maximum efficiency, relies on universal engineering principals. If a solar car can be designed to conserve energy, so can every other product on the market. And indeed, many of the technologies developed in solar cars can be and have been transferred into various industries (tires and ighting, for example). To sum, by continuing to design and construct solar cars, Blue Sky Solar Racing challenges the public to support the research and development of green technology.

The levy holds a significant part of our budget and is consequently an important part of our success. In the last few years the levy has been used to fund our most competitive event - Formula Student Germany. As it is an overseas event we would not be able to afford the competition expenses and shipping costs without the levy. This event draws the strongest competitors from all over the world to

compete in six days of racing and engineering evaluation. Since the last referendum we have earned three trophies; a strong symbol of the support and dedication we receive from the University and its students. Securing the levy vote this year would again mean the continued support and funding of our competition expenses.

The University of Toronto Formula SAE Racing Team Since 1999 the team has designed, built and raced Formula-style race cars around the globe. 8) The continuation of the Special Projects Levy portion of the fee through the 2016-17 fall/winter academic period.

A referendum was held from February 26, 2015 to March 2, 2015, in which Applied Science and Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

TL;DR (sic) – Proposal to continue the Temporary Special Levy fund at \$115.00/year for 2015/6 and 2016/7 to continue improving undergraduate academic experience. Lack of qualifying submissions may be transferred to the SkuleTM Endowment Fund if approved by the Engineering Society Board of Directors.

The Engineering Society is proposing that the Temporary Special Levy be continued at \$115 per year (\$57.50 per session) for the years 2015 - 2016 and 2016 - 2017.

This year, the fund is being reduced from \$125.00/year to \$115.00/year because the income from the Skule Endowment Fund is slowly replacing the need for a Special Levy Fund.

The fund has been crucial to the improvement of the undergraduate academic experience since its creation in 1983. In the 80s when the curriculum became too theoretical due to the post-war aftermath, engineering students voted to pay additional money to directly improve their practical learning experience. The fund has been used to benefit all departments, paying for new computers for the ECF and departmental computer labs, for experiment set-ups and tutorial

demonstrations for all departments, and for tutor training for the Engineering Society tutoring service. The purpose of the fund is the purchase of equipment or services, such as laboratory setups, computer lab updates, and tutoring services that will directly enhance the engineering undergraduate education.

At the end of each fiscal year, leftover funds that have not been spent due to a lack of qualifying submissions may be transferred to the SkuleTM Endowment Fund if approved by the elected Engineering Society Board of Directors, which includes representatives from each discipline.

9) The continuation of the Endowment Fund portion of the fee through the 2016-17 fall/winter academic period.

A referendum was held from February 26, 2015 to March 2, 2015, in which Applied Science and Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

Preamble

TL;DR (sic) – Proposal to continue SkuleTM Endowment Fund levy of \$100/year for 2015/6 and 2016/7 school years. Endowment Fund intended to eliminate need for future students to pay into the Temporary Levy Fund. Engineering Society and University of Toronto have agreed to have the funds held and invested by the University while elected student representatives control the use of income or principal. Already, the fund has contributed 1 million dollars to secure student space at the Centre of Engineering Innovation and Entrepreneurship.

The Engineering Society is proposing continuation of the SkuleTM Endowment Fund levy of \$100 per year (\$50 per session) for the years 2015 - 2016 and 2016 - 2017.

The Skule™ Endowment Fund was established by referendum in the spring of 2011. Since then a total of \$1,072,316.02 has been collected. Since 1983, engineering students have paid into the Temporary Special Levy, initially \$100 per year until 2013 when it was increased to \$125. The Temporary Special Levy Fund is expended by engineering departments to pay for laboratory equipment, academic facilities, and computer labs. The Endowment Fund is intended to gradually eliminate the need for future students to pay this levy.

The goals of the SkuleTM Endowment Fund are:

- Establish a permanent endowment for improvement of student facilities, academic facilities, and student club funding
- In the short term, reduce the cost of the Temporary Special Levy by offsetting it with income from the Endowment Fund
- In the long term, replace the Temporary Special Levy with the associated gains of the Endowment Fund
- Create a long---term financial plan for provision of capital projects such as building renovations and construction of new student space

The Engineering Society has reached an agreement with the University of Toronto that allows the funds to be held and invested by the University in trust while elected student representatives retain control over the use of any income or principal.

Interest earned from the principal collected through the levy may be used each year to fund academic and student life improvements following the same procedure as the existing Temporary Special Levy. Capital improvements previously funded through similar student levies include the renovation of the Sandford Fleming Atrium and the Engineering and Computer Science Library. The levy for the Endowment Fund will be renewed by referendum every two years.

In addition, the principal of the fund can be spent on capital projects such as building renovations and student space construction in the future when the need arises. These decisions will be made by elected student representatives with the Engineering Society. Already, the fund has contributed \$1 million to the Centre of Engineering Innovation and Entrepreneurship, an entirely new engineering building the Faculty of Applied Science and Engineering is about to build on St. George St. adjacent to the Galbraith Building. At this early stage, capital contributions from students through the Endowment Fund provides substantially superior student facilities in this new building while legally protecting the space from size reduction in the future, thereby improving student experience in the Faculty for decades to come. Further, it will be our generation of students that will be known for contributing to a leading vision for engineering the profession.

An example of such a student-run Endowment Fund has been in place at the University of Waterloo since 1990. The Waterloo Engineering Education Foundation (WEEF) has collected more than \$12,000,000.00 to date and distributes up to \$533,333.33 per year to student clubs, departments, and special projects.

Students will be able to opt out by Friday the end of February of each year, and a cheque for the amount paid will be cut, payable to them, by the Engineering Society.

Preamble

Dear Engineering Society student body,

In 2004, the University of Toronto Aerospace Team (UTAT) had its humble beginnings as an after school project with five dedicated members who had a passion for aerospace, competing in the annual Canadian Aeronautics and Space Institute (CASI) Free-Flight competition. As our team matured, our designs evolved and we steadily rose in the rankings and competed in additional competitions. In 2007, UTAT began competing in the Society for Automotive Engineering (SAE) Aero series competitions. In 2010, UTAT began entering into additional classes within the SAE competition. In 2012 UTAT added the

Unmanned Systems Canada (USC), Association for Unmanned Vehicles Systems International (AUVSI), and the Intercollegiate Rocket Engineering Competition (IREC) to our annual competitions. Finally, in 2014 UTAT began competing in the Canadian Satellite Design Challenge (CSDC), adding an element of space to our historically aeronautics team.

UTAT is both the largest, and the fastest growing student design team at the University of Toronto. In the past three years active membership has increased by over 400%, we now compete annually in five national and international design competitions, we co-organize three international conferences, and we host an aerospace design competition for high school students. The majority of our student population is comprised of members of the Engineering Society, however we also have a significant population of students from the Faculty of Arts & Science as well as the Faculty of Medicine.

UTAT is an interdisciplinary design team, and is separated into five divisions, with each having their own membership, structure, and annual projects.

Powered Flight: Developing aerial vehicles for precision payload drops

with applications for humanitarian aid missions

UAV: Developing autonomous aerial remote sensing platforms

for advanced monitoring capabilities with applications to

the agricultural, oil & gas, and mining industries

Rocketry: Developing suborbital rockets to be used exclusively for

scientific initiatives for high school students

Space Systems: Developing a microfluidics-based high-data-throughput

astrobiology platform for inspace research on a small

satellite

Outreach: Engaging youth and promoting the aerospace industry

within the local, national, and international communities

Although the funding provided from members of the engineering society would be put towards all projects within UTAT, the main cost driver is associated with launch costs for our Space Systems Division, which amounts to nearly 75% of the total budget. With the introduction of this division in 2014, UTAT is looking to establish a long-term program at U of T whereby students can build and launch their own spacecraft on three-year intervals. The significance of this initiative is that it would mean that students have the opportunity to launch their own spacecraft within a single university career. A program of this nature is unparalleled in Canada, and would further establish U of T as an international leader in innovation and student development.

The support of members from the Engineering Society will allow our team to continue to expand, to continue to enrich the educational experience of students, and continue to promote the aerospace industry. UTAT will continue to be at the forefront of innovation and student development, and with your support will remain more than just an after school project.

The fee included \$30.86 (\$15.43) per session for the society portion of the fee; \$121.92 (full-time only) per session for the Supplementary Health Coverage portion of the fee; \$84.27 (\$84.27 part-time) per session for the Dental Plan portion of the fee; \$7.88 (\$3.94 part-time) per session for the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee; \$2.50 (\$1.25 part-time) per session for the Ontario Public Interest Research Group portion of the fee; and \$0.50 (\$0.25 part-time) per session for the Bikechain portion of the fee.

Requests

1) A cost of living increase in the Society portion of the fee.

At its meeting held on March 30, 2015, the GSU General Council approved a resolution to request a cost of living increase to the Society portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

2) An inflationary increase in the Supplementary Health Coverage portion of the fee.

At its meeting held on March 30, 2015, the GSU General Council approved a resolution to request an inflationary increase to the Supplementary Health Coverage portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

3) An inflationary increase in the Dental Plan portion of the fee.

At its meeting held on March 30, 2015, the GSU General Council approved a resolution to request an inflationary increase to the Dental Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

4) A cost of living increase in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee.

At its meeting held on March 30, 2015, the GSU General Council approved a resolution to request an inflationary increase to the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

5) An inflationary increase in the Bikechain portion of the fee.

A referendum was held from March 26, 2013 to March 28, 2013 in which graduate students were asked to support the establishment of a board-approved cost-of-living increase for the Bikechain portion of the fee. The wording of the question was as follows:

Preamble

Bikechain is the student- and community-run university bicycle repair shop, that offers the use of tools, the guidance of skilled volunteers for free, and a bike lending program to the campus community. In March of 2010, graduate students at the University of Toronto voted in a referendum to collect a levy of \$0.50 [per session] from fulltime members and \$0.25 [per session] from part time members effective September 1, 2010. In 2012, the Bikechain Board determined – based on its continued growth, extending of service, ever-increasing costs and precarious nature of some funding (such as the cancellation fo Work Study positions) – that it will require cost-of-living increases of the Bikechain fee to keep up with current demands and times.

In its deliberations, the GSU Council determined that based on the original March 1982 referendum question, consumer price index increases were to be automatically incorporated into the fee level.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

7) The establishment of a new Sexual Education Centre designated portion of the fee.

A referendum was held from March 10, 2015 to March 12, 2015, in which graduate students were asked to support the establishment of a new designated portion of the U of T GSU fee and the allowance of annual cost of living increases. The wording of the question is as follows:

Preamble

The University of Toronto Sexual Education Centre (SEC) is a volunteer-run oncampus group which provides free safer sex supplies such as condoms (including internal and latex free), lube, dental dams, and gloves as well as pregnancy tests and safer injection kits. SEC's office is open 10am until 7pm, Monday to Friday during fall and winter semesters. Individuals may visit the SEC office to pick up safer sex supplies, obtain referrals and resources from our volunteers, and to the library or lounge space. SEC also provides free educational presentations and organizes fun, sex-positive events throughout the year, including Sexual Awareness Week. For wider distribution, SEC provides bulk orders of safer sex supplies to individuals who request them. Many of these individuals are leaders of the U of T community, such as residence dons at the undergraduate and graduate level.

Currently, SEC receives no funding from the University of Toronto Graduate Students' Union (UTGSU). SEC receives a levy of 25 cents (\$0.25) per student per semester (not including summer semesters) as a refundable part of the University of Toronto Students' Union (UTSU) fee, as per a 1996 referendum.

SEC has requested that the UTGSU establish a refundable designated portion of the UTGSU fee.

Pending the support of the UTGSU's general membership, the designated fee would be refundable to members, and subject a formal Memorandum of Agreement concerning the payment of fees, member refunds, accountability for student fee revenue, and the terms and conditions related to the fee. The fee and agreement between the UTGSU and SEC would be subject to review by the UTGSU Council every two years.

The UTGSU is seeking consent from its members to establish a new designated portion of the UTGSU fee for the fall and winter sessions. The proposed increase is \$0.50 for full-time students per semester (\$0.25 part-time) paid by all graduate students, beginning in the fall 2015 session.

8) The establishment of a new Students for Barrier-Free Access designated portion of the fee.

A referendum was held from March 10, 2015 to March 12, 2015, in which graduate students were asked to support the establishment of a new designated portion of the U of T GSU fee. The wording of the question is as follows:

Preamble

Students for Barrier-free Access (SBA) is a University of Toronto student organization that advocates for equity, access, and the rights of undergraduate and graduate disabled students both on and off campus. SBA has a drop-in centre where students gather to socialize and access resources and support. SBA also provides study space, printing, a library of disability-related resources, computers with assistive software, and a new \$16,000 yearly scholarship initiative for disabled undergraduate and graduate students.

Currently, SBA receives no funding from the University of Toronto Graduate Students' Union (UTGSU).SBA receives a levy from undergraduate students as a refundable part of the University of Toronto Students' Union (UTSU) fee.

Pending support of the general membership, implementation of the fee would be subject to the UTGSU and SBA reaching a formal Memorandum of Agreement concerning payment of fees, member refunds, accountability for student fee revenue, and the terms and conditions related to the fee. The fee and the agreement between the UTGSU and SBA would be subject to review by the UTGSU Council every two years.

With increased funding they will:

- (1) increase staff hours to include an additional full-time staff person;
- (2) create more funding opportunities for graduate students and ensure long-term financial feasibility for their scholarship program;
- (3) maintain the accessible computer lab—a unique resource on the University of Toronto campus;
- (4) expand their capacity to liaise with a diversity of campus-based groups and offices to better address issues around accessibility for disabled students; and (5) extend their reach to include cross-college/university initiatives in order to address larger systemic barriers to education for disabled students.

The UTGSU is seeking consent from its members to establish a new designated portion of the UTGSU fee for the fall and winter sessions. The proposed increase is \$2.00 for full-time students per semester (\$1.00 part time) paid by all graduate students, beginning in the fall 2015 session.

Preamble:

In the 2014-15 academic year, the sessional Nursing Undergraduate Society (NUS) fee was \$30.34 for all full-time undergraduate Faculty of Nursing students. This fee includes \$17.34 per session (full-time only) for the society portion of the fee, \$8.00 for the RNAO portion of the fee, and \$5.00 for the CNSA portion of the fee.

The NUS is seeking consent from its members to permit the continuation of annual cost of living increases, based on the Ontario December-over-December Consumer Price Index (CPI) to the society portion of the NUS levy, beginning in September 2015.

Currently, the NUS has consent from its members to allow annual cost of living increases based on a referendum held in September 2011 which expires this year.

Based on the current Ontario December-over-December CPI of 1.9% for 2014, the fee increase for September 2015 would be \$0.33 for all full-time undergraduate students. The NUS would retain the ability to implement this increase until 2020 with the per session increase not exceeding \$2.00. Subsequent

referendum approval will be required to continue the cost of living increase provision after the 2019-2020 session.

If approved, the NUS will be authorized to request automatic cost of living increases on the members' behalf, upon a two-thirds majority approval of the Society executive at a regularly scheduled Society meeting, as per the NUS bylaws.

5) An inflationary increase in the Dental Plan portion of the fee

At its meeting held on March 30, 2015, the UTSU Board approved a resolution to request an inflationary increase to the Dental Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

6) An inflationary increase in the Student Commons portion of the fee (St. George students only)

At its meeting held on March 30, 2015, the UTSU Board approved a resolution to request an inflationary increase to the Student Commons portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students & First-Entry Divisions has not received any complaints concerning the process leading up to the request.

7) An increase to the Downtown Legal Services portion of the fee.

A referendum was held from March 24, 2015 to March 26, 2015 in which UTSU students were asked to support the establishment of an increase to the Downtown Legal Services portion of the fee. The wording of the question is as follows:

Preamble:

Downtown Legal Services (DLS) is the University of Toronto's Student Legal Clinic. We provide free legal assistance to students in a variety of areas of law including academic offences and appeals, criminal law, tenant housing law and family law. We also provide free notary and affidavit services for students.

At present, all full-time undergraduate students on the St. George Campus are charged \$1.50 per semester for DLS as a designated portion of the University of

Toronto Students' Union fee. Full-time undergraduate students at the University of Toronto at Mississauga (UTM) are charged \$0.50 per semester for DLS. These fees are fully refundable during the UTSU refund period. The DLS fees have not increased since 2003. In that time, demand for our services has continued to rise beyond our capacity to assist.

DLS and UTSU are seeking consent from UTSU members for an increase to the designated portion of the UTSU fee for DLS. The proposed increase for full-time students on the St. George Campus is \$1.50 per semester (for a total fee of \$3.00 per semester). For full-time students at UTM, the proposed increase is \$0.50 per session (for a total fee of \$1.00 semester). We also request that the total levy be indexed annually to the Statistics Canada Ontario consumer price index rate for the previous year pending the approval of the UTSU Board.
