Capital Project: Project Planning Report for the University of Toronto Mississauga Biology Greenhouse – Sources of Funding and Total Project Cost

JURISDICTIONAL INFORMATION:

Under the *Policy on Capital Planning and Capital Projects*, proposals for capital projects with a project budget over \$3 million and up to \$10 million (Approval Level 2) are placed on the consent agenda of the Academic Board to be considered for approval and are subsequently confirmed by the Executive Committee. Capital Project: Project Planning Report for the University of Toronto Mississauga Biology Research Greenhouse - Sources of Funding and Total Project Cost

HIGHLIGHTS:

This item anticipates that the motion to approve in principle the Project Planning Committee Report for the University of Toronto Mississauga Biology Greenhouse, dated October 15, 2013, has been approved. As well, it is anticipated that the project scope totalling approximately 432.0 gross square metres or about 276.9 net assignable square meters (nasm) has also been approved in principle.

FINANCIAL IMPLICATIONS:

a) Total Project Cost Estimate

The proposed Total Project Cost (TPC) for the Biology Greenhouse project is \$4,170,391.

b) Operating Costs

Annual energy and maintenance costs are expected to range from \$72,400 to \$86,000. Additional annual operating costs related to staffing and transportation (operating cost of van) are estimated at \$67,600 per year. UTM's annual Operating Budget has provided for these increased costs that total between \$140,000 to \$153,600.

The annual estimated cost of energy and maintenance; between \$262 and \$311 / nasm.

c) Funding Sources
