## **Changes to Existing Programs and Courses**

## **Department of Anthropology**

#### *Note regarding consultation:*

All changes have been approved by the Departmental Curriculum Committee, and reviewed by the Dean's Office.

#### Course change – ANTD05H3

#### Rationale:

This course offers a significant experiential research component in the anthropology curriculum, intended for Specialists and Majors who will benefit from intensive, hands-on engagement with field-based research in the discipline. The course requires a substantial commitment on the part of students to carry out (supervised) independent fieldwork outside of class time. Adding a minimum GPA or assessment from the instructor to the calendar description serves to more clearly signal the necessary pre-requisites for student success.

This proposal has been submitted out of cycle because the course will be offered in Winter 2017. Calendar Copy Showing Changes:

### ANTD05H3 Advanced Fieldwork Methods in Social and Cultural Anthropology

This course provides students with experience in carrying out ethnographic research in the Greater Toronto Area. Working with the Center for Ethnography, students define and execute a research project of their own design. This course culminates in an original research paper. Prerequisite: [ANTB19H3 and ANTB20H3 and ANTC60H3] and [at least two an additional 1.0 credit at the C-level (1.0 credit) in socio-cultural anthropology] and [a cumulative GPA of at least 2.7 or permission of the instructor]. Preference will be given to Specialists and Majors in Anthropology, in that order. **Enrolment Limits: 15** Breadth Requirement: Social & Behavioural Sciences
