JURISDICTIONAL INFORMATION:

New Courses

ENGC18H3 Colonial and Postcolonial Literature

Over the course of five centuries, European empires changed the face of every continent. The present world bears the traces of those empires in the form of nation-states, capitalism, population transfers, and the spread of European languages. We will consider how empire and resistance to empire have been imagined and narrated in a variety of texts.

Prerequisite: Any 8.0 credits Exclusion: ENG270Y

Breadth Requirement: Arts, Literature & Language

Rationale:

This course will complement the current ENG course offerings in African, Caribbean, and South Asian literature by supplying a larger contextual and theoretical frame. The course provides a global focus that will attract students who may have wrongly imagined that literature defined by region was not global and only of local interest.

The course is being proposed out of cycle so that it can be offered in the Fall 2017 term.

ENGC19H3 Transnational Literature

How have writers had to re-invent generic conventions to imagine the world beyond the nation and the new links among distant places?

Prerequisite: Any 8.0 credits

Exclusion: ENG370H
