RECOMMENDATION:

BE IT RESOLVED

THAT beginning in the fall 2017 session, the **Association of Part-time Undergraduate Students** fee be increased as follows:

- (a) an increase of \$0.06 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee;
- (b) an increase of \$5.42 per fall and winter session in the Accident & Prescription Drug Insurance Plan portion of the fee; and
- (c) an increase of \$4.53 per fall and winter session in the Dental Plan portion of the

THAT beginning in the fall 2017 session, the **Engineering Society** fee be increased as follows:

- (a) an increase of the society portion of the fee of \$0.38 per fall and winter sessions (\$0.35 part-time);
- (b) the continuation of the Blue Sky Solar Car Team portion of the fee at \$2.75 per fall and winter session (full-time only) through 2018-19;
- (c) the continuation of the Concrete Canoe Team portion of the fee, and increase of \$0.35 per fall and winter session (full-time only) through 2018-19;
- (d) the establishment of a new designated portion of the fee for the Concrete Toboggan Team at \$1.50 per fall and winter session (full-time only) through 2018-19;
- (e) the continuation of the Engineers Without Borders portion of the fee and increase of \$0.25 per fall and winter session (full-time only) through 2018-19;
- (f) the continuation of the Formula SAE Racing Team portion of the fee at \$2.75 per fall and winter session (full-time only) through 2018-19;
- (g) the continuation of the Human Powered Vehicle Design portion of the fee and increase of \$0.75 per fall and winter session (full-time only) through 2018-19;
- (h) the establishment of a new designated portion of the fee for Robotics for Space Exploration at \$1.75 per fall and winter session (full-time only) through 2018-19;

- (i) the continuation of the University of Toronto Aerospace Team portion of the fee and increase of \$0.07 per fall and winter session (full-time only) through 2018-19.
- (j) the continuation of the University of Toronto Robotics Association portion of the fee and increase of \$0.50 per fall and winter session (full-time only) through 2018-19.

THAT beginning in the fall 2017 session, the **Innis College Student Society** fee be increased as follows:

(a) an increase of \$3.50 per fall and winter session in the World University Service of Canada (WUSC) portion of the fee.

THAT beginning in the fall 2017 session, the **Master of Information Student Council** and the **Museum Studies Student Association** fees be increased as follows:

(a) the establishment of a new designated portion of the fee for the Tech Fund levy at \$25.00 per fall and winter session (\$12.50 part-time).

THAT beginning in the fall 2017 session, the **University of Toronto Graduate Students' Union** fee be increased as follows:

- (a) an increase of \$0.01 per session in the Bikechain portion of the fee (\$0.01 part-time);
- (b) an increase of \$0.12 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee (\$0.06 part-time);
- (c) an increase of \$0.05 per fall and winter session in the OPIRG portion of the fee (\$0.03 part-time);
- (d) an increase of \$0.01 per session in the Sexual Education Centre portion of the fee (\$0.01 part-time);
- (e) an increase of \$5.36 per fall and winter session in the Dental Plan portion of the fee (full- and part-time); and
- (f) an increase of \$14.13 per fall and winter sessions in the Supplementary Health Coverage portion of the fee (\$14.18 part time¹);

THAT beginning in the fall 2017 session, the **University of Toronto Students' Union** (UTSU, legally the Students' Administrative Council) fees be increased as follows:

- (a) an increase of \$0.37 per session in the society portion of the fee;
- (b) for full-time undergraduates on the St. George Campus only, the establishment of a designated Accessibility Resources Fund portion of the fee of \$0.50 per fall and winter session;
- (c) for full-time undergraduates on the St. George Campus only, an increase of \$0.01 per session in the Bikechain portion of the fee;
- (d) an increase of \$0.16 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee;
- (e) for full-time undergraduates on the St. George Campus only, an increase of \$0.06 per session in the Downtown Legal Services portion of the fee;

¹ Owing to a student society administrative error, full-time and part-time students were charged \$137.06 and \$137.01, respectively, for the Supplementary Health Coverage portion of the UTGSU fee. This year's separate increase amounts of \$14.13 and \$14.18 re-align the two fees.

- (f) for full-time undergraduates on the UTM Campus only, an increase of \$0.02 per session in the Downtown Legal Services portion of the fee,
- (g) for full-time undergraduates on the St. George Campus only, an increase of \$0.93 per session in the Student Commons portion of the fee;
- (h) an increase of \$0.01 per session in the Student Refugee Program portion of the fee:
- (i) for full-time undergraduates on the St. George Campus only the establishment of a designated University of Toronto Aerospace Team portion of the fee of \$2.77 per fall and winter session; and
- (j) an increase of \$6.93 per fall and winter session in the Accident & Prescription Drug Plan portion of the fee; and
- (k) an increase of \$1.45 per fall and winter session in the Dental Plan portion of the fee.

THAT beginning in the fall 2017 session, the **Varsity Publications Inc.** society fee be increased as follows:

(a) an increase of \$0.04 per session in the society portion of the fee.

Re: Student Society Proposals for Fee Increases:

University of Toronto St. George and Multi-Campus

The Office of the Vice-Provost, Students has received a number of fee change requests from student societies. The applications have been reviewed in light of the requirements of the *Policy for Compulsory Non-Academic Incidental Fees*, are found to be in compliance with these requirements, and are recommended for approval.

Requests for fee increases from student societies must meet a number of requirements. Section B.4. of the *Policy for Compulsory Non-Academic Incidental Fees* outlines the University's general expectations:

Requests to change the fee collected on behalf of a student society and requests for new fees shall be approved only when evidence has been presented that the request has been authorized by due constitutional process in the organization. The procedures to request approval of a new fee or an increase to an existing fee shall be published in the Handbook for Student Societies.

Cost of Living Increases

(a) Where the amount of an increase in the fee charged is not greater than the year-over-year change in consumer prices for Ontario as measured by Statistics Canada (December-over-December) as of December 31 of the previous year, the request must be supported by the results of a previous referendum approving the principle of a cost-of-living adjustment. In special circumstances (e.g., when a portion of a student society fee is designated for a health plan or capital project), other inflation indexes or predetermined inflation factors may be used, provided that the request is supported by the results of a previous referendum approving the use of the specific inflation index or predetermined inflation factor.

Referendum Requirement

(a) Where the amount of an increase in the fee charged is greater than the year-over-year change in consumer prices, the request must be supported by the majority of the society's members voting in a recent referendum.

The procedures for handling fee change requests (from the *Handbook for Student Societies* published by the OVPS) also provide that requests for a fee increase must be supplied with the following:

Evidence that the request to change the existing fee (or to institute a new charge) has been authorized by due constitutional process of the organization. This evidence should include a copy of or specific reference to the section of the society's constitution which related to the mechanism for fee changes, minutes of the meeting at which the resolution to request the change was passed, details and results of any referenda related to the subject which may have been held within the division, and publicity given the matter to ensure that those who may be affected by the change are aware of the proposal, including size and purpose of the increase, and have had the opportunity to make their views known.

Normally, the administration intersects with these processes at two points. Initially, student societies may seek advice from the OVPS on the wording of the referendum questions (with respect to clarity and technical language). The second point occurs after the referendum when the student society makes the formal request for a fee increase. The recommendation for approval is derived from the assessment of whether or not the society has met the requirements established in the *Policy* and relevant procedures.

Occasionally, the OVPS is asked to look into complaints about referendum procedures and compliance with relevant portions of the society's constitution and/or by-laws. The results of these investigations play a significant role in the assessment of the request and the recommendation for approval.

The assessment of requests for fee increases is normally based upon the following expectations:

- 1. The student society must make the request in a manner consistent with the *Policy for Compulsory Non-Academic Incidental Fees* and the University's procedures for increases to student society fees;
- 2. When required, there must be a positive result in a referendum for a fee increase (special conditions established by the society's by-laws, such as quorum, must also be met);
- 3. The referendum question itself should be clear and provide enough information to students in order to gain a full understanding of the implications of the question and proposed fee for them;
- 4. The referendum must be held in a fair manner, advertised and promoted in a reasonable manner, and the members of each organization should be given a reasonable opportunity to vote; and
- 5. Each organization must comply with the provisions of its own by-laws, rules of procedure, and specific policies and procedures approved by the society's board or council.

Societies which have previously received approval (by referendum) from their members for an annual cost of living increase in the society's portion of the fee may request increases, upon approval by the society's board or council, of up to the previous Ontario December-over-December cost of living increase (consumer price index) calculated by Statistics Canada. The December 2016 consumer price index for Ontario was 2%.

As outlined in the excerpt from the *Policy* above, where members of a society have given consent (through a previous referendum) to the concept of inflationary increases according to a specific inflation factor or measure, this inflation factor may be used. For example, the University of Toronto Students' Union (UTSU), the University of Toronto Graduate Students' Union (UTGSU), and the Association of Part-Time Undergraduate Students (APUS) may request increases in the designated portions of their fees for health and dental plans at a rate established by approval of a previous referendum. UTSU and APUS may request increases in their health and dental plan fees of up to 10%. The UTGSU may request increases in its health and dental plan fees of an amount less than or equal to a health industry index.

It is important to note that when dealing with a student society request for a fee change, it is the society's own constitution, by-laws, or established policies that set the standards for acceptable results in referenda. In some cases, society constitutions establish a minimum voter turnout in order to consider a referendum result to be valid. The University has not established additional criteria with respect to valid referendum voter turnout.

In addition, with respect to both requests for increases based upon the results of a referendum, and increases which require only the approval of the society's board or council, the administration relies on the assurances of student societies that due constitutional processes and fair procedures have been followed.

Association of Part-time Undergraduate Students (APUS)

Background

In fall/winter of 2016-17, the APUS fee was \$117.53 per session charged to all part-time undergraduate students on all campuses. The fee included \$3.89 per session for the Canadian Federation of Students (CFS)/CFS-Ontario; \$54.24 (including an administration fee and sales tax) per session for Accident & Prescription Drug Insurance Plan; and \$45.25 (including an administration fee and sales tax) per session for a Dental Plan.

Requests

1) A cost of living increase in the Canadian Federation of Students (CFS) & CFS-Ontario portion of the fee.

At its meeting held on March 24, 2017, the APUS Board of Directors approved a resolution to request a cost of living increase to the Canadian Federation of Students (CFS) & CFS-Ontario portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

2) An inflationary increase in the Accident & Prescription Drug Insurance portion of the fee.

At its meeting held on March 24, 2017, the APUS Board of Directors approved a resolution to request an inflationary increase to the Accident & Prescription Drug Insurance Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

3) An inflationary increase in the Dental Plan portion of the fee.

At its meeting held on March 24, 2017, the APUS Board of Directors approved a resolution to request an inflationary increase to the Dental Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

Recommendations

Engineering Society (EngSoc)

Background

In the fall/winter 2016-17, the University of Toronto Engineering Society fee was \$152.39 per session, charged to all full-time Faculty of Applied Science & Engineering students (\$23.35 per session for part-time students and Professional Experience Year [PEY] students). The fee included \$24.84 per session (\$23.35 part-time) for the society portion of the fee; and \$1.90 for the Skule Night portion of the fee.

Requests

1) A cost of living increase in the society portion of the fee.

At its meeting held on February 26, 2017, the University of Toronto Engineering Society Council approved a resolution to seek a cost of living increase in the society portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

2) The continuation of the Blue Sky Solar Car Team portion of the fee.

A referendum was held from March 8, 2017 to March 10, 2017, in which Applied Science and Engineering students were asked to support the continuation of the levy for the next two years. The wording of the question is as follows:

University of Toronto Blue Sky Solar Racing Team Preamble Who are we?

The University of Toronto Blue Sky Solar Racing Team is a student-run multidisciplinary initiative that aims to challenge conventional ideas on education, transportation, and sustainability through the design, construction and competition of solar-powered vehicles. The team was first established in 1992 and has since constructed 8 solar cars and raced in 10 competitions.

The solar car project is an amazing and challenging journey that is fueled by passion and dedication from our team members. We generate innovative solutions for an electric car that can race for 3000 km over a 7 day time period across the Australian Outback powered only by the sun. Two years, from design to the finish line, are required for the team to complete the whole project.

What do we do for Engineering Students?

Blue Sky is a diverse family of over 150 people and we are always looking for dedicated members who are interested in being a part of the team. As a part of the team, members gain hands-on experience with cutting-edge technologies to build the most competitive solar vehicle. Team members also get to work with our diverse industry partners to gain valuable advice and knowledge. By voting yes, you are supporting your classmates, friends, and fellow aspiring engineers to take part in this unique learning experience.

When not racing in the Australian Outback or in other places around the world, the team participates in numerous public and campus events to educate the public and U of T students about the state-of-the-art photovoltaic, battery, and electric vehicle technologies and promote the emergence of sustainable transportation solutions.

What's next for Blue Sky?

After an exciting 3rd place win, the Blue Sky team is back and more motivated than ever to take on the challenge of the 2017 World Solar Challenge (WSC) in Australia this October. Currently, we are in the midst of fabrication of the solar car, and preparing for the competition. Our expected rollout for the ninth generation car is in June, when we unveil what we have tirelessly working on to the public. We are gathering more support than ever from the Faculty, the students, and our industry partners with one bold mission - to place in the Top 5 in the world at the 2017 Bridgestone World Solar Challenge.

The levy funds will be used to fund our journey to the World Solar Challenge in Australia. Race crew members will be paying their own expenses to get to Australia as a testament to their commitment to the project and the value of the race experience. The funding will be used to get our most important item, the car itself, to Australia. The levy is key in contributing to these shipping fees as it is an overseas competition.

3) The continuation and increase of the Concrete Canoe Team portion of the fee.

A referendum was held from March 8, 2017 to March 10, 2017, in which Applied Science and Engineering students were asked to support the continuation and an increase of the levy for the next two years. The wording of the question is as follows:

University of Toronto Concrete Canoe Team Preamble

For the last 30-plus years, the University of Toronto Concrete Canoe Team has provided students with a unique opportunity every year to design and build a fully seaworthy canoe made of concrete, an unlikely material choice for a racing vehicle. Although concrete is a dense material and is relatively weak in tension, we alter its characteristics to make it both low density and flexurally strong. We push the edges of materials knowledge and watercraft design by experimenting with new concrete mixes and canoe hulls, furthering and developing new uses for concrete in civil and materials engineering.

To do this, we rely heavily on the continued support of our engineering undergraduate students through our student levy, which comprises a significant portion of our revenue. Funding for our team allows us to procure materials and equipment to conduct experiments and construct our canoe, as well as pay for transportation and lodging costs associated with attending competitions.

Your support throughout the years have allowed us to create canoes that produce excellent results. In the annual Canadian National Concrete Canoe Competition hosted by the Canadian Society for Civil Engineering, we have consistently

University of Toronto Concrete Toboggan Team Preamble

The University of Toronto Concrete Toboggan Team is a club consisting entirely of U of T Engineering students. Each year our team designs, builds, and races a toboggan complete with braking and steering systems, concrete skis, and a superstructure to prevent injury to riders. As we enter our 25th year as a team participating in the annual Great Northern Concrete Toboggan Race (GNCTR), the oldest Engineering design competition in Canada, we are looking to start a levy for our team to help us reach new heights.

Concrete Toboggan is an important part of the Skule community; promoting multidisciplinary collaboration, and interschool interaction and competition. This year our competition team represented 7 disciplines and all 5 years of Skuligans.

University of Toronto Human Powered Vehicle Design Team (HPVDT) Preamble

The Human-Powered Vehicle Design Team is a student organization at the University of Toronto that is focused on the design and construction of innovative, high-performance, human-powered vehicles. Our goal is to provide students with practical, hands-on experience in engineering design while promoting efficiency, sustainability and the use of human power as a means of reducing society's impact on the environment. The projects we tackle range from annual student competitions to one-of-a-kind recordsetting demonstrations. HPVDT is requesting a levy to supplement other sources of funding in order to cover the costs of tools, materials, training equipment, competitions, and vehicle upkeep.

Preamble -

Robotics for Space Exploration (RSX) is a highly ambitious design club affiliated with the University of Toronto. We are interested in a variety of space robotics design projects, ranging from terrestrial rovers to atmospheric payloads. Since our founding in 2013, RSX has grown from 5 members to over 50. Similarly, our design and manufacturing capabilities have grown, from rovers hastily thrown together with hand tools to one that is properly designed, simulated and tested with printed circuit boards and well-machined parts. However, we didn't just land upon these more professional manufacturing methods. Over the past 3 years, we've had to allocate a large chunk of our budget to build up a repertoire of our own tools and machining equipment, to meet the needs of our designs. Even still, many of the manufacturing techniques that are accessible to most of our competitors are not feasible for us, and our ability to realize great designs is often limited by the resources available to us.

Apart from participating in design competitions around the world, RSX also recognizes the importance of giving back and mentoring members of our own community. Since 2015, we have hosted the annual Space Exploration and Engineering Kompetition (SEEK) three times, each with an enthusiastic turnout. Expanding this competition to a larger number of students and to a younger group of students in high schools requires financial resources that we don't have access to yet.

RSX also participates in outreach events geared toward even younger audiences. Every year, we provide robotic demonstrations directed to an elementary-aged audience at the Ontario Science Centre during their annual "Robots Rule" event. In the future, we hope to expand our outreach opportunities, for example, by expanding our mentorship toward high school participants in SEEK.

We have managed to accomplish so much despite the young age of our club and the limited available resources, and all this had only been possible through the dedication of our executive and general members. We know that we can accomplish so much more with the support of the entire engineering student body through this levy. With added support from within the university, we are confident that RSX's limit will only lie in the bounds of our imagination, because we truly believe that for us, "The sky is not the limit. It just gets in our way!"

University of Toronto Aerospace Team (UTAT) Preamble

The University of Toronto Aerospace Team (UTAT) seeks the consent of Engineering Society Students at the University of Toronto to continue to collect its levy, adjusting for inflation at 2.1%, as was established in academic 2014-15 for \$3.25.

The proceeds of this levy will be used by UTAT to provide extracurricular opportunities for engineering society students to develop Aerospace systems including fixed-wing drones, multi-rotor aerial vehicles, and rockets; take part in competitions with those vehicles; and develop systems to conduct scientific research onboard those vehicles. In short, the levy will allow for UTAT to more effectively work towards its mission of enriching the experiences of students by promoting interest in the aerospace industry.

In academic 2016-17 much of UTAT's work was preparing to serve its members more effectively. UTAT's membership surpassed 150 students in its 5 divisions: Aerial Robotics, Outreach, Rocketry, Space Systems, and Unmanned Aerial Vehicles. UTAT expanded its administrative capacity to support these divisions too by reorganizing its business development branch, and laying the groundwork for a new marketing and leadership organizations to give students opportunities not only to design vehicles, but also experience what working at an aerospace firm might really be like.

In academic 2017-18 UTAT will be competing in the Unmanned Systems Canada (USC) competition for multi-rotor aerial vehicles, the Association for Unmanned Vehicles Systems International (AUVSI) competition for fixed wing drones, and the Intercollegiate Rocket Engineering Competition (IREC). Furthermore the Rocketry Division will explore the opportunity to develop a vehicle capable of breaking the Canadian amateur rocketry altitude record, and the UAV Division will explore the opportunity to develop a vehicle to compete in one of the world's most prestigious UAV competitions in Australia. Finally, the Space Systems Division will be competing in the Canadian Satellite Design Challenge (CSDC) with the end goal of launching their satellite into Low Earth Orbit, however it is not expected that proceeds from the Engineering Society Students levy will be distributed to this division under the current budget.

The Tech Fund works to facilitate the purchase and implementation of a vast amount of technologies (hardware and software) and services at the request of the iSchool students, and also funds a large number of student planned events and iSchool workshops throughout the academic year.

The last Tech Fund referendum, which was held during the 2012-2013 academic year, generated a successful outcome in favour of the Tech Fund receiving a fee in the amount of \$100 per year for full-time students and \$50 per year for part-time students. However, at the discretion of the current 2016-2017 committee, the Tech Fund has decided to cut the fee in half as they intend to bring in (with minor fluctuations depending on iSchool enrollment) only as much as the committee is able, and has been seen, to spend in a single academic year (\$30,000).

Referendum Statement

All students registered in the Master of Information and Master of Museum Studies programs will contribute \$25.00 per academic session (no fee charged during the summer session) for full-time students (for a total of \$50.00 for fall/winter period) and \$12.50 per academic session (no fee charged during summer session) for part-time students (for a total of \$25.00 for fall/winter period) towards the Tech Fund. Concurrent Registration Option (CRO) students will pay the equivalent fee of a full-time student. The reinstatement of the collection of fees for the Tech Fund will be determined by this referendum and, provided the referendum is successful, will be applied to the 2017 fall session.

At its meeting held on March 31, 2017, the UTSU Board approved a resolution to request an inflationary increase to the Dental Plan portion of the fee.

In the course of considering this request, the Office of the Vice-Provost, Students has not received any complaints.

Recommendations

THAT beginning in the fall 2017 session, the **University of Toronto Students' Union** (UTSU, legally the Students' Administrative Council) fees be increased as follows:

- (a) an increase of \$0.37 per session in the society portion of the fee;
- (b) for full-time undergraduates on the St. George Campus only, the establishment of a designated Accessibility Resources Fund portion of the fee of \$0.50 per fall and winter session:

- (c) for full-time undergraduates on the St. George Campus only, an increase of \$0.01 per session in the Bikechain portion of the fee;
- (d) an increase of \$0.16 per session in the Canadian Federation of Students (CFS)/CFS-Ontario portion of the fee;
- (e) for full-time undergraduates on the St. George Campus only, an increase of \$0.06 per session in the Downtown Legal Services portion of the fee;
- (f) for full-time undergraduates on the UTM Campus only, an increase of \$0.02 per session in the Downtown Legal Services portion of the fee,
- (g) for full-time undergraduates on the St. George Campus only, an increase of \$0.93 per session in the Student Commons portion of the fee;
- (h) an increase of \$0.01 per session in the Student Refugee Program portion of the fee:
- (i) for full-time undergraduates on the St. George Campus only the establishment of a designated University of Toronto Aerospace Team portion of the fee of \$2.77 per fall and winter session; and
- (j) an increase of \$6.93 per fall and winter session in the Accident & Prescription Drug Plan portion of the fee; and
- (k) an increase of \$1.45 per fall and winter session in the Dental Plan portion of the fee.

If approved, the total UTSU-St. George fee will be \$213.71 per fall and winter session, charged to all full-time undergraduate students on the St. George campus; and the total UTSU-UTM fee will increase to \$196.32 per fall and winter session, charged to all full-time undergraduate students on the University of Toronto Mississauga campus.

Varsity Publications

Background

In the fall/winter 2016-17, the **Varsity Publications Inc.** fee was \$1.97 per session, charged to all full-time undergraduate University of Toronto students.

Requests

2) A cost of living increase in the society portion of the fee.

At its meeting held on March 18, 2017, Varsity Publications Inc. Board of Directors approved a resolution to request a cost of living increase to the society fee.
