## **PREVIOUS ACTION TAKEN:**

At its meeting of June 27, 2017, the Governing Council approved the annual delegation of authority to the President to act on behalf of the Council during the summer months. Council delegated authority for appointments, curriculum changes and "decisions on other matters the urgency of which does not permit their deferral until the next regular meeting of the Governing Council or its appropriate standing committee or board." The resolution also specified that all actions taken under this authority be approved by the Chair of the Governing Council prior to implementation and reported to the appropriate board or committee for information.

#### **HIGHLIGHTS:**

The following resolutions were approved under summer executive authority.
