# **1 Course Modification:**

## LINB20H3: Sociolinguistics

### Learning Outcomes:

Previous:

**New**: LINB20H3 is being redesigned for a hybrid learning environment. Sociolinguistics is a course which is offered as a three-hour lecture with no tutorials. With OUCI funding, the course content will be redesigned and delivered innovatively by the use of instructional technology and engaging learning activities designed based on sound research in the field of Scholarship of Teaching and Learning (SoTL). The redesign of the course in a hybrid environment: a. Reduces the lecture time from three hours to two hours so that our students can easily process the delivered information more easily and effectively. b. Helps us to move beyond face-to-face learning to a hybrid learning model which can also become a model for future online offering of this course of other course offerings in the program. Replacing one hour of the three-hour lecture with a series of 15 - 20 minute digital lecturettes focusing on specific topics followed by two hours of active learning in the classroom. The digital videos will provide our students with solid knowledge needed to participate in active learning activities during the remaining two hours. These digital lecturettes will be created during the winter and summer 2018 semesters, combining lecture slides with audio recordings, as well as incorporating simple animated materials.

### Mode of Delivery: Previous: In Class

New: In Class; Online

### **Rationale:**

The primary purpose of this change is to promote student active learning within a communicative approach, in line with the university pedagogy. This approach aligns with a variety of theoretical foundations based on the learners' needs. That is to actively engage students in their learning in a blended (hybrid) learning environment in which:

a. Students take some/more control of their learning process.

b. Students become more self-directed and engaged in their learning through easy-to-access tools and resources. Currently, this course is offered as a three-hour lecture with no tutorials. By replacing one hour of the three-hour lecture with a series of 15 - 20 minute digital lecturettes followed by two hours of active learning in the classroom, we will reduce the lecture time from three hours to two hours. This will ensure that our students can process the delivered information more easily and effectively.

Through redesigning this course from an in-person to a hybrid model, we use innovative teaching and engaging learning strategies that are mainly technology-based. This includes digital lectures, online discussion forums, and auto-corrected online quizzes with question pools.
