
Project Description

5,539 GSM New Construction expanding student study space.



Project Status

Original project tender was over budget requiring redesign to meet the established budget. Project was redesigned and retendered and awarded within budget. Necessary municipal approvals delayed the project's site work. Upon excavating for the project's foundation, several abandoned foundations were discovered which required a redesign of the new building's foundations system, again delaying the progress of construction. Once the site was ready to accept the structural steel structure, the first columns were not yet fabricated resulting in additional delays. Currently gaps in the fabrication process are translating into delays.


Project Description

5,448 GSM of renovation and 520 GSM of new construction new construction within a building originally constructed in 1910 to house student programs.

Project Status

Project was initially delayed by municipal approvals which encumbered access to some of the exterior construction. Further delays resulted from the discovery of differing site conditions as the interior was being demolished in preparation for the renovation work. Additionally, several floors of the interior buildout were suspended during construction due to changes in the owner's requirements requiring major redesign, negotiation and re-sequencing of planned construction work. These contract changes have exhausted the project contingencies and additional funding has been sought through governance to complete the project.

Project Description

1,716 GSM of interior renovation and 180 GSM of new construction within the University's original and most iconic building. New construction consists of an elevator tower adjacent to the existing building. The project consists of 5 phases:

Phase 1: Re-establishment of the library within East and West Hall,

Phase 2: Create a conference centre at the Croft House,

Phase 3: University College Quadrangle renewal,

Phase 4: Upgrading classrooms and addition of a new elevator tower

Phase 5: Upgrade air handling units to air condition the south wing/Croft

Project Status

As demolition proceeded in this landmark building, the discovery of differing site conditions repeatedly delayed planned progress. The overall project is about 60% complete and running with about 180 working days delay. The main building work is planned for completion in October 2019 with the elevator tower addition completed in January 2020.


Project Status
