Establishment of UTMSU as a Representative Student Committee

JURISDICTIONAL INFORMATION:

Under Section 5.5.1 of its *Terms of Reference*, the Campus Affairs Committee is responsible for policy concerning representative student societies and campus organizations.

PREVIOUS ACTION TAKEN:

On May 31, 2004, the Governing Council approved a resolution that the Scarborough Campus Students' Union (SCSU) be recognized as the Representative Student Committee and primary representative body of full-time undergraduate students registered at the University of Toronto at Scarborough (UTSC); and that the Governing Council cease its recognition of the Students' Administrative Council (SAC) as the Representative Student Committee of full-time undergraduate students registered at UTSC – subject to certain conditions and expectations.

HIGHLIGHTS:

At present, the Students' Administrative Council, operating as the University of Toronto Students' Union (UTSU), the University of Toronto Graduate Students' Union (UTGSU), the Association of Part-time Undergraduate Students (APUS), and the Scarborough Campus Students' Union (SCSU), are recognized by the Governing Council as "Representative Student Committees" pursuant to the *University of Toronto Act* (1947).

The *Act* provides that the Governing Council "may make provision for enabling the students of the University, University College and the federated universities and federated colleges to appoint a representative committee of themselves to be chosen in such manner as shall be approved by the [Governing Council], which shall be the recognized official student medium of communication on behalf of such students between them and the [Governing Council]."

For the purpose of the Act, full-time undergraduate students at the University of Toronto Mississauga (UTM) are represented by the UTSU, part-time undergraduate students are represented by APUS, and graduate students are represented by the UTGSU.

Over the years, and particularly after the establishment of the SCSU as the representive student committee for UTSC full-time undergraduate students along with the change in campus governance structure, the establishment of Erindale College Students' Union, operating as the University of Toronto Mississauga Students' Union (UTMSU), as the Representative Student Committee for UTM full-time undergraduate students has been considered. With the growth at UTM and the tri-campus model, the establishment of the UTMSU as a Representative Student Committee is indicative of the natural evolution of student government at U of T. The University recognizes that the UTMSU has been operating in a similar fashion to a Representative Student Committee and the initiative undertaken is a formalization of what has been occurring in practice.

The UTSU and UTMSU had entered into an Associate Membership Agreement (AMA) in April 2008. In January 2018, discussions began between the two societies to end the AMA between the organizations. The University, in respecting the autonomy of the UTSU and UTMSU has not intervened to facilitate this change. In ending the agreement, the UTSU also agreed that the UTMSU could become the Representative Student Committee for UTM fulltime undergraduate students. UTM students would no longer pay fees to the UTSU or be represented by the UTSU.

The following motion, entitled "Endorsement of the Separation of the UTSU and UTMSU", was presented at both the UTSU Annual General Meeting held on October 30, 2018 and the UTMSU Annual General Meeting held on November 29, 2018.

WHEREAS the University of Toronto Students' Union (the "UTSU") and the University of Toronto Mississauga Students' Union (the "UTMSU") entered into an Associate Membership Agreement (the "AMA") on the 30th of April, 2008;

AND WHEREAS the UTMSU Board and Executive have in considering whether to continue the AMA undertaken due diligence, considered the benefits to UTM students of continuing the relationship and of terminating the AMA, and have received legal advice;

AND WHEREAS the UTMSU Board and Executive, having considered the matter carefully, formed the view that it is in the best interests of UTM's student body to terminate the AMA; NOW, THEREFORE, BE IT RESOLVED that the termination of the AMA, be endorsed following board approval of the settlement terms.

At both the UTSU AGM and the UTMSU AGM the vote passed unanimously. At the UTSU AGM all those present – 222 UTSU members – voted in favour. At the UTMSU AGM, the votes were 1,107 in favour (119 attendees present and the remainder by proxy), 0 against, and 0 abstentions.

Fees:

At present, full-time undergraduate students registered at the University of Toronto Mississauga (UTM) are charged \$160.80 per session for the University of Toronto Mississauga Students' Union (UTMSU) and \$222.54 per session for the University of Toronto Students' Union (UTSU). (See summary of fees attached)

The UTMSU and UTSU are jointly supporting the realignment of all UTMSU and UTSU services and representation into a single, restructured UTMSU fee of \$383.34 beginning in fall 2019. If this proposal is accepted, UTM students would no longer be charged a UTSU fee and all of the current designated components of the UTSU fee would be included in the new realigned UTMSU fee.

All relevant conditions applicable to the current UTMSU and UTSU fees (cost-of-living and inflation increases) would still apply.

The Protocol

The Protocol was negotiated pursuant to requirements established by the Ministry of Training, Colleges and Universities. The relevant Ministry guideline (from the Ontario Operating Funds Distribution Manual) is as follows:

5.2.7. Compulsory non-tuition-related ancillary fees (except as exempted in Section 5.2.8) which were in effect during the 1993-94 academic year can neither be increased above 1993-94 levels, nor expanded to include new fees, except through the implementation of a protocol which has been agreed to by representatives of the institution's administration and student government representatives ... and which has received approval from the institution's governing body. The protocol(s) will set out the means by which students will be involved in decisions to increase the existing compulsory non-tuition-related ancillary fees or to introduce new ones.

The term "student governments" is defined by the Ministry as "the minimum number of student organizations which have both elected leadership and by-laws setting out their methods of operation and which, when viewed in combination at an individual institution, represent all students who are eligible to vote for a student organization."¹

Therefore, if UTM students are no longer represented by any of the existing signatories to the agreement (i.e. the UTSU, APUS, and the UTGSU), the Protocol will no longer meet the requirements of the Ministry. If the Protocol does not meet these requirements, its provisions will no longer enable the Council on Student Services (COSS), the UTSC Council on Student Services (CSS), and the UTM Quality Services to Students group (QSS), the related mechanisms for fee increases.

Therefore, the motion is subject to a condition that UTSU continue to formally represent UTM students under the Protocol for the explicit purposes of meeting the requirements of the Ministry of Training, Colleges and Universities.

FINANCIAL IMPLICATIONS:

The total fee paid by students will not change; however, should the proposal be accepted, UTM students would no longer be charged a UTSU fee and all of the current designated components of the UTSU fee would be included in the new realigned UTMSU fee.

RECOMMENDATION:

Be It Recommended,

THAT University of Toronto Mississauga Students' Union be recognized as the Representative Student Committee and primary representative body of full-time undergraduate students registered at the University of Toronto Mississauga; and

THAT the Governing Council cease its recognition of the University of Toronto Students' Union (formerly operating as the Students' Administrative Council) as the Representative Student Committee of full-time undergraduate students registered at the University of Toronto Mississauga;

Subject to the following condition and expectation:

that for the purposes of the Memorandum of Agreement between the University of Toronto, the Students' Administrative Council, the Graduate Students' Union and the Association of Part-Time Undergraduate Students for a Long-Term

¹ Note: the 2019-2020 Tuition Fee Framework and Ancillary Fee Guidelines Publicly-Assisted Universities refers to Student Governing Body in relationship to the Protocol and defines the term "...as the minimum number of student organizations which have both elected leadership and by laws setting out their methods of operation and which, when viewed in combination at an individual institution, represent all students who are eligible to be represented by a student organization except students who have voluntarily opted out of being represented by the student governing body."

Protocol on the Increase or Introduction of Compulsory Non-Tuition Related Fees (the "Protocol"), the Students' Administrative Council shall continue to represent full-time undergraduate students registered at the University of Toronto Mississauga until such a time as a new or revised Protocol is approved.

and

THAT all fees currently charged to University of Toronto Mississauga students on behalf of the University of Toronto Students' Union be henceforth charged on behalf of the University of Toronto Mississauga Students' Union, effective beginning in the Fall 2019 session.
