1. Senior Appointment

The Chair reminded members that as per the *Policy on Appointments and Remuneration* the Executive Committee approves vice-provostial appointments. She indicated that the matters under consideration were (1.) a recommendation for a title change from Vice-Provost, Graduate Education to Vice-Provost, Graduate Research and Education, and (2.) a recommendation for an appointment to the vice-provostial role. Committee would be considering the concurrent appointment as Dean, School of Graduate Studies, at its meeting on April 23, 2014.

At the invitation of the Chair, Professor Cheryl Regehr provided detailed background for the title change of the vice-provostial portfolio referring to the review that was undertaken by the Advisory Search Committee for the Dean, School of Graduate Studies and the recommendations that had been proposed by the Committee.
