## 1. Reviews of Academic Programs and Units – Part 1

# a. Follow-up Reports from Previous Reviews

Professor Smyth thanked Dr. Mallinick and her staff for their tremendous work in support of the reviews of academic programs and units. She said that, at the November 1, 2016 meeting of the Committee on Academic Policy and Programs (AP&P), three follow-up reports previously requested by the AP&P had been discussed. The reports addressed the reviews of the Faculty of Information and its Programs, the University of Toronto Mississauga (UTM) Department of English and Drama and its Programs, and the Faculty of Arts and Science (FAS) Human Biology Undergraduate Programs. Professor Nelson confirmed that the AP&P had held a thorough discussion of the follow-up reports, and the key points were reflected in the meeting minutes.

A member praised the strategies employed by the Faculty of Information to reduce students' time to completion rates. Professor Regehr noted that the Vice-Provost, Graduate Research and Education and Dean of the School of Graduate Studies had been holding discussions on the same topic with the divisional Vice-Deans, Graduate.

# Semi-Annual Report on the Reviews of Academic Units and Programs, April-September 2016
