2. Review of Academic Programs and Units – Part 1 (for information)*

a. Follow-up Reports from Previous Reviews

The Committee received a summary report by Ernest Lam, Chair of the Committee on Academic Policy and Programs (AP&P) regarding the five follow-up reports from previous academic programs and unit reviews that had been considered by AP&P at its meeting on November 1, 2017. It was decided this time would be re-allocated to agenda items related to the *University-Mandated Leave of Absence Policy,* which is coming forward with an update on the consultation process underway by the Vice-Provost, Students, and a newly anticipated agenda item on a capital project related to Greenhouse Gas (GHG) Campus Retrofits that will be introduced by Scott Mabury, Vice-President University Operations. The Provost will bring forward the UTM Academic Plan for information and feedback. The Striking Committee will
