At its meeting of January 28, 2003, the Council of the School of Graduate Studies approved the following motion:

**THAT** SGS Council approve the proposal of the Department of French Language and Literature to allow direct admission to its Ph.D. program, effective September 2003, as follows:

- That applicants with a University of Toronto four-year bachelor's degree, or its equivalent from a recognized university, that includes at least seven full-course equivalents in French Language and Literature, with an average grade of at least an A- in the overall program, be admissible to the fiveyear Ph.D. program in French Language and Literature;
- 2) That candidates admitted to the five-year Ph.D. program in French language and Literature have the same program requirements as those currently in place for candidates admitted to the four-year degree (i.e., those admitted on the basis of a Master's degree) except that:
  - i) they must complete four additional full-course equivalents in French Language and Literature, as approved by the Department; and
  - ii) they must complete both parts of the Departmental Field Examination by December of the third year of registration in the Ph.D. program.
- 3) That candidates for the Ph.D. degree admitted to a five-year program be required to complete four full-course equivalents,

with an average of at least an A-, during their first year of the program in order to remain in good standing and to continue in the Ph.D. program.

### 8.2 French Language and Literature

**MOTION** ( / ) **THAT** SGS Council approve the proposal of the Department of French Language and Literature to allow direct admission to its Ph.D. program, effective September 2003, as follows:

- That applicants with a University of Toronto four-year bachelor's degree, or its equivalent from a recognized university, that includes at least seven full-course equivalents in French Language and Literature, with an average grade of at least an A- in the overall program, be admissible to the five-year Ph.D. program in French Language and Literature;
- 2) That candidates admitted to the five-year Ph.D. program in French language and Literature have the same program requirements as those currently in place for candidates admitted to the four-year degree (i.e., those admitted on the basis of a Master's degree) except that:
  - i) they must complete four additional full-course equivalents in French Language and Literature, as approved by the Department; and
  - ii) they must complete both parts of the Departmental Field Examination by December of the third year of registration in the Ph.D. program.
