---

The Adult Education and Counselling Psychology Department would like to change the title of one of its two graduate programs from "Adult Education" to "Adult Education and Community Development." All faculty members in the Department are in agreement with this request which is not associated with any substantive changes to the Adult Education Program.

When OISE merged with the University of Toronto the Adult Education Department and the Counselling Psychology Program came together into one Department called: "Adult Education, Community Development and Counselling Psychology." Needless to say people found this title rather cumbersome. Last year we made the decision to change the names of BOTH the Department and the Adult Education Program respectively, to:

"The Adult Education and Counselling Psychology Department" and

"The Adult Education and Community Development Program"

By some oversight, only the Department's name was changed at that time.

We would now like to complete this modification. Since there is no substantive Program change involved we are hoping it will be possible to do this in time for the new Program name to be included in next year's Bulletin. Professor Angela Miles and Professor Jack Quarter, our Departmental representative on the [SGS, Division II Executive], will be happy to provide any further information that may be of use in the Committee's deliberations.
