- This proposal has been discussed and approved by the faculty in both the Philosophy of Education and the History of Education specializations, which together comprise the History and Philosophy of Education program. It was then submitted and approved by Dr. Nina Bascia, Chair, Dept of Theory and Policy Studies.

5. Brief Summary of Proposed Change:

This change involves adding an option to the M.Ed. degree. At present students in both the History and Philosophy of Education program have only 'Option II' open to them (8 1/2 courses and an Major Research Paper). We propose adding 'Option IV,' which already exists as an M.Ed. option in the OISE/UT <u>Bulletin</u>; this would require 10 1/2 courses and no research paper. So far as the Philosophy of Education specialization is concerned, students will be required to take the Introduction to Philosophy course, TPS1440; as of 2005, M.Ed students in both options will be required to take TPS1440. Students in the History of Education specialization will be required to take TPS1460, 'Historical Research Methods in Education,' and 5 of their 10 courses would be chosen from the History of Education's course offerings. Both specializations will retain Option II.

If students currently registered in Option II in either specialization desired to transfer to Option IV, we would consider such requests on a case-by-case basis and upon consulting with their faculty advisor and our admissions committees. It is likely that such requests would be approved.

7. Rationale:

Some of our M.Ed. students are more interested in pursuing questions in the philosophy of education and history of education through course work and the research opportunities that are available in their courses, rather than through an MRP. We would like to meet their intellectual needs by offering them this option, one that already exists for other OISE/UT programs. They will continue to conduct research through their course papers. For those students who wish to pursue MRP-level research and are considering further graduate education, we will recommend Option II.

8. Financial and/or Planning Implications:

There are no financial implications involved. In the Philosophy of Education specialization, TPS1440, the Introduction to Philosophy course already exists and is taught regularly as a mandatory course for other degree requirements (M.A, Ed.D, and Ph.D). TPS1460, the History of Education mandatory course for the existing M.Ed degree, already exists and is taught on a regular basis.
