• The SESE Faculty Caucus has discussed the addition of a course only option M.Ed during its last meeting (November 2004). The consensus was in favour of the proposal. Student representatives in the SESE Graduate Programs Committee also approved this addition (Fall 2004)

5. Brief Summary of Proposed Change:

Addition of Option IV (10 half courses) to the SESE Med program which already offers Med, Option II (8 half courses and a Major Research Paper) and Option III (6 half courses and a thesis).

This option will be available to currently registered students.

7. Rationale:

The OISE/UT Bulletin, in the opening institutional sections ("Minimum Admission and Degree Requirements", p. 23, 2004-5) lists 4 options for fulfilling an M.Ed degree at OISE/UT. SESE has always participated in two of them, Option II (8 half courses and a major research paper) and Option III (6 half courses and a thesis). At this point, SESE would like to add to its own program and option which has already been approved for the Second Language Education Program in the Department of Curriculum, Teaching and Learning, at OISE/UT: Option IV (10 half courses).

We concur with SLE that the extent of work required of students will be equivalent in either option. In addition, the Department of Sociology and Equity Studies in Education Admissions Committee has noted that there are generally two types of M.Ed. applications addressed to the Department: 1. those that have very specific research goals focused within SESE's research areas – these research goals are better served by a shorter course load and a thesis or major research paper; 2. professionals who are interested in the overall equity issues of the department – their interest is in taking courses from all SESE research areas. It is the second group that the M. Ed. with coursework only would better serve.

Many Master's programs in the Faculty of Arts at the University of Toronto are completed by coursework only, and some departments even encourage this. Since OISE/UT now lists it in the official OISE/UT Bulletin as an option for potential students, the Department of Sociology & Equity Studies would like to add this option to Option II and Option III as part of its program for M.Ed. studies.

There are no financial implications in relation to his proposal. The courses will be taught on load with current SESE faculty. SESE will not be offering extra courses in relation to this proposal and we anticipate simply a resulting minimal rise in current course enrolments.
