ITEM IDENTIFICATION:

School of Graduate Studies: Proposal to revise the Terms of Reference for the Graduate Academic Appeals Board, article 7(b), the term of appointment of teaching staff representatives, effective September 2004.

JURISDICTIONAL INFORMATION:

The Committee has the authority to approve appeal procedures related to academic regulations.

PREVIOUS ACTION TAKEN:

The School of Graduate Studies approved this proposal at its Council meeting on May 25, 2004.

HIGHLIGHTS:

This request arises because there are a number of current members whose terms will end in the coming academic year. The Board faces the loss of these valuable and experienced members because of a restriction on the number of terms that members may serve. Continuity is very important on the Board and the caseload currently is not onerous. This change would bring the Board guidelines into line with Governing Council Academic Appeals Committee terms of reference with respect to the ability of members to serve more than one term.

FINANCIAL AND/OR PLANNING IMPLICATIONS:

There are no new/additional financial resources required to implement the procedural change.

RECOMMENDATION:

School of Graduate Studies University of Toronto

GRADUATE ACADEMIC APPEALS BOARD TERMS OF REFERENCE

TERM

- 7.(a) The Chair and the Alternate Chair may each hold office for a maximum of five years from the date of their respective appointments. An appointment may be renewed by the Dean for further one-year periods indefinitely.
- (b) A member and alternate member representing the teaching staff of the divisions shall each hold office for a maximum of three years from the date of the appointment. An appointment may be renewed once for a maximum period of three years for further three-year periods indefinitely.
- (c) A student member and alternate student member shall hold office for a period of one year from the date of the appointment. An appointment may be renewed once for a maximum period of one year.
- (d) Where, at the expiration of the term of a Chair, Alternate Chair, teaching staff member or student member, that person is a member of a Hearing Panel which has commenced the hearing of an appeal, that person may continue as a member of the Board for the purpose of hearing and determining that appeal, notwithstanding that the person's appointment is not otherwise renewed, and notwithstanding that the person may no longer be eligible to be a member of the Board except for this provision.
