Dear Sandra:

Please find enclosed this Faculty's proposal for a program change to the Master of Social Work degree. In a nutshell, the Faculty proposes to align the MSW course load with Canadian Association of Schools of Social Work accreditation standards and to move the program towards specializations taken in the second year. Under the new curriculum, the first year of the MSW will consist of generic content taken by all students. At the end of the first year, students will elect to take one of the following four specializations: children and their families; mental health and health; social exclusion and community diversity; gerontology. The accompanying table sets out the structure of the generic year followed by the program of study for each second year specialization.

I apologize for the unconventional way in which this proposal has come to you but we were unaware until the March meeting of Division II Executive that there was a separate process for notification of program change. You will know that we brought all of the proposed course changes to the Division II Executive earlier this month and it is during this meeting that we learnt of the need for prior program approval.

The proposed new MSW curriculum is the product of considerable hard work and consultation within the Faculty and between the Faculty and human service agencies in Toronto. There is now considerable enthusiasm for the new program among faculty and our agency partners and we are very hopeful that implementation of the new first year can begin on schedule in the 2004-2005 academic year. We would be very grateful for any assistance you can provide in enabling us to achieve this objective.

Request to School of Graduate Studies on Proposed Changes to the MSW Programme

Conceptualization of the proposed changes

Human services are among the fastest growing sectors of the Canadian economy. Along with the growth is an increasing diversification of the sector, with fields of practice rising up around specific areas of need. This process will continue with or without the social work profession as employers and the country as a whole go in search of the workers they need to staff the new, more specialized service agencies of the future. While the notion of generic social work has a role to play in this increasingly complex environment, it is clear that graduates will also require more specific skills if they are to thrive in the new human service sector. To put this another way, generic social work is a necessary, but no longer sufficient preparation for practice. The overall aim of the new programme is therefore to produce graduates who are ready to enter the field of their choice after first receiving a thorough grounding in the knowledge, values and skills common to all social workers. The specializations will be built upon the expertise of core teaching faculty and have all been developed with the very active participation of partner agencies in each of the respective fields.

Resources

The proposed new curriculum does not require additional resources. The current curriculum entails a total of twenty half credit courses including practicum, which is equivalent to three half courses. The course requirement for the advanced standing program is nine half courses including two half credits of practicum. The proposed curriculum has a reduced course requirement of 17 credits, which is in line with the CASSW standards for accreditation. The teaching faculty complement currently stands at 25.5, including one potential new hire, the search for which is already under way.

Goals and Objectives

- To prepare graduates for ethical, innovative and effective social work practice in a Goals diverse society;
- To prepare graduates for competent practice which integrates theory and research;
- To prepare graduates capable of integrating practice and policy;
- To prepare graduates who have a generic foundation of core social work knowledge, values and skills, applicable to all fields and methods of practice;
- To prepare graduates for practice in specialized areas, defined by student interest, faculty expertise and demand from the field.

Objectives

To prepare students for professional practice according to the accreditation standards of CASSW;

- To provide a generic foundation of core social work knowledge, values and skills applicable to all fields and methods of practice;
- To prepare students for social work practice interventions based on research evidence:
- To prepare students for specialized practice in four identified areas: a) social work with children and their families; b) diversity and social justice c) social work in gerontology; d) social work in mental health and health;
- To strengthen our partnerships with social work agencies in areas of particular interest to the Faculty for the purposes of enriching our curriculum and of producing graduates with the requisite skills to function in those agencies;
- To encourage inter-disciplinary linkages through the promotion of collaborative programs that can be incorporated within the MSW.

Content

For the list of courses, please see attached tables.

Major changes are summarized below:

- Dropping the streaming of students upon admission to Individual Family Group and Policy Organization Community concentrations
- Providing a generic first year curriculum which incorporates knowledge, skills and values appropriate for all levels of practice
- Providing four specializations in the advanced year
- Reducing course credit load from 20 to 17

Implementation

The Faculty plans to implement the first year of the proposed curriculum to the incoming two year MSW class in the Fall of 2004. The second year of the new curriculum will be implemented for the year II and advanced standing students in the Fall of 2005. The MSW students currently in the programme will complete the existing curriculum.

Evaluation

Evaluation of the curriculum will be carried out through three different activities: student evaluation of courses, end of year survey of MSW year I students, and exit survey of graduating class. The results of the evaluation are summarized and distributed to all instructors. Teaching faculty, sessional instructors and teaching assistants review and discuss the results on a regular basis.

Professional contribution

The proposed curriculum strengthens the ability of our graduates to integrate policy and practice, as this is identified as an important need by the field. Graduates of the program will have the ability to design interventions based on research evidence in their areas of specialization. It is expected that the proposed curriculum will enhance the employability of our graduates as they have the knowledge and skills required for competent practice in a specific area of social work.

In closing, please note that students will also be encouraged (although not at this stage required) to take one of the growing number of collaborative programs in which FSW is participating. Collaborative programs are graduate level, interdisciplinary programs normally consisting of 3 half-credit courses. In the past, these courses were entirely subsumed within the course requirements of the MSW. In the future, 2 of the courses will be included (as electives) within the MSW, meaning that students will need to take 1 half credit in addition to those required for the MSW in order to complete a collaborative program as well as the MSW. Among the collaborative programs in which the Faculty of Social Work is currently a partner are: (a) aging and the life course, (b) addiction studies, (c) ethnic and pluralism studies, (d) women's studies, and (e) South Asian studies.

Those students choosing the thesis route in the MSW Program will be required to take the appropriate section of Ph.D. Research Methods (SWK 6308Y) as an additional requirement, typically, in the Winter or Summer Session of their first year. An MSW thesis is equivalent to two half-credits, so students choosing to pursue this option will do the thesis in lieu of the two MSW electives.
