Academic Board and Committee on Academic Policy and Programs – Terms of **Reference Revisions Regarding the Connaught Committee**

JURISDICTIONAL INFORMATION:

The Governing Council approves the terms of reference of its Boards and Committees.

PREVIOUS ACTION TAKEN:

The Connaught Fund was established by the Governing Council in 1972 and has been overseen by the Connaught Committee, a committee of the Governing Council.

HISTORY OF CONSULTATIONS:

On the recommendation of the Implementation Committee for the Task Force on Governance, the Vice-President, Research recently presented to the Connaught Committee a proposal for revisions to the Terms of Reference of the Connaught Fund. The proposed revisions were unanimously endorsed by the Committee. In early May, 2011 members of the Implementation Committee were then invited to provide input on the proposal.

HIGHLIGHTS:

The Connaught Committee is currently a Standing Committee that reports to the Governing Council by means of an annual report to the Committee on Academic Policy and Programs on matters concerning the Connaught Fund. The Fund, which originated from the sale of the University's Connaught Laboratories in 1972, is used to promote research as well as the application of professional expertise and resources of the University of Toronto to matters of public interest in all research fields.

It is being proposed that the existing reporting structure be altered such that the Connaught Committee would no longer be a committee of the Governing Council. Rather, responsibility for the Connaught Committee, and its role with respect to the Connaught Fund, would rest with the Vice-President, Research, consistent with other research funds. As Chair of the Connaught Committee, the Vice-President, Research would ensure that accountability was met through the provision of information about the Fund to the

University community and the public using electronic or other means. The proposed membership of the Connaught Committee would include the following:

- the Vice-President, Research (Chair);
- two members of the University's senior administration, or their designates;
- the Dean of the School of Graduate Studies or designate;
- four other faculty members representing the four broad disciplinary areas of the humanities, social sciences, physical sciences, and life sciences, appointed by the Committee Chair, to serve for not more than three years each;
- other representatives of the University research community, at the discretion of the Chair.

The proposed revised Terms of Reference of the Connaught Fund are attached for information only as Appendix "A".

In order to accommodate the proposed structural changes to the Connaught Fund terms of reference, outlined above, the following changes to the terms of reference of the Academic Board and the Committee on Academic Policy and Programs would be required.

- Section 4.9 of the Terms of Reference of the Committee on Academic Policy and Programs would be modified, removing reference to "Connaught Committee activities" as one of the matters on which the Committee would receive an annual report; and
- 2) Section 3.3 of the Academic Board Terms of Reference dealing with the Connaught Committee would be deleted.

Section 4.9 of the Committee on Academic Policy and Programs Terms of Reference now reads as follows.

4.9 Monitorial responsibilities

The Committee is responsible for monitoring academic matters as may be required by general policy, as specified herein or by resolution of the Academic Board, the Executive Committee or the Governing Council. The Committee receives annual reports or such more frequent regular reports as it may determine, on matters within its purview, including reports on the following:

- Reviews of Academic Units and Programs;
- Major modifications to programs, as approved by divisional Councils;

- Establishment and termination of transcript notations within existing degree programs;
- Connaught Committee activities;
- Student Financial Support;
- Research and international activities;
- Student awards.

Section 3.3 of the Academic Board Terms of Reference now reads as follows.

3.3 Connaught Committee

The Connaught Committee is a Standing Committee that reports annually through the Committee on Academic Policy and Programs to the Governing Council on matters concerning the Connaught Fund.

Proposals for use of Connaught monies that would have a major steering effect are handled in the same manner as other major research proposals.

Proposals to amend the terms of reference of the Connaught Fund are considered by the Academic Board and confirmation by the Executive Committee.

ACTION:

This proposal is to be forwarded to the relevant governance bodies in cycle 6: June 1, 2011 to the Academic Board; June 13, 2011 to the Executive Committee; and June 23, 2011 to the Governing Council. The Terms of Reference of the Connaught Fund will be established by the Vice-President, Research.

RECOMMENDATION:

Be it Recommended

THAT responsibility for the Connaught Committee and its role with respect to the Connaught Fund be assigned to the Vice-President, Research;

THAT Section 3.3 of the Terms of Reference of the Academic Board dealing with the Connaught Committee be deleted, effective immediately; and

THAT Section 4.9 of the Terms of Reference of the Committee on Academic Policy and Programs be revised, removing reference to "Connaught Committee activities", effective immediately.

Appendix A

Draft Proposed Revisions

THE CONNAUGHT FUND Terms of Reference

A fund, known as the Connaught Fund, was established by Governing Council in 1972, with original assets and liabilities as outlined in Appendix A.

Purpose of the Fund

The primary purpose of the Fund is the promotion of research and the application of professional expertise and resources of the University to matters of public interest in all research fields.

Management of the Fund

Responsibility for the Connaught Committee is assigned to the Vice-President, Research. Use of the Fund will be directed by the Connaught Committee.

Membership of the Connaught Committee comprises the following.

- the Vice-President, Research (Chair);
- two members of the University's senior administration, or their designates;
- the Dean of the School of Graduate Studies or designate;
- four other faculty members representing the four broad disciplinary areas, appointed by the Committee Chair, to serve for not more than three years each; and
- other representatives of the University research community, at the discretion of the Chair.

Connaught funds shall be used to support outstanding research by individuals or groups of scholars in the University. Grants are intended to encourage research of exceptional calibre or the development of new areas of research by scholars of outstanding achievement. Awards will be made in accordance with the most exacting standards of peer review.

Awards for the support of research activities consistent with the purpose of the Fund will be made to graduate students, and to new and established faculty researchers through granting programs designed and operated by the Connaught Committee. The Connaught Committee will establish program procedures, eligibility requirements, and procedures for assessing applications and nominations in compliance with the purpose of the Fund.

The Committee will establish appropriate review panels that will be responsible for reviewing applications and nominations for research awards and fellowships in accordance with established procedures.

The Connaught Committee shall establish annually the budget to be used to support the Connaught awards, in keeping with the University's *Policy on the Preservation of Capital of Endowment Funds*.

The Chair, on behalf of the Connaught Committee, shall maintain up-to-date public information, via the Office of the Vice-President, Research website or other means, on the following: the capital value of the Fund, the income earned by the Fund, the awards made during the reporting year, and changes in programs offered, and any material procedural changes in implementation of the Connaught programs. This will ensure transparency for and accountability to the University's research community, including the Governing Council, and will provide the opportunity for comment on the general purposes for which the Fund is being used.

Investment of the Fund

The Connaught Fund is invested as part of the long-term capital appreciation pool and is governed by the *Policy on the Preservation of Capital of Endowment Funds* and the investment policy for University funds which are approved by the Business Board of Governing Council.

Appendix A

Establishment of the Fund

A fund – known as "The Connaught Fund" – was established by the Governing Council in 1972. It consisted of the following elements:

- 1. Proceeds from the sale of assets of the Connaught Medical Research Laboratories to the Canada Development Corporation as of June 30, 1972.
- 2. The liquid assets of Connaught Medical Laboratories which were retained by the University as of June 30, 1972.
- 3. Proceeds from the sale of valley land in the Township of North York and Vaughan on the western perimeter of the lands owned by the Connaught Medical Research Laboratories and sold to the Metropolitan Toronto and Region Conservation Authority.
- 4. The interest earnings on the above funds from July 1, 1972, through to December 31, 1972, were also capitalized and form part of the Fund.
- 5. All the assets held by the Connaught Trust Endowment Fund as at June 30, 1972.

Liabilities of the Fund

With the sale of the Connaught Medical Research Laboratories as a going concern to the Canada Development Corporation, the University of Toronto – under terms of an Agreement dated the 23^{rd} day of June, 1972 – undertook to assume certain liabilities actual and contingent, inclusive of but not limited to:

- (a) Liability for past service deficiency in the funding of Employee's Pension Plan.
- (b) Continuing liability for payment of Workmen's Compensation payments in respect of claims prior to June 30, 1972.
- (c) Fees for professional services related to the Agreement dated the 23rd day of June, 1972, with the Canada Development Corporation, and in connection with the sale of the valley land in the Township of North York and Vaughan on the western perimeter of the lands owned by the Connaught Medical Research Laboratories and sold to the Metropolitan Toronto and Region Conservation Authority.
