## ITEM IDENTIFICATION:

Report on projects submitted for the one-time-only Ministry Facilities Renewal Grant.

## JURISDICTIONAL INFORMATION:

These projects are tabled for information.

## PREVIOUS ACTION TAKEN:

None.

## HIGHLIGHTS:

This year the Ministry requested submissions from institutions for facilities renewal projects that would be eligible for a special one-time-only funding allocation. Projects having expenditures already incurred and paid for during 2004/05 were eligible as were projects that could be initiated shortly after June 2005. The University of Toronto submission was valued at \$26,020,860 and comprised large and small facilities renewal projects in support of educational infrastructure. The request for funding was approved in its entirety and, as such, has provided an opportunity to undertake more projects than would normally be possible during this period. (Table attached)

Almost all facilities renewal projects listed having a value of up to \$2 million have received University approval, or will be approved this year under the jurisdiction of the Accommodations & Facilities Directorate (AFD). Projects having a stated value of over \$2 million are either aggregates of many small campus-wide projects or have been considered previously as part of larger capital projects, consistent with the *Policy on Capital Planning and Capital Projects*, by the Planning & Budget Committee and approved by the Academic Board.

## FINANCIAL AND/OR PLANNING IMPLICATIONS:

Almost all capital projects address some aspect of facilities renewal. This special Ministry Facilities Renewal Grant has allowed the University to advance its schedule for this work without impacting the borrowing capacity.
