#### **ITEM IDENTIFICATION:**

The Relocation of the John H. Daniels Faculty of Architecture, Landscape and Design to One Spadina Crescent (Phase 2) –Sources of Funding and Total Project Cost

#### JURISDICTIONAL INFORMATION:

Under the *Policy on Capital Planning and Capital Projects*, "...proposals for capital projects exceeding \$10 million must be considered by the appropriate Boards and Committees of Governing Council on the joint recommendation of the Vice-President and Provost and the Vice-President, University Operations. (...) Normally, they will require approval of the Governing Council. Execution of such projects is approved by the Business Board. If a project will require financing as part of the funding, the project proposal must be considered by the Business Board."

## PREVIOUS ACTION TAKEN:

In April 2011, Governing Council approved the transfer of Site 07 (One Spadina Crescent) to the John H. Daniels Faculty of Architecture, Landscape and Design, with the Faculty of Arts and Science program in Visual Art.

In May 2013, Governing Council approved in principle the Project Planning Report for the relocation of the John H. Daniels Faculty of Architecture, Landscape and Design to One Spadina, and in addition, approved in principle the Phase One project scope totalling 4,600 gross square metres (approximately 2,100 net assignable square metres), with a total project cost of \$23.8 million, to be funded as follows:

## FINANCIAL IMPLICATIONS

# a) Total Project Cost Estimate

The project planned for Site 7 comprises two distinct phases:

Phase 1, with a space program of 2,100 nasm (4,600 gsm) and total estimated cost of \$23.8 million, was approved by Governing Council in May 2013.

Phase 2, consisting of the demolition of 4,100 gross sq.m. and new construction with a space program currently estimated at 4,690 nasm (6,790 gross), has an estimated total project cost of \$40.16 million.

The proposed Total Project Cost (TPC), for the two phases, has been established at \$63.96 million.
