Transcript Innovation Initiative

# JURISDICTIONAL INFORMATION:

Under section 5.6 of its Terms of Reference, the Academic Affairs Committee has responsibility for approving "Transcript notations within existing degree programs. An annual report on the establishment and termination of transcript notations is submitted to the Committee on Academic Policy and Programs for information."

## **HIGHLIGHTS:**

The academic transcript has remained essentially the same for many decades, essentially a chronological listing of courses and grades. The Transcript Innovation Initiative (TII) aims to explore how the academic transcript, in digital form, might evolve to represent more fully the student experience.

As a paper document, the transcript's length limits what it might contain. Digital versions, however, can embed links to other data sources. For example, a transcript recipient might be able to click on a degree and see what the learning outcomes are, or click on a course and see the description. Many other similar possibilities also exist. The University introduced a digital PDF version of the transcript in November 2019, setting the stage for these enhancements.

The University community is now being asked to provide input on what content should be included in an expanded digital transcript. A website for feedback has been created at

www.uoft.me/tii . This input will shape the recommendations, which go forward to the project steering committee and its sponsors.
