PREVIOUS ACTION TAKEN:

At the May 31, 2014 Business Board meeting, the Chair of the Audit Committee reported that the Audit Committee had completed its review of Audit Committee governance activities. As part of this process, the University tendered its external auditor services for the 2014-15 financial statements and recommended the appointment of Ernst & Young. The Audit Committee also performed an assessment of the external auditor's performance at its meeting of June 17, 2019.

HIGHLIGHTS:

Ernst & Young LLP are completely independent, perform excellent work, have extensive expertise in both accounting for not-for-profit generally, and for the university sector specifically, are proactive in bringing issues and new developments forward, meet the

University's very tight deadlines and heavy workload requirements for the various audits, and therefore should be retained for the upcoming fiscal year (2020-21).

FINANCIAL IMPLICATIONS:
