ITEM IDENTIFICATION:

Advice from the Council on Student Services (COSS)

JURISDICTIONAL INFORMATION:

The University Affairs Board is responsible for policy and operational matters concerning student services, including levels of service offered, fees charged and categories of users.

Section 5.2.1 of the Terms of Reference provide that the University Affairs Board approve fees for St. George Campus student services, representative student committees and multi-campus organizations.

PREVIOUS ACTION TAKEN:

The Vice-Provost, Students last reported advice from COSS to the University Affairs Board on March 11, 2020.

HIGHLIGHTS:

At its meeting held on February 16, 2021, COSS considered the operating plans and fees of Student Life; the Faculty of Kinesiology and Physical Education: Co-Curricular Programs, Services, and Facilities; and Hart House.

The resolutions for approval of the plans and fees of Student Life; the Faculty of Kinesiology and Physical Education: Co-Curricular Programs, Services, and Facilities; and Hart House received the support of the majority of students present and voting. Pursuant to the terms of the *Protocol on the Increase or Introduction of Compulsory Non-tuition Related Fees* (the *Protocol*), the administration will present plans which include a request for permanent fee increases.

FINANCIAL AND/OR PLANNING IMPLICATIONS:

Recommendations for approval of each division's operating plans and budgets are outlined in the documentation provided to the University Affairs Board. The proposed operating plans and budgets meet the requirements for approval by the Governing Council, pursuant to the *Protocol* and are presented for approval.

SUBJECT:	Advice on Fees and Operating Plans from the Council on Student Services (COSS)

Included in this package are detailed annual reports and operating plans for St. George campus and University-wide co-curricular services for 2021-22. The operating plans and budgets have been prepared with input from the managers of the services, from student users of the services, from various advisory and governing bodies, and from the Council on Student Services (COSS) established under the terms of the *Protocol on the Increase or Introduction of Compulsory Non-tuition Related Fees* (the *Protocol*).

Pursuant to the *Protocol*, a key duty of COSS is to provide advice to University Affairs Board (UAB) in respect of the services' operating plans, budgets and changes in fees governed by the *Protocol*. Decisions of COSS (i.e., approval or the absence of approval) related to operating plans and fees are conveyed to the UAB when the service's plan is under consideration by the Board. If COSS does not approve a fee increase, the administration is entitled to seek approval by the UAB based on two indices.

This memorandum summarizes the outcomes of COSS's consideration of the operating plans and budgets.

COSS Voting on Operating Plans, Budgets, and Fees

For the operating plans, budgets, and associated compulsory non-academic incidental fees to be approved by the Council on Student Services, they require the support of a majority of students present at the meeting when the votes are held.

At its meeting held on February 16, 2021, COSS considered the four resolutions listed below. The results of each vote are provided for the information of members of the Board.

1. Student Life 2021-22 Operating Plans and Budget: Health & Counselling Fee

Be it resolved:

THAT the 2021-22 operating plans and budget for Student Life recommending an increase in the Health & Counselling Fee for a full time student on the St. George Campus to be increased to \$83.92 (\$16.78 for a part time student), which

represents a year over year increase of \$2.45 (\$0.49 for a part time student) or 3.01%, as presented in the documentation from David Newman (Executive Director, Student Experience), be approved.

The vote on the resolution was as follows: In favour: 13 (including 7 students) Opposed: 2 (including 2 students) Abstentions: 0 Resolution Passed

2. Student Life 2021-22 Operating Plans and Budget: Student Services Fees

Be it resolved:

THAT the 2021-22 operating plans and budget for Student Life recommending an increase in the Student Services Fees for a full time student on the St. George Campus to be increased to \$100.79 (\$20.16 for a part time student), which represents a year over year increase of \$1.92 (\$0.38 for a part time student) or 1.92%.

The vote on the resolution was as follows: In favour: 12 (including 6 students) Opposed: 2 (including 2 students) Abstentions: 1 (including 1 students) Resolution Passed

3. Faculty of Kinesiology and Physical Education: Co-Curricular Programs, Services and Facilities 2021-22 Operating Plans and Budget

Be it resolved:

THAT the 2021-22 operating plans and budget for the U of T Sport and Rec Programs, Services and Facilities at the Faculty of Kinesiology and Physical Education, as presented in the documentation from Beth Ali (Executive Director, Athletics and Co-curricular Physical Activity) be approved;

THAT the sessional fee for a full-time student on the St. George campus be decreased to \$196.71 (\$39.34 for a part-time student), which represents a year over year decrease of \$1.57 (\$0.31 for a part-time student) or -0.79%; and

THAT the sessional fee for a full-time student at UTM or UTSC be decreased to \$22.82 (\$4.56 for a part-time student), which represents a year over year decrease of \$0.18 (\$0.04 for a part-time student) or -0.79%.

The vote on the resolution was as follows: In favour: 15 (including 9 students) Opposed: 0 Abstentions: 0 Resolution Passed

4. Hart House 2021-22 Operating Plans and Budget

Be it resolved:

THAT the 2021-22 operating plans and budget for Hart House, as presented in the documentation from John Monahan, Warden, be approved;

THAT the sessional fee for a full-time student on the St. George campus be increased to \$107.49 (\$21.50 for a part-time student), which represents a year over year increase of \$2.06 (\$0.41 for a part time student) or 1.95%; and

THAT the sessional fee for a full-time student at UTM or UTSC be increased to \$3.30 (\$0.67 for a part-time student), which represents a year over year increase of \$0.07 (\$0.02 for a part time student) or 1.95%.

The vote on the resolution was as follows: In favour: 12 (including 6 students) Opposed: 3 (including 3 students) Abstentions: 0 Resolution Passed
