#### **ITEM IDENTIFICATION:**

Minor Modification Graduate Curriculum Changes, Master of Management and Professional Accounting (MMPA) Program, UTM

#### JURISDICTIONAL INFORMATION:

Under section 5.6 of its *Terms of Reference*, the Academic Affairs Committee is responsible formajor and minor modifications to existing degree programs. All major modifications shall be reported annually for information to the appropriate body of Governing Council.

#### **PREVIOUS ACTION TAKEN:**

No previous action was taken on this proposal.

#### HIGHLIGHTS:

The Graduate Curriculum Change proposals (enclosed) outline Minor Modifications to existing graduate programs and courses. These curricular changes are intended to have significant positive effects on a cumulative basis, but are considered to be minor changes in the context of the UTQAP. Proposals for changes brought forward at this meeting were reviewed by the IMI Graduate Curriculum Committee on February 16, 2021 and will come into effect during the 2021-2022 Academic Year.

#### Master of Management & Professional Accounting (MMPA) Program

Offered through the University of Toronto Mississauga's (UTM) Institute for Management & Innovation (IMI), the Master of Management & Professional Accounting (MMPA) Program is proposing changes to two of their existing required courses – MGT2282H and MGT2283H, Integration & Professional Decision Making I and II (respectively). These two half-credit courses currently function as four distinct quarter-credit courses; each with their own instructor, learning objectives, and assessments. The MMPA Program is proposing to formally split each existing half-credit course into two quarter-credit courses, creating four separate Integration & Professional Decision Making courses. While all four courses will deal with the same broad subject area, each will be a unique offering that covers a distinct topic. The splitting of these courses will provide clarity to students with respect to content organization and allows for a natural 'pause' between the courses.

As all Integration & Professional Decision Making courses are required for the 27-month program, the 24-month advanced standing option, and the 12-month advanced standing option of the MMPA, a corresponding program change proposal accompanies the course change proposal. These program changes will further achieve the clarity that the course splits aim to provide to students.

### FINANCIAL IMPLICATIONS:

There are no net implications for the campus' operating budget.

The Master of Management & Professional Accounting (MMPA), offered through the Institute for Management & Innovation (IMI) at the University of Toronto Mississauga (UTM) is proposing program requirement changes to their 27-month program, their 24-month Advanced Standing Option, and their 12-month Advanced Standing Option. These program requirement changes reflect the concurrently proposed splitting of two existing required half-credit courses (MGT2282H and MGT2283H) to create four quarter-credit courses. Both courses are currently required for the 27-month program, the 24-month Advanced Standing Option, and the 12-month Advanced Standing Option, therefore all four new quarter-credit courses will also be required across all three MMPA program options. The total number of credits for all three program options will remain unchanged.

## 3 Academic Rationale

The MMPA Program is concurrently proposing the splitting of two existing half-credit courses to create four quarter-credit courses. These course changes will formalize how the courses have been organized and administered for a number of years and clarifies the program curriculum for students. Program requirements will now more clearly reflect how the curriculum around 'Integration and Professional Decision Making' is organized, providing students with a better understanding of course goals and expectations as well as how this content relates back to program learning outcomes. Students will further benefit by the creation of a natural 'break' or 'pause' in the curriculum of the four courses, allowing for a 'fresh start' in each of the courses. Program requirement changes as a result of these course splits are reflected in Appendix A below.

## 4 Impact on Students

These program requirement changes do not alter the total number of credits required to complete any of the three program options nor are there any changes to program learning outcomes, student assessments, or curricular content. As such, no negative impact to continuing and incoming students is expected. As suggested above, students will instead see a benefit from a more streamlined presentation of the curricular content around 'Integration and Professional Decision Making'.

## **5** Consultation

Consulted the current faculty teaching the courses and they are supportive of the change.

As this program change reflects the formalization of course changes that have been in practice for a number of years, no change to resources is anticipated.

## Master of Management & Professional Accounting

### **Program Description**

The Master of Management & Professional Accounting (MMPA) program is designed to educate future leaders of the accounting profession at the master's level in management and at the professional level in accounting and related subjects. The curriculum is organized to provide an excellent understanding of:

- the challenges, functions, and needs of management;
- accounting, finance, auditing, and tax;
- essential professional subjects;
- management skills; and
- professional capabilities.

Students from any undergraduate background may apply. The MMPA is offered as a 27month program, a 24-month advanced-standing option, and a 12-month advancedstanding option.

## MMPA Program (27-Month)

### **Minimum Admission Requirements**

- Applicants are admitted under the General Regulations of the School of Graduate Studies. Applicants must also satisfy the Institute for Management and Innovation's additional admission requirements stated below.
- An appropriate bachelor's degree with a standing equivalent to at least a University of Toronto mid-B.
- Satisfactory Graduate Management Admission Test (GMAT) score. Note: the GMAT requirement will be waived for applicants who meet the following criteria:
  - have studied for four years at a North American university and graduated with a four-year degree, or
  - have graduated from one of the following programs: the University of Toronto Mississauga's BCom (Accounting specialist), the Rotman School's BCom (Accounting specialist), or the University of Toronto Scarborough's BBA (specialist in Management and Accounting).
- Applicants whose primary language is not English and who graduated from a university where the language of instruction and examination was not English must also demonstrate proficiency in English. See <u>General Regulations section</u> <u>4.3</u> for requirements.

### **Program Requirements**

The program runs for 27 months covering seven sessions of full-time study.

- Coursework. The program requires the successful completion of 18.0 full-course equivalents (FCEs) in required courses, as listed below.
- **Co-op work placements**. Students will also complete two co-op work placements (MGT 1090H and MGT 2090H) in accounting or finance-related areas.

  - have studied for four years at a North American university and graduated with a four-year degree, or
  - have graduated from one of the following programs: the University of Toronto Mississauga's BCom (Accounting specialist), the Rotman School's BCom (Accounting specialist), or the University of Toronto Scarborough's BBA (specialist in Management and Accounting).

- **Co-op work placement**. One co-op work placement (MGT 2090H) in accounting or finance-related areas taken in the Winter session.

## Part 2: Summary of Changes

The current MGT2282H and MGT2283H courses are currently each taught in two parts (informally referred to as Part A & Part B within both courses), for a total of four 'parts' or modules that cover "Integration and Professional Decision Making". Each 'part' is effectively run as a standalone course with a different instructor and distinct curriculum, course

objectives, and assessments. Splitting both courses to create four distinct courses in "Integration and Professional Decision Making" not only formalizes what has been done informally in practice for many years, it clarifies and streamlines the curriculum for students. Additionally, the creation of four formal courses will help to simplify the administration for each course (e.g. instructor/ course evaluations) and allow all four courses to be offered within a standard academic term (i.e. MGT2282H will no longer need to be an extended course).

## **Course Description**

## Academic Rationale

Integration and Professional Decision Making is currently taught across two courses in the MMPA Program (MGT2282H and MGT2283H). Within each course, the content is further divided into two 'parts' (four parts total across both courses), with a different instructor and distinct content, course objectives, and assessments. Students are currently assessed twice within each course with the grades of both 'parts' of the course contributing equally to the final grade. Essentially, the two half-credit (0.5) courses are operating as four quarter-credit (0.25) courses.

These courses were originally set up as two half-credit courses, as it was believed it would reduce the administrative burden to manage two half-credit courses instead of four quarter-credit courses. It soon became clear the courses needed to operate as four quarter-credit courses and this became the standard in practice. By splitting these two existing courses to create four courses, the MMPA Program will be formalizing what has been done in practice for many years while providing added clarity for students. Offering four distinct courses helps students to understand how the content is organized within the program and inserts a natural 'pause' or 'break' between topics/ 'parts' across the courses. This gives students a 'fresh start' with each new course.

#### **Course Objectives:**

#### **Instructional Approach:**

#### **Course Objectives:**

The focus of this course is on Performance Measurement (PM) and Management Decision Making (MDM). Any organization has to have controls and activities in place to ensure that its strategic objectives and goals are met. Underlying these controls and activities are issues involving strategic decision-making, effective governance, risk management and performance evaluation. This course will integrate these issues and other important areas of PM and MDM, such as business valuations, revenue and cost management and management systems and controls, with other topics covered in other courses through the use of integrative case simulations.

#### Howard Gardner's Multiple Intelligences Model

The MMPA Program takes the view that intelligence has more than one dimension, and the MMPA students need to develop along all seven dimensions identified by Howard Gardner during their Program. MGT 2282B will assist students in developing on all of these, except for musical intelligence. The seven dimensions are:

**Linguistic intelligence** involves sensitivity to spoken and written language, the ability to learn languages, and the capacity to use language to accomplish certain goals. This intelligence includes the ability to effectively use language to express oneself rhetorically or poetically; and language as a means to remember information. Writers, poets, lawyers and speakers are among those that Howard Gardner sees as having high linguistic intelligence.

**Logical-mathematical intelligence** consists of the capacity to analyze problems logically, carry out mathematical operations, and investigate issues scientifically. In Howard Gardner's words, in entails the ability to detect patterns, reason deductively and think logically. This intelligence is most often associated with scientific and mathematical thinking.

**Interpersonal intelligence** is concerned with the capacity to understand the intentions, motivations and desires of other people. It allows people to work effectively with others. Educators, salespeople, religious and political leaders and counselors all need a well-developed interpersonal intelligence.

**Intrapersonal intelligence** entails the capacity to understand oneself, to appreciate one's feelings, fears and motivations. In Howard Gardner's view it involves having an effective working model of ourselves, and to be able to use such information to regulate our lives.

#### **Course Objectives:**

The course is designed to integrate the technical materials learned in performance measurement (financial and management accounting), assurance, tax, finance, information systems and organizational effectiveness with the practical experience obtained by students to date.

The primary objective of the course is to simulate real professional situations, giving students an opportunity to apply technical knowledge and professional judgement to such situations. Application skills will be developed through the use of case materials. An important secondary objective is to develop case writing skills and an approach to writing professional examinations. Specifically, this course will require students to be highly motivated and to dedicate adequate time to the readings and class preparation. Students are expected to conduct themselves with the utmost integrity and to maintain an optimal learning environment for themselves and others.

In this course students are given the opportunity to further develop their abilities to analyze problems logically, carry out mathematical operations, and investigate issues. This is referred to as the *Logical-mathematical intelligence* in Gardener's Multiple Intelligences model.

#### Course methodology:

The course is taught utilizing previous UFE and CFE multi-competency examination questions. The first session will focus on the case approach, role playing and professional judgement. Each session will build on these skills and will involve the writing and submission of a case simulation.

<u>Class attendance at the times marked on the timetable is mandatory for all students</u> for purposes of both participation and case writing submissions. Students are

# required to write practical simulations using Word and Excel and submitting same on Quercus.



### Adaptive delivery to the changing world:

This is a "new world" for all of us. All members of our class had previously had me in intro auditing and business law and you each know how I enjoy our "chalk and talk" approach to learning materials. Simulation writing is a very important skill. You can learn a lot of technical - but at the end of the day your professional lives are gauged by your ability to help your employer, your client - whoever. Said another way, you need to be "competent" in your dealings with others. Our goal in 2283B is to provide you an approach in dealing with simulations, and in particular those that relate to "assurance". I, as you instructor, have used the same approach for over 30 years. It is an approach that works for me. You have to develop the approach that works for you. This is done by carefully assessing how you read; how you plan; how you write. You want to develop an approach that reduces your stress and maximizes your performance. In a normal year, you would write a simulation for the first part of a class and then we would take it up for the second part. We would share ideas. You would agree or disagree with how issues are identified and discussed. In the end, we would all learn from that discussion. We would encourage you to "do more" simulations; to sign up for other sessions like Densmore; do sessions provided by your firm; locate a mentor who could also help.

We are in a different world. <u>All of our objectives can still be achieved</u>. We just need to sort out a proper balance and a best method of delivery. I will no longer have my "chalk" in hand. I will adapt – and so will you. I will seek your advice as we progress as to what you need/want and what we can do to make things better. I do however need your commitment to work hard; to write simulations "for real" and to participate. As a class you have never let me down and I know that will continue to be the case. Our sessions together are important.

In our course, we are a "team" and we work together to ensure we collectively have a positive and supportive learning environment. Like baking a cake – sometimes it takes experimentation get the right "mix"/outcome. I will always be open to your advice and suggestions. At this point – my thinking is to have you write the case either in advance or at the start of class and then to do an "on line" take up. In the end – I envisage our class as still having the practical application with time for you to ask questions and absorb the materials in a practical manner.

We will be flexible and adjust accordingly.
