## **ITEM IDENTIFICATION:**

Constitutional Amendments: Faculty of Kinesiology and Physical Education

#### JURISDICTIONAL INFORMATION:

The Governing Council has the authority to establish faculty and college councils and to determine the composition, powers, and duties of those councils under the provisions of the *University of Toronto Act, 1971*, as amended by 1978, chapter 88, Section 2(14)(i).

Section 5.2.2 of the Academic Board Terms of Reference calls for amended divisional constitutions to be considered by the Board and confirmed by the Executive Committee.

## **PREVIOUS ACTION TAKEN:**

Previous revisions to the Faculty of Kinesiology and Physical Education Constitution were approved by the Academic Board on January 29, 2015, and confirmed by the Executive Committee of the Governing Council on February 9, 2015.

#### HIGHLIGHTS:

The proposed amendments to the Faculty of Kinesiology and Physical Education Faculty Council Constitution were discussed at Professoriate meetings and the Faculty Council meeting on January 8, 2024. The revised constitution was shared with all Faculty Council members on February 12, 2024. On February 20, 2024, the Faculty Council Executive Committee recommended that the amendments be added to the agenda of Faculty Council. An update was provided to Faculty Council on March 1, 2024.

Additionally, as part of the consultation process for the amendments to the Constitution of the Council of Athletics and Recreation (CAR), CAR received the proposed changes to the Faculty Council Constitution and a presentation was made at the January 9, 2024 meeting. Changes to the CAR Constitution were approved on February 26, 2024. The CAR Constitution is included in the Faculty Council Constitution as an Appendix, and will be considered by the University Affairs Board for approval.

The changes to the Faculty of Kinesiology and Physical Education Faculty Council Constitution include the following:

- Updating references to Policies and delegated authority, for example the Policy on Certificates (For Credit and Not-for Credit)
- Added teaching stream faculty appointment titles to the definition of "Teaching Staff"
- Added the position of Vice-Chair and increased the term of the appointment from 2 to 3 years
- Clarified the role of the Council of Athletics and Recreation
- Removed gendered language

At a regular Faculty Council meeting on April 5, 2024, the Faculty of Kinesiology and Physical Education Faculty Council Constitution was recommended for Academic Board approval.

#### **CONSTITUTION OF THE COUNCIL**

#### OF THE

#### FACULTY OF KINESIOLOGY AND PHYSICAL EDUCATION

#### UNIVERSITY OF TORONTO

- Article I. The Council of the Faculty of Kinesiology and Physical Education, hereafter described as the "Faculty Council", exercises its responsibilities under the provisions of the University of Toronto Act, 1971, as amended.
- Article II. In this Constitution and the accompanying by-laws:
- Section 2.01 "Faculty" means the Faculty of Kinesiology and Physical Education and "Council" means the properly composed Council of the Faculty of Kinesiology and Physical Education of the University of Toronto.
- Section 2.02 "Teaching Staff" means a member of the Faculty of Kinesiology and Physical Education who holds an academic appointment of 50% or more in the Faculty of Kinesiology and Physical Education and who holds the rank of Professor, Associate Professor, Assistant Professor, Assistant Professor (conditional), Senior Lecturer, Lecturer, Senior Tutor, Tutor, Senior Athletics Instructor or Athletics Instructor.
- Section 2.03 "Administrative Staff" means an appointed staff member of the Faculty of Kinesiology and Physical Education who is not a member of the teaching staff and who holds an appointment of 50% or more.
- Section 2.04 "Undergraduate student" means any student registered in a program of study leading to a degree, post-secondary diploma, or certificate in the Faculty of Kinesiology and Physical Education who is not registered in the School of Graduate Studies.

For the purpose of Appendix A (The Council of Athletics and Recreation Constitution), "student" means any student defined according to the current regulations governing elections to the Governing Council.

- Section 2.05 "Graduate student" means any student registered with the School of Graduate Studies in a program of study leading to a degree, postsecondary diploma or certificate in the Faculty of Kinesiology and Physical Education.
- Section 2.06 "Alumni" means anyone who has received a degree, post-secondary diploma, or certificate from the Faculty, or who has completed one

Joanne Chou - 20224-105+27 20:38:32 UTC University of Toronto year of full-time studies while registered in the Faculty, who is no longer registered as a student and who is not a member of the teaching or administrative staff of the University.

- Article III. Subject to the provisions of the University of Toronto Act, 1971, and the approval, as required or appropriate, of the Governing Council of the University, Council shall have the following powers and duties:
- Section 3.01 Council shall determine the number, size, composition and authority of Standing Committees of the Faculty Council.
- Section 3.02 Council recommends for approval to the appropriate body of Governing Council amendments to divisional academic policies. Academic policy sets out the principles for, the general directions of, and/or priorities for the teaching and research activities of the Faculty.
- Section 3.03 Council plays an advisory role, tendering advice to the divisional administration.
- Article IV The specific powers and duties of Council are the following:
- Section 4.01 Council shall determine the rules and regulations for governing its procedures and its decisions shall be made by resolutions passed at its meetings.
- Section 4.02 Council shall pass by-laws regulating the exercise of its powers, the calling and conduct of its meetings, and the method of appointment or election of its members.
- Section 4.03 Council shall have the power to establish, alter, or disband its committees as deemed necessary and to determine their composition, authority, quorum, and method of appointment of their members and chairs. Council has authority over recommendations brought forward by such committees, be that in its decision-making capacity or in its advisory role.
- Section 4.04 Council shall determine the standards of admission of students to the Faculty and may delegate this responsibility to committees or officers of the Faculty. New policies and practices or amendments to existing ones which affect the whole Faculty are recommended to the appropriate body of Governing Council for approval.
- Section 4.05 Council shall award scholarships, bursaries, prizes and other awards in the name of the Faculty and may delegate this responsibility to committees or officers of the Faculty.

Section 4.06 Council shall establish policies and procedures with respect to petitions and appeals by undergraduate students in connection with the application of academic rules and regulations by officers of the Faculty or by instructors in connection with academic standing in the Faculty. A Committee of Council shall make rulings on all such appeals and such rulings shall be final and binding, subject to an appeal to the Governing Council.

Procedures for academic appeals by graduate students are determined by the School of Graduate Studies in accordance with the *Policy on Academic Appeals within Divisions*.

Section 4.07 Determine the nature and content of all courses of study and programs offered by the Faculty, subject to the approval of the Governing Council, where required and shall monitor the quality and standards of the programs.

Council shall consider the content, quality, and requirements of the academic programs and courses of study that lead to degrees, diplomas, certificates, credits, and non-credit courses over which the Faculty has authority; it shall consider proposals for the closure of any such programs or courses of study; and it shall monitor the quality and standards of the programs and courses of study.

Council shall recommend for approval to the appropriate body of Governing Council proposals for new academic programs.

Council shall have delegated authority to approve proposals for major and minor modifications to existing academic programs. Definitions of major modifications of existing programs, minor modifications, and new academic programs are provided in the *University of Toronto Quality Assurance Process* and are subject to change. Guidance from the Office of the Vice-Provost, Academic Programs, should be sought prior to the development of any such proposal. All major modifications shall be reported annually for information to the appropriate body of Governing Council.

Council shall have delegated authority to approve proposals for the modification of existing diploma and certificate programs, pursuant to the University's *Policy on Diploma and Certificate Programs*. An annual report on such actions as required by the *Policy*, shall be provided for information to the appropriate body of Governing Council.

Section 4.08 Subject to the provisions of the above, Council may delegate its authority for the approval of minor modifications to academic programs to various committees. All such changes shall be reported for information to Council. The decision of whether a matter is major or minor may be made by the Committee Chair in consultation with the Chair of Council, and/or the Dean or his/her

designate, and/or the Vice-President and Provost or his/her designate.

- Section 4.09 Council may be one venue in which consideration and discussion of a review report of an academic program and/or unit may occur, consistent with the protocol outlined in the University of Toronto Quality Assurance Process.
- Section 4.10 Council shall review and approve or recommend for approval to the Governing Council proposals concerning Extra-Departmental Units in the Faculty, pursuant to the *Policy on Interdisciplinary Education* and Research Planning.
- Section 4.11 Council shall have delegated authority to approve transcript notations within existing degree programs, in accordance with University policy. An annual report on such actions, as required by policy, shall be provided for information to the appropriate body of Governing Council.
- Section 4.12 Council shall consider recommendations from the Council of Athletics and Recreation concerning overall policies in athletics and recreation, subject to the approval of the Governing Council, as required.
- Section 4.13 Council shall consider operating plans and budget proposals from the Council of Athletics and Recreation and comment on them to the appropriate body of Governing Council.
- Article V Powers, duties, and responsibilities of the Dean
- Section 5.01 Council recognizes that the Dean exercises powers under the authority of the "*Policy on Appointment of Academic Administrators*" which states that "the Dean of the Faculty is the chief executive officer of the Faculty and reports directly to the Vice-President and Provost."
- Section 5.02 While the Dean may delegate authority to other academic administrators in the Faculty, the Dean retains responsibility for the overall direction of the Faculty and, in particular, for authority over the budget and other financial matters, personnel matters, including appointments and promotions, and extra-Faculty relationships. In this respect, Council recognizes that the Dean has ultimate authority for the allocation and management of the Faculty's resources.
- Section 5.03 The Dean shall consult with members of the Faculty on matters of policy and practice but is ultimately responsible for all administrative decisions that are within his/her jurisdiction and authority.

- Section 5.04 The Dean shall advise Council of the resource implications of proposed academic policy decisions.
- Section 5.05 The Dean may consult with Council on administrative proposals that may have a significant impact on the academic programs of the Faculty.
- Article VI The Membership of the Faculty Council comprises:
- Section 6.01 Ex-officio members (with voting privileges, unless otherwise noted):
  - The President of the University or designate
  - The Vice-President and Provost or designate
  - The Dean of the School of Graduate Studies or designate (non-voting)
  - The Dean of the Faculty
  - One professional librarian appointed by the University Librarian
  - The Vice Deans of the Faculty
  - The Associate Deans of the Faculty
  - The Assistant Deans of the Faculty
  - The Registrar of the Faculty
  - The Chief Administrative Officer of the Faculty
  - The President of the Faculty's Undergraduate Student Society
  - The President of the Faculty's Graduate Student Society
  - The President of the Faculty's Alumni Association or designate
- Section 6.02 Other voting members of the Council may be elected or appointed, and include the following constituencies:
  - All teaching staff of the Faculty as defined in section 2.02.
  - Two professors emeritae/i of the Faculty.
  - One member elected from and by the staff with curricular teaching duties in undergraduate practica courses.
  - One member elected from and by those who serve as Faculty of Kinesiology and Physical Education practica instructors on a sessional, part-time basis.
  - Seven undergraduate students elected from and by the students in the undergraduate program in the Faculty of Kinesiology and Physical Education.

- One graduate student elected from and by the students in the graduate program in the Faculty of Kinesiology and Physical Education.
- Four members elected from and by the administrative staff of the Faculty.
- The Co-Chairs of the Council of Athletics and Recreation.
- Article VII. Term and Quorum of Council
- Section 7.01 The term of office of the Faculty Council members and committees shall be from July 1 to June 30 of the following calendar year, with some student members beginning in the September session.
- Section 7.02 The quorum for a meeting of Council shall be one-third of the voting members. This number will be determined each year.
- Article VIII Officers
- Section 8.01 Faculty Council members shall elect at its final meeting of the year, from among its members, the Chair. The term of office shall normally be for two years from July 1 to June 30. In the absence of the Chair, the Council shall elect an Acting Chair, upon the recommendation of the Dean.

The Chair shall be a non-voting member of Council.

- Section 8.02 The Chair shall preside at all meetings of Council. In the absence of the Chair, any member of the Executive Committee may convene the meeting and an acting Chair shall be chosen by a majority of voting members present for the meeting.
- Section 8.03 The Secretary shall be appointed by the Dean and shall be a non-voting ex-officio member of Council.
- Article IX Meetings of Faculty Council
- Section 9.01 The Faculty Council shall meet at least four times during each academic year. Notice of each meeting, including a proposed agenda, shall be given to members at least one week in advance of the meeting.
- Section 9.02 A special meeting may be called by the Chair of the Faculty Council, the Dean of the Faculty of Kinesiology and Physical Education, or upon the written request of five members of the Faculty Council. In the case of special meetings, a notice of three business days is required.

- Section 9.03 Each voting member of Council has one vote on any question. Motions pass with a simple majority unless otherwise stated in the rules of procedure of the Council. In case of a tie vote, the Chair may cast a deciding vote or redirect the question for further consideration.
- Section 9.04 The meetings of Faculty Council are open to all members of the University community except when matters of a confidential nature are under discussion. The Faculty Council will then move *in camera.*
- Section 9.05 The members of Faculty Council are entitled to participate fully in meetings of the Faculty Council, to speak, to propose motions, to vote on all questions except those where the Chair rules there is a conflict of interest, and to serve on committees and task groups selected and/or appointed by the Faculty Council. In the case of substantive motions which are not on the Council agenda, a two-thirds vote is necessary to add them to the agenda. Members of Committees who are not members of Council may address Council on matters within the jurisdiction of the committee of which they are a member and participate in the debate but they may not vote.
- Section 9.06 The decisions of Faculty Council are available to all members of the University community through the Minutes of Faculty Council, which are kept in the Faculty Office.
- Article X By-Laws
- Section 10.01The procedures of Council will be set forth in the By-Laws of Council.
- Section 10.02 The composition, powers, duties, and procedures of Standing and Special Committees shall be set forth in the By-Laws of Council.
- Article XI Parliamentary Authority
- Section 11.01 The rules contained in the most recent edition of Bourinot's Rules of Order shall govern the Council in all cases to which they are applicable and in which they are not inconsistent with the By-Laws and any special rules of order the Council may adopt.
- Article XII Amendment of the Constitution and By-Laws
- Section 12.01 The Constitution of the Council may only be amended with the approval of the Council and the Governing Council of the University of Toronto. Voting shall take place at a regularly constituted meeting to which there has been three weeks notice of the proposed amendment. An affirmative vote to amend the Constitution is required by two-thirds of the members of Council present and voting. Following approval of the recommended amendment by

- Section 12.02 The By-Laws of the Council may be amended at any regular meeting of the Council by a two-thirds majority of those present and voting, provided that there has been three weeks notice of the proposed amendment.
- Article XIII. Council of Athletics and Recreation
- Section 13.01 The athletic and recreational activities of the Faculty shall be governed by a Council, whose constitution and powers are outlined in the Constitution of the Council of Athletics and Recreation, as in Appendix A hereto, which forms part of the Constitution of the Faculty Council.
- Section 13.02 Amendments to the Constitution of the Council of Athletics and Recreation will be considered for approval by the Faculty Council and the Governing Council body with assigned responsibility for Athletics and Recreation.

#### APPENDIX A to the Constitution of the Council of the Faculty of Kinesiology and Physical Education

#### CONSTITUTION OF THE COUNCIL OF ATHLETICS AND RECREATION

#### **ARTICLE I – NAME**

The "Council" shall be named the Council of Athletics and Recreation of the Faculty of Kinesiology and Physical Education.

#### **ARTICLE II – OBJECTIVES**

Subject to the approval of the Council of the Faculty of Kinesiology and Physical Education, the Council oversees the athletic and recreational programs and services provided by the Faculty. The objectives for athletics and recreation programs are, in order of priority:

- 1.a. To provide; vocational instruction, physical recreation, intramural, intercollegiate, and other athletic competition.
- b. To contribute to and promote the continuing well-being of members of the University community by providing programs that stress the values and habits of physical activity and by providing physical activity and sport program opportunities.
- 2.a. To provide opportunity for outstanding students, to pursue world standards of performance and to provide for empirical research into the requirements of excellence in selected sports.
- b. To supplement Physical Activity & Sport opportunities for members of the adjacent community by providing and promoting appropriate programs on a regular basis in co-operation with External Government Organizations.
- c. To supplement, where possible, Physical Activity & Sport opportunities for the community to use University facilities for training, competitions and special demonstrations.

The Council is responsible for all athletics and recreational program areas on the St. George campus, the Intercollegiate and High Performance Sport program, and any Physical Activity & Sport programs which are administered on a university-wide basis.

## **ARTICLE III – POWERS AND DUTIES**

The Council exercises its powers and duties under the University of Toronto Act, 1971, as amended. These powers and duties, subject where necessary to the approval of the Governing Council, shall be:

- a. To recommend policy on all matters pertaining to Physical Activity and Sport.
- b. To serve, by virtue of its representative nature, as a medium of information, communication and co-ordination.
- c. To establish committees, define their membership, and delegate powers and duties to them through its By-Laws, and to review and deal with reports of these committees.
- d. To recommend the annual operating plan for athletics and recreation, including the allocation of funds to program areas, for approval by Governing Council.
- e. To recommend policy regarding the use of the athletics and recreation facilities administered by the Faculty.
- f. To recommend the fees to be levied in support of athletics and recreation for approval by Governing Council.
- g. To recommend policy regarding the fees charged for the use of the athletic and recreation facilities.
- h. To determine the criteria for and to award prizes and awards in recognition of athletic achievement.
- i. To exercise final disciplinary authority over athletics and recreation members insofar as use of the athletic and recreation facilities and participation in programs and services are concerned.
- j. To make rules and regulations to govern the proceedings of the Council.
- k. To determine the manner and procedure of election of its members and to conduct such elections and by-elections.
- 1. To fill vacancies that arise on Council or to conduct elections to fill vacancies on Council. (The decision to appoint, or to conduct elections, shall be made by the Striking Committee with the consent of Council, and should be determined by length of time left in vacancy, financial and logistical difficulties in conducting elections, and availability of appropriate candidates.)

#### **ARTICLE IV – MEMBERSHIP**

Gender equity in the membership of Council and its committees is a goal of the Faculty.

#### a. Ex Officio:

i) The President of the University.

ii) The Dean of the Faculty of Faculty of Kinesiology and Physical Education.

iii) The Directors of Athletics and Recreation at University of Toronto Mississauga and University of Toronto Scarborough.

iv) The Assistant Dean, Co-curricular Physical Activity and Sport of the Faculty of Kinesiology and Physical Education.

Each of the above members may designate a representative at any time and such representatives shall have full speaking and voting rights on Council.

b. Instructional and administrative staff of the Faculty whose primary responsibilities deal with the non-credit programs and services in athletics and recreation:

Four full-time staff members elected by and from among the full-time staff. In keeping with the Faculty's goal of ensuring gender equity, normally there will be two female members and two male members.

c. Students:

i) twelve student members, (in keeping with the Faculty's goal of ensuring gender equity, normally there will be six female and six male) elected by student members of the athletic and recreational programs and services of the Faculty.

ii) three student members – one appointed by each of the *University of Toronto Students' Union (UTSU)*, the Association of Part-time Undergraduate Students (APUS), and the Graduate Students' Union (GSU).

d. Staff:

i) one teaching staff member of the University, elected by teaching staff members of the athletic and recreation programs and services of the Faculty.

ii) one administrative staff member of the University, elected by administrative staff members of the athletic and recreational programs and services of the Faculty.

- e. Alumnae/i: one alumnae/i member elected by alumnae and alumni members of the athletic and recreational programs and services of the Faculty.
- f. General Public: one member of the public, appointed by the President because of recognized expertise with recreational activities.
- g. T-Holders (a T-Holder is an alumna/us who was a member of an intercollegiate team):

i) In keeping with the Faculty's goal of ensuring gender equity, normally there will be one female member appointed by the Board of Directors of the T-Holders' Association.

ii) In keeping with the Faculty's goal of ensuring gender equity, normally there will be one male member appointed by the Board of Directors of the T-Holders' Association.

h. The Chair of the Council of the Faculty of Kinesiology and Physical Education, the Chief Administrative Officer of the Faculty and the Faculty's non-academic directors, shall be non-voting assessors to the Council.

## **ARTICLE V - OFFICERS**

The Officers of the Council shall be:

- a. Honorary Chair the President of the University of Toronto or designate
- b. Co-Chairs elected by the Council from among its non-ex officio members
- c. Executive Secretary the Dean of the Faculty or designate

## **ARTICLE VI - MEETINGS**

- a. All meetings of the Council and its standing and special committees shall be open except as provided in the By-Laws.
- b. The Co-Chairs shall determine the frequency of its meetings.
- c. The Council shall meet at least two times during each academic year.

# **ARTICLE VII – COUNCIL EXECUTIVE**

The Council Executive shall consist of the officers in Article V, plus two annually appointed members of the Council. Such members shall be appointed at the April or the first meeting of Council.

This Executive has the authority to act on important issues when it is impossible or impractical to schedule a full Council meeting. Any actions taken by Council Executive shall be brought to Council's attention at the earliest possible time.

## **ARTICLE VIII – AMENDMENTS**

On the recommendation of two-thirds of the voting members present at any meeting, the Council may propose an amendment to its Constitution to the Council of the Faculty of Kinesiology and Physical Education, for its approval and transmission to the Governing Council of the University of Toronto. At least three weeks notice of any proposed amendment shall be given to the Council.

## Article I. FACULTY COUNCIL CONSTITUTION

## I. Derivation of Authority from the U of T Act

The Council of the Faculty of Kinesiology and Physical Education, hereafter described as the "Faculty Council", exercises its responsibilities under the provisions of the University of Toronto Act, 1971, as amended.

II. Definitions

Article II. In this Constitution and the accompanying By-laws:

- <u>II-1</u> Section 2.01-"Faculty" means the Faculty of Kinesiology and Physical Education and "Council" means the properly composed Council of the Faculty of Kinesiology and Physical Education of the University of Toronto.
- <u>II-2</u> <u>Section 2.02</u> "Teaching Staff" means a member of the Faculty of Kinesiology and Physical Education who holds an academic appointment of 50% or more in the Faculty of Kinesiology and Physical Education and who holds the <u>ranktitle</u> of Professor,; Associate Professor,; Assistant Professor, <u>Professor, Teaching</u> <u>Stream; Associate Professor, Teaching Stream;</u> Assistant Professor (conditional),, <u>Teaching Stream;</u> Senior Lecturer; Lecturer; Senior Tutor; Tutor; Senior Athletics Instructor or Athletics Instructor; Assistant Professor (conditional); or Assistant Professor, Teaching Stream (conditional).
- II-3-"Other Academic Appointee" means a current University employee who is<br/>involved in the delivery of Faculty programs and a) who holds a part-time<br/>academic appointment of less than 50% in the Faculty and who holds the title<br/>of Professor; Associate Professor; Assistant Professor; Professor, Teaching<br/>Stream; Associate Professor, Teaching Stream; Associate Professor, Teaching Stream; Senior Lecturer; Lecturer; Senior Tutor; or Senior Athletics<br/>Instructor or Athletics Instructor or b) is a Sessional Lecturer I, II, or III.
- <u>II-4</u> Section 2.03- "Administrative Staff" means an appointed staff member of the Faculty of Kinesiology and Physical Education who is not a member of the Teaching Staff and who holds an appointment of 5025% or more.

<u>II-5</u> <u>Section 2.04</u> "Undergraduate Student" means any student registered in a program of study leading to a degree, post-secondary diploma, or <u>for credit</u> certificate in the Faculty of Kinesiology and Physical Education who is not registered in the School of Graduate Studies.

For the purpose of Appendix A (The Council of Athletics and Recreation Constitution), "student" means any student defined according to the current regulations governing elections to the Governing Council.

- <u>II-6</u> Section 2.05-"Graduate Student" means any student registered within the School of Graduate Studies in a program of study leading to a degree, post- secondary diploma, or <u>for credit</u> certificate in the Faculty of Kinesiology and Physical Education.
- <u>II-7</u> <u>Section 2.06</u> "Alumni" means anyone who has received a degree, post- secondary diploma, or <u>for credit</u> certificate from the Faculty, or who has completed one year of full-time studies <u>or equivalent</u> while registered in the Faculty, who is no longer registered as a student and who is not a member of the teaching or administrative staff of the University.

## III. Article III. Council's General Powers and Duties

Subject to the provisions of the University of Toronto Act, 1971<u>, as amended</u>, and the approval, as required or <u>as</u> appropriate, of the Governing Council of the University, Council shall have the following powers and duties:

<u>III-1</u> Section 3.01-Council shall determine its composition, and the number, size, composition, and authority of Standing Committees of the Faculty Councilits committees.</u>

# III-2 Section 3.02 Academic policies

Council recommends for approval to the appropriate body of Governing Council amendments to divisional academic policies. Academic policy sets out the principles for, the general directions of, and/or priorities for the teaching and research activities of the Faculty.

## III-3 Section 3.03 Advisory role

Council plays an advisory role, tendering advice to the divisional administration.

#### IV. Article IV Council's Specific Powers and Duties

The specific powers and duties of Council are the following:

## IV-1 Section 4.01 Determine its rules and regulations

Council shall determine the rules and regulations for governing its procedures and its decisions shall be made by resolutions passed at its meetings.

#### IV-2 By-Laws

Section 4.02 Council shall pass by-laws setting forth its procedures and regulating the exercise of its powers, the calling and conduct of its meetings, and the method of appointment or election of its members.

## IV-3 Section 4.03 Establish committees

Council shall have the power to establish, alter, or disband its committees as deemed necessary and to determine their composition, authority, quorum, and method of appointment of their members and chairs. Council has authority over recommendations brought forward by such committees, be that in its decision-making capacity or in its advisory role.

The composition, powers, duties, and procedures of its committees shall be set forth in the By-Laws of Council.

## IV-4 Section 4.04 Admissions

Council shall determine the standards of admission of students to the Faculty and may delegate this responsibility to committees or officers of the Faculty. New <u>admissions</u> policies and practices or amendments to existing ones which affect the whole Faculty are recommended to the appropriate body of Governing Council for approval.

## IV-5 Section 4.05 Awards

Council shall award scholarships, bursaries, prizes, and other awards in the namegift of the Faculty and may delegate this responsibility to committees or officers of the Faculty.

## IV-6 Section 4.06-Petitions and appeals

Council shall establish policies and procedures with respect to petitions and appeals by undergraduate students in connection with the application of academic rules and regulations by officers of the Faculty or by instructors in connection with academic standing in the Faculty. A Committee of Council shall make rulings on all such appeals and such rulings shall be final and binding, subject to an appeal to the Governing Council.

Procedures for academic appeals by graduate students are determined by the School of Graduate Studies in accordance with the <u>Policy on Academic</u> <u>Appeals within Divisions</u>.

# IV-7 Academic programs

# II. Section 4.07 Determine the nature and content of all courses of study and programs offered by the Faculty, subject to the approval of the Governing Council, where required and shall monitor the quality and standards of the programs.

Council shall consider the content, quality, and requirements of the academic programs and courses of study that lead to degrees, diplomas, certificates, credits, credit and non-credit courses over which the Faculty has authority; it shall consider proposals for the closure of any such programs or courses of study; and it shall monitor the quality and standards of the programs and courses of study.

Council shall recommend for approval to the appropriate body of Governing Council proposals for new<u>the establishment and closure of</u> academic programs.

<u>Council shall have delegated authority to approve proposals for the</u> <u>establishment and closure of Category 1 and Category 2 for credit certificates</u> <u>in accordance with the *Policy on Certificates (For Credit and Not-for-Credit).*</u> <u>These approvals shall be reported annually for information to the appropriate</u> <u>body of Governing Council.<sup>1</sup></u>

<u>Council shall approve proposals for Category 3 Not-for-Credit certificates.</u> <u>These approvals shall be reported to the Provost's Office for inclusion in an</u> <u>annual report to the Committee on Academic Policy & Programs.</u>

Council shall have delegated authority to approve proposals for major and minor modifications to existing academic programs-, diplomas, and

<u>certificates.</u><sup>2</sup> Definitions of major modifications of existing programs, minor modifications, and new academic programs are provided in the University of Toronto Quality Assurance Process and are subject to change. Guidance from the Office of the Vice Provost, Academic Programs, should be sought prior to the development of any such proposal. All major modifications shall be reported annually for information to the appropriate body of Governing Council.

Council shall have delegated authority to approve proposals for the modification of existing diploma and certificate programs, pursuant to the University's *Policy on Diploma and Certificate Programs*. An annual report on such actions as required by the *Policy*, shall be provided for information to the appropriate body of Governing Council.

## IV-8 Section 4.08 Delegation of authority

Subject to the provisions of the above, Council may delegate its authority for the approval of minor modifications to academic programs to various committees. All such changes shall be reported for information to Council. The decision of whether a matter is major or minor may be made by the Committee Chair in consultation with the Chair of Council, and/or the Dean or <u>his/herDean's designate, and/or the Vice-President and Provost or the</u> <u>Vice-President & Provost's designate.</u> <u>designate, and/or the Vice-President and Provost or his/her designate.</u>

#### IV-9 Section 4.10-Interdisciplinary units

Council shall review and approve or recommend for approval to the Governing Council proposals concerning Extra-Departmental Units in the Faculty, pursuant to the <u>Policy on Interdisciplinary Education and Research Planning and the</u> <u>Guidelines for Extra-Departmental Units</u>.

#### IV-10 Section 4.09 Review of academic programs and units

Council may be one venue in which consideration and discussion of a review report of an academic program and/or unit may occur, consistent with the protocol outlined in the University of Toronto Quality Assurance Process.

## IV-11 Section 4.11 Transcript notations

Guidance from the Office of the Vice-Provost, Academic Programs, should be sought prior to the development of any such proposal.

Council shall have delegated authority to approve transcript notations within existing degree programs, in accordance with <u>the University Transcripts</u> <u>PolicyUniversity policy.</u> An annual report on such actions, as required by policy, shall be provided for information to the appropriate body of Governing Council.

- Section 4.12 Council shall consider recommendations from the Council of Athletics and Recreation concerning overall policies in athletics and recreation, subject to the approval of the Governing Council, as required.
- Section 4.13 Council shall consider operating plans and budget proposals from the Council of Athletics and Recreation and comment on them to the appropriate body of Governing Council.

## V. Article V Powers, Duties, and Responsibilities of the Dean

- V-1Section 5.01 Council recognizes that the Dean exercises powers under the authority of the Policy on Appointment of Academic Administrators" Policy on Appointment of Academic Administrators" which states that "the Dean of the Faculty is the chief executive officer of the Faculty and reports directly to the Vice-President and Provost."
- V-2Section 5.02 While the Dean may delegate authority to other academic administrators in the Faculty, the Dean retains responsibility for the overall direction of the Faculty and, in particular, for authority over the budget and other financial matters, personnel matters, including appointments and promotions, and extra-Faculty relationships. In this respect, Council recognizes that the Dean has ultimate authority for the allocation and management of the Faculty's resources.
- V-3Section 5.03 The Dean shall consult with members of the Faculty on matters of policy and practice but is ultimately responsible for all administrative decisions that are within <u>his/herthe Dean's</u> jurisdiction and authority.
- V-4Section 5.04 The Dean shall advise Council of the resource implications of proposed academic policy decisionspolicies.

V-5<del>Section 5.05</del> The Dean may consult with Council on administrative proposals that may have a significant impact on the academic programs of the Faculty.

VI. Article VI The Membership of the Faculty Council comprises:

    One member elected from and by the staff with curricular teaching duties in undergraduate practica courses.
    One member elected from and by those who serve as Faculty of Kinesiology and Physical Education practica instructors on a sessional, part-time basis.
  - ii) Seven undergraduate students elected from and by the students in the undergraduate program in the Faculty of Kinesiology and Physical Education.
  - iii) One graduate student elected from and by the students in the graduate program in the Faculty of Kinesiology and Physical Education.
  - iv) Four members elected from and by the administrative staff of the Faculty.
  - <u>v) 1 Alumni</u>
  - <u>vi)</u> Two professors emeritae/i of the Faculty.All consenting emeritus professors for a term of three years following their appointment as emeriti
  - vii) The Co-Chairs of the Council of Athletics and Recreation
- VI-2 Ex-officio members (voting, unless otherwise noted)
  - i) The President of the University, or designate
  - ii) The Vice-President and Provost, or designate
  - iii) The Dean of the School of Graduate Studies, or designate (non-voting)
  - iv) The Dean of the Faculty
  - v) One professional librarian appointed by the University Librarian
  - v) The Vice Dean(s), Associate Dean(s) and/or Assistant Dean(s) of the Faculty
  - vi) The Executive Director(s) of the Faculty
  - vii) The Registrar of the Faculty
  - viii) The Chief Administrative Officer of the Faculty
  - ix) Director of Equity, Diversity, and Inclusion
  - x) The President of the Faculty's Undergraduate Student Society
  - xi) The President of the Faculty's Graduate Student Society
  - xiii) The President of the Alumni Association or designate

## VII. Article VII. Term and Quorum of Council

VII-1\_Section 7.01 The term of office of the Facultymembers of Council members and its Committees shall be from July 1 to June 30 of the following calendar year, with somethe term of Student members beginning in the September session.

VII-2\_Section 7.02 The Quorum for a meeting of Council shall be one-third of the voting members. This number will be determined each year.

## VIII. Article VIII Officers

#### VIII-1 Section 8.01 FacultyChair/Vice-Chair

<u>The</u> Council <u>membersnormally</u> shall elect at its final meeting of the year, <u>by</u> <u>and</u> from among its members<del>, the Chair. The term of office shall normally</del> be for two years from July 1 to June 30. In the absence of the Chair, the <u>Council shall elect an Acting that year, a</u> Chair, <del>upon the recommendation of</del> the Dean. <u>and a Vice-Chair for the succeeding three years</u>. <del>The Chair shall be</del> <u>a non-voting member of Council</u>.

## VIII-2 Section 8.02 Presiding Officer

The Chair shall preside at all meetings of Council. <u>In the absence of the Chair,</u> <u>the Vice-Chair shall preside.</u> In the absence of <u>both</u> the <u>Chair and the Vice-</u> Chair, any member of the Executive Committee may convene the meeting and <u>an actinga</u> Chair shall be chosen by a majority of <u>the</u> voting members present for the meeting.

## VIII-3 Section 8.03 Term of Chair and Vice-Chair

The Chair and Vice-Chair will each serve a three-year term renewable to a maximum of one additional consecutive term. The Chair shall be a non-voting member of Council.

#### VIII-4 Secretary

<u>The Secretary of Council shall be appointed by the Dean in consultation with</u> <u>the Chair.</u> The Secretary shall be <del>appointed by the Dean and shall be</del> a non-voting *ex -officio* member of Council.

# IX. Article IX Meetings of Faculty

IX-1 Regular meetings

Section 9.01 The Faculty Council shall meet at least four times during There shall normally be four regular meetings of Council in each academic year. Notice of each meeting, including a proposed agenda, shall be given to members at least one week in advance of the meeting.

# IX-2 Section 9.02 Special Meeting

A special meeting may be called by the Chair of the Faculty Council, the Dean of the Faculty of Kinesiology and Physical Education, or upon the written request of fiveone-third of voting members of the Faculty Council. In and shall be convened within 30 days to consider the matter(s) requiring the case meeting. Notice of special meetings, such a notice of three business days is required meeting shall be given at least 1 week prior to the meeting.

## IX-3 Section 9.03 Voting

Each voting member of Council has one vote on any question. Motions pass with a simple majority unless otherwise stated in the rules of procedure of the Council. In <u>the</u> case of a tie vote, the Chair may cast a deciding vote or redirect the question for further consideration.

IX-4\_Section 9.04 The Meetings of Faculty Council areshall be open to all members of the University community public except when matters of a confidential nature are under discussion. The Faculty may be discussed. Council will then move in camera.

Section 9.05 The members of Faculty Council are entitled to participate fully in meetings of the Faculty Council, to speak, to propose motions, to vote on all questions except those where the Chair rules there is a conflict of interest, and to serve on committees and task groups selected and/or appointed by the Faculty Council. In the case of substantive motions which are not on the Council agenda, a two thirds vote is necessary to add them to the agenda. Members of Committees who are not members of Council may address Council on matters within the jurisdiction of the committee of which they are a member and participate in the debate but they may not vote.

Section 9.06 The decisions of Faculty Council are available to all members of the University community through the Minutes of Faculty Council, which are kept in the Faculty Office.

## Article X By Laws

Section 10.01The procedures of Council will be set forth in the By-Laws of Council.

## Section 10.02 The composition, powers, duties, and procedures of Standing and Special Committees shall be set forth in the By-Laws of Council.

## X. Article XI Parliamentary Authority

Section 11.01 The rules contained in the most recent edition of Bourinot's Rules of Order, shall govern the Council in all cases to which they are applicable and in which they are not inconsistent with the By-Laws and any special rules of order the Council may adopt.

## XI.\_Article XII Amendment of the Constitution and By-Laws

## XI-1 Section 12.01 Constitution

The Constitution of the Council may only be amended with the approval of the Council and the <u>appropriate body of the</u> Governing Council<del> of the University of</del> Toronto. Voting shall take place at a regularly constituted meeting to which there has been <u>three weeks21 days'</u> notice of the proposed amendment. An affirmative vote to amend the Constitution is required by two-thirds of the members of Council present and voting. Following approval of the recommended amendment by Council, the amendment is forwarded to <u>the appropriate body of the</u> Governing Council for approval.

## XI-2 By-Laws

The By-Laws of the Council may be amended at any regular meeting with the <u>approval</u> of the Council by a two-thirds majority of those <u>Council members</u> present and voting, provided that. Voting shall take place at a regularly constituted meeting to which there has been three weeks 21 days' notice of the proposed amendment.

## XII.\_Article XIII. Council of Athletics and Recreation

XII-1 Section 13.01-The athletic U of T Sport and recreational activities of Rec Programs, Services and Facilities at the Faculty of Kinesiology and Physical Education (Sport & Rec) operating plans and budgets shall be governed received, reviewed, and recommended for approval by aGoverning Council, by the Council of Athletics and Recreation whose constitution and powers are outlined in the Constitution of the Council of Athletics and Recreation, as in Appendix A hereto, which forms part of the Constitution of the Faculty Council. The Faculty Council may delegate specific responsibilities for sport and recreational activities of the Faculty to the Council of Athletics and Recreation. XII-2 Section 13.02-Amendments to the Constitution of the Council of Athletics and Recreation will be considered for approval by the Faculty Council and the Governing Council body with assigned responsibility for Athletics and Recreation.

#### APPENDIX A to the Constitution of the Council of the Faculty of Kinesiology and Physical Education

#### CONSTITUTION OF THE COUNCIL OF ATHLETICS AND RECREATION

#### ARTICLE I - NAME

#### I. Name

I-1 The "Council" shall be named the Council of Athletics and Recreation of the Faculty of Kinesiology

#### ARTICLE II - OBJECTIVES

- 1.a. To provide; vocational instruction, physical recreation, intramural, intercollegiate, and other athletic competition.
- b. To contribute to and promote the continuing well-being of members of the University community by providing programs that stress the values and habits of physical activity and by providing physical activity and sport program opportunities.
- 2.a. To provide opportunity for outstanding students, to pursue world standards of performance and to provide for empirical research into the requirements of excellence in selected sports.
- b. To supplement Physical Activity & Sport opportunities for members of the adjacent community by providing and promoting appropriate programs on a regular basis in co- operation with External Government Organizations.
- c. To supplement, where possible, Physical Activity & Sport opportunities for the community to use University facilities for training, competitions and special demonstrations.

The Council is responsible for all athletics and recreational program areas on the St. George campus, the Intercollegiate and High Performance Sport program, and any Physical Activity & Sport programs which are administered on a university wide basis.

#### ARTICLE III - POWERS AND DUTIES

The Council exercises its powers and duties under the University of Toronto Act, 1971, as amended. These powers and duties, subject where necessary to the approval of the Governing Council, shall be:

Constitution for the Faculty of Kinesiology and Physical Education

## II. General Powers and Physical Education.Duties

Subject to the <u>provisions of the University of Toronto Act</u>, 1971, as amended, and the approval, as required or appropriate, of the <u>Governing</u> Council of the <del>Faculty of Kinesiology</del> and Physical Education, the<u>University</u>, Council <del>oversees</del>shall have</u> the <del>athletic</del>following powers and <del>recreational programs</del><u>duties</u>:

- II-1 The Council advises on the operating plans and services provided by the Faculty. The objectives budgets for athletics the sport and recreational program areas on the St. George campus, and sport and recreation programs are, in order of priority: which are administered on a university wide basis.
- II-2Council shall determine the number, size, composition and authority of Sub<br/>Committees of the Council of Athletics and Recreation. Creation of Sub-committees will<br/>be reported to Faculty Council for information.
- II-3 Council advises on programmatic changes within Sport & Rec to be considered by the appropriate committee of Faculty Council or by officers of the Faculty.

## **III. Specific Powers and Duties**

The specific powers and duties of Council are the following:

- III-1<u>To recommend, for approval to the appropriate body</u> of the Governing Council, shall be:the annual Sport & Rec operating plans and budget.
- III-2\_To recommend policy on all matters pertaining the fees to Physical Activity and be levied in support of Sport. & Rec for approval by Governing Council.
- III-3\_To serve, by virtue of its representative nature, as a medium of information, and communication and co-ordination.
- <u>III-4</u> To recommend policy regarding the use of the athletics and recreation facilities administered by the Faculty.
- III-5\_To establish committees, define their membership, and delegate powers and duties to them through its By-Laws, and to review and deal with reports of these committees. <u>Committees will consider items relevant to sport and recreational program areas on</u> the St. George campus, and sport and recreation programs which are administered on a university wide basis. Such committees will be reported to Faculty Council.
- d. To recommend the annual operating plan for athletics and recreation, including the allocation of funds to program areas, for approval by Governing Council.
  - X-7<u>I-1</u> To recommend policy regarding the use of the athletics and recreation facilities administered by the Faculty.
- f. To recommend the fees to be levied in support of athletics and recreation for approval by Governing Council.
- g. To recommend policy regarding the fees charged for the use of the athletic and recreation

facilities.

- h. To determine the criteria for and to award prizes and awards in recognition of athletic achievement.
- i. To exercise final disciplinary authority over athletics and recreation members insofar as use of the athletic and recreation facilities and participation in programs and services are concerned.
  - III-6\_To make rules and regulations to govern the proceedings of the Council.
  - III-7 To determine the manner and procedure of election of its members and to conduct such elections and by-elections.
  - III-8\_To fill vacancies that arise on Council or to conduct elections to fill vacancies on Council. (The decision to appoint, or to conduct elections, shall be made by the Striking Committee with the consent of Council, and should be determined by length of time left in vacancy, financial and logistical difficulties in conducting elections, and availability of appropriate candidates.)

#### **ARTICLE IV – MEMBERSHIP**

#### IV. Gender equityMembership

The student members shall include two Arts and Science Students, two students representing Professional Faculties, one part-

time undergraduate student, one graduate student, one University of Toronto Scarborough student, one University of Toronto Mississauga student, and four students at large.

- b. three student members one appointed by each of the University of Toronto Students' Union (UTSU), the Association of Part-time Undergraduate Students (APUS), and the <u>University of Toronto</u> Graduate Students' Union (GSU).UTGSU).
- iii) <u>Alumni: Staff</u>:one teaching staff <u>alumni</u> member of the University, elected by teaching staff members of the athletic and recreation programs and services <u>alumni</u>, as defined in section II.7 of the Faculty <u>Council Constitution</u>.
- e. Alumnae/i: one alumnae/i member elected by alumnae and alumnimembers of the athletic and recreational programs and services of the Faculty.

i) one administrative staff member of the University, elected by administrative staff members of the athletic and recreational programs and services of the Faculty.

f. General Public: one member of the public, appointed by the President because of recognized expertise with recreational activities.

g. iv)<u>Two</u>T-Holders (a T-Holder is an alumna/usindividual who washas won a member U of T athletic letter (i.e., a T) an intercollegiate team): appointed by the Board of DirectorsExecutive of the T-Holders' Association
 i) In keeping with the Faculty's goal of ensuring gender equity, normally there will be one female member appointed by the Board of Directors of the T-Holders' Association.

- iii)Directors of Athletics and Recreation at University of Toronto Mississauga and University of Toronto Scarborough
- iv) Executive Director, Student Experience, Student Life

# v) <u>Warden of Hart House</u>

Each of the above members may designate a representative at any time and such representatives shall have full speaking and voting rights on Council.

## IV-3-Non-voting Assessors

h)The Chair of the Council of the Faculty of Kinesiology and Physical Education, the Chief-Administrative Officer of the Faculty and the Faculty's non-academic directors, shall be nonvoting assessors to the Council.

- vi) Chair of the Council of the Faculty of Kinesiology and Physical Education
- vii) the Chief Administrative Officer of the Faculty
- viii) <u>Director, Equity, Diversity</u> and <u>Inclusion of the Faculty</u>
- ix) <u>Faculty's non-academic directors</u>, <u>Director</u>, <u>Intercollegiate Athletics & High</u> <u>Performance</u>
- x) Director, Sport & Recreation
- xi) Director, Sports Medicine Clinic

xii) <u>4 Kinesiology and Physical Education Undergraduate Association (KPEUA)</u> <u>Representatives</u>

- xiii) Varsity Board Co-Chairs
- xiv) 2 Intramural Sports Council members

# V. Term and Quorum of Council

V-1 <u>The term of office of members of Council and its Committees</u> shall be non-voting assessors<u>from July 1</u> to the CouncilJune 30, with the term of Student members beginning in September.

# <u>V-2</u> Quorum for a meeting of Council shall be one-third of the voting members. <u>This number will be determined each year.</u>

# VI-ARTICLE V-.\_Officers

The Officers of the Council shall be:

- i) Honorary Chair the President of the University of Toronto or designate
- ii) Co-Chairs elected by the Council from among its non-ex officio members
- iii) Executive Secretary the Dean of the Faculty or designate

## ARTICLE VI - MEETINGS

## VII. Meetings

All meetings of the Council and its standing and special committees shall be open except as provided in the By-Laws.

The Co-Chairs shall determine the frequency of its meetings.

The Council shall meet at least two times during each academic year.

## ARTICLE VII - COUNCIL EXECUTIVE

## VIII. Council Executive

The Council Executive shall consist of the officers in Article  $\frac{1}{\sqrt{1}}$ , plus two annually appointed members of the Council. Such members shall be appointed at the April or the first meeting of Council.

This Executive has the authority to act on important issues when it is impossible or impractical to schedule a full Council meeting. Any actions taken by Council Executive shall be brought to Council's attention at the earliest possible time.

## IX. Amendments

On the recommendation of two-thirds of the voting members present at any meeting, the Council may propose an amendment to its Constitution to the Council of the Faculty of Kinesiology and Physical Education, for its approval and transmission to the Governing Council of the University of Toronto. At least <u>three weeks21 days'</u> notice of any proposed amendment shall be given to the Council.



# THE FACULTY OF KINESIOLOGY AND PHYSICAL EDUCATION FACULTY COUNCIL CONSTITUTION

# I. Derivation of Authority from the U of T Act

The Council of the Faculty of Kinesiology and Physical Education, hereafter described as the "Faculty Council", exercises its responsibilities under the provisions of the University of Toronto Act, 1971, as amended.

## II. Definitions

In this Constitution and the accompanying By-laws:

- II-1 "Faculty" means the Faculty of Kinesiology and Physical Education and "Council" means the properly composed Council of the Faculty of Kinesiology and Physical Education of the University of Toronto.
- II-2 "Teaching Staff" means a member of the Faculty of Kinesiology and Physical Education who holds an academic appointment of 50% or more in the Faculty of Kinesiology and Physical Education and who holds the title of Professor; Associate Professor; Assistant Professor; Professor, Teaching Stream; Associate Professor, Teaching Stream; Assistant Professor, Teaching Stream; Senior Lecturer; Lecturer; Senior Tutor; Tutor; Senior Athletics Instructor or Athletics Instructor, Assistant Professor (conditional); or Assistant Professor, Teaching Stream (conditional).
- II-3 "Other Academic Appointee" means a current University employee who is involved in the delivery of Faculty programs and a) who holds a part-time academic appointment of less than 50% in the Faculty and who holds the title of Professor; Associate Professor; Assistant Professor; Professor, Teaching Stream; Associate Professor, Teaching Stream; Assistant Professor, Teaching Stream; Senior Lecturer; Lecturer; Senior Tutor; Tutor; or Senior Athletics Instructor or Athletics Instructor or b) is a Sessional Lecturer I, II, or III.
- II-4 "Administrative Staff" means an appointed staff member of the Faculty of Kinesiology and Physical Education who is not a member of the Teaching Staff and who holds an appointment of 25% or more.
- II-5 "Undergraduate Student" means any student registered in a program of study leading to a degree, post-secondary diploma, or for credit certificate in the Faculty of Kinesiology and Physical Education who is not registered in the School of Graduate Studies.

For the purpose of Appendix A (The Council of Athletics and Recreation Constitution), "student" means any student defined according to the current regulations governing elections to the Governing Council.

- II-6 "Graduate Student" means any student registered in the School of Graduate Studies in a program of study leading to a degree, post-secondary diploma, or for credit certificate in the Faculty of Kinesiology and Physical Education
- II-7 "Alumni" means anyone who has received a degree, post-secondary diploma, or for credit certificate from the Faculty, or who has completed one year of full-time studies or equivalent while registered in the Faculty, who is no longer registered as a student and who is not a member of the teaching or administrative staff of the University.

## III. Council's General Powers and Duties

Subject to the provisions of the University of Toronto Act, 1971, as amended, and the approval, as required or as appropriate, of the Governing Council of the University, Council shall have the following powers and duties.

- III-1 Council shall determine its composition, and the number, composition, and authority of its committees.
- III-2 Academic policies

Council recommends for approval to the appropriate body of Governing Council amendments to divisional academic policies. Academic policy sets out the principles for, the general directions of, and/or priorities for the teaching and research activities of the Faculty.

III-3 Advisory role

Council plays an advisory role, tendering advice to the divisional administration.

## IV. Council's Specific Powers and Duties

The specific powers and duties of Council are the following:

IV-1 Determine its rules and regulations

Council shall determine the rules and regulations for governing its procedures and its decisions shall be made by resolutions passed at its meetings.

IV-2 By-Laws

Council shall pass by-laws setting forth its procedures and regulating the exercise of its powers, the calling and conduct of its meetings, and the method of appointment or election of its members.

IV-3 Establish committees

Council shall have the power to establish, alter, or disband its committees as deemed necessary and to determine their composition, authority, quorum, and method of appointment of their members and chairs. Council has authority over recommendations brought forward by such committees, be that in its decision-making capacity or in its advisory role.

The composition, powers, duties, and procedures of its committees shall be set forth in the By-Laws of Council.

## IV-4 Admissions

Council shall determine the standards of admission of students to the Faculty. New admissions policies and practices or amendments to existing ones which affect the whole Faculty are recommended to the appropriate body of Governing Council for approval.

IV-5 Awards

Council shall award scholarships, bursaries, prizes, and other awards in the gift of the Faculty and may delegate this responsibility to committees or officers of the Faculty.

## IV-6 Petitions and appeals

Council shall establish policies and procedures with respect to petitions and appeals by undergraduate students in connection with the application of academic rules and regulations by officers of the Faculty or by instructors in connection with academic standing in the Faculty. A Committee of Council shall make rulings on all such appeals and such rulings shall be final and binding, subject to an appeal to the Governing Council.

Procedures for academic appeals by graduate students are determined by the School of Graduate Studies in accordance with the *Policy on Academic Appeals within Divisions*.

# IV-7 Academic programs

Council shall consider the content, quality, and requirements of the academic programs and courses of study that lead to degrees, diplomas, certificates, credit and non-credit courses over which the Faculty has authority; it shall consider proposals for the closure of any such programs or courses of study; and it shall monitor the quality and standards of the programs and courses of study.

Council shall recommend for approval to the appropriate body of Governing Council proposals for the establishment and closure of academic programs.

Council shall have delegated authority to approve proposals for the establishment and closure of Category 1 and Category 2 for credit certificates in accordance with the <u>Policy on Certificates (For Credit and Not-for-Credit)</u>. These approvals shall be reported annually for information to the appropriate body of Governing Council.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup>Definitions of Category 1 and 2 certificates are provided in the *Policy on Certificates (For Credit and Not-for-Credit)*. The *Policy* states that new Category 3 certificates "must undergo the appropriate divisional approval" and must be submitted to the Provost's Office for inclusion in an annual report to the Committee on Academic Policy & Programs.

Council shall approve proposals for Category 3 Not-for-Credit certificates. These approvals shall be reported to the Provost's Office for inclusion in an annual report to the Committee on Academic Policy & Programs.

Council shall have delegated authority to approve proposals for major and minor modifications to existing academic programs, diplomas, and certificates.<sup>2</sup> All major modifications shall be reported annually for information to the appropriate body of Governing Council.

IV-8 Delegation of authority

Subject to the provisions of the above, Council may delegate its authority for the approval of minor modifications to academic programs to various committees. All such changes shall be reported for information to Council. The decision of whether a matter is major or minor may be made by the Committee Chair in consultation with the Chair of Council, and/or the Dean or Dean's designate, and/or the Vice-President and Provost or the Vice-President & Provost's designate.

IV-9 Interdisciplinary units

Council shall review and approve or recommend for approval to the Governing Council proposals concerning Extra-Departmental Units in the Faculty, pursuant to the <u>Policy on Interdisciplinary Education and Research Planning</u> and the <u>Guidelines for</u> <u>Extra-Departmental Units</u>.

IV-10 Review of academic programs and units

Council may be one venue in which consideration and discussion of a review report of an academic program and/or unit may occur, consistent with the protocol outlined in the University of Toronto Quality Assurance Process.

# IV-11 Transcript notations

Council shall have delegated authority to approve transcript notations within existing degree programs, in accordance with the <u>University Transcripts Policy</u>. An annual report on such actions, as required by policy, shall be provided for information to the appropriate body of Governing Council.

# V. Powers, Duties and Responsibilities of the Dean

V-1 Council recognizes that the Dean exercises powers under the authority of the *Policy on Appointment of Academic Administrators* which states that "the Dean of the Faculty is the chief executive officer of the Faculty and reports directly to the Vice-President and Provost."

<sup>&</sup>lt;sup>2</sup> Definitions of major modifications of existing programs, minor modifications, and new academic programs are provided in the <u>University of Toronto Quality Assurance Process</u> and are subject to change. Guidance from the Office of the Vice-Provost, Academic Programs, should be sought prior to the development of any such proposal.

- V-2 While the Dean may delegate authority to other academic administrators in the Faculty, the Dean retains responsibility for the overall direction of the Faculty and, in particular, for authority over the budget and other financial matters, personnel matters, including appointments and promotions, and extra-Faculty relationships. In this respect, Council recognizes that the Dean has ultimate authority for the allocation and management of the Faculty's resources.
- V-3 The Dean shall consult with members of the Faculty on matters of policy and practice but is ultimately responsible for all administrative decisions that are within the Dean's jurisdiction and authority.
- V-4 The Dean shall advise Council of the resource implications of proposed academic policies.
- V-5 The Dean may consult with Council on administrative proposals that may have a significant impact on the academic programs of the Faculty.

# VI. Membership of Council

- VI-1 Elected or appointed members (voting, unless otherwise noted):
  - i) All Teaching Staff as defined in section II-2
  - ii) Seven undergraduate students elected from and by the students in the undergraduate program in the Faculty of Kinesiology and Physical Education.
  - iii) One graduate student elected from and by the students in the graduate program in the Faculty of Kinesiology and Physical Education.
  - iv) Four members elected from and by the administrative staff of the Faculty.
  - v) 1 Alumni
  - vi) All consenting emeritus professors for a term of three years following their appointment as emeriti
  - vii) The Co-Chairs of the Council of Athletics and Recreation.
- VI-2 Ex-officio members (voting, unless otherwise noted)
  - i) The President of the University, or designate
  - ii) The Vice-President and Provost, or designate
  - iii) The Dean of the School of Graduate Studies, or designate (non-voting)
  - iv) The Dean of the Faculty
  - v) One professional librarian appointed by the University Librarian
  - vi) The Vice Dean(s), Associate Dean(s) and/or Assistant Dean(s) of the Faculty
  - vii) The Executive Director(s) of the Faculty
  - viii) The Registrar of the Faculty
  - ix) The Chief Administrative Officer of the Faculty

- x) Director of Equity, Diversity, and Inclusion
- xi) The President of the Faculty's Undergraduate Student Society
- xii) The President of the Faculty's Graduate Student Society

xiii) The President of the Alumni Association

## VII. Term and Quorum of Council

- VII-1 The term of office of members of Council and its Committees shall be from July 1 to June 30, with the term of Student members beginning in September.
- VII-2 Quorum for a meeting of Council shall be one-third of the voting members. This number will be determined each year.

## VIII. Officers

VIII-1 Chair/Vice-Chair

The Council normally shall elect at its final meeting of the year, by and from among its members for that year, a Chair, and a Vice-Chair for the succeeding three years.

VIII-2 Presiding Officer

The Chair shall preside at all meetings of Council. In the absence of the Chair, the Vice-Chair shall preside. In the absence of both the Chair and the Vice-Chair, any member of the Executive Committee may convene the meeting and a Chair shall be chosen by a majority of the voting members present for the meeting.

## VIII-3 Term of Chair and Vice-Chair

The Chair and Vice-Chair will each serve a three-year term renewable to a maximum of one additional consecutive term. The Chair shall be a non-voting member of Council.

## VIII-4 Secretary

The Secretary of Council shall be appointed by the Dean in consultation with the Chair. The Secretary shall be a non-voting *ex officio* member of Council.

## IX. Meetings

IX-1 Regular meetings

There shall normally be four regular meetings of Council in each academic year. Notice of each meeting, including a proposed agenda, shall be given to members at least one week in advance of the meeting.

IX-2 Special Meeting

A special meeting may be called by the Chair of the Faculty Council, the Dean, or upon the written request of one-third of voting members of the Council and shall be convened within 30 days to consider the matter(s) requiring the meeting. Notice of such a meeting shall be given at least 1 week prior to the meeting.

IX-3 Voting

Each voting member of Council has one vote on any question. Motions pass with a simple majority unless otherwise stated in the rules of procedure of the Council. In the case of a tie vote, the Chair may cast a deciding vote or redirect the question for further consideration.

IX-4 Meetings of Council shall be open to the public except when matters of a confidential nature may be discussed. Council will then move *in camera*.

## X. Parliamentary Authority

The rules contained in the most recent edition of Bourinot's Rules of Order, shall govern the Council in all cases to which they are applicable and in which they are not inconsistent with the By-Laws and any special rules of order the Council may adopt.

## XI. Amendment of the Constitution and By-Laws

XI-1 Constitution

The Constitution of the Council may only be amended with the approval of the Council and the appropriate body of the Governing Council. Voting shall take place at a regularly constituted meeting to which there has been 21 days' notice of the proposed amendment. An affirmative vote to amend the Constitution is required by two-thirds of the members of Council present and voting. Following approval of the recommended amendment by Council, the amendment is forwarded to the appropriate body of the Governing Council for approval.

XI-2 By-Laws

The By-Laws of the Council may be amended with the approval of a two-thirds majority of Council members present and voting. Voting shall take place at a regularly constituted meeting to which there has been 21 days' notice of the proposed amendment.

## XII. Council of Athletics and Recreation

XII-1 The U of T Sport and Rec Programs, Services and Facilities at the Faculty of Kinesiology and Physical Education (Sport & Rec) operating plans and budgets shall be received, reviewed, and recommended for approval by Governing Council, by the Council of Athletics and Recreation whose constitution and powers are outlined in the Constitution of the Council of Athletics and Recreation, as in Appendix A hereto, which forms part of the Constitution of the Faculty Council. The Faculty Council may delegate specific responsibilities for sport and recreational activities of the Faculty to the Council of Athletics and Recreation. XII-2 Amendments to the Constitution of the Council of Athletics and Recreation will be considered for approval by the Faculty Council and the Governing Council body with assigned responsibility for Athletics and Recreation.

## APPENDIX A to the Constitution of the Council of the Faculty of Kinesiology and Physical Education

## CONSTITUTION OF THE COUNCIL OF ATHLETICS AND RECREATION

## I. Name

I-1 The "Council" shall be named the Council of Athletics and Recreation

## II. General Powers and Duties

Subject to the provisions of the University of Toronto Act, 1971, as amended, and the approval, as required or appropriate, of the Governing Council of the University, Council shall have the following powers and duties:

- II-1 The Council advises on the operating plans and budgets for the sport and recreational program areas on the St. George campus, and sport and recreation programs which are administered on a university wide basis.
- II-2 Council shall determine the number, size, composition and authority of Sub Committees of the Council of Athletics and Recreation. Creation of Sub-committees will be reported to Faculty Council for information.
- II-3 Council advises on programmatic changes within Sport & Rec to be considered by the appropriate committee of Faculty Council or by officers of the Faculty.

## III. Specific Powers and Duties

The specific powers and duties of Council are the following:

- III-1 To recommend, for approval to the appropriate body of Governing Council, the annual Sport & Rec operating plans and budget.
- III-2 To recommend the fees to be levied in support of Sport & Rec for approval by Governing Council.
- III-3 To serve, by virtue of its representative nature, as a medium of information, and communication.
- III-4 To recommend policy regarding the use of the athletics and recreation facilities administered by the Faculty.
- III-5 To establish committees, define their membership, and delegate powers and duties to them through its By-Laws, and to review and deal with reports of these committees. Committees will consider items relevant to sport and recreational program areas on the St. George campus, and sport and recreation programs which are administered on a university wide basis. Such committees will be reported to Faculty Council.
- III-6 To make rules and regulations to govern the proceedings of the Council.
- III-7 To determine the manner and procedure of election of its members and to conduct such elections and by-elections.

III-8 To fill vacancies that arise on Council or to conduct elections to fill vacancies on Council. (The decision to appoint, or to conduct elections, shall be made by the Striking Committee with the consent of Council, and should be determined by length of time left in vacancy, financial and logistical difficulties in conducting elections, and availability of appropriate candidates.)

# IV. Membership

The Council encourages diversity in its membership of the Council and its committees, and seeks to include representation from Indigenous Peoples, Black and racialized persons, women, persons with disabilities, and people of diverse sexual and gender identities.

- IV-1 Members
  - i) Staff:
    - a. four full-time administrative staff of the Faculty whose primary responsibilities deal with the non-credit programs and services in athletics and recreation elected by and from among the full-time staff.
    - b. one University of Toronto teaching staff member, elected by teaching staff members as defined in section II.2 of the Faculty Constitution.
    - c. one University of Toronto administrative staff member, elected by administrative staff members of the athletic and recreational programs and services of the Faculty.
  - ii) Students:
    - a. twelve student members, elected by student members of the athletic and recreational programs and services of the Faculty. The student members shall include two Arts and Science Students, two students representing Professional Faculties, one part-time undergraduate student, one graduate student, one University of Toronto Scarborough student, one University of Toronto Mississauga student, and four students at large.
    - b. three student members one appointed by each of the University of Toronto Students' Union (UTSU), the Association of Part-time Undergraduate Students (APUS), and the University of Toronto Graduate Students' Union (UTGSU).
  - iii) Alumni: one alumni member elected by alumni, as defined in section II.7 of the Faculty Council Constitution.
  - iv) Two T-Holders (a T-Holder is an individual who has won a U of T athletic letter (i.e., a T), appointed by the Executive of the T-Holders' Association.
- IV-2 Ex-officio members
  - i) Dean of the Faculty of Faculty of Kinesiology and Physical Education
  - ii) Executive Director, Co-Curricular Athletics and Physical Activity Programs, Faculty of Kinesiology and Physical Education
  - iii) Directors of Athletics and Recreation at University of Toronto Mississauga and University of Toronto Scarborough

- v) Executive Director, Student Experience, Student Life
- vi) Warden of Hart House

Each of the above members may designate a representative at any time and such representatives shall have full speaking and voting rights on Council.

- IV-3 Non-voting Assessors
  - i) Chair of the Council of the Faculty of Kinesiology and Physical Education
  - ii) Chief Administrative Officer of the Faculty
  - iii) Director, Equity, Diversity and Inclusion of the Faculty
  - iv) Director, Intercollegiate Athletics & High Performance

  - vi) Director, Sports Medicine Clinic
  - vii) 4 Kinesiology and Physical Education Undergraduate Association (KPEUA) Representatives
  - viii) Varsity Board Co-Chairs
  - ix) 2 Intramural Sports Council members

## V. Term and Quorum of Council

# IX. Amendments

On the recommendation of two-thirds of the voting members present at any meeting, the Council may propose an amendment to its Constitution to the Council of the Faculty of Kinesiology and Physical Education, for its approval and transmission to the Governing Council of the University of Toronto. At least 21 days' notice of any proposed amendment shall be given to the Council.
