**PREVIOUS ACTION TAKEN:**

The *Tuition Fee Schedule for Self-funded Programs 2025-26* was approved by the Governing Council at its meeting on April 3, 2025.

**HIGHLIGHTS:**

The University offers a number of programs that are not eligible for funding under the Ministry's operating grants program, and, therefore, their fees are not subject to government regulation. The programs are self-funded and tuition fees are set at levels necessary to cover the full costs and consider fees in similar programs at other universities. Annual changes in tuition fees reflect not only inflation but may also reflect

variations in real costs as programs and services change. The proposed fee levels and year-over-year increases for self-funded programs are described in Table 1.

**FINANCIAL IMPLICATIONS:**

Revenue projections for self-funded programs are included in the *Budget Report 2026-27 and Long-Range Budget Guidelines 2026-27 to 2030-31*.
