ITEM IDENTIFICATION:

Tuition Fee Schedules for Publicly-funded Programs 2026-27

JURISDICTIONAL INFORMATION:

Pursuant to Section 5.11 (a) of the Business Board's Terms of Reference, the Business Board recommends the schedule of tuition fees to Governing Council for approval.

PREVIOUS ACTION TAKEN:

The *Tuition Fee Schedules for Publicly-funded Programs 2025-26* was approved by the Governing Council at its April 3, 2025 meeting.

HIGHLIGHTS:

Tuition revenue from publicly-funded programs is budgeted to generate \$2.1 billion in 2026-27, representing approximately 57% of the University's total budgeted operating revenue of \$3.66 billion.

Tuition fees at the University of Toronto are determined in accordance with the University's *Tuition Fee Policy*, the *Statement of Commitment Regarding International Students* and the Provincial Government's Tuition Framework. The *Tuition Fee Policy* speaks to five elements: advocacy, fee revenue, fee differentiation, fee level commitment and monitoring. In presenting this tuition schedule, the University reaffirms its commitment to student aid for domestic students and its accessibility statement. A full overview of financial assistance available to students is included in the *2024-25 Annual Report on Student Financial Support*, which accompanies these schedules through governance.

Note that the tuition fees in these schedules are limited to for-credit publicly-funded programs. Fees for non-credit continuing education or life-long learning programs are established locally within the relevant divisions and the School of Continuing Studies and are not discussed in these schedules.

Domestic Tuition Fees

Changes to domestic tuition fees in publicly funded programs at Ontario colleges and universities are subject to a fee framework set by the Provincial Government. Under the framework, the Government sets limits on increases to fees (and in some cases, requires reductions or freezes) and retains the option to reduce operating grant funding to institutions that contravene the framework. The framework applies only to tuition for students that generate operating grant funding from the Government; as such, it does not apply to the majority of international students, non-publicly funded programs (e.g. Executive MBA), and continuing education programs.

On January 17, 2019, the Ontario government announced a 10% cut to domestic tuition fees beginning in 2019-20, and a freeze at that level for 2020-21. The freeze on Ontario resident domestic tuition has remained in place since then and the Government committed to extending it to at least 2026-27.

Consistent with the known Provincial, the 2026-27 Budget and Long-Range Guidelines was built with the following assumptions for 2026-27:

- Ontario resident domestic tuition fees will remain frozen for all programs except the anomaly programs noted below.
- Non-Ontario resident domestic tuition in undergraduate programs will increase by 5%.
- Non-Ontario resident domestic tuition in graduate programs will remain frozen.
- Domestic tuition in the Master of Arts and Master of Science programs will increase by 3.1% as those programs have now reached the Ministry-approved sector average of \$7,600. The Master of Science in Applied Computing program will increase by 7.5% for incoming students under the Government's anomaly program. Tuition increases for continuing students in the Applied Computing program will be limited to a maximum of 5% per annum under the University's internal policy commitment to continuing students.

On February 12, 2026, the Province announced a new Framework on domestic tuition fees that will allow universities to increase Ontario resident fees by 2% starting in Fall 2026. The

new Framework also permits up to 2% increases in 2027-28 and 2028-29, and thereafter increase fees at the lesser of 2% or a three-year average of the Consumer Price Index. While the Government's announcement came too late to integrate into the 2026-27 Budget Report, the University plans to apply 2% increases (Schedule 2) starting in Fall 2026 (or the Summer 2026 term, if permitted) and has appended a second set of Tuition Fee Schedules to present these fees for approval. This Report also includes a set of Tuition Fee Schedules (Schedule 1) with a 0% increase for 2026-27, which was the basis for the 2026-27 Budget Report and will serve as the fee basis for Summer 2026.

International Tuition Fees

International fees are set at a level that takes into consideration the full cost of providing programs and with reference to fees at peer universities in Canada and abroad.

Overall, undergraduate international tuition fees will increase by an average of 4.1% and graduate international tuition fees will increase by an average of 3.6%, excluding international PhD students paying domestic rates, and 2.1% when international PhD fees are included. To provide prospective applicants with information for planning purposes, the attached schedules also include currently planned tuition fees for international students for 2027-28 **for information only**. These fees are subject to change next year when the final tuition fees are brought forward to governance for approval as part of the 2027-28 budget plan.

International tuition fees for students entering and continuing in the tri-campus Arts & Science, Architecture, and Applied Science & Engineering programs will increase by 4% in 2026-27. The Medicine MD program fees will increase by 3% for new and continuing students. Most other international fees will increase by 5%, consistent with the assumptions in last year's plan and reflecting their lower fee levels. International fees for all the conjoint programs with the Toronto School of Theology will increase by 5% for 2026-27.

As is the case with domestic tuition fees, international tuition fees for the second and upper years of the Commerce, Business Administration, Management, Computer Science, Bioinformatics, Data Science, UTM Visual Studies, and Communication, Culture, and Information Technology (CCIT) programs are differentiated from the first-year general arts & science fee. Commerce, Business Administration, and Management fees will increase by 4% while the other programs listed above will increase by 5% in 2026-27.

As of 2018-19, most international PhD students at the University of Toronto pay tuition fees equivalent to those of domestic students, and the fees will continue to be aligned for 2026-27.

International tuition fee increases in research-stream master's, professional master's, and professional doctoral programs vary by program, but primarily range from 1.5% to 5%, with higher 6% increases in entering fees for the MSW, OISE EDD, and OISE professional master's programs. Fee increases consider the resource requirements of the programs and the level of the tuition fee relative to competing programs. Fee increases for continuing students are limited to a maximum of 5% under the University's policy.

FINANCIAL IMPLICATIONS:

Revenue projections for publicly-funded programs are included in the *Budget Report 2026-27 and Long Range Budget Guidelines 2026-27 to 2030-31*. Related information on student financial support accompanies this report in the *Annual Report on Student Financial Support, 2024-25*.

RECOMMENDATION:

Be it Resolved,

THAT

(a) the 2026-27 tuition fees as described in Schedule 1 of the Tuition Fee Schedule for Publicly-Funded Programs 2026-27, be approved;

(b) the 2026-27 tuition fees as described in Schedule 2 of the Tuition Fee Schedule for Publicly-Funded Programs 2026-27, be approved;

AND

(c) subject to the final provisions in the Provincial Government's Tuition Fee Framework, Schedule 1 fees will be implemented for fees in the Spring/Summer term and Schedule 2 for fees will be implemented starting in the Fall term.

Tuition Planning and Context

The following report provides the proposed 2026-27 tuition fees for for-credit degree, diploma, and certificate programs at the University of Toronto. An overview of the policy frameworks and context for fee setting is included along with detailed schedules of the fees in the appendices. Note that fees for non-credit continuing education or life-long learning programs are established locally within the relevant divisions, including the School of Continuing Studies, and are not discussed in this report.

Tuition fees at the University of Toronto are determined in accordance with the University's Tuition Fee Policy, the Statement of Commitment Regarding International Students, and the Provincial Government's Tuition Framework.

The Provincial Framework for Domestic Tuition Fees

Changes to domestic tuition fees in publicly funded programs at Ontario colleges and universities are subject to a fee framework set by the Provincial Government. Under the framework, the Government sets limits on increases to fees (and in some cases, requires reductions or freezes) and retains the option to reduce operating grant funding to institutions that contravene the framework. The framework applies only to tuition for students that generate operating grant funding from the Government; as such, it does not apply to the majority of international students, non-publicly funded programs (e.g. Executive MBA), and continuing education programs.

On January 17, 2019, the Ontario government announced a 10% cut to domestic tuition fees beginning in 2019-20, and a freeze at that level for 2020-21. The freeze has remained in place since then – with some exceptions as described below – and the Government committed to extending it to at least 2026-27.

In 2021-22, the Government introduced a new policy allowing for differentiated tuition for “non-Ontario resident” domestic students. The University has applied these increases to non-Ontario resident students in undergraduate programs, starting with 3% in 2022-23 and 5% since then.

In 2023-24, the Government introduced a one-time tuition anomaly adjustment where a program's tuition rate was at least 15 per cent lower than the sector average of comparable programs.

The University received approval for special anomaly increases for tuition in our doctoral stream Master of Arts and Master of Science programs, as well as the MSc in Applied Computing, which were all significantly below comparable programs in Ontario. The University increased incoming domestic fees by 3 per cent for Fall 2023, and 7.5

per cent for Fall 2024 and Fall 2025. The MSc in Applied Computing program will increase fees by 7.5% again in 2026-27 as part of the multi-year plan to increase its fee to be closer to the sector average; fees for the Master of Arts and Master of Science will be increased by 3.1 per cent as those programs have now reached the sector average of \$7,600. Tuition increases for continuing students in the MSc in Applied Computing will be limited to 5% in accordance with the University's commitment to continuing students.

On February 12, 2026, the Province announced a new Framework on domestic tuition fees that will allow universities to increase domestic non-Ontario resident fees by 2% starting in Fall 2026. The new Framework also permits up to 2% increases in 2027-28 and 2028-29 and thereafter increase fees at the lesser of 2% or a three-year average of the Consumer Price Index. While the Government's announcement came too late to integrate into the 2026-27 Budget Report, the University plans to apply 2% increases starting in Fall 2026 (or Summer 2026 term, if permitted) and has appended a second set of Tuition Fee Schedules to present these fees for approval. This Report also includes a set of Tuition Fee Schedules with a 0% increase for 2026-27, which was the basis for the 2026-27 Budget Report and will serve as the fee basis for Summer 2026 term fees.

Tuition Revenue

The 2026-27 Budget includes incremental, for-credit tuition fee revenue reduction of \$28 million. This reflects the net impact of updated international and domestic enrolment plans, a continued freeze to Ontario resident domestic tuition fees, a 5% increase to non-Ontario resident undergraduate domestic fees, the special anomaly increases described earlier, and a 3.7% average increase in international tuition fees.

As noted above, the 2026-27 Budget does not include any revenues from the planned increase of 2% starting in Fall 2026. This will create a positive variance to plan in 2026-27 but will be essentially net neutral over the first three years of the five-year plan, which calls for 3% increase in each of 2027-28 and 2028-29.

The University continues to monitor the impact of tuition fees to ensure that enrolment is unaffected, as required by the University's Tuition Fee Policy. Demand for University programs from both domestic and international students continue to be strong and undergraduate entering averages continue to be exceptional. The most recent statistics from the Ontario Universities Application Centre (OUAC) show that almost two-thirds of new U of T students have a 90%+ high school average, and 1 in every 5 high school graduates with a 90%+ average enrolls at the University of Toronto.

Student Financial Support

Undergraduate and graduate students at the University of Toronto have access to a wide range of financial supports through the University in addition to those available through government loan and grant programs like the Ontario Student Assistance Program (OSAP). Some are based on need, and others on measures of merit, such as academic achievement or leadership. There are supports for international and Canadian students as well as dedicated supports for students with disabilities.

The University of Toronto is independently committed to financial aid and is guided by the 1998 Governing Council Policy on Student Financial Support, which will continue to drive funding for need-based student aid for domestic students.

The policy sets out the principle that domestic students should have access to the resources that will enable them to meet their financial needs, as determined through the Ontario Student Assistance Program (OSAP), with appropriate modifications as determined by the Vice-Provost, Strategic Enrolment Management and the University Registrar, in consultation with the academic divisions of the University. The Province's Student Access Guarantee (SAG) requires institutions to provide non-repayable aid to assist domestic, OSAP-eligible students in direct-entry undergraduate programs with expenses related to tuition, books and supplies not covered by OSAP. The University's commitment goes well above these government requirements.

The University's primary mechanism for providing need-based financial aid to OSAP-eligible, direct-entry, domestic undergraduate students is the University of Toronto Advance Planning for Students (UTAPS) program which was redesigned in 2023-24 to make it more responsive to student needs and less impacted by changes in the Government's OSAP need assessment policies. These changes give the University greater flexibility to grant financial support earlier and to consider more accurate living costs for the GTA in need calculations. This has allowed for a much more targeted allocation of UTAPS support focused on the students who need it most.

Need-based financial aid for domestic students in second entry and professional master's programs is administered in divisionally run programs, allowing for a more individualized and nuanced approach to providing assistance. Divisional programs are supported where necessary by access to an institutionally negotiated line of credit.

University practice has been to link the change in the UTAPS budget to the domestic fee framework. While tuition for Ontario resident students remains frozen, growth in the domestic population and rising costs of living in the Toronto area will increase need for UTAPS support. In response, the 2026-27 budget includes a 3% increase to UTAPS bringing it to \$42 million, which is topped up by about \$2.5 million in funding from endowments including the Boundless Promise Program. While UTAPS is the primary program to meet student financial needs, the University and each academic division provide additional funding outside of UTAPS to support students facing unexpected financial challenges.

The large direct-entry undergraduate divisions continue to make significant investments in merit-based scholarships for international students from diverse global regions. Divisions are earmarking 6% of total international undergraduate tuition to support International Scholars awards to reduce the cost for top international applicants from around the world. Each division has designed its own awards program based on diverse criteria including merit, financial need, priority regions for diversification, and intended program of study. The 2026-27 Budget sets aside \$88 million for the International Scholars program and the full-ride Pearson Scholarships for exceptional international students.

The combination of University and provincial student financial support programs enhance access to the University's excellent education opportunities for a wide array of students. For example, students who receive OSAP typically only pay a fraction of the posted tuition and fees, with the average undergraduate in a direct-entry program paying just 24% of the posted tuition fee sticker price in 2024-25 (after OSAP and University grants are factored in). This figure has fallen from 47% in 2016-17 because of short-term government policy changes and emergency pandemic supports but is expected to return to higher levels as these policies wind down.

Additional information on the University's student aid programs and OSAP can be found in the 2024-25 Student Financial Aid Report and the 2026-27 Budget Report.

University of Toronto Fee Level Commitment

The University's Tuition Fee Policy (Appendix A) states that in establishing the tuition fee schedule, a commitment will be made to each student upon entry as to the level of fees to be charged over the normal course of the full-time program of study. Beginning in 1998-99, the University of Toronto made a commitment to students in its fee schedules that, unless otherwise noted, no student continuing in a program will be subject to a fee increase of more than 5% per year.

This commitment remains in effect regardless of the provincial tuition framework in place at any given point in time and applies for the normal length of each program, as posted on the University's website. For students in the doctoral stream, the commitment is in effect for two years at the master's level and typically for four years at the doctoral level (with some exceptions for longer doctoral programs). For students who participate in Co-op or internship programs as part of their undergraduate program, the normal length of full-time study increases by one year. For undergraduate students entering the University through an International Foundation Program, the normal length of study also increases by one year.

Tuition Fee Structures

Program Fees and Course Fees

Full-time undergraduate student fees are levied in one of two ways: program fees or course fees. Under a program fee structure, students pay a single fee for study classified as full-time for fee purposes. Under a course fee structure, students pay a fee for each course in which they are registered. Most University of Toronto programs levy fees under the program fee model.

Programs with higher fees in upper years

In some undergraduate programs, students are admitted after completing one or more years of study in arts and science courses. During the initial year(s), students pay general arts and science tuition; upon admission to the program, students pay a higher tuition fee in upper years. This structure reflects the move from a general program to an upper-year specialized program. These programs include: Commerce; Business Administration; Management; Computer Science; Bioinformatics; Data Science; UTM Visual Studies; Communication, Culture and Information Technology (CCIT); and the undergraduate program in Information.

Bachelor of Information (BI) students complete the equivalent of two years of full-time study at the undergraduate level in any discipline before transferring into the BI program. Once registered in the BI program, students pay the same tuition as Computer Science students. Note that the University is currently developing a proposal for a new four-year BI program, which is factored into outer year enrolment and fee revenue plans

Combined, Double Degree, and Dual Degree Program Fees

The University has about 140 combined degree program offerings and has been developing additional double degree and dual degree programs in recent years. Schedules B4 & D5 provide detailed information on fees for these programs. The proposed fees by year of study for almost all cases are based on the fees for the constituent programs proposed in Schedules B1-B3, C, & D1-D4.

Part-Time and Partial Fees

Some students at the University of Toronto are charged partial fees primarily based on the tuition fee for full-time study. The following formulas guide the derivation of partial fees:

1. When computing a partial fee, the respective fee for full-time study is the tuition fee for either domestic or international students, depending on the legal status of the student.
2. Part-time fees for undergraduate programs are typically equal to the full-time fees pro-rated on a per-course basis relative to the full-time course load, except in a couple of special cases.
 - The program fee for part-time domestic MD Extended Clerkship students is assessed on a per term basis, typically in the summer and fall terms. No international students are expected in this program.
 - Fees for the part-time domestic PharmD for Pharmacists program are assessed on per half course basis.
3. Part-time fees for graduate programs are normally set at 30% of the full-time annual fee with the following exceptions:
 - The Nursing Post-Masters Nurse Practitioner Diploma program is offered on a part-time basis only and fees are assessed on a program fee basis.
 - The part-time Medicine Graduate Diploma in Health Research is available to MD students and fees are assessed on a per term basis.
 - The UTM Master of Forensic Accounting is only offered on a part-time basis. The proposed part-time program fee rates for 2026-27 are listed in Schedules C & D4.
4. Because of the minimum costs incurred for registration in any program, no tuition fee in 2026-27, after refunds in the case of full withdrawal from the University, shall be less than \$348.

Conjoint Programs with the Toronto School of Theology

In accordance with the Memorandum of Agreement between the University of Toronto and the Toronto School of Theology (TST), proposed tuition fees for conjoint undergraduate and graduate programs are forwarded to the Business Board for review and approval annually – these fees are included in the accompanying schedules. The ThD degree program was fully phased-out during 2024-25.

Note that tuition fees for TST's non-conjoint programs are not included as these are not University of Toronto programs. Approval for these fees is through the TST Board of Trustees.

2026-27 Tuition Fees

Tuition Fees for Domestic Students

The University's Tuition Fee Policy (Appendix A) states that public funding should be supplemented as necessary to offer students an educational experience of a quality that ranks with that of the finest public research universities in the world. Furthermore, it calls for a differentiated fee structure in which tuition fees reflect individual program goals, resource requirements, program costs, etc.

Tuition fees therefore differ by program. Appendix B Undergraduate Domestic Tuition Fee Schedules list the proposed tuition fees for domestic students by residency, by program, and by entering cohort where relevant. For the purposes of this report, direct-entry undergraduate programs are programs of study into which a student may be admitted directly from high school (e.g., Engineering, Arts and Sciences, Architecture, Music, and Kinesiology) plus the Transitional Year Program (TYP). Second-entry undergraduate programs are programs of study that require a student to have some university preparation before admission to the program (e.g., Law JD, Medicine MD, Dentistry DDS, PharmD and Nursing). Graduate fees are listed in Appendix D.

Undergraduate students entering first year in 2026-27 should note that tuition fees for upper year students in the Commerce, Business Administration, Management, Computer Science, Data Science, Information, Bioinformatics, UTM Visual Studies, and Communication, Culture, and Information Technology (CCIT) programs are provided separately in Schedules B2. Fees for the upper years of these programs in 2027-28 will be submitted to Governing Council for approval in Spring 2027 and will comply with the Provincial Tuition Framework in place at that time.

As noted previously, this Report includes a second set of Schedule B tuition fee schedules that present domestic fee levels with the 2% allowable fee increase announced by the Province on February 12, 2026. These fees will be applied on students starting in Fall 2026, unless permitted earlier by the province as additional details on the new Tuition Framework are made available.

Tuition Fees for International Students

The University of Toronto recognizes the important contributions of international students to our academic and research mission (Appendix A) and continues to invest in services to enhance the experience and success of our international students. The proposed international fees listed in Appendix D are set at a level that takes into consideration the full cost of providing a program and with reference to fees at peer universities in Canada and abroad.

The international tuition fees for students entering and continuing in the tri-campus Arts & Science, Architecture, and Applied Science & Engineering programs will increase by 4% in 2026-27. The Medicine MD program fees will increase by 3% for new and continuing students. Most other

fees will increase by 5%. International fees for all conjoint programs with the Toronto School of Theology will increase by 5%. The weighted average undergraduate international tuition fee increases across all programs and years of study in 2026-27 will be 4.1%.

International tuition fees for the second and upper years of the Commerce, Business Administration, Management, Computer Science, Bioinformatics, Data Science, UTM Visual Studies, and Communication, Culture and Information Technology (CCIT) programs are differentiated from the first-year general arts & science fee. Commerce, Business Administration, and Management fees will increase by 4% while the other programs listed above will increase by 5% in 2026-27.

International tuition for most PhD programs will continue to be aligned with domestic tuition in 2026-27. International tuition fee increases in research-stream master's, professional master's, and professional doctoral programs vary by program, but primarily range from 1.5% to 5%, with higher 6% increases in entering fees for the MSW, OISE EDD, and OISE professional master's programs. In all cases, continuing fee increases are limited to a maximum of 5% under the University's policy.

In response to competitive pressures from peer programs, international fees for the Master of Biotechnology, Master of Forensic Accounting, Master of Management of Innovation, Master of Science in Biomedical Communication, Master of Urban Innovation, and Master of Science in Pharmacy programs will remain at their current levels for 2026-27.

The weighted average increase for international graduate tuition, excluding PhD programs, will be 3.6% in 2026-27. When international PhD programs are included, the average increase in international graduate fees is 2.1%.

Schedule D5 includes the international fees for students in combined, double degree or dual degree programs. Most combined programs do not currently have international students enrolled. If they do in future, international tuition fees would be charged following the same practices as outlined in the domestic Schedule B4.

Planned 2027-28 International Tuition Fees for Information Only

The University provides a supplemental schedule of currently planned fees for 2027-28 **for information only** to assist students considering applying to the University in the future. Note that these fees are subject to change when the University finalizes its plans next year.

For planning purposes, undergraduate tri-campus Arts & science, Architecture, and engineering international fees are projected to increase by 4% in 2027-28, with variations in other programs to reflect competitive environments (lower rate of increase) or exceptional resource requirements (higher rate of increase). The upper year fees for undergraduate Computer Science, Bioinformatics, Data Science, UTM Visual Studies, and Communication, Culture and Information Technology (CCIT) programs are projected to rise by 5%.

Appendix A: Policies

The University's Tuition Fee Policy

The University of Toronto's tuition fee policy should reflect its mission as an internationally significant, public research university with undergraduate, graduate and professional programs of excellent quality. Such a goal assumes an appropriate level of funding which, for a public university, means principal support from the Provincial and Federal Governments, and from endowment funds as well as tuition fees. It also assumes the existence of programs of student aid to maintain the accessibility of the University to students of varying financial means. The effect of this policy should be neutral with regard to enrolment levels, which will be determined from time to time through the University's planning processes. Our tuition fee policy has five elements:

1. **Advocacy.** In making the case for public policies strongly supportive of an accessible public system of university education, the University will continue to advocate ongoing and substantial public investment in the university sector.
2. **Fee Revenue.** The University of Toronto will continue to be a public university, for which ongoing and substantial support from government will always be essential. The basic principle of the tuition policy is that public funding should be supplemented as can be demonstrated to be necessary to offer students an educational experience of a quality that ranks with that of the finest public research universities in the world.
3. **Fee Differentiation.** The University should continue to move toward a more differentiated structure of fees across programs. In setting fees for each particular program, the following factors will be taken into account:
 - Fees should take into account the plans and aspirations of each academic division, and the level of resources necessary to achieve high program quality.
 - Program costs should be taken into account in setting fees.

- Fees should be set at a level that is competitive with programs of similar quality in institutions with which we compete or expect to compete for students.
- Fee levels should be relatively higher in programs for which the future income prospects of graduates are relatively higher.
- Fee levels should reflect a justifiable balance across public and private sources of revenue per student.
- Fee policy should allow for intentional, disproportionate public subsidies and intra-university cross-subsidies, where a case for cross-subsidization can be made.

In bringing forward the tuition fee schedule each time, the administration shall provide an explanation taking account of the above factors.

4. **Fee Level Commitment.** The tuition fee schedule will include a commitment to be made to each student upon entry as to the level of fees to be charged over the normal course of the full-time program of study.
5. **Monitoring.** In presenting the annual Report on Enrolment, the Vice-President and Provost shall include commentary regarding the effects, if any, of changes in tuition fees upon changes in enrolment.

Statement of Commitment Regarding International Students

Preamble

International students are an essential feature of the University of Toronto's participation in international scholarship. They contribute to the international character of the University's research and provide opportunities for the international exchange of knowledge through its teaching programs. The presence of outstanding students from all parts of the world in the University's undergraduate and graduate, professional, and research programs, helps to achieve the excellence the University seeks to assure for all its activities. On the University's campuses international students also make an important and positive contribution to the cultural life of the community and create lasting relationships of benefit to individuals as well as to the institution and the country generally. And finally, by enrolling international students, the University of Toronto, as an internationally significant university, has an opportunity to share its educational resources with other countries whose institutions are still evolving.

In light of these considerations, the Governing Council has adopted the Statement of Commitment Regarding International Students that commits the University to enrolling a broad mix of international students in its programs, and that articulates the basic principles that will guide their admission to the University, arrangements for their financial support, right of access to academic courses and programs, and the provision of services to address their particular needs.

This Statement of Commitment applies to University of Toronto students in university degree, diploma and certificate programs who are not Canadian citizens, permanent residents, or convention refugees.

Statement of Principles

1. Within the Framework of divisional academic plans, the University of Toronto welcomes international students into all of its programs.
2. The admission of international students will be consistent with the Policies and Principles for Admission to the University of Toronto approved by the Governing Council in 1991.
3. The University will broaden and strengthen its recruiting efforts abroad.
4. Once admitted to the University, international students will have access to the same range of courses and support services on the same basis as other students.

Financial Support

1. International students who are admitted and enrolled may encounter financial emergencies and the University will provide financial assistance as needed and where possible.
2. The University will develop a program of international admission scholarships using its own resources and support from external sources to be awarded on the basis of exceptional academic merit and financial need.
3. The Report of the Vice-Provost, Students on Student Financial Support, submitted annually to governance for information, will include data on the support provided to international students.

Accompanying Notes to Tuition Fee Tables (Schedule 1):

1. Tuition fee rates for each year are effective May 1st. For example, the tuition fees for 2026-27 commence in the Summer 2026 session.
2.
 - A. Tuition fee increases for domestic students are to comply with both the Provincial Tuition Fee Framework, and the University's internal Fee Level Commitment to continuing students. The Fee Level Commitment ensures increases of no more than 5% annually for in-program students, guaranteed for the normal length of a full-time program. Students who exceed the normal length of their program are charged the same tuition as students in the final year of that program.
 - B. The 2023-24 Provincial Tuition Framework approved multi-year domestic tuition fee increase anomaly adjustments for most MA and MSc programs, as well as the MSc in Applied Computing. Domestic fees for students in these programs may increase by up to a maximum of 7.5% per annum until the University's rates equalize with approved university peer program sector averages as determined by the Ministry (MSc in Applied Computing - \$17,320; MA/MSc - \$7,600). The University will limit fee increases for continuing students in these anomaly programs to a maximum of 5% per annum under its internal Fee Level Commitment policy.
 - C. Due to the late Ministry announcement of the 2023-24 Tuition Framework's tuition fee increase anomaly adjustment process, the approved changes could not be implemented until Fall 2023/Winter 2024. Consequently, graduate doctoral stream Master spring start programs will be unable to fully equalize their domestic tuition rates with the Fall start anomaly programs until 2027-28.
3. The Bachelor of Information is starting a new four-year direct-entry program beginning in 2027-28. All cohorts of the phasing out two-year Bachelor of Information program will still follow the path of first completing at least the equivalent of two years of full-time study at the undergraduate level in any discipline. The lowest 3-campus A&S Year 1-2 fee rates are displayed for demonstration purposes. These BI students will then pay the same tuition as Computer Science students. For the fees associated with the new four-year BI program, refer to tables B2 and D2.
4. TST Undergraduate Basic Degree Program students who entered prior to 2019 will be charged slightly lower fees than the posted rate for 2026-27 above based on the grandparenting rules that existed at their date of entry and compliant with the annual increase limits allowed by the Tuition Frameworks.
5. The combined degree programs involving the three Arts & Science campuses' HBA or HBSc programs are restricted to specific combinations of specialist, major, or minor programs. Please refer to the respective divisional academic calendar for further details.

10. Each MGA combined degree program cohort will start in the prior Fall at the other institution and then register as MGA students at UofT in the following Summer. UofT continuing student fees will be levied in Fall/Winter Year 2.
11. In the event a MD/MBA student is able to register in a graduate half course in the Fall term of Year 5, no MBA tuition will be charged.
12. Each cohort starts in January at the Universidad Torcuato Di Tella in Argentina and then will register at UofT after 4.5 years.
13. Each cohort will pay tuition at the partner institution in Year 1, tuition at UofT in Year 2. Students will only be registered at UofT in the Fall term of the third year of time so will be charged 50% of the prevailing MEd continuing student tuition fee rate.
14. Each cohort will start in the prior Fall at the Sapienza Università di Roma (Italy) and then be registered at the Universidade do Porto (Portugal) or Université Paris-Saclay (France) in Winter and Summer of Year 1. such that students will ultimately be charged the same or slightly less in total compared to the phasing-out 4-year program. The total academic requirements are remaining unchanged at 23.25 full-course equivalents.

16. The combined PharmD 4-Year/Management MBA degree program is being phased out due to the transition to the three-year PharmD program. The last cohorts entered the PharmD 4-year program in Fall 2024.
17. The Medicine Doctor of Medicine / Dentistry MSc (Oral and Maxillofacial Surgery Specialty) combined degree program is limited to the coursework-only option. No international students are anticipated.
18. The structure of the Master of Finance (MFIN) program is changing from 20-months to 15-months beginning Fall 2026. Last cohort in the 20-month program started in Fall 2024 so is expected to be fully phased-out by 2026-27.
19. The structure of the Master of Management Analytics (MMA) program is changing from 11-months to 15-months beginning Fall 2026. The 11-month program offering is phasing-out but there is potential uncertainty that all students will complete their degree requirements prior to Fall 2026.
20. Each cohort will start in the prior Fall at the Madrid campus of IE University and then register as MPP students in the following summer. Students will register at UofT in Year 2 for three terms. UofT continuing student (Year 2) fees will be levied in Year 2 Fall/Winter.
21. Each cohort will be registered in either the MGA or MPP program at UofT in Year 1 and then registered at Columbia in the MIA or MPA program in Year 2. Each institution will charge tuition per the applicable degree being pursued.
22. Students will have the option to start one of the combined MGA/MPP or MPP/MPP programs at UofT or Tokyo University. The applicable Year 1 UofT degree program tuition will be charged if students start at UofT and the applicable continuing student (Year 2) UofT degree program tuition will be charged if students start at Tokyo.
23. Each cohort will be registered and located at the University of Toronto for Year 1 Fall/Winter. Students will then complete their UofT internships in Europe/Eurasia in Year 1 Summer. In Year 2, students will be registered at LUISS in Rome for three terms and be charged tuition by LUISS.

Accompanying Notes to Tuition Fee Tables (Schedule 2):

1. Domestic Ontario resident fee rate increases will be effective as of Fall 2026 term (or the Summer 2026 term if permitted). For the domestic non-Ontario resident and the international fee rate increases, they remain effective as of the Spring/Summer 2026 terms.
2.
 - A. Tuition fee increases for domestic students are to comply with both the Provincial Tuition Fee Framework, and the University's internal Fee Level Commitment to continuing students. The Fee Level Commitment ensures increases of no more than 5% annually for in-program students, guaranteed for the normal length of a full-time program. Students who exceed the normal length of their program are charged the same tuition as students in the final year of that program.
 - B. The 2023-24 Provincial Tuition Framework approved multi-year domestic tuition fee increase anomaly adjustments for most MA and MSc programs, as well as the MSc in Applied Computing. Domestic fees for students in these programs may increase by up to a maximum of 7.5% per annum until the University's rates equalize with approved university peer program sector averages as determined by the Ministry (MSc in Applied Computing - \$17,320; MA/MSc - \$7,600). The University will limit fee increases for continuing students in these anomaly programs to a maximum of 5% per annum under its internal Fee Level Commitment policy.
 - C. Due to the late Ministry announcement of the 2023-24 Tuition Framework's tuition fee increase anomaly adjustment process, the approved changes could not be implemented until Fall 2023/Winter 2024. Consequently, graduate doctoral stream Master spring start programs will be unable to fully equalize their domestic tuition rates with the Fall start anomaly programs until 2027-28.
3. The Bachelor of Information is starting a new four-year direct-entry program beginning in 2027-28. All cohorts of the phasing out two-year Bachelor of Information program will still follow the path of first completing at least the equivalent of two years of full-time study at the undergraduate level in any discipline. The lowest 3-campus A&S Year 1-2 fee rates are displayed for demonstration purposes. These BI students will then pay the same tuition as Computer Science students. For the fees associated with the new four-year BI program, refer to tables B2 and D2.
4. TST Undergraduate Basic Degree Program students who entered prior to 2019 will be charged slightly lower fees than the posted rate for 2026-27 above based on the grandparenting rules that existed at their date of entry and compliant with the annual increase limits allowed by the Tuition Frameworks.
5. The combined degree programs involving the three Arts & Science campuses' HBA or HBSc programs are restricted to specific combinations of specialist, major, or minor programs. Please refer to the respective divisional academic calendar for further details.

12. Each cohort starts in January at the Universidad Torcuato Di Tella in Argentina and then will register at UofT after 4.5 years.
13. Each cohort will pay tuition at the partner institution in Year 1, tuition at UofT in Year 2. Students will only be registered at UofT in the Fall term of the third year of time so will be charged 50% of the prevailing MED continuing student tuition fee rate.
14. Each cohort will start in the prior Fall at the Sapienza Università di Roma (Italy) and then be registered at the Universidade do Porto (Portugal) or Université Paris-Saclay (France) in Winter and Summer of Year 1. Students will register at UofT in Year 2 for three terms. UofT continuing student (Year 2) fees will be levied in Year 2 Fall/Winter.
15. The PharmD program has transitioned to a three-year program as of the Fall 2025 cohort. Students will be charged Fall/Winter program fees plus Summer program fees will be introduced as of Summer 2026 onwards

- such that students will ultimately be charged the same or slightly less in total compared to the phasing-out 4-year program. The total academic requirements are remaining unchanged at 23.25 full-course equivalents.
16. The combined PharmD 4-Year/Management MBA degree program is being phased out due to the transition to the three-year PharmD program. The last cohorts entered the PharmD 4-year program in Fall 2024.
 17. The Medicine Doctor of Medicine / Dentistry MSc (Oral and Maxillofacial Surgery Specialty) combined degree program is limited to the coursework-only option. No international students are anticipated.
 18. The structure of the Master of Finance (MFIN) program is changing from 20-months to 15-months beginning Fall 2026. Last cohort in the 20-month program started in Fall 2024 so is expected to be fully phased-out by 2026-27.
 19. The structure of the Master of Management Analytics (MMA) program is changing from 11-months to 15-months beginning Fall 2026. The 11-month program offering is phasing-out but there is potential uncertainty that all students will complete their degree requirements prior to Fall 2026.
 20. Each cohort will start in the prior Fall at the Madrid campus of IE University and then register as MPP students in the following summer. Students will register at UofT in Year 2 for three terms. UofT continuing student (Year 2) fees will be levied in Year 2 Fall/Winter.
 21. Each cohort will be registered in either the MGA or MPP program at UofT in Year 1 and then registered at Columbia in the MIA or MPA program in Year 2. Each institution will charge tuition per the applicable degree being pursued.
 22. Students will have the option to start one of the combined MGA/MPP or MPP/MPP programs at UofT or Tokyo University. The applicable Year 1 UofT degree program tuition will be charged if students start at UofT and the applicable continuing student (Year 2) UofT degree program tuition will be charged if students start at Tokyo.
 23. Each cohort will be registered and located at the University of Toronto for Year 1 Fall/Winter. Students will then complete their UofT internships in Europe/Eurasia in Year 1 Summer. In Year 2, students will be registered at LUISS in Rome for three terms and be charged tuition by LUISS.

 25. If permitted for summer 2026, the domestic Ontario resident fee rates would be increased by 2 per cent for the following summer start programs: 1) PharmD 3-Year \$6,140, 2) MFE \$31,120, 3) MBT \$18,080, 4) MAccFin Year 1 \$19,980, 5) MAccFin Year 2 \$9,990, and 6) MSW Advanced Standing Option \$9,600. The fee schedules for the combined BBA/MaccFin and PharmD 4-year/MBA programs would also be recalibrated accordingly.
