Audited Financial Statements for the Fiscal Year ended April 30, 2026

JURISDICTIONAL INFORMATION:

In accordance with section 5 of the Business Board terms of reference, the Board recommends the approval of the annual audited financial statements to Governing Council. The Audit Committee reviews with the administration and the external auditors the University's annual audited financial statements and the external auditors' report thereon, satisfies itself with respect to the integrity of the statements and the fairness of their presentation, and recommends them for approval to the Business Board. As part of this review, the Audit Committee reviews the signed statement of administrative responsibility in connection with the preparation of the financial statements and reviews relevant written communications from the external auditors, including any schedule of unadjusted differences.

PREVIOUS ACTION TAKEN:

The University of Toronto audited financial statements for the fiscal year ended April 30, 2025, were approved on June 24, 2025.

HIGHLIGHTS:

The University continues to be in a strong financial position due to high demand for our programs and prudent fiscal management, resulting in substantial operating reserves and an excellent credit rating. However, the University is operating in an environment of lower revenue growth compared to the past decade, with limits on domestic and international fees. While domestic demand remains very strong, international enrolment growth plans have been recalibrated slightly to reflect a more challenging recruitment market resulting from changes to Canadian immigration policy. At the same time, despite returning to more moderate levels over the last two years, inflation continues to put pressure on divisional budgets. Expenses are continuing to outpace the rate of revenue growth, primarily due to compensation increases and the rising cost of employee benefits. Current geopolitical tensions are also putting upward pressure on operating and capital expenditures (for example, through elevated fuel costs in supply chains).

The University's net income of \$436 million (8.8% of revenues) was driven largely by strong returns on working capital investments, as well as funds set aside for future priorities in accordance with approved academic and budget plans. The positive net income also includes infrastructure costs that were capitalized and not expensed in the year, offset by amortization expense. Notwithstanding strong investment returns for the year, the rate of increase in revenue (1.6%) was insufficient to fully offset the rate of increase in expenses (3.7%).

In fiscal 2026, the University's net assets increased by \$890 million to \$11.55 billion in 2026. This increase is mainly due to net income of \$436 million, endowed donations and grants of \$100 million, and investment gains on externally restricted endowments of \$357 million, offset by \$3 million in remeasurements on employee future benefit obligations. These net assets are comprised of the following:

- \$4.48 billion of endowments, representing 38.8% of net assets,
- \$7.65 billion of internally restricted net assets, which is further broken down into:
 - \$2.37 billion in land
 - \$2.98 billion of investment in other capital assets
 - (\$439 million) in net unfunded liability associated with pension and other employee future benefits, including the pension special payment reserve
 - \$1.48 billion in capital projects and infrastructure reserves
 - \$673 million of operating contingency reserves
 - \$340 million in research support
 - \$252 million in other reserves held for future spending; and
- (\$581 million) of deficit.

The deficit is largely due to the internal financing of capital construction in accordance with the University's debt strategy.

Ancillary operations have seen revenue growth for the fifth consecutive year and positive net income in each of the last 4 years. Changes in demand for on-campus services due to flexible work arrangements, increased costs due to a period of high inflation, and rising staffing costs posed challenges for ancillary operations in the first few years post-pandemic, however, an increasing presence of administrative staff across the three campuses is expected to result in higher demand going forward, particularly in food services and parking.

The University continues to invest in vital capital infrastructure. In 2026, the University spent \$726 million on capital asset additions, including projects such as:

- the Lash Miller Building expansion, Toronto High Containment Facility, Innis College expansion, Academic Wood Tower, and the new Oak House residence at the St. George campus;
- the Scarborough Academy of Medicine and Integrated Health (“SAMIH”) and a new parking structure at UTSC;
- a new student residence at UTM; and
- major equipment, including acquisitions as part of Project LEAP.

In 2024, the University secured two credit facilities (\$113 million in total), to fund Project LEAP, a \$138-million infrastructure project that will cut emissions in half on the St. George campus by phasing out natural gas in favour of electricity in the campus’s central steam plant and carry out deep energy retrofits to some of the most energy-intensive buildings. At April 30th, the University had drawn \$68 million from these facilities. Interest on these facilities are capitalized until the project is completed.

In 2026, \$2.4 billion of revenues were from student fees, which is a 11.9% over the last 5 years. While enrolment continues to be strong, student fee revenue decreased slightly by \$7 million from last year mainly because of weaker than expected international enrolment and the completion of many students from the exceptionally large incoming cohort of 2021, offset by some domestic enrolment growth. Government grants provided in support of student enrolments amounted to \$788 million. Together these two sources account for 63.8% of revenues for the year.

During the year, the University raised a total of \$493 million from philanthropy on an annual fundraising goal of \$310 million.¹ This amount includes \$436 million in pledges and gifts (donations) and \$57 million in philanthropic research grants from non-government sources. The Defy Gravity campaign seeks to engage 225,000 alumni in one million contributions of time and talent and to raise \$4 billion for the University’s highest priorities—a target that reflects the ambition and scale of the University’s community and its potential for global impact. From its inception on January 1, 2019 through April 30, 2026, the Defy Gravity campaign has raised \$2.75 billion dollars toward its ambitious \$4 billion goal and has surpassed 87% of its goal for alumni engagement and 98% of its goal for alumni contributions.

The Long-term Capital Appreciation Pool, which includes the University’s endowment funds, benefited from the strong performance of public market equities during fiscal year 2026, realizing a return of 14.3% (net of all fees and expenses). The UTAM managed portion of the Expendable Funds Investment Pool (EFIP) achieved a return of 3.5% (net of all fees and expenses). The primary driver of the return was the portfolio yield. Short-term EFIP investments managed by the University achieved a return of 3.3%

Endowments increased by \$547 million to \$4.5 billion this year, driven by positive investment returns of \$558 million (net of investment fees), \$100 million in endowed donations, and \$33

¹ This number includes federated universities and other affiliated institutions, but excludes donations to partner hospitals.

million in University matching funds and transfers, offset by \$144 million in distributions. In 2024, the University implemented a new Advancement Investment Model (AIM) to provide a predictable source of income that supports strategic investment in fundraising and support the University's ambitious plans to grow its annual fundraising results. In 2026, \$7.8 million, or 0.24% of the opening market value of the endowment, was directed to AIM, while the vast majority of the annual payout (\$136 million of \$144 million) was distributed to the over 7,600 individual endowment funds per normal practice. AIM is based on similar models used in other major Canadian and U.S. public and private institutions.

The University continues to be successful at generating funding for research, including support for personnel, operations, and infrastructure. Government and other grants received in 2026 for restricted purposes totaled \$675 million, including \$620 million for research and \$55 million for capital infrastructure and other purposes.

In 2026, the University paid \$2.7 billion for salaries and employee benefits comprising 60% of the University's \$4.5 billion in expenses, which is predominantly funded from University operating funds (mostly student fees and government grants).

In July 2021, the University became a member of the University Pension Plan Ontario ("UPP"), which is a jointly-sponsored multi-employer defined benefit pension plan. The University remains responsible to fund any net pension obligations related to service up to the transition date, for the first 10 years, after which the responsibility for such changes becomes gradually shared over the next 10 years with the other participants of the UPP. The net pension obligations may fluctuate in the future based on changes to the UPP's actuarial assumptions and for changes in experience in future periods. The University has set aside \$315 million in a pension special payments reserve to fund any future obligations, of which \$90 million has been transferred to the UPP for this purpose.

Additional details on expenses include:

- \$415 million for student financial support (9.2% of total expenses)
- \$334 million for materials, supplies and services (7.4% of total expenses)
- \$277 million for amortization of capital assets (6.1% of total expenses)
- \$162 million for inter-institutional contributions (3.6% of total expenses)

Highlights

Established in 1827, the University of Toronto (the “University”) is Canada’s top-ranked university, providing world-class research and teaching to over 100,000 students (over 92,000 Full-Time Equivalents of course activity) across our three campuses: downtown Toronto (“St. George”), Scarborough (“UTSC”) and Mississauga (“UTM”).

As one of the largest universities in North America, the University provides students with a broad range of academic programs and courses, while a unique college system offers the rich learning experience of small, close-knit communities. The following financial report reveals a vibrant university in positive financial shape approaching its bicentennial year in 2027.

Over the past 5 years, the University has benefited from the Ontario and Federal governments’ continued financial support for higher education and advanced research, helping to ensure access, increase graduate enrolment, and finance vital infrastructure. During that same period, the University has grown significantly, with an increase of 7.6% in the number of students.

In March 2025, the Governing Council approved the appointment of Professor Melanie Woodin as the 17th President of the University of Toronto for a five-year term, effective July 1, 2025. In her installation address on October 17, 2025, the President outlined her vision of the university as an indispensable source of resilience and strength for Canada at a time of profound social, economic, and geopolitical disruption – calling on the U of T community to “meet the moment”.

In response, the institution is focused on opportunities to address challenges that are facing the country at this moment in history: the responsible adoption of artificial intelligence, preparing graduates for a rapidly shifting economy, and mobilizing university research for economic and societal impact.

The University is also looking ahead to its Bicentennial celebrations in 2027, with a series of events throughout the year that will provide a unique opportunity to reflect, celebrate and imagine how this university – and the people who provide its energy and purpose – can continue to build on a legacy of excellence, equity, and impact.

Following the Bicentennial celebrations, the University of Toronto will launch a comprehensive, consultative long-range planning process, built with faculty, students, staff, alumni, and partners across all three campuses.

As the University builds upon its great success to date, it will continue to draw on the talent and leadership of faculty and staff, as well as the loyalty and generosity of alumni and benefactors. At the same time, the University will need strong support from government partners—at all levels—that recognize the University’s unique and critical role within Canadian higher education.

Financial Results and Challenges

The University continues to be in a strong financial position due to high demand for our programs and prudent fiscal management, resulting in substantial operating reserves and an excellent credit rating. However, the University is operating in an environment of lower revenue growth compared to the past decade, with limits on domestic and international fees. While domestic demand remains very strong, international enrolment growth plans have been recalibrated slightly to reflect a more challenging recruitment market resulting from changes to Canadian immigration policy. At the same time, despite returning to more moderate levels over the last two years, inflation continues to put pressure on divisional budgets. Current geopolitical tensions are also putting upward pressure on operating and capital expenditures (for example, through elevated fuel costs in supply chains).

In fiscal 2026, the University's net assets increased by \$890 million to a total of \$11.55 billion. The increase was primarily the result of net income of \$436 million, investment income on externally restricted endowments of \$357 million, and restricted donations to the University's endowment of \$100 million, offset by actuarial losses on employee future benefit plans of \$3 million.

The University's net income of \$436 million was driven largely by strong returns on working capital investments in the current high-interest rate environment, as well as funds set aside for future priorities in accordance with approved academic and budget plans. The positive net income also includes infrastructure costs that were capitalized and not expensed in the year, offset by amortization expense. These capital investments included projects such as:

- the Lash Miller Building expansion, Toronto High Containment Facility, Innis College expansion, Academic Wood Tower, and the new Oak House residence at the St. George campus;
- the Scarborough Academy of Medicine and Integrated Health ("SAMIH") and a new parking structure at UTSC;
- a new student residence at UTM; and
- major equipment, including acquisitions as part of Project LEAP.

Notwithstanding strong investment returns for the year, the rate of increase in revenue (1.6%) was insufficient to fully offset the rate of increase in expenses (3.7%), primarily due to ongoing inflationary impacts and compensation increases negotiated with many of the University's bargaining units. Cash flows from operations continued to be constrained at \$160 million for the year, an indication of the tightened fiscal environment on traditional revenue sources excluding income from investments.

Revenues from ancillary operations have increased for the fifth consecutive year, exceeding pre-pandemic levels for the third straight year. Net income from ancillary operations has also returned to positive levels for the last four fiscal years. An increased presence of administrative staff across the three campuses is expected to result in higher demand in areas such as food services and parking.

Statement of Operations

Over the past five years, the number of students at the University has grown by 7.6%. This substantial increase in enrolment has raised revenues from student fees and government grants while also increasing expenses in salaries and benefits, due to the resulting growth in faculty and staff and related salary increases. In turn, higher numbers of students, faculty, and staff have increased the need for construction and renovations, which impact operating expenses as well as interest and

amortization expenses. Planning for these capital infrastructure needs has included a prudent increase in financial reserves.

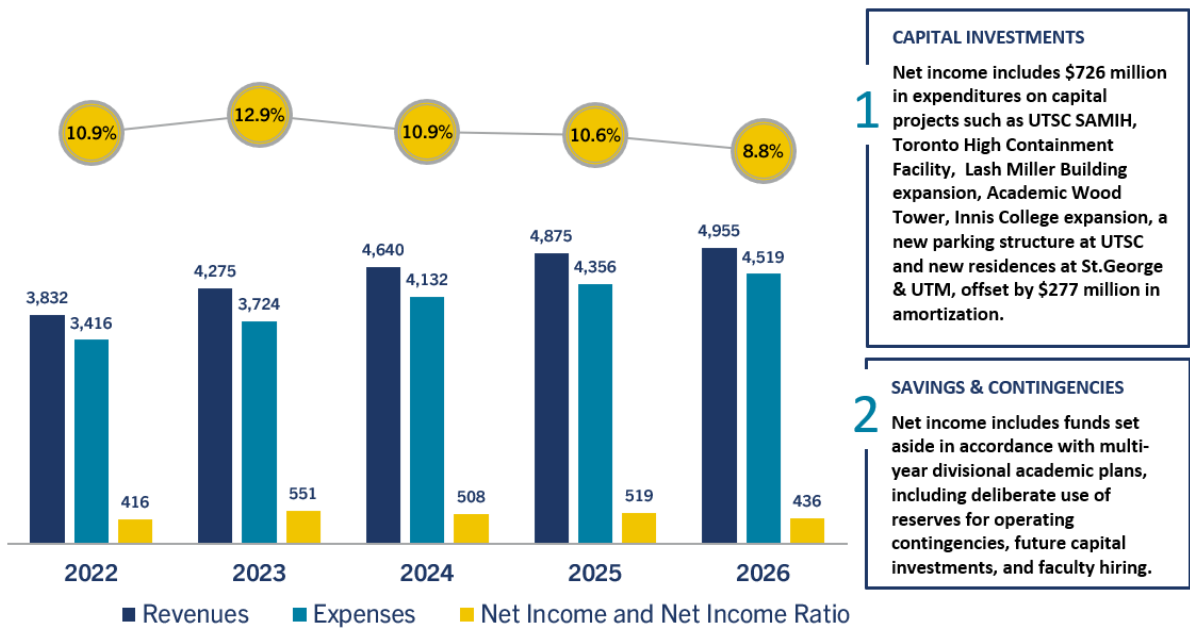
The University continues to welcome a large community of international students. Experience and data show consistently that this is an important factor in academic excellence and global competitiveness, as well as a major benefit to the regional and national economy. A diverse student body enables intercultural learning and exchange on campus. It offers all students an immersive and global education and the opportunity to be part of a global alumni network. To mitigate the ways international student recruitment can be affected by geopolitical developments, the University has successfully pursued initiatives to diversify global recruitment. Fall 2025 saw continued progress in diversifying the incoming class of international students, which included students from 132 countries. The University drew more than forty students from each of 15 different countries and less than half of total international students from any single source.

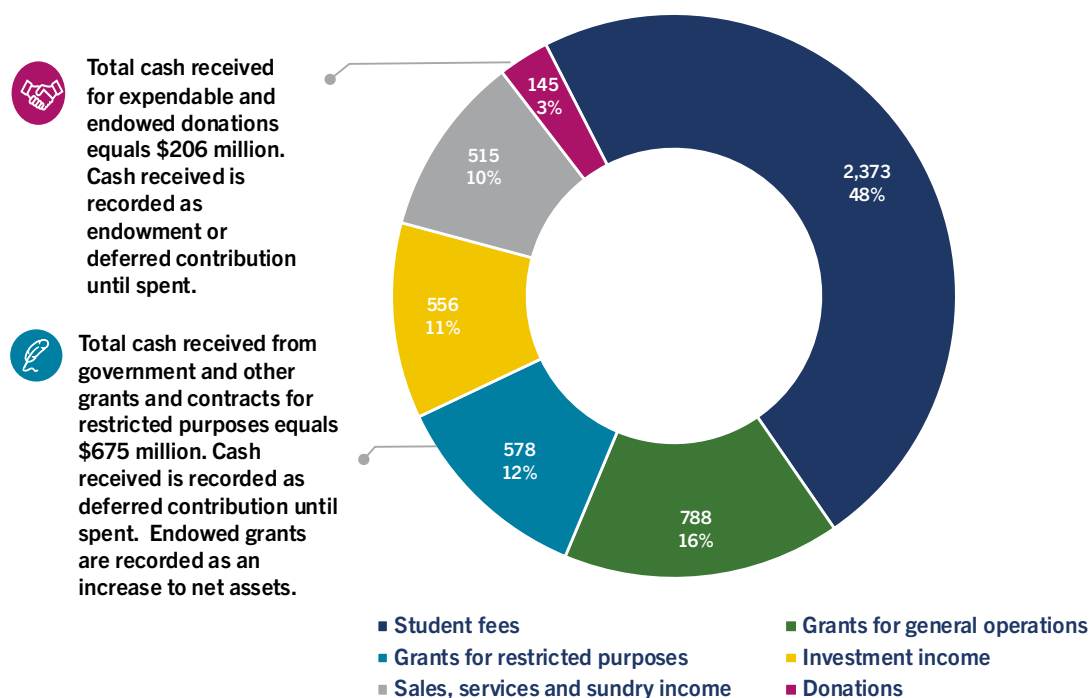
The net income of \$436 million primarily reflects strong returns on working capital investments, funds used for capital infrastructure, and funds set aside in accordance with multi-year divisional academic and budget plans. These plans call for deliberate use of reserves for operating contingencies, future capital investment in academic facilities and other amenities, endowment matching opportunities, and faculty hiring.

In 2026, \$3.16 billion or 63.8% of revenues were from student fees and government grants provided in support of student enrolments. An additional \$578 million represented government and other grants and contracts for restricted purposes. Together these three sources accounted for 75.5% of revenues for the year. As noted above, the category of sales, services, and sundry income (which includes residence, parking, and food service operations) has seen substantial improvement, in part due to increasing activity on campus.

(\$ millions) for the year ended April 30

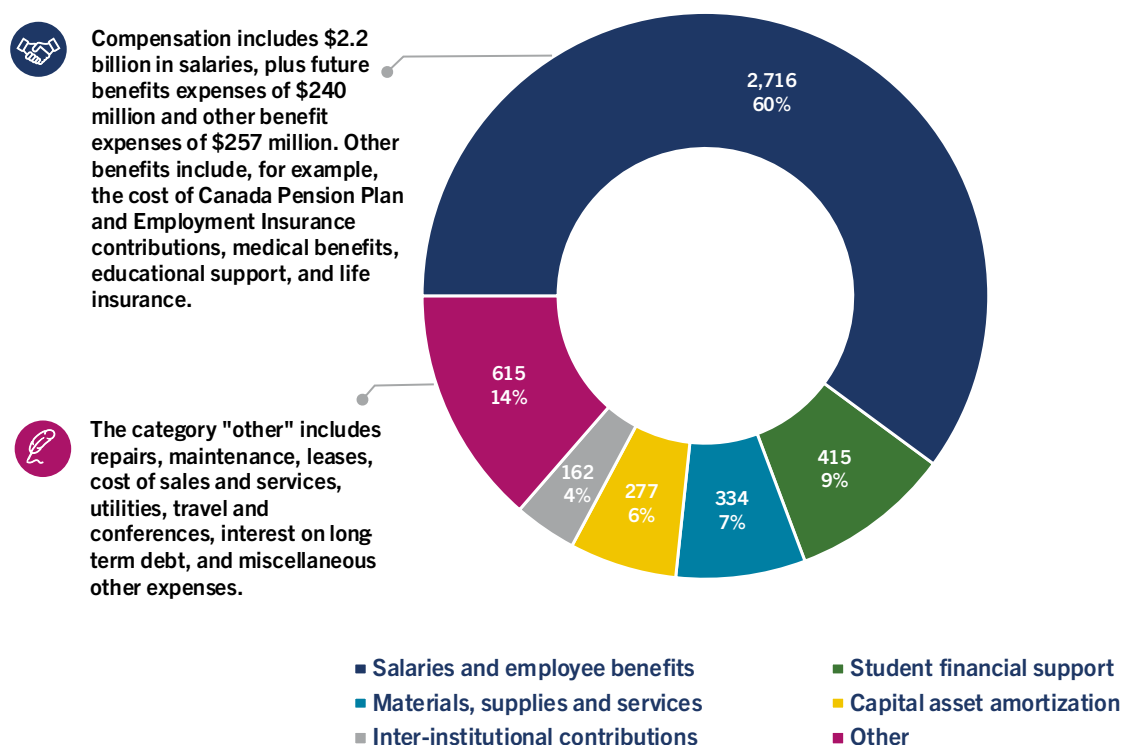


In 2026, the University incurred \$2.72 billion for salaries and employee benefits, comprising 60.1% of the University's \$4.52 billion in expenses. Faculty and staff salaries and benefits relating to teaching, research and administrative activities are predominantly funded from university operating funds (mostly student fees and government grants).¹ Additional details on expenses include:

- \$415 million for student financial support (9.2% of total expenses)
- \$334 million for materials, supplies and services (7.4% of total expenses)
- \$277 million for amortization of capital assets (6.1% of total expenses)
- \$162 million for inter-institutional contributions (3.6% of total expenses)

Balance Sheet

Financial highlights for the fiscal year ending April 30, 2026 include:

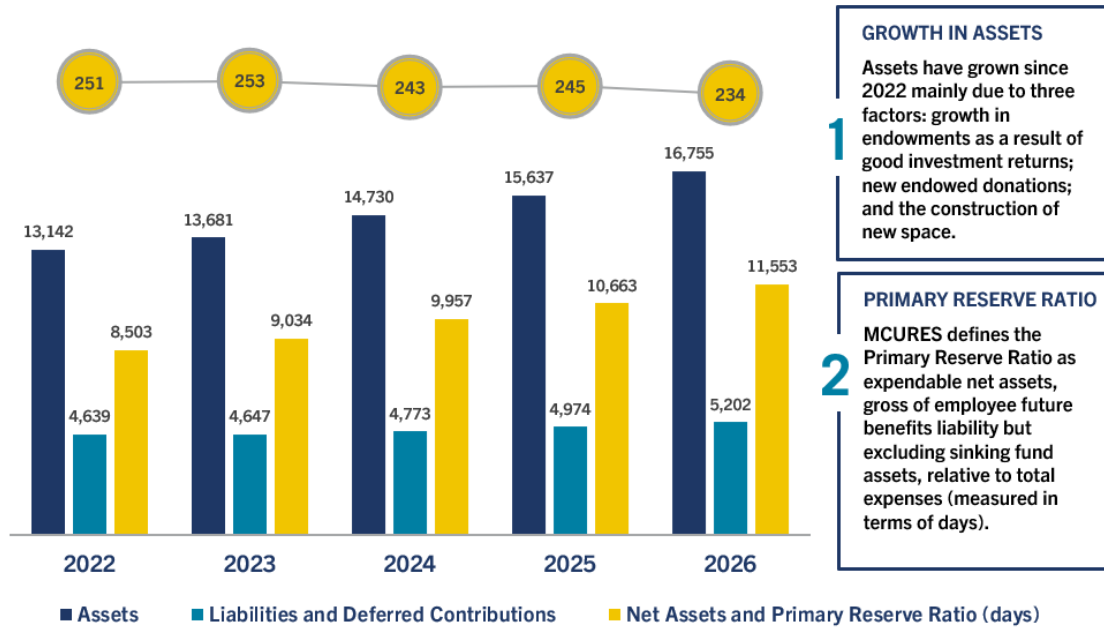

Assets have grown since 2022 mainly due to three factors: the growth in endowments as a result of investment returns; the receipt of endowed donations; and the construction of additional space to accommodate the increased number of students.

Net assets² increased by \$890 million to \$11.55 billion in 2026. This increase is mainly due to net income of \$436 million, endowed donations and grants of \$100 million, and investment gains on externally restricted endowments of \$357 million, offset by \$3 million in remeasurements on employee future benefit obligations.

² Net assets reflect the University's net worth and change over time through the net income or net loss for the year, and changes in endowments. Changes in endowments may derive from receipt of endowed donations and investment income on externally restricted endowments (representing income earned above the amount made available for spending). Such income does not flow through the consolidated statement of operations but rather is added directly to the endowment balance in accordance with current generally accepted accounting principles for not-for-profit organizations.

Net assets are composed of the following:

- \$4.48 billion of endowments, representing 38.8% of net assets,
- \$7.65 billion of internally restricted net assets, and
- (\$581 million) of deficit (primarily related to internal financing of capital construction in accordance with the University's debt strategy – see the "Debt" section below for more information).

The \$4.48 billion of endowments represent over 7,600 individual endowment funds, which are restricted by Governing Council or donor agreements to approved academic priorities. Endowment funds for student aid and support totaled \$1.9 billion in 2026.

The \$7.65 billion of internally restricted net assets comprises:

- \$2.37 billion in land
- \$2.98 billion of investment in other capital assets³
- (\$439 million) in net unfunded liability associated with pension and other employee future benefits, including the pension special payment reserve
- \$1.48 billion in capital projects and infrastructure reserves
- \$673 million of operating contingency reserves
- \$340 million in research support
- \$252 million in other reserves held for future spending

³ This figure represents internal monies previously spent by the University for capital projects which will be reduced over time as these capital assets are amortized.

Deferred contributions increased by \$33 million in 2026 to \$1.20 billion, mainly due to donations and research grants received and held for future spending. Deferred capital contributions increased by \$32 million in 2026 to \$1.31 billion, of which \$96 million remains unspent and designated for future capital projects.

Role of the Government of Ontario

The provincial government provides operating grants and regulates tuition fees for domestic students in publicly funded programs. The provincial government also invests in student financial support, research, and infrastructure.

Provincial Operating Grants

The Ontario post-secondary education system operates under a differentiation policy framework. The framework is operationalized through a series of institutional Strategic Mandate Agreements, which specify the role of each university in the system and how they will build on institutional strengths to drive system-wide objectives and government priorities.

Fiscal year 2025-26 is the first year of the University's fourth Strategic Mandate Agreement with the Province ("SMA4"), which covers the period April 1, 2025 to March 31, 2030. It largely follows the approach of SMA3 and includes the following features:

- Continuation of the performance-based funding framework but with 8 metrics, down from the 10 included in SMA3. Under SMA4, one of the two SMA3 research metrics has been eliminated and the Skills & Competencies metric has been discontinued.
- Enrolment-related metrics are focused on domestic students and exclude international.
- 5% of total funding is linked to meeting certain reporting deadlines, engaging with the Province on the refinement or development of new metrics (including around efficiencies), and attesting to a commitment to research security.

The SMA performance-based funding framework continues to be linked to 25% of operating grant funding provided to the University through mechanisms designed in collaboration with the Ministry of Colleges, Universities, Research Excellence and Security (the "Ministry") to increase predictability and minimize volatility for institutions. For funding purposes, each university is measured against its own past performance, not against other institutions. Targets are established formulaically, taking into consideration past performance and the variability of results in recent years. Each target includes a range of allowable performance outcomes, with partial funding provided if performance falls below the allowable performance range. The Ministry also added a stop-loss mechanism that limits any funding loss to a maximum of 5% for each metric in the event of a missed target.

As Canada's leading research-intensive university, performance-based funding allows the University to benchmark its strengths in areas such as innovation, research funding, and graduate employment, and have funding reflect its achievements in these areas. The University has allocated its performance-based funding envelope among eight metrics, with an option to adjust each year in response to changing priorities. The University exceeded its targets in all five years of the SMA3 evaluation period and again exceeded targets in Year 1 (2025-26) of SMA4.

The SMA4 also sets out a multi-year enrolment plan. Under the plan, the University and the Province agreed to hold constant the level of domestic undergraduate enrolment at the University of Toronto over the period of the agreement. The University has been eligible for full enrolment funding provided

it maintained a five-year average enrolment within $\pm 3\%$ of its target. This excludes separately funded enrolment expansions in nursing and the Scarborough Academy of Medicine & Integrated Health described below.

In May 2022, the Government announced funding to support the new SAMIH, which will expand enrolment in our MD, Physical Therapy, and undergraduate life sciences programs on the Scarborough campus. In addition, the physician assistant program and a portion of our nurse practitioner program will be delivered through SAMIH. In 2023, the Government announced a further expansion of some medical programs which will result in additional growth funding for spaces in health science programs.

The Government is also providing funding for the expansion of our undergraduate nursing program as part of their broader strategy to address health sector workforce shortages.

In 2024-25, the Province committed to a 7% increase in operating grant funding phased in over three years to 2026-27 through the PSE Financial Sustainability Fund. This welcome increase in grant funding is helping to offset some of the impact of the continued tuition freeze but provides growth on only 20% of budgeted operating revenues.

In February 2026, the government announced significant new investments in the postsecondary sector that will take effect in the 2026-27 fiscal year. These very welcome new investments will increase the University's funded enrolment level and overall revenues from government operating grants. Additional details are still forthcoming and will be formalized in an amendment to the SMA4 agreement in Summer 2026.

Tuition Fees and Student Aid

In January 2019, the Province mandated a 10% cut to domestic tuition fees, beginning in 2019-20, and has subsequently frozen fees at these lower levels to 2025-26 which has reduced the real value of tuition after inflation by almost 30% since 2018-19. Beginning in 2022-23, institutions have been allowed to increase domestic, out-of-province tuition by up to 5% per year, however this change has limited impact as this applies to just a small portion of the University's domestic enrolment. Tuition fees paid by international students are not regulated by the Province and have therefore been unaffected. The tuition fee freeze is applied to domestic students in Ontario enrolled in all programs that are funded via the provincial operating grant, including direct entry undergraduate, second entry and professional master's, and doctoral stream programs. In February 2026, the Province announced that universities would be allowed to increase domestic tuition fees by 2% starting in September 2026.

The impact of the 10% reduction and six-year freeze has had a differential impact across the University depending on program mix and divisional revenue sources. Strategies used to mitigate the impact included changes to faculty and staff hiring plans, deferral of capital projects, service reductions, and operating cost efficiencies.

Student fee revenue decreased slightly by \$7 million from last year to \$2.37 billion mainly because of weaker than expected international enrolment and the completion of many students from the exceptionally large incoming cohort of 2021, offset by some domestic enrolment growth.

The University remains committed to the goal of accessibility and to working with the Provincial and Federal governments to support access. Students have access to a wide range of financial supports through the University in addition to those available through government loan and grant programs like the Ontario Student Assistance Program ("OSAP"). Some are based on need, and others on

measures of merit, such as academic achievement or leadership. There are supports for international and Canadian students as well as dedicated supports for students with disabilities. In 2026, the University spent \$415 million on student financial support, a 34.3% increase from \$309 million in 2022.

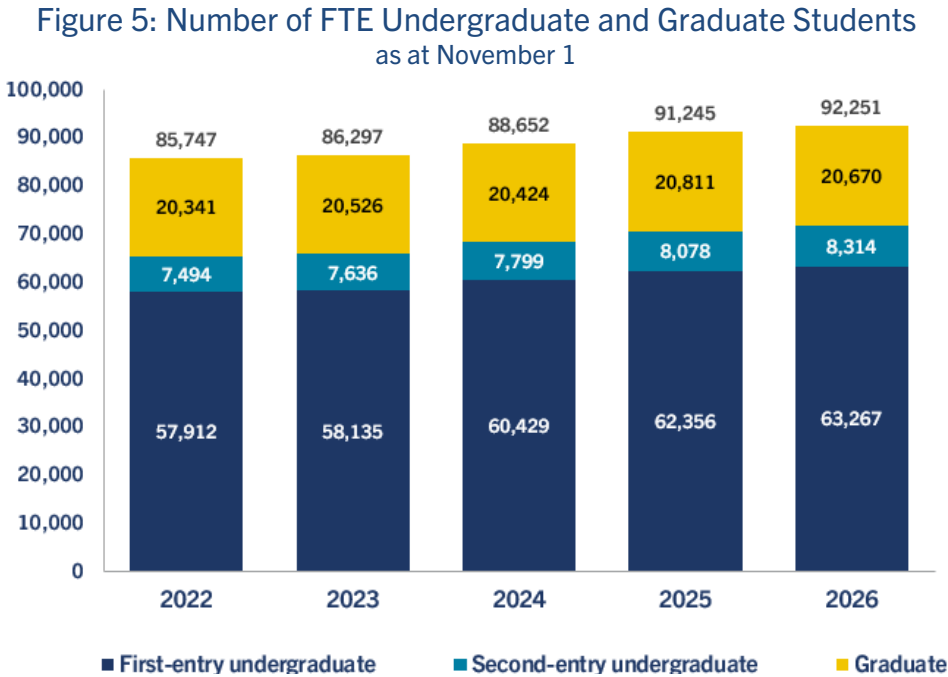
Changes to the OSAP program since 2019 have reduced the overall amount of non-repayable student aid for students and, by extension, the University’s regulatory obligation to cover unmet financial need as defined by OSAP under the Student Access Guarantee. However, the University remains firm in its internal access guarantee that financial circumstances should not stand in the way of a qualified domestic student entering or completing their degree and has provided additional needs-based support to students beyond the government requirements.

Capital Funding

The University receives funding support to help with the critical maintenance repairs, upgrades, and renewal of existing facilities through the Facilities Renewal Program (“FRP”). In 2026, the University received \$12.8 million in funding under the FRP.

Student Enrolment

Demand for student spaces has increased significantly since 2022 as a result of population growth in Ontario, increased higher education participation rates and a growing reputation around the globe as a destination of choice for international students. The University has increased enrolment to accommodate this additional student demand with student FTE enrolment increasing from 85,747 in 2022 to 92,251 in 2026, an increase of 7.6%.



Given the strong demand from domestic students and challenging international recruitment market created by the Federal Government’s changes to student permit policies, most recent growth has

been in domestic enrolments. In their February 2026 announcement, the Province indicated that it would be funding much of this achieved growth and plans to fund an additional 40,000 spaces across the college and university sectors in future years which is very welcome news. Further details on their expansion plans are anticipated in Summer 2026.

Financial Planning

The University is currently operating in a new planning environment with more constraints on revenue growth compared to the past decade. Demand for our programs continues to be strong with deep domestic and international undergraduate applicant pools. However, the seven-year cut-and-freeze to domestic tuition and frozen provincial grant funding levels have limited growth, and changes to Canada's immigration policies are creating uncertainty with international recruitment. The government's investments in operating grants and unfreezing of domestic tuition will make a difficult fiscal 2026-27 a bit easier, but they are not a panacea. With the modest tuition growth and stable grants, we do not forecast annual revenue growth much above general inflation over the next five years.

The University's 2026-27 budget includes adding about 500 domestic undergraduate spaces, primarily through the funded nursing, medicine, and SAMIH expansions, with the capacity to expand further if the Province provides additional funded spaces. Revenues are expected to increase modestly over the next several years, primarily as a result of increased government funding, a slight increase in international enrolment, planned separately funded enrolment expansion programs, and modest fee increase assumptions. Revenue growth in 2026-27 will be used primarily to address compensation and inflationary pressures, and support key institutional priorities to improve students services and supports, recruit world-class student and faculty talent, and invest in critical infrastructure.

The long-range budget plan for 2026-27 to 2030-31 was finalized before the government's February 2026 announcements and so incorporates a freeze of domestic tuition fees in 2026-27 and a 3% increase thereafter and no planned changes to government operating grants. Even with the additional funding, revenues are expected to grow by just 3.7% in 2026-27 and average around 3% over the next four years. The modest growth is a result of a recalibration of international enrolment levels to better reflect the current recruitment market, limited new domestic enrolment and limited tuition fee increases. As revenue growth slows, the University will need to continue pursuing initiatives to increase the effectiveness of service delivery and expense containment measures. To that end, the University has initiated an institution-wide administrative excellence initiative to ensure that resources are directed to the highest priorities.

Research and Capital Infrastructure

The Institutional Strategic Research Plan 2024-29 ("ISRP") guides the University's efforts to tackle global challenges. The ISRP articulates five strategic objectives that will inform and propel the University's research and innovation over the five years. Cultivating an environment to leverage opportunities and foster collaboration and partnerships is a key objective of the ISRP. Strong research funding support from the provincial and federal governments, and a broad range of other public and private sector entities, are key to the University's research and innovation preeminence, including support for research operations and infrastructure that help the University to attract and retain top research talent from across Canada and around the world.

Federal Budget 2025 announced \$1.7 billion to launch the Canada Impact+ Research Talent Initiative, a suite of programs to attract leading international researchers to Canada. The University and TAHSN hospitals received a nomination allocation envelope of \$35 million to nominate senior faculty for Canada Impact+ Research Chairs who would receive either \$500,000 or \$1 million annually for eight years if selected. For each nomination (24 for intake one) the University requested a corresponding Canada Impact+ Emerging Leader (early career researcher) position, each funded at \$100,000 per year for six years to hire an early-career researcher. Each Impact+ Research Chair also brings an infrastructure award of \$4 million to address the equipment and maintenance needs of the Chair and Emerging Leader. The results of the first intake for this program will be announced in late June 2026 and intake two in September 2026. If successful, these awards will bring significant research funding and excellent faculty to the University. The Canada Impact+ Research Training awards for PhDs and Postdoctoral Fellows are being awarded bringing \$18.32 million over 3 years to support 92 trainees. There was also protection for the three granting councils that were largely shielded from the federal overall 15% budget cuts, with reductions limited to 2%. This will impact some funding in the next fiscal year, including the Canada First Research Excellence Fund (CFREF).

University researchers, scholars and innovators are successful in securing funds from a rich array of national and international sources, including the federal and provincial governments, the not-for-profit sector, and private-sector partnerships.

One hallmark of the successful combination of the innate strength of the University research community, and the intense institutional focus, is the achievement of the goal of increased Canada Research Chair (“CRC”) allocations over five years. The University currently holds 330 CRCs, the country’s largest allocation of CRCs, spread across three campuses and fourteen fully affiliated hospitals. To increase the participation of underrepresented groups nationally in the CRC Program, institutions are required to progressively meet targets for the representation of four federally designated groups (women and gender minorities, Indigenous peoples, racialized minorities, and persons with disabilities) among their chair cohorts, leading up to a December 2029 deadline. The University is surpassing its interim targets for CRCs in all four federally designated groups and is implementing strategies to meet federal targets by 2029.

The federal Research Support Fund (“RSF”) and the Incremental Project Grant (“IPG”) contribute to the institutional (also known as “indirect”) costs of tri-agency funded research. In 2024-25, the RSF and the IPG provided critical indirect cost support of \$62.3 million. The University’s effective rate of federal indirect costs recovered from these programs has averaged around 20% over the last decade, relative to the University’s average indirect cost rate, most recently calculated to be 64.1%. The gap (currently 44%) in funding constrains our potential as an internationally competitive research institution and requires the redirection of funds to indirect costs of research from other operations. In 2024, the Federal Government announced a multi-year plan to increase funding for the IPG program for research-intensive institutions like the University of Toronto. IPG program funding will progressively grow in the next four fiscal years from \$73.8 million in 2024-25 to \$208.5 million in 2028-29 and beyond.

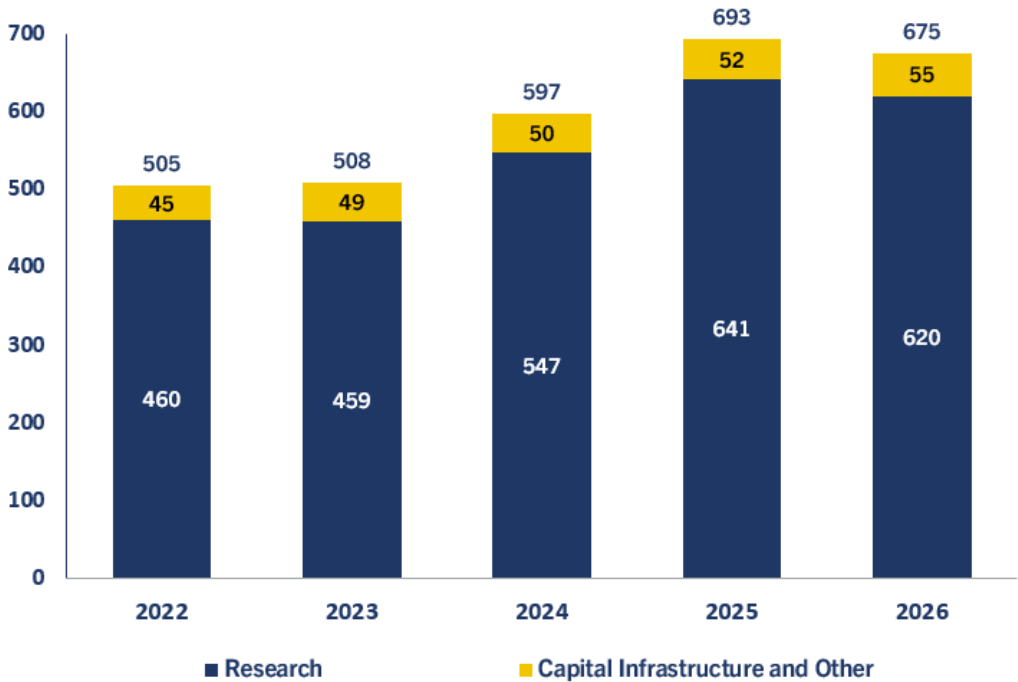
Other important government funded initiatives include the following:

- Canada’s Defence Industrial Strategy earmarks \$6.6 billion to ensure that Canadian industry plays a central role in this generational effort to rebuild the military. This includes investments in BOREALIS (Bureau of Research, Engineering and Advanced Leadership in Innovation and Science) which will better connect Canada’s innovation programs and partners – including universities– who are advancing dual-use research and innovation. The

university has already submitted proposals for Defence Innovation Secure Hubs (DISH) and expects further funding calls in late 2026.

- In November 2025, the federal government announced \$42.5 million in federal funding for state-of-the-art artificial intelligence infrastructure for SciNet at the University of Toronto. This investment was funded through the Canadian Sovereign AI Compute Strategy and is delivered via the Digital Research Alliance of Canada’s National AI Compute – Rapid Deployment initiative. The initiative aims to address the growing demand for high-performance AI computing across the country.

The University continues to be successful at generating funding for research, including support for personnel, operations, and infrastructure. These financial statements account for funds received as follows:

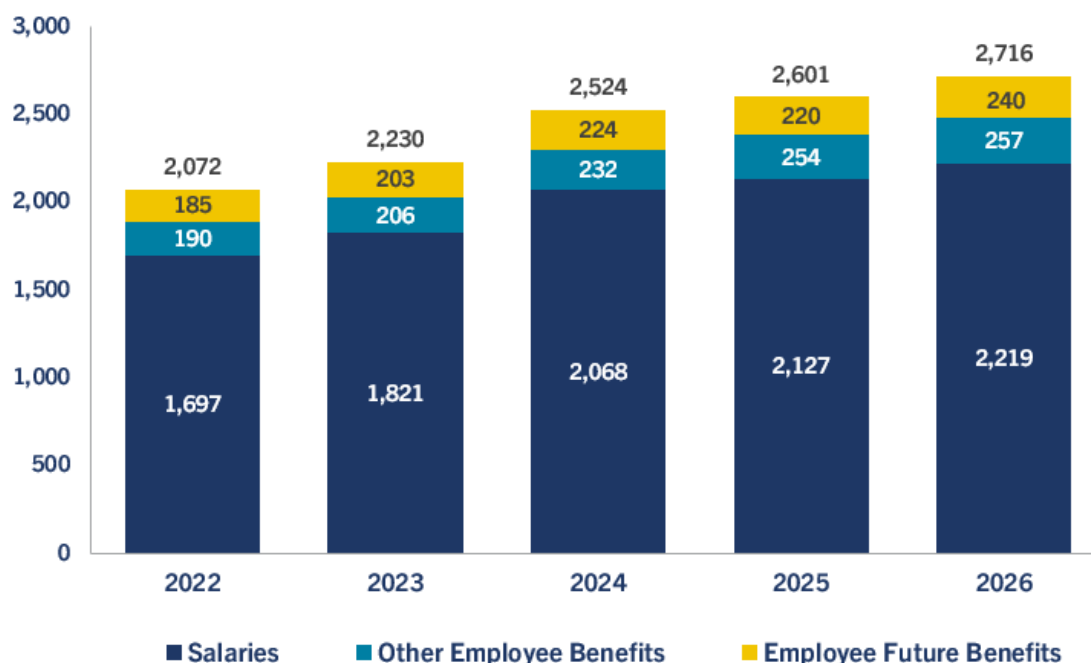
- Research grants are recorded as revenue when the related expenditures are incurred; and
- Unspent research grants are recorded as deferred contributions.

Government and other grants received in 2026 for restricted purposes totaled \$675 million, including \$620 million for research and \$55 million for capital infrastructure and other purposes. These were reported as follows: \$577 million as revenue from grants for restricted purposes and \$98 million as deferred contributions and deferred capital contributions.

Salaries and Benefits

Over the period 2022 to 2026, salaries and benefits increased from \$2.07 billion to \$2.72 billion. This is the result of negotiated compensation increases for employee groups as well as an increase of 11.5% in the total number of faculty and staff over that time period. The total cost of salaries and benefits increased by 4.4% compared to 2025.

In 2026, the University had 3,653 faculty, 168 librarians, and 9,546 administrative staff, which includes both full and part time employees.

The following are the most current agreements to April 30, 2026:

- Three-year agreement with administrative and technical staff, represented by the United Steelworkers (USW), starting July 1, 2023, to June 30, 2026, with 9% across-the-board salary increase at July 1, 2023 (including a 7% adjustment for the 3-year Bill 124 moderation period), 2% at July 1, 2024, and 1.8% at July 1, 2025.
- Previously arbitrated awards for across-the-board salary increases for the University of Toronto Faculty Association (UTFA) were 3.5% effective July 1, 2023, and 2.5% effective July 1, 2024. A further arbitrated increase of 2.5% took effect July 1, 2025, representing the third and final year of a three-year collective agreement covering the period from July 1, 2023, to June 30, 2026. The increases followed an arbitrated increase of 7% for the 3-year Bill 124 moderation period, effective July 1, 2022.

- Three-year agreement with the CUPE, Local 3902, Unit 1 representing students, mainly graduate students, working as teaching assistants, teaching laboratory assistants, markers, graders, and instructors starting January 1, 2024, to December 31, 2026. Compensation increases of 9% at January 1, 2024 (including a 7% adjustment for the 3-year Bill 124 moderation period), 2% at January 1, 2025, and 1.8% at January 1, 2026.

Employee benefits expenses of \$497 million for the year is made up of employee future benefits expenses of \$240 million and other employee benefits expenses of \$257 million.⁴ Other employee benefits expenses include, for example, the cost of legislated benefits (e.g., Canada Pension Plan and Employment Insurance), medical benefits for active staff, educational support, life insurance, and several types of leaves.

The University is a member of the University Pension Plan Ontario (“UPP”), which is a jointly sponsored multi-employer defined benefit pension plan. The UPP was formally established on January 1, 2020, to cover employees, retired employees, and other members under the existing plans at the University of Toronto, University of Guelph and Queen’s University. The assets and liabilities of the University’s registered pension plan (“RPP”) were transferred to the UPP as at July 1, 2021 (the “Effective Date”). As of the Effective Date, the accrual of benefits and contributions under the UPP commenced for members of the RPP, all of whom transferred to the UPP, and benefits and contributions under the RPP ceased. Other employee groups have joined the UPP since the effective date. The UPP reported an actuarial surplus of \$0.25 billion on a smoothed asset basis as of January 1, 2025.

The University remains responsible to fund any net pension obligations (determined based on the UPP actuarial assumptions) related to service up to the transition date of July 1, 2021, with any deficits to be funded over 15 years. These past service net pension obligations may fluctuate in the future based on changes to the UPP’s actuarial assumptions and for changes in experience in future periods, which will continue to be the responsibility of the University to fund for the first 10 years, after which the responsibility for such changes becomes gradually shared over the next 10 years with the other participants of the UPP, after which the responsibility is totally shared with all participants. The University has set aside a pension special payment reserve of \$315 million in internally restricted net assets, including payments made to the UPP totaling \$90 million as a prepayment of potential future obligations. The University does not recognize any share of the UPP’s pension surplus or deficit in its financial statements, but accounts for contributions to the UPP on a defined contribution basis.

At April 30, 2026, the accrued pension obligation of \$147 million in the University’s financial statements relates mainly to its supplemental pension arrangements. The obligation for employee future benefits other than pension at April 30, 2026 is \$806 million. The obligation is determined based on actuarial valuations using accounting assumptions. The annual current service and finance costs are included in the consolidated statement of operations and any actuarial gains or losses are recorded directly in net assets instead of being reported in the consolidated statement of operations.

⁴ Employee future benefits represent benefits to be provided to employees in the future based on service in the current year. They include pensions, long-term disability insurance, cost of living adjustments for survivor income, and medical benefits for pensioners. These are accounted for using the accrual basis of accounting and therefore reflect the cost of providing these benefits irrespective of the amount of funding provided in support of these benefits.

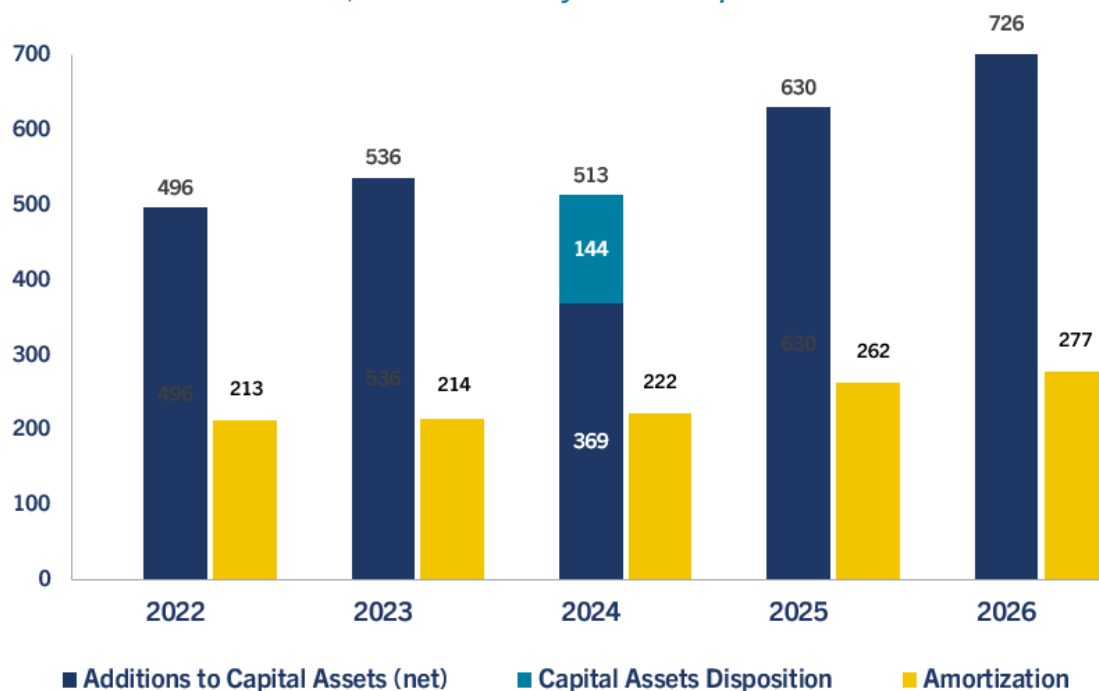

Space

The University has undertaken an ambitious capital construction program to accommodate increased numbers of students and expand and update research infrastructure. This program includes a significant expansion of the Mississauga and Scarborough campuses and further expansion and renovation on the St. George campus. Additional space requirements are partially due to growth in the numbers of graduate students and undergraduate medical students.

In 2022, the University spent an additional \$77 million on the construction of the Schwartz Reisman Innovation Campus, \$61 million on the UTM Science Building, \$46 million on the construction of the UTSC Student Residence, \$27 million on the Fitzgerald Building Revitalization, and \$21 million on the UTSC Instructional Centre II.

In 2023, the University spent an additional \$43 million on the construction of the Schwartz Reisman Innovation Campus, \$30 million on the UTM Science Building, \$43 million on the construction of the UTSC Student Residence, \$13 million on the Fitzgerald Building Revitalization, \$21 million on the Academic Wood Tower and \$47 million on the UTSC Instructional Centre II. The University also spent \$22 million on the new Oak House student residence at the St. George campus.

In 2024, the University completed construction of the Schwartz Reisman Innovation Campus (Phase 1) and spent an additional \$76 million on the construction of the UTSC Instructional Centre II, \$35 million on the new Oak House student residence at the St. George campus, \$27 million on the Academic Wood Tower, \$18 million on the UTSC SAMIH, \$13 million on the UTM Science Building, and \$10 million on the Lash Miller Building expansion. The University also completed the construction of the Harmony Commons residence at UTSC. Harmony Commons was subsequently sold to a related party for \$147 million, however, the University will continue to operate the residence for its students. The University also acquired a 20% share of the CampusOne student residence located near the St. George campus, giving access to its 890 beds.

In 2025, the University spent an additional \$21 million on the construction of the UTSC Instructional Centre II, \$58 million on a new parking structure at UTSC, \$24 million on the new Oak House student residence at the St. George campus, \$31 million on the Academic Wood Tower, \$49 million on the UTSC SAMIH, \$31 million on the Toronto High Containment Facility, \$22 million on the new residence at UTM, and \$16 million on the Lash Miller Building expansion. The University also made major equipment acquisitions including \$28 million as part of Project LEAP and \$52 million at SciNet.

In 2026, the University spent an additional \$61 million on the UTSC SAMIH, \$57 million on the new residence at UTM, \$52 million on the Lash Miller Building expansion, \$51 million on a new parking structure at UTSC, \$34 million on the Toronto High Containment Facility, \$24 million on the Innis College expansion, \$28 million on the Academic Wood Tower, and \$29 million on the new Oak House residence at the St. George campus. The University also made major equipment acquisitions, including \$41 million as part of Project LEAP.

The University's future obligations for deferred and pending maintenance of all academic and administrative buildings (excluding campus/utility infrastructure and asbestos containment and removal) across all three campuses increased by \$46 million to \$1.50 billion in 2026. Most of the growth can be attributed to two key factors - (i) persistent high inflation rates since 2020 in the local non-residential construction sector have significantly driven labour and material costs up for deferred maintenance projects; and (ii) building systems constructed during two periods of large-scale facility growth at the University in the 1960s and 2000s are simultaneously entering critical renewal periods. This obligation will continue to be managed strategically to ensure the reliability of building systems and prevent unexpected failures and incidents.

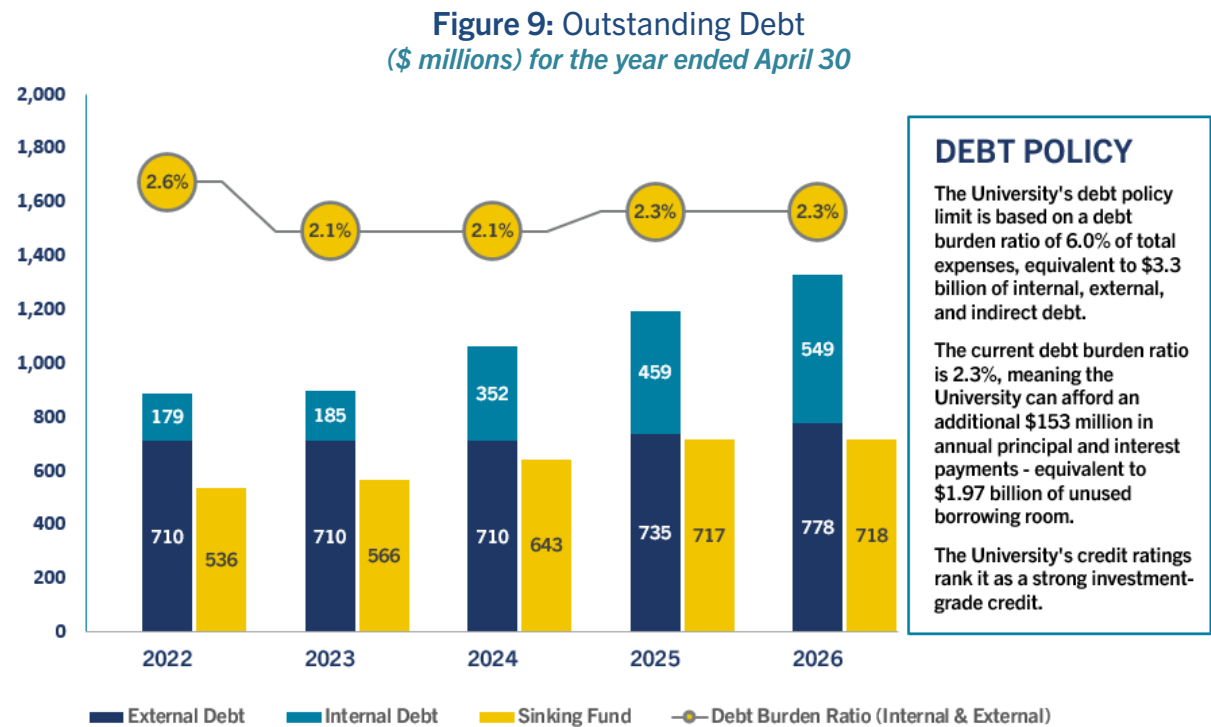
At the University, deferred maintenance is addressed directly through projects funded by a dedicated internal budget, external debt, and the FRP. Jointly, the current funding level represents 0.71% of the current total replacement value of all campus buildings, which is significantly lower than the provincial average investment of 1.49%. In February 2025, the Governing Council approved an additional one-time investment of \$350 million over the next three years to address the most pressing deferred maintenance needs across all three campuses.

To prioritize deferred maintenance projects, the University employs an evidence-based, multi-factor model. This data-driven process effectively identifies the most critical issues and ensures that it strategically invests in projects that pose the greatest risk to infrastructure and occupant experience.

The University is also planning to address deferred maintenance in the context of climate change. It is well established that climate change poses a significant risk to physical infrastructure. Decarbonization and infrastructure resilience are key prevention and mitigation strategies being employed alongside deferred maintenance. Project LEAP, a \$138 million infrastructure project which commenced in 2024, will cut emissions in half on the St. George campus by phasing out natural gas in favour of electricity in the campus’s central steam plant and carry out deep energy retrofits to some of the most energy-intensive buildings.

Debt

The University’s debt strategy sets the debt policy limit based on a debt burden ratio of 6.0% (interest plus principal repayments divided by adjusted total expenditures). The University’s definition of debt includes exposure to indirect (off balance sheet) debt held by joint venture partners. Prior to May 1, 2023, the debt policy limit was based on a debt burden ratio of 5.0%, however the definition of debt did not consider indirect debt.



The University is committed to prudently and strategically allocating debt to high priority capital projects. At a 6.0% debt burden ratio, the debt strategy provides for a total debt limit of \$3.29 billion at April 30, 2026, made up of external debt capacity of \$2.10 billion plus \$1.19 billion in internal financing. At April 30, 2026, the actual outstanding long-term debt consists of \$710 million (gross of \$1 million of issue costs and premiums) of debentures, construction credit facilities of \$68 million, and internal debt of \$549 million. At April 30, 2026, the actual debt burden ratio was 2.3%, well below the 6.0% policy limit. The University has a voluntary sinking fund in the amount of \$718 million that was established for the purposes of accumulating funds to repay the principal of the University’s debentures at maturity. In 2024, as part of Project LEAP, the University secured two new credit

facilities to fund the acquisition of clean and energy efficient equipment for use at its St. George campus in order to significantly reduce the University's annual carbon emissions. At April 30th, the University had drawn \$68 million from these facilities.

At April 30, 2026, the University's long-term credit ratings are Aa1 with stable outlook (Moody's Investors Service), AA+ with stable outlook (S & P Global Ratings), and AA with stable trends (DBRS Morningstar), which ranks the University as a strong investment-grade credit. All credit rating agencies rate the University at or above the Province of Ontario.

Donations

All fundraising conducted on behalf of the University's faculties, colleges, schools, and divisions is done in service to academic plans and priorities approved by the Provost with the involvement of Principals, Deans and faculty.

Immediately following the successful closure of the Boundless campaign on December 31, 2018, with \$2.64 billion raised, the University entered the quiet phase of the Defy Gravity campaign that will elevate the University's position as one of the world's leading public universities and advance the University community's outsized impact in solving complex social, economic, and health problems. The campaign will also seek to engage 225,000 alumni in one million contributions of time and talent and to raise \$4 billion for the University's highest priorities—a target that reflects the ambition and scale of the University's community and its potential for global impact. From its inception on January 1, 2019 through April 30, 2026, the Defy Gravity campaign has raised \$2.75 billion dollars toward its ambitious \$4 billion goal and has surpassed 87% of its goal for alumni engagement and 98% of its goal for alumni contributions.

For the period May 1, 2025 to April 30, 2026, the University raised a total of \$493 million on an annual fundraising goal of \$310 million.⁵ This amount includes \$436 million in pledges and gifts (donations) and \$57 million in philanthropic research grants from non-government sources.

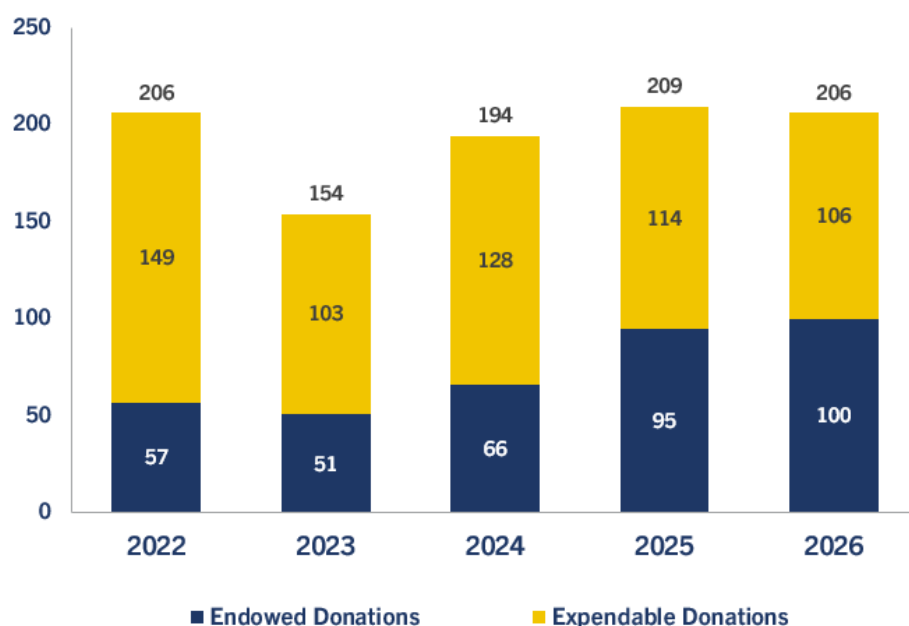

Donations⁶ are recorded in the financial statements as follows:

- Unrestricted expendable donations are recorded as revenue when received
- Restricted expendable donations are recorded as revenue when the related expenditures are incurred
- Unspent restricted expendable donations are recorded as liabilities (deferred contributions or deferred capital contributions)
- Endowed donations are not recorded as revenue, rather, they are added directly to endowments, as additions to net assets.

In 2026, donations received by the University (excluding receipts by the federated universities, other affiliated institutions, philanthropic research grants and donations to partner hospitals) totaled \$206 million and were reported as follows: \$145 million in expendable donations was reported as revenue, of which \$106 million was received in the current year and \$39 million was received and deferred in prior years, and \$100 million was added directly to endowments. It should be noted that the following graph tracks donations received by fiscal year. There is usually a lag between the growth in pledges and related commitments, and the actual cash receipt of funds.

Endowments

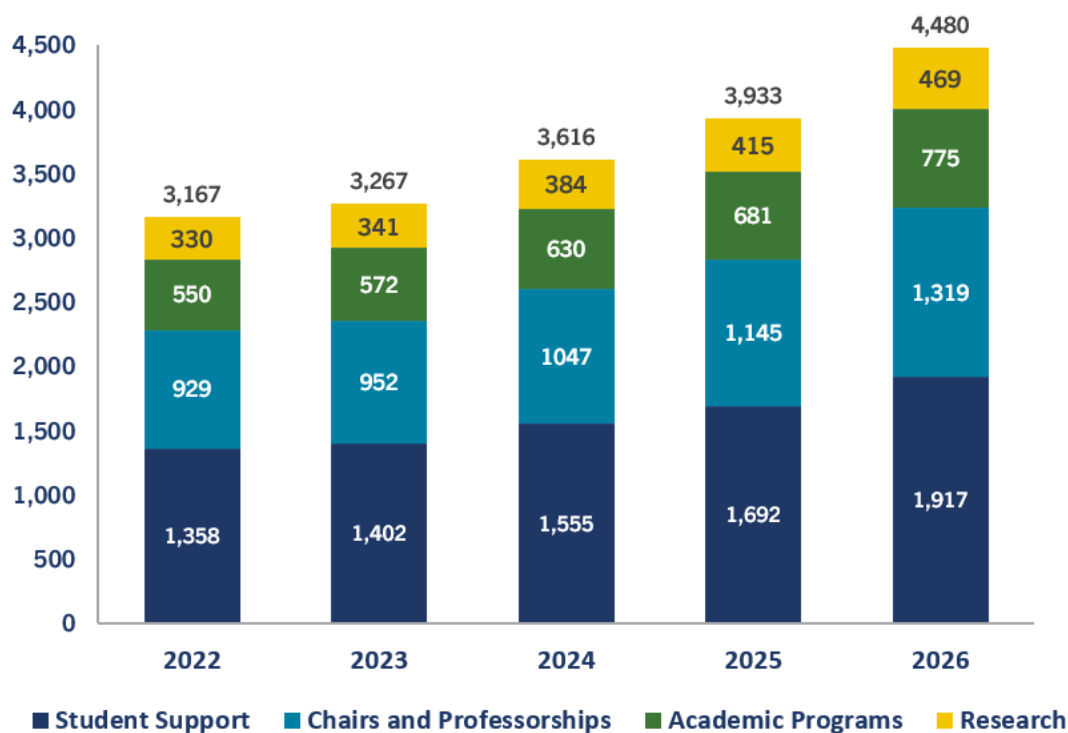
Endowments are funds that are subject to restrictions relating both to capital and to investment earnings. The investment income earned on endowments is subject to the University's preservation

⁶ Donations revenue recorded in the University's financial statements does not include donations to the federated universities: Victoria University, University of St. Michael's College, and The University of Trinity College. Nor does it include philanthropic research grants, which are recorded as government and other grants revenue for restricted purposes.

of capital policy and must be used in accordance with purposes jointly agreed upon by the University and donors, or as determined by Governing Council. Endowments are not available for use in support of general operating activities.

At April 30, 2026, there were more than 7,600 individual endowment funds, usually supported by an agreement between the University and a donor or reflecting a collection of small donations with common restrictions. The University’s endowment market value was \$4.48 billion (compared to book value of \$3.47 billion including full inflation protection of \$1.06 billion). This leaves a preservation above inflation (provision for investment return fluctuations) of \$1.01 billion against a possible future market downturn. The majority of endowments are in support of student aid (\$1.92 billion) and chairs and professorships (\$1.32 billion).

Endowments are managed in a unitized pool with an annual spending rate. The University’s endowment spending objective is to provide a predictable amount for spending (payout) each year that increases with inflation. To do this, the University preserves capital by constraining the annual spending rate and setting funds aside when investment returns are good. This strategy protects against inflation and creates a provision for investment return fluctuations from which funds can be released to maintain spending when there is a moderate downturn in the financial markets. The annual spending rate is expected to be between 3% and 5% of the opening market value of endowments. In 2024, the University implemented an Advancement Investment Model (AIM) to provide a predictable source of income that supports strategic investment in fundraising and the University’s ambitious plans to grow its annual fundraising results. AIM includes an annual levy on the endowment payout. In 2026, \$7.8 million, or 0.24% of the opening market value of the

endowment, was directed to AIM, while the vast majority of the annual payout (\$136 million of \$144 million) will be distributed to individual endowment funds per normal practice. AIM is based on similar models used in other major Canadian and U.S. public and private institutions.

In fiscal 2026, the total fair value of endowments increased by \$547 million as follows:

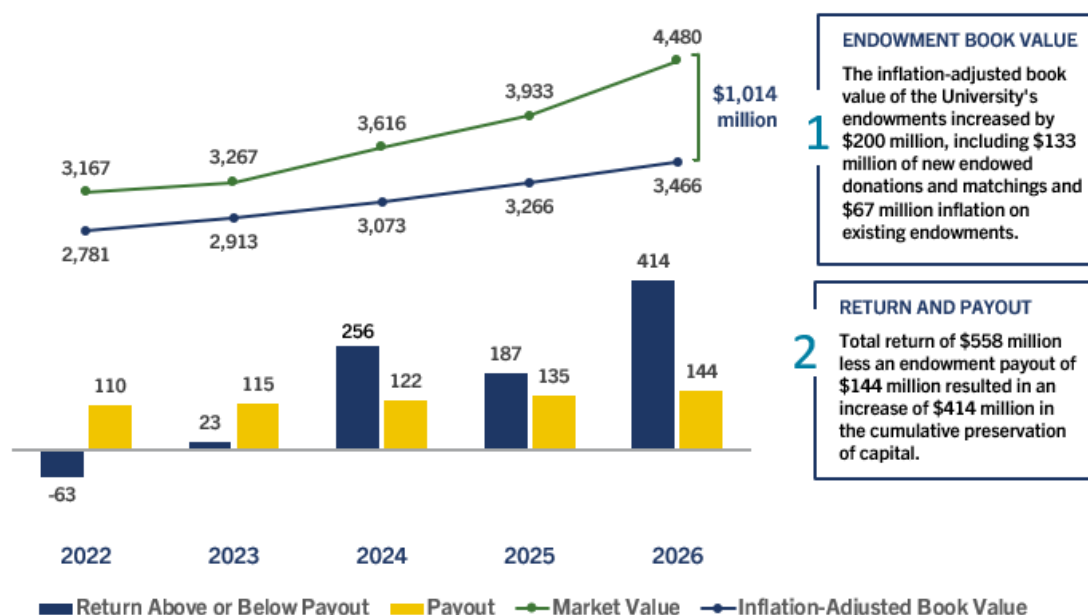
- \$357 million increase on externally restricted endowments, consisting of a \$482 million investment gain and a \$125 million withdrawal for payout
- \$57 million increase on internally restricted endowments, consisting of a \$76 million investment gain and a \$19 million withdrawal for payout
- \$100 million of externally endowed donations and grants
- \$33 million transfer into endowments

In fiscal 2025, the total fair value of endowments increased by \$317 million as follows:

- \$161 million increase on externally restricted endowments, consisting of a \$278 million investment gain and a \$117 million withdrawal for payout
- \$26 million increase on internally restricted endowments, consisting of a \$44 million investment gain and an \$18 million withdrawal for payout
- \$95 million of externally endowed donations and grants
- \$35 million transfer into endowments

(\$ millions) for the year ended April 30

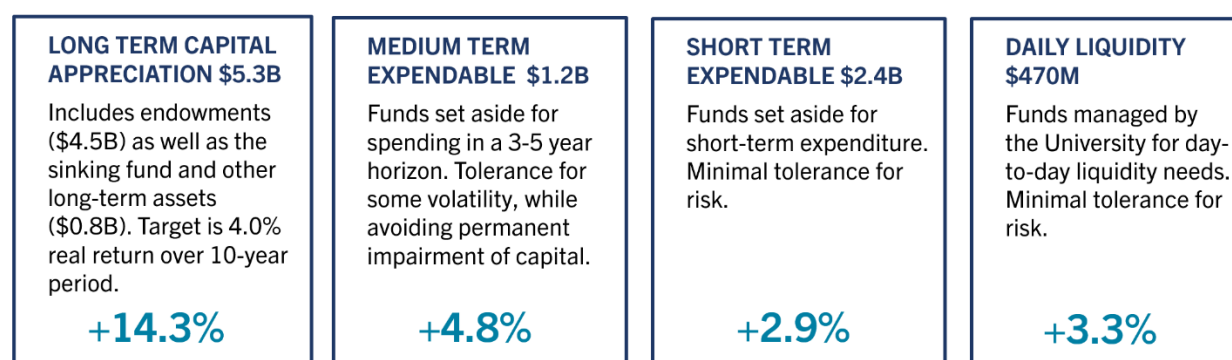


Investment Earnings

Total investment earnings for the year amounted to \$913 million (gross of \$76 million in fees and other expenses) consisting of \$612 million gain on investments held for endowments and \$301 million gain on other investments. These earnings were recorded in the financial statements as follows:

- \$612 million gains on investments held for endowments (gross of \$54 million in fees and other expenses), of which:
 - \$357 million investment gain was recorded as a direct increase to endowments in the consolidated statement of changes in net assets
 - \$255 million was recorded as investment income in the consolidated statement of operations, of which
 - \$144 million was made available for spending
 - \$54 million in fees and other expenses
 - \$57 million gain on internally restricted endowments
- \$301 million gain on other investments (gross of \$22 million in fees and other expenses) was recorded as an increase of investment income in the consolidated statement of operations

RISK TOLERANCE AND RETURN OBJECTIVES

The University establishes the investment risk and return objectives for each of these pools via the University Funds Investment Policy, which is approved by the Business Board. These objectives reflect the University's liability requirements and aim to produce balanced, secure returns for the University over time.

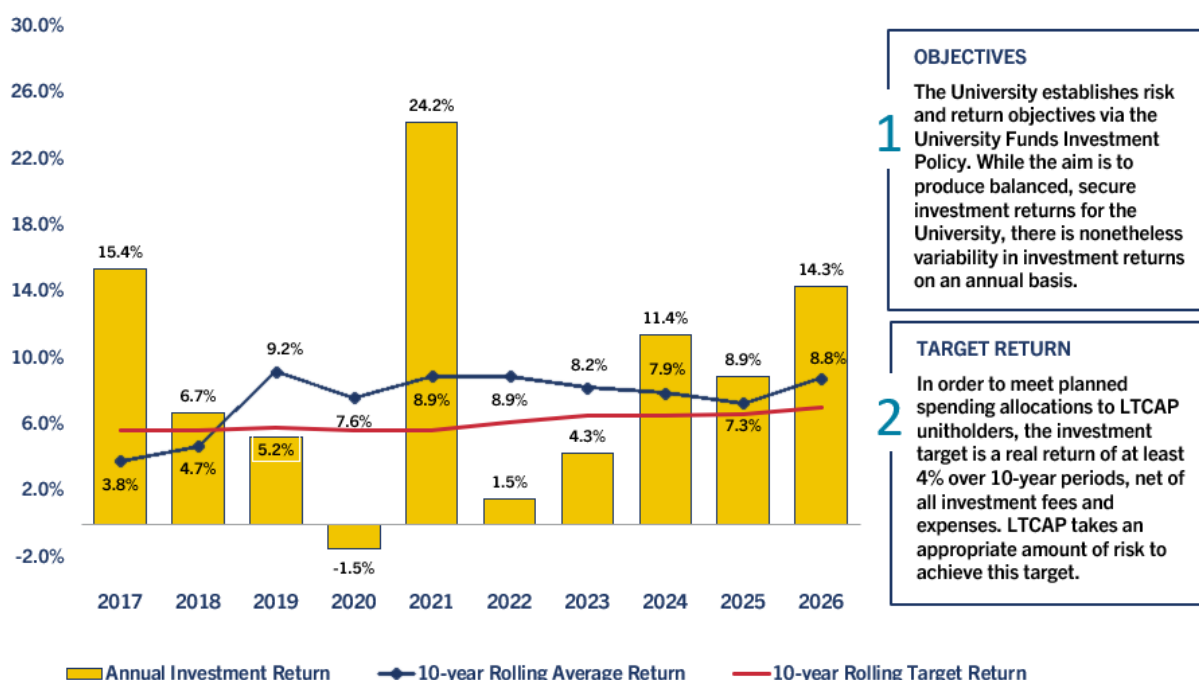
Almost all of the University's investments are invested in the long-term capital appreciation pool ("LTCAP") or the expendable funds investment pool ("EFIP"). The University establishes the investment risk and return objectives for each of these pools via the University Funds Investment Policy, which is approved by the Business Board. These objectives reflect the liability requirements and aim to produce balanced, secure returns for the University. Nonetheless, there is variability in investment returns on an annual basis. The actual investment return is a key determinant of whether the University records a net income or a net loss for the year.

Long-term Capital Appreciation Pool

The fair value of LTCAP was \$5.31 billion at April 30, 2026, of which \$4.48 billion was for endowments, representing 84.4% of the balance invested in LTCAP.

In order to meet planned spending allocations to LTCAP unitholders, the investment target is a real investment return of at least 4% over 10-year periods, net of all investment fees and expenses. The University evaluates the long-term investment performance for the LTCAP against the target investment return and risk limits, as well as against the returns of a benchmark Reference Portfolio. The primary objective for LTCAP is to achieve its target investment return over the long term, while controlling risk within the specified risk limits. The Reference Portfolio serves as an objective yardstick for measuring the value gained or lost through the University of Toronto Asset Management Corporation's ("UTAM") investment management activities compared to the investment returns that would be available in the capital markets using a low-cost, public market passive investment approach with the same long-term return objective as LTCAP and similar long-term risk. Despite continued volatility in capital markets, geopolitical and economic uncertainty, LTCAP realized a return of 14.3% (net of all fees and expenses, including UTAM costs) during fiscal year 2026. LTCAP's fiscal year return benefited from the strong performance of public market equities. Over the same period, the Reference Portfolio returned 17.3%. Over a longer horizon, LTCAP outperformed both the Reference Portfolio as well as its Target Return over the 10-year period ending April 30, 2026.

Expendable Funds Investment Pool

The investment policy for EFIP reflects very short-term investments managed by the University and short-term and medium-term portfolios managed by UTAM.

EFIP is invested in fixed income instruments, including bonds, fixed income derivatives, as well as cash and cash equivalent instruments. Fixed income investments are sensitive to interest rate movements, where, all things equal, they are subject to mark-to-market gains when interest rates decrease, and mark-to-market losses when interest rates increase. During the fiscal year, the UTAM-managed EFIP portfolios achieved a return of 3.5% (net of all fees and expenses including UTAM costs). The primary driver of the return was the portfolio yield. Over the same period, the EFIP benchmark recorded a return of 2.9%.

The EFIP short-term portfolio is invested in total return swaps that reference a Canadian short-term fixed income index, as well as in cash and cash equivalent instruments. The duration of this portfolio was approximately 1.5 years at the end of the fiscal year.⁷ Overall, the EFIP short-term portfolio realized a return of 2.9% (net of all fees and expenses) during the fiscal year, which compared to its benchmark return of 2.4% over the same period. Both the total return swaps and the cash and cash equivalent instruments generated positive returns during the period.

The EFIP medium-term portfolio is invested in longer-term fixed-income securities compared to the short-term portfolio. The duration of this portfolio was approximately 3.7 years at the end of the fiscal year. During the fiscal year, the portfolio achieved a return of 4.8% (net of all fees and expenses). The return was driven by the portfolio yield and strong active manager performance. The EFIP medium-term portfolio benchmark returned 4.2% in the fiscal year.

The return objective and risk tolerance for each category of EFIP funds (excluding funds loaned internally) as at April 30, 2026 is as follows:

⁷ Duration is a measure of interest rate sensitivity of the price of a fixed income instrument. Duration is primarily impacted by a fixed income security's coupon rate, yield and remaining time to maturity. All things equal, an immediate increase/decrease in interest rates of 100 bps (1%) would result in a fixed income instrument with a duration of 5 years losing/gaining 5% of its value (i.e., the loss/ gain would be equivalent to its duration).

Responsible Investing

UTAM is the investment manager for the University's LTCAP and EFIP portfolios. UTAM incorporates environmental, social and governance (ESG) factors into its investment decision-making, stewardship activities (engagement, proxy voting and advocacy), and reporting and disclosure. The University believes that ESG factors can have a material impact on the long-term risk and return of a given investment and that incorporating relevant and material ESG issues into the decision-making processes is consistent with the University's fiduciary duty.

A key component of the University of Toronto's 2021 climate announcement was the commitment to net zero emissions in the LTCAP portfolio by 2050. This commitment coincided with UTAM joining the Net-Zero Asset Owner Alliance. The Alliance has established a framework for setting interim targets on various decarbonization initiatives to guide members in achieving net zero emissions in their portfolios by 2050. In accordance with the Alliance's Target Setting Protocol, in 2022 UTAM established interim targets with respect to emissions, engagement and transition financing.

For example, in 2022, UTAM announced a new carbon footprint reduction target for the equity, equity-like and corporate bond component of the LTCAP portfolio - a 50% reduction by 2030, using 2019 baseline levels. UTAM reports its progress towards this new carbon reduction target annually in its [Carbon Footprint Report](#)⁸.

Statement of Administrative Responsibility

The administration has prepared the consolidated financial statements in accordance with Canadian accounting standards for not-for-profit organizations developed by the Chartered Professional Accountants of Canada. The administration believes that the consolidated financial statements present fairly the University’s consolidated financial position as at April 30, 2026, and its consolidated results of operations and its consolidated cash flows for the year then ended. In order to achieve the objective of fair presentation in all material respects, reasonable estimates and judgments were employed. Additionally, management has ensured that financial information presented elsewhere in this Financial Report has been prepared in a manner consistent with that in the consolidated financial statements.

In fulfilling its responsibilities and recognizing the limits inherent in all systems, the administration has developed and maintains a system of internal controls designed to provide reasonable assurance that University assets are safeguarded from permanent loss and that the accounting records are a reliable basis for the preparation of consolidated financial statements.

Aon has been retained by the University in order to provide an estimate of the University’s liability for pension and other employee future benefits. Management has provided the valuation actuary with the information necessary for the completion of the University’s actuarial report and retains ultimate responsibility for the determination and estimation of the pension and other employee future benefits liabilities reported.

Governing Council carries out its responsibility for review of the consolidated financial statements and this Financial Report principally through the Business Board and its Audit Committee. The members of the Audit Committee are not officers or employees of the University. The Audit Committee meets regularly with the administration, as well as the internal auditors and the external auditors, to discuss the results of audit examinations and financial reporting matters, and to satisfy itself that each party is properly discharging its responsibilities. The auditors have full access to the Audit Committee with and without the presence of the administration.

The consolidated financial statements as at and for the year ended April 30, 2026 have been reported on by Ernst & Young LLP, the auditors appointed by Governing Council. The independent auditor’s report outlines the scope of their audit and their opinion on the presentation of the information included in the consolidated financial statements.

Independent Auditor's Report

To the Members of the **Governing Council of the University of Toronto**:

Opinion

We have audited the consolidated financial statements of the **Governing Council of the University of Toronto** and its subsidiaries (the "University"), which comprise the consolidated balance sheet as at April 30, 2026, and the consolidated statement of operations, consolidated statement of changes in net assets and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying consolidated financial statements present fairly, in all material respects, the consolidated financial position of the University as at April 30, 2026, and its consolidated results of operations and its consolidated cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the consolidated financial statements* section of our report. We are independent of the University in accordance with the ethical requirements that are relevant to our audit of the consolidated financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other information

Management is responsible for the other information. The other information comprises the information included in the Financial Report, but does not include the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information, and in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements, or our knowledge obtained in the audit or otherwise appears to be materially misstated.

We obtained the Financial Report prior to the date of this auditor's report. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact in this auditor's report. We have nothing to report in this regard.

Responsibilities of management and those charged with governance for the consolidated financial statements

Management is responsible for the preparation and fair presentation of the consolidated financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of

consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, management is responsible for assessing the University's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the University or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the University's financial reporting process.

Auditor's responsibilities for the audit of the consolidated financial statements

Our objectives are to obtain reasonable assurance about whether the consolidated financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the University's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the University's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the consolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the University to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

- Plan and perform the group audit to obtain sufficient appropriate audit evidence regarding the financial information of the entities or business units within the University as a basis for forming an opinion on the group consolidated financial statements. We are responsible for the direction, supervision and review of the audit work performed for purposes of the group audit. We remain solely responsible for our audit opinion.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

Notes to the Consolidated Financial Statements

(All tabular amounts are in millions of dollars unless otherwise indicated)

1. Description

The Governing Council of the University of Toronto, which operates under the name University of Toronto (the “University”), is a corporation under the University of Toronto Act, a statute of the Legislative Assembly of Ontario. The University is an institution dedicated to providing post-secondary education and to conducting research. The University’s vision is to be a leader among the world’s best public universities in its discovery, preservation and sharing of knowledge through its teaching and research, and its commitment to excellence and equity.

These consolidated financial statements include the assets, liabilities, revenues, expenses, and other transactions of all the operations and organizations, including wholly owned subsidiaries, under the jurisdiction of Governing Council. These consolidated financial statements do not include the assets, liabilities and operations of Victoria University, The University of Trinity College, University of St. Michael’s College, Sunnybrook Health Sciences Centre (“Sunnybrook”) and the affiliated colleges under the memorandum of agreement with the Toronto School of Theology, each of which is a separate, non-controlled corporate body with separate financial statements.

The University holds title to the land and original buildings of Sunnybrook. The land and original buildings were acquired for the sum of one dollar and are used for hospital purposes, and for related medical research and teaching purposes. The property is leased to the Board of Directors of Sunnybrook, a separate corporation, under a ground lease, which is perpetually renewable every 21 years at the option of the Board of Directors of Sunnybrook.

The University is a registered charitable organization and, as such, is exempt from income taxes under the *Income Tax Act* (Canada).

2. Summary of significant accounting policies

These consolidated financial statements have been prepared in accordance with Part III of the *CPA Canada Handbook – Accounting*, which sets out generally accepted accounting principles (“GAAP”) for not-for-profit organizations in Canada and includes the significant accounting policies summarized below:

a. Investments and investment income

Investments are carried at fair value except for the real estate directly held by the University for investment purposes. Fair value amounts represent estimates of the consideration that would be agreed on between knowledgeable, willing parties who are under no compulsion to act. It is best evidenced by a quoted market price if one exists. The calculation of estimated fair value is based upon market conditions at a specific point in time and may not be reflective of future fair values.

The value of investments recorded in the consolidated financial statements is determined as follows:

- i. Short-term notes and treasury bills are valued based on cost plus accrued interest, which approximates fair value. Money market funds are valued based on closing quoted market prices.

- ii. Bonds and publicly traded equities are valued based on quoted market prices. If quoted market prices are not available for bonds, estimated values are calculated using discounted cash flows based on current market yields and comparable securities, as appropriate.
- iii. Investments in pooled funds (other than private investment interests and hedge funds) are valued at their reported net asset value per unit.
- iv. Hedge funds are valued based on the most recently available reported net asset value per unit, adjusted for the expected rate of return of the fund through April 30. The University believes the carrying amount of these financial instruments is a reasonable estimate of fair value.
- v. Private investment interests consisting of private investments and real assets comprise private externally managed pooled funds with underlying investments in equities, debt, real estate assets, infrastructure assets and commodities. The investment managers of these interests perform and provide valuations of the underlying investments on a periodic basis. Annual financial statements of the private investment interests are audited and are also provided by the investment managers. The value of the investments in these interests is based on the latest valuations provided (typically December 31), adjusted for subsequent cash receipts and distributions from the fund, and cash disbursements to the fund through April 30. The University believes that the carrying amount of these financial instruments is a reasonable estimate of fair value. Because private investments are not readily traded, their estimated values are subject to uncertainty and therefore may differ from the value that would have been used had a ready market for such investments existed.
- vi. Real estate directly held by the University for investment purposes is originally valued at cost and, when donated, at the value determined through an appraisal process at the date of donation. Subsequently, real estate is valued at cost less any provision for impairment.

Investment transactions are recorded on a trade date basis and transaction costs are expensed as incurred.

Investment income is recorded on an accrual basis, consisting of interest, dividends, income distributions from pooled funds, and realized and unrealized gains and losses. Investment income is recorded as revenue in the consolidated statement of operations except for investment income earned on externally restricted endowments, for which only the amount made available for spending is recorded as revenue. In years where the investment income earned is more than the amount made available for spending, the excess is recorded as a direct increase in endowments. In years where the investment income earned is below the amount made available for spending, the shortfall is recorded as a direct decrease in endowments.

b. Derivative financial instruments

Derivative financial instruments are used to manage particular market and currency exposures for risk management purposes primarily with respect to the University's investments and as a substitute for more traditional investments, and for the University's floating rate long-term debt. Derivative financial instruments and synthetic products that may be employed include bonds, equity and currency futures, options, swaps and forward contracts. The majority of the notional exposure of the derivative financial instruments (except for currency derivatives) is backed by liquid assets (short-term investments), reducing the use of leverage. The fair value of derivative financial instruments reflects the daily quoted market amount of those instruments, thereby taking into account the

current unrealized gains or losses on open contracts. Investment dealer quotes or quotes from a bank are available for substantially all the University's derivative financial instruments.

Derivative financial instruments are carried at fair value, with changes in fair value during the year recorded in the consolidated statement of operations.

c. Investments in significantly influenced entities and interests in joint venture arrangements

Joint ventures and investments in for-profit entities subject to significant influence are accounted for using either the equity method or proportionate consolidation based on the degree of economic and operational integration with the University's core activities. The proportionate consolidation method has been adopted where it most appropriately reflects the substance of the University's higher ongoing involvement and degree of exposure to the assets, liabilities and risks of the joint venture. Otherwise, the equity method has been adopted.

The following investments are accounted for using the equity method, whereby the investment is initially recorded at cost, net of any impairment and adjusted thereafter for the University's share of the entity's net surplus or deficit and any further impairments, and reduced by any distributions received:

- (i) CampusOne Student Residence
- (ii) UTSC Residence Limited Partnership
- (iii) The Toronto Pan Am Sports Centre Inc.
- (iv) MaRS Phase 2 Investment Trust

The following investment is accounted for using proportionate consolidation, whereby the University's pro rata share of each of the assets, liabilities, revenues and expenses that are subject to joint control is combined on a line-by-line basis with similar items in the these consolidated financial statements and inter-organizational balances and transactions are eliminated to the extent of the University's proportionate interest:

- (i) Spadina Sussex University Residence Co-tenancy

d. Senior unsecured debentures and other long-term debt

Senior unsecured debentures and other long-term debt are initially recorded at fair value and subsequently measured at amortized cost using the effective interest rate method. Senior unsecured debentures and other long-term debt are reported net of related premiums, discounts and transaction issue costs.

e. Other financial instruments

Other financial instruments, including cash and cash equivalents, accounts receivable, loans receivable and accounts payable and accrued liabilities, are initially recorded at their fair value and are subsequently measured at their amortized cost, net of any provisions for impairment.

f. Cash and cash equivalents

Cash and cash equivalents consist of balances with banks and highly liquid investments that are readily convertible to known amounts of cash and are subject to an insignificant risk of changes in value. An investment qualifies as a cash equivalent when it has a short maturity of approximately three months or less from the date of acquisition. Cash and investments meeting the definition of

cash and cash equivalents held for investing rather than liquidity purposes are classified as investments.

g. Inventory valuation

Retail inventories are carried at the lower of cost, determined using the first-in, first-out method, and net realizable value.

h. Employee benefit plans

i. Pension plans

The University is a member of the University Pension Plan Ontario (“UPP”), which is a multi-employer jointly sponsored, defined benefit plan. The University does not recognize any share of the UPP’s pension surplus or deficit as insufficient information is available to identify the University’s share of the underlying pension assets and liabilities. The University also accounts for its contributions to the UPP on a defined contribution basis. The University’s contributions are expensed in the period they come due.

The University also provides an unfunded and unregistered Supplementary Account Plan (“SAP”). The SAP is a defined contribution arrangement established to provide retirement income on the portion of eligible members’ (faculty members, librarians, and professional or managerial staff, who are active members of the UPP) salary that is not covered by the UPP, up to a specified cap. The contribution of 10% of the eligible salary and the investment return based on the annual investment return (net of fees and expenses) earned under the UPP are expensed in the year they are earned by eligible members and credited to each member’s notional account.

Prior to the SAP, the University had a Supplemental Retirement Arrangement (“SRA”), an unfunded and unregistered arrangement that is now closed for future accruals. The SRA provided defined benefits for retired and deferred vested members whose benefits exceeded the *Income Tax Act* (Canada) maximum pension at the time of their retirement or termination. Finance costs are expensed during the year, while remeasurements and other items, representing actuarial gains and losses, and past service costs, are recognized as a direct increase or decrease in net assets. The accrued liability is determined using a roll-forward technique to estimate the accrued liability using accounting assumptions from the most recent actuarial valuation report.

ii. Other employee benefits plans

The University maintains other retirement and post-employment benefits for most of its employees and accounts for these using the immediate recognition approach. Under this approach, the University recognizes the amount of the accrued obligation net of the fair value of plan assets in the consolidated balance sheet. Current service and finance costs are expensed during the year, while remeasurements and other items, representing the total of the difference between actual and expected return on plan assets, actuarial gains and losses, and past service costs, are recognized as a direct increase or decrease in net assets. The accrued liability for unfunded plans is prepared using accounting assumptions.

i. Cloud computing arrangements

The University analyzes its cloud computing arrangements to determine if a software element in the arrangement is a software intangible asset. Any such asset is accounted for as a software intangible asset. If the software element is not an asset, the University accounts for it as a software service and expenses it as incurred. Expenditures on implementation activities that are directly attributable to preparing the software service for its intended use that do not give rise to a separate intangible asset are capitalized as an asset for implementation of software services. The asset for implementation of software services is expensed using the straight-line method over the expected period of access to the software service.

The assets for implementation of software services are reviewed for impairment whenever events or changes in circumstances indicate that the carrying value of an asset may not contribute to the University's ability to provide goods and services or the future service potential of the asset has been reduced. Any impairment results in a write-down of the asset for implementation of software services and an expense in the consolidated statement of operations. An impairment loss is not reversed if the fair value of the related asset subsequently increases.

j. Capital assets and collections

Purchased capital assets are recorded at cost. Contributed capital assets are recorded at fair value at the date of contribution. Amortization is provided on a straight-line basis using the following annual rates:

Buildings and land improvements	2.5% - 10%
Equipment and furnishings	4% - 20%
Library books	20%

The University allocates salary and benefit costs related to personnel who directly manage capital projects through the application of a project management fee applied to total construction costs, excluding insurance, financing charges, and applicable taxes. The fee, which ranges from 2.0% to 5.0%, is calculated on a declining basis as total construction costs increase.

Capital assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying value of an asset may not contribute to the University's ability to provide goods and services. Any impairment results in a write-down of the capital asset and an expense in the consolidated statement of operations. An impairment loss is not reversed if the fair value of the related capital asset subsequently increases.

The value of library, art and other special collections has been excluded from the consolidated balance sheet except for a nominal value of \$1. Donated collections are recorded as revenue at values based on appraisals by independent appraisers and are expensed in the year received. Purchased collections are expensed in the year they are acquired.

When collections are deaccessioned and then sold, proceeds from the sale are included in deferred contributions and recognized as revenue when the cost of insurance, cleaning, restoration and conservation of works in the collection are expensed.

k. Revenue recognition

The University follows the deferral method of accounting for contributions, which include donations and government grants.

Unrestricted donations, contributed rare books, and other collections are recorded as revenue when received or receivable if amounts can be reasonably estimated and collection is reasonably assured. Due to the uncertainty involved in collecting pledged donations, they are not recognized until received.

Externally restricted contributions, other than endowment contributions, are deferred when initially recorded in the accounts and recognized as revenue in the period in which the related expenses are incurred. Externally restricted amounts can only be used for the purposes designated by external parties. Externally restricted contributions received towards the acquisition of depreciable capital assets are deferred when initially recorded in the accounts and amortized to revenue on the same basis as the related capital assets are amortized.

Endowment contributions and contributions of non-amortizable capital assets are recorded as direct increases in net assets in the year in which they are received or receivable.

Student fees are recorded as revenue when courses and seminars are held. Sales, services and sundry income revenues are recorded at point of sale for goods or when the service has been provided.

l. Foreign currency translation

Monetary assets and liabilities denominated in foreign currencies are translated at the exchange rate in effect at year-end. Operating revenues and expenses are translated at exchange rates in effect on the date of the transaction. Gains or losses arising from these translations are included in income except to the extent that they relate to investments, in which case they are recognized in the same manner as investment income.

m. Use of accounting estimates

The preparation of consolidated financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, related amounts of revenues and expenses, and disclosure of contingent assets and liabilities. Significant areas requiring the use of management estimates include the assumptions used in the determination of the fair value of financial instruments where the values are based on non-observable inputs that are supported by little or no market activity, the valuation of pension and other retirement benefit obligations, and the recording of contingencies. Actual results could differ from those estimates.

n. Contributed services and materials

Volunteers contribute an indeterminable number of hours per year. Because of the difficulty of determining their fair value, contributed services and materials are not recognized in the consolidated financial statements.

o. Change in accounting policy

Effective May 1, 2025, the University adopted the new Accounting Guideline AcG-20, Customer's Accounting for Cloud Computing Arrangements ("AcG-20"). This new guideline provides guidance on both accounting for a customer's expenditures in a cloud computing arrangement and determining whether a software intangible asset exists in the arrangement.

The University has made an accounting policy choice under AcG-20 to capitalize directly attributable expenditures on implementation activities when the arrangement is a software service. The asset for implementation of software services is expensed using the straight-line method over the expected period of access to the software services.

The University adopted AcG-20 retrospectively. This adoption had no impact on the University's consolidated financial statements for the year ended April 30, 2026 and 2025.

3. Investments

The University's investments are managed using two pools: the long-term capital appreciation pool ("LTCAP"), and the expendable funds investment pool ("EFIP"). LTCAP mainly includes endowment funds (note 13), the voluntary sinking fund (note 8) established to repay the principal of the University's debentures at maturity and funds set aside to cover long-term disability payments (note 7). EFIP consists mainly of the University's working capital for operations. The University of Toronto Asset Management Corporation ("UTAM") manages each of the pools according to the investment return target and risk tolerance of each pool as described in the University Funds Investment Policy. UTAM incorporates environmental, social and governance factors into its investment decision-making and practices active ownership in its management of both portfolios.

The University has adopted an investment benchmark called the Reference Portfolio for LTCAP, which has an asset mix that reflects the University's long-term return objective and risk appetite for this pool. The Reference Portfolio is designed to be a simple portfolio that can be easily implemented, and only includes public market asset classes. However, the actual investments in LTCAP include asset classes and strategies, such as hedge funds and private investments, that are not represented in the Reference Portfolio. These other investments have been reclassified and mapped to the most appropriate Reference Portfolio asset classes in the table above. In some cases, derivative financial instruments are used to obtain market exposures to various asset classes. The majority of the notional exposure of derivative financial instruments (except for currency derivatives) is backed by liquid assets (short-term investments), reducing the use of leverage. Leverage is however used to

add government bond exposure to the LTCAP portfolio to enhance downside risk protection. The table above includes the notional exposure (including any mark-to-market gains/losses) of derivative financial instruments other than currency derivatives in the Reference Portfolio asset classes.

Short-term investments consist of cash and bank term deposits. The negative amount of short-term investments in the LTCAP represents the notional exposure of the derivative financial instruments that is not backed by liquid assets as a result of the use of leverage. International equities include developed equity markets in Europe, Australasia and the Far East and exclude the United States and Canada. Global equities include all developed equity markets as well as various emerging equity markets. Investments in the “Other” category consist mainly of absolute return hedge funds.

The table below shows the fair value of the same investments for each pool without the reallocation of short-term investments (related to derivative instruments), hedge funds, private investments and real assets to the relevant Reference Portfolio asset class or classes.

In fiscal 2026, the University’s investment income of \$556 million (2025 - \$591 million) recorded in the consolidated statement of operations consists of income related to investments held for endowments of \$255 million (2025 - \$208 million), gross of \$54 million (2025 - \$47 million) in fees and other expenses (note 13), and a gain of \$301 million (2025 - \$383 million) on investments other than those held for endowments, gross of \$22 million (2025 - \$21 million) in fees and other expenses.

Included in investment income is an unrealized loss of \$5 million (2025 - \$17 million) as a result of the change in fair value of its investments that were estimated using a valuation technique based on assumptions that are not supported by observable market prices or rates for certain of its investments. Management believes there are no other reasonable assumptions for these investments that would generate any material changes in investment income.

Uncalled commitments

As at April 30, 2026, approximately 12.7% (2025 – 12.2%) of the University’s investments are invested in private funds managed by third-party managers. These private funds typically take the form of limited partnerships managed by a General Partner. The legal terms and conditions of these private investment funds, which cover various areas of private equity investments, private credit and

real asset investments (e.g., real estate, infrastructure), require that investors initially make an unfunded commitment and then remit funds over time (cumulatively up to a maximum of the total committed amount) in response to a series of capital calls issued to the investors by the manager. As at April 30, 2026, the University has uncalled commitments of approximately \$945 million (2025 - \$927 million). The capital committed is called by the manager over a pre-defined investment period, which varies by fund, but is generally between three and five years from the date the private fund closes. In practice, for a variety of reasons, the total amount committed to a private fund is typically not fully called.

Derivatives are financial contracts, the value of which is derived from changes in an underlying asset, index of prices or rates, interest rate, foreign exchange rate, etc. The University uses derivative financial instruments as a substitute for traditional investments to manage financial risks and to manage currency exposures. The University has entered into foreign currency forward contracts to manage its exposure to exchange rate fluctuations on investments denominated in foreign currencies in accordance with its hedging policy (note 19).

The University has entered into equity and bond futures contracts, and equity and bond swap contracts to obtain exposure to those asset classes. These derivatives are used as a substitute for traditional investments to obtain market exposures to these asset classes. Equity and bond futures contracts oblige the University to pay or receive the difference between a predetermined amount (the notional amount) and the market value at contract expiry. Equity and bond swap contracts are agreements for the exchange of cash flows based on the notional amount of the contract whereby one party commits to making payments based on the return of an underlying instrument in exchange for fixed or floating interest rate payments. To the extent the total return of the instrument or index underlying the transaction exceeds or falls short of the offsetting interest rate obligation, the University will receive a payment from, or make a payment to, the counterparty.

The notional amounts above do not represent amounts exchanged between parties. Instead, they represent the contractual amount to which a rate or price is applied for computing the cash flows to be exchanged and are therefore not recorded as receivables or payables in the consolidated financial statements. The University may have contracts to buy and sell similar underlying assets; in these cases, the notional amounts are presented above on a gross basis.

Contracts with a positive mark-to-market (fair value) are recorded as receivables, while contracts with a negative mark-to-market are recorded as payables. These are included in accounts receivable,

and accounts payable and accrued liabilities, respectively, in the consolidated balance sheet. The maturity dates of the currency forwards and futures contracts as at April 30, 2026 range from May 2026 to June 2026. The maturity dates of the equity and bond swap contracts as at April 30, 2026 range from May 2026 to October 2026. Required collateral of \$4 million (2025 - \$6 million) has been provided to the relevant exchanges against the futures contracts as at April 30, in the form of short-term investments. As at April 30, the University has \$3.0 billion (2025 - \$3.0 billion) in short-term investments compared to the \$3.7 billion (2025 - \$3.7 billion) of notional value of equity and bond futures, and equity and bond swap contracts. Leverage is used to add government bond exposure to the LTCAP portfolio to enhance downside risk protection.

a) CampusOne Student Residence

The University has a 20% interest in the CampusOne Student Residence ("CampusOne"), a 25-storey, 890-bed student residence building strategically situated adjacent to the St. George campus. The investment provides the University access to much needed student residence spaces. Subject to availability, the University is able to reserve residence beds on a priority basis. The University recognizes 20% of CampusOne's excess (deficiency) of revenues over expenses in its consolidated statement of operations and as an investment on the consolidated balance sheet.

The following financial information for CampusOne was prepared in accordance with Canadian accounting standards for private enterprises. Any differences in the reporting framework are not material to the University's consolidated financial statements. Audited financial statements are prepared for CampusOne (as at and for the year ended December 31, 2025).

b) UTSC Residence Limited Partnership

The University is the General Partner of UTSC Residence Limited Partnership (“UTSC Residence LP”), which owns Harmony Commons, a 746-bed student residence situated at the University’s Scarborough Campus.

The University, as General Partner, will receive a portion of the profits of UTSC Residence LP at a future date based on a profit-sharing formula defined in the limited partnership agreement. The University recognizes its share of UTSC Residence LP’s excess of revenues over expenses in its consolidated statement of operations and as an investment on the consolidated balance sheet. As at December 31, 2025, the University has not yet benefited in the profit-sharing formula defined in the limited partnership agreement. As such, the University has not adjusted its investment in UTSC Residence LP and no amounts have been recorded in these consolidated financial statements as the University’s share of the net income.

The following financial information for UTSC Residence Limited Partnership was prepared in accordance with Canadian accounting standards for private enterprises. Any differences in the reporting framework are not material to the University’s consolidated financial statements. Separate financial statements are prepared for UTSC Residence Limited Partnership (as at and for the year ended December 31, 2025).

The University operates Harmony Commons under a licensing agreement. During the year, the University paid licensing fees to UTSC Residence Limited Partnership of \$9.8 million (2025 - \$9.9 million).

c) Toronto Pan Am Sports Centre Inc.

The University has a 50% interest in Toronto Pan Am Sports Centre Inc. (“TPASC”), a jointly owned and controlled corporation (a joint corporation pursuant to the *Business Corporations Act* (Ontario) and the *City of Toronto Act* (2006)) with the City of Toronto for the purpose of operating the Toronto Pan Am Sports Centre facilities that include a premier aquatics centre as well as a state-of-the-art training and competition venue. The University recognizes 50% of the joint venture’s excess (deficiency) of revenues over expenses in its consolidated statement of operations and as an investment on the consolidated balance sheet.

The following financial information for TPASC was prepared in accordance with Canadian public sector accounting standards and represents the University’s 50% share. Any differences in the reporting framework are not material to the University’s consolidated financial statements. Separately audited financial statements are prepared for TPASC (as at and for the year ended December 31, 2025).

As at December 31, 2025, the University's share of the accumulated surplus represents unspent funds designated in support of major maintenance and capital requirements. No amounts have been recorded in these consolidated financial statements as the University's share of the accumulated surplus is not contemplated to be and is not readily realizable by the University.

During the year, the University paid \$2 million (2025 - \$2 million) in user fees to TPASC representing its share of the cost for using the facilities. During the year, the City of Toronto and the University each acquired an additional 5,692 (2025 - 5,360) common shares of TPASC in exchange for \$2 million (2025 - \$2 million) each representing funding from the Legacy Funding agreement dated December 18, 2014, to be contributed to TPASC to fund capital reserves and operating costs. These transactions occurred in the normal course of business and have been recorded at their exchange amounts, which is the amount agreed upon by both parties.

The construction of the Toronto Pan Am Sports Centre was governed by virtue of an agreement prior to the establishment of TPASC. The University has recorded \$90 million (2025 - \$90 million) in capital assets (note 6), representing the University's 50% share of the construction cost of the facility.

d) TRIUMF Inc.

The University is a member of TRIUMF Inc. ("TRIUMF"), a not-for-profit corporation, with 20 other universities. Each university has an undivided 1/21 interest in its assets, liabilities and obligations. The land and buildings it occupies are owned by The University of British Columbia. The facilities and its operations are funded by federal government grants, and the University has made no direct financial contribution to date. TRIUMF's net assets are not contemplated to be and are not readily realizable by the University. The University's interest in the assets, liabilities, and results of operations of TRIUMF are not included in these consolidated financial statements (note 21c).

The following financial information for TRIUMF was prepared in accordance with Canadian public sector accounting standards, including accounting standards that apply to government not-for-profit organizations, except that all capital assets and related provisions for decommissioning costs, if any, are expensed in the year in which the costs are incurred. Any differences in the reporting framework are not material to the University's consolidated financial statements.

e) MaRS Phase 2 Investment Trust

The University has a 20% interest in MaRS Phase 2 Investment Trust (the “Trust”), a unit trust governed by the laws of the Province of Ontario, established by deed of trust dated July 15, 2011 with MaRS Discovery District, a charitable organization. The Trust manages a 20-storey state-of-the-art building that is a world-class convergence centre dedicated to improving commercial outcomes from Canada’s science, technology and social innovations. The University assessed the investment value in the Trust upon acquisition and, as a result, wrote down the investment to nil. There have been no changes to the investment value as at April 30, 2025 and 2026.

During the year, the University made payments of \$11 million (2025 - \$11 million) to the Trust for leasing certain premises and its related operating costs.

These transactions occurred in the normal course of business and have been recorded at their exchange amounts, which is the amount agreed upon by both parties.

f) Spadina Sussex University Residence Co-tenancy

The University has a 75% interest in Spadina Sussex University Residence Co-tenancy, a joint venture formed to construct, develop, manage and operate the Oak House student residence project (“Oak House”) at the St. George campus. Oak House is comprised of a 23-storey student residence tower containing 508 residence beds and retail space, and 10 townhomes containing a total of 17 beds. Oak House commenced operations in September 2025. These financial statements contain the University’s share of the assets, liabilities, revenues, and expenses of Spadina Sussex University Residence Co-tenancy.

a) Loans receivable - related party

As at April 30, 2026, the University has loans receivable from UTSC Residence Limited Partnership, a related party. The loans bear interest at rates between 4.10% and 5.00% (2025 - 3.85% and 4.75%), increasing by 0.25% on each anniversary of the occupancy date (September 1). Interest on the loans is due monthly and principal payments begin on November 1, 2026. The balance of the loans receivable are due in full when UTSC Residence Limited Partnership secures external financing.

b) Loan receivable

The loan receivable bears interest at 6.11% per annum, compounding monthly, with a term of 25 years. Interest on the principal and capitalized accrued interest is payable on a monthly basis beginning in June 2026. Principal and interest payments are payable on a quarterly basis beginning in August 2027, based on a 25-year amortization period from the original advance date.

c) Cloud computing arrangements

For the year ended April 30, 2026, the University expensed \$22 million (2025 - \$18 million) for software services in cloud computing arrangements, which are included in materials, supplies and services on the consolidated statement of operations. There were no directly attributable expenditures on implementation activities related to software services during the year (2025 – nil).

The University develops replacement property values of buildings and contents for insurance purposes using various sources and valuation methods that conform to insurance industry practice

and standards. The insured replacement value of buildings is approximately \$8.4 billion, and contents is approximately \$3.4 billion, which includes library books of approximately \$1.0 billion.

The University holds a wide range of library, art and other special collections that are protected and preserved for public exhibition, education, research, and the furtherance of public service. Rare books and special collections include manuscripts, archives, and cartographic, graphic, film, audio and video materials. The University rarely disposes of items in these collections.

As at April 30, 2026, the University has \$1,183 million (2025 - \$782 million) of construction-in-progress that was included in buildings, and equipment and furnishings, which will not be amortized until the capital assets are put into use.

7. Employee benefit plans

The University has a number of funded and unfunded defined benefit plans that provide pension (including a supplementary account plan and supplemental retirement arrangement), other retirement and post-employment benefits to most of its employees.

On July 1, 2021 (the “Effective Date”), the University became a member of the UPP and transferred the assets and liabilities, including the pension obligations, of the University’s registered pension plan (“RPP”) to the UPP. As of the Effective Date, the accrual of benefits and contributions under the UPP commenced for members of the RPP, and benefits and contributions under the RPP ceased.

Any pension surplus or deficit of the UPP is a joint responsibility of the members and employers for service after the transition date of July 1, 2021, and may affect future contribution rates for members and employers. The University remains responsible to fund any net pension obligations (determined based on the UPP actuarial assumptions) related to service up to the transition date of July 1, 2021, over 15 years. The net pension obligations may fluctuate in the future based on changes to the UPP’s actuarial assumptions and for changes in experience in future periods, which will continue to be the responsibility of the University to fund for the first 10 years, after which the responsibility for such changes becomes gradually shared over the next 10 years with the other members of the UPP, after which the responsibility is totally shared with all members.

Contribution rates are determined by the UPP sponsors (representing employees and employers). The most recent actuarial valuation filed with pension regulators by the UPP as at January 1, 2025 indicated an actuarial surplus on a going concern basis of \$245 million using an actuarial (smoothed) value of the assets.

Contributions made to the UPP during the year are included in employee benefits expense in the consolidated statement of operations and amounted to \$163 million (2025 - \$154 million). In 2025, the University made an additional prepayment of \$30 million to the UPP from its pension special payments budget. Cumulative prepayments of \$90 million (2025 - \$90 million) are included in the pension special payments reserve (notes 5 and 12) to be applied against any future required pension special payments.

Other retirement benefit plans are contributory health care plans with retiree contributions adjusted annually, such as extended health, semi-private and dental care. Another plan also provides for long-term disability income benefits after employment, but before retirement.

The employee benefits expense for the year includes pension expense of \$179 million (2025 - \$164 million), other retirement benefits expense of \$61 million (2025 - \$56 million) and other employee benefits of \$257 million (2025 - \$254 million). Remeasurements, which are recorded in the

consolidated statement of changes in net assets, rather than in the consolidated statement of operations, are as follows:

Actuarial valuations for retirement benefit plans are performed biannually for contributory health care plans, with the most recent as at January 1, 2025, and annually for long-term disability (LTD) and other supplementary retirement plans (SRAs), with the most recent as at January 1, 2026. The University measures its accrued benefit obligation (using a roll-forward technique from the most recent actuarial valuation) and the fair value of plan assets for accounting purposes as at April 30 of each year.

To measure the accrued benefit obligation for retirement benefit plans, other than pension, as at April 30, 2026, the rates of increase in the per capita cost of covered medical and dental benefits are both assumed to be 5.3%. Both rates are expected to remain stable until 2030, before gradually decreasing to 4.1% in 2040, and remain at that level thereafter.

The accrued pension liability of \$147 million (2025 - \$142 million) mainly represents the University's obligation for its SRAs.

As at April 30, 2026, the University has set aside investments of \$40 million (2025 - \$30 million) for its SRAs and \$159 million (2025 - \$139 million) for its other benefit plans. The University has also set aside \$315 million (2025 - \$250 million) for its pension special payments obligations, of which \$90 million has been transferred to the UPP.

A voluntary sinking fund (note 3) was established for the purpose of accumulating funds to repay the principal of the University's debentures at maturity. The value of the fund included in investments as at April 30, 2026 amounts to \$718 million (2025 - \$717 million), which includes accumulated investment income of \$147 million (2025 - \$174 million). The accumulated investment income is included in operating contingencies in internally restricted net assets.

Net unamortized transaction costs comprise premiums and transaction issue costs.

a) Credit facilities

In 2024, the University secured the following credit facilities to fund the acquisition of clean and energy efficient equipment for use at its St. George campus in order to significantly reduce the University's annual carbon emissions (the "project"):

- i. A non-revolving credit facility (the "senior facility"), made available during the acquisition period, of up to \$63 million, bearing interest at the Canadian Overnight Repo Rate Average plus 51.5 basis points, and due the earlier of November 1, 2027 and substantial completion of the project. Upon completing the acquisitions, the senior facility will be converted to a term loan bearing interest at the same rate.

The University entered into two interest rate swap agreements with the senior lender to convert its interest rate exposure on the senior facility from a floating rate to a fixed rate (note 19). Under the interest rate swap and credit agreements, the University pays a hedged, all-in fixed rate of 3.783% on the senior facility. The interest rate swap agreements expire on October 29, 2027 and October 31, 2052.

A non-revolving credit facility (the "junior facility"), made available during the acquisition period, of up to \$50 million, bearing interest at 1.0% per annum, and due the earlier of November 1, 2027 and substantial completion of the project. Upon completing the acquisitions, the junior facility will be converted to a term loan bearing interest at the same rate.

The senior and junior facilities are secured by the project assets under a general security agreement.

9. Government remittances payable

As at April 30, 2026, accounts payable and accrued liabilities include government remittances payable of \$61 million (2025 - \$56 million).

a) Investment in land and other capital assets

Investment in land and other capital assets represents the amount of net assets that are not available for other purposes because they have been used to fund the purchase of capital assets. It consists of unamortized capital assets purchased with unrestricted resources (net of debt) plus the carrying amount of capital assets purchased with unrestricted resources (net of debt) that will not be amortized.

b) Employee benefits

Internally restricted net assets have been reduced by the portion of employee future benefits obligations to be funded by future operating budgets.

c) Pension special payment reserve

This reserve represents funds that have been set aside as a contingency against future pension special payment risk (note 7).

d) Capital projects and infrastructure reserves

These represent reserves in respect of capital projects at various stages of planning, design and construction, including:

- **Capital projects in progress** - \$685 million (2025 - \$931 million) - unspent funds at the end of the fiscal year, in respect of capital projects and alterations and renovations in progress that are part of the University's major infrastructure building and renewal program less amounts spent without funding on hand;
- **Reserves for future major capital projects** - \$583 million (2025 - \$558 million) - funds set aside for specific, major capital projects in the project planning stage with an anticipated project cost in excess of \$10 million; and

- **Other divisional infrastructure reserves** - \$213 million (2025 - \$188 million) - funds held by divisions as a general reserve for alterations and renovations, as well as funds earmarked for capital projects in the project planning stage with an anticipated project cost less than \$10 million.

e) Operating contingencies

These funds represent operating reserves available for spending to protect against possible adverse circumstances such as changes in student enrolment due to geopolitical events, investment return fluctuations and salary cost escalations, as well as other strategic priorities.

f) Research support

These funds represent departmental funds reserved for Canada Research Chairs and related research allowances, start-up research funds and funds provided to faculty and librarians under an expense reimbursement program.

g) Departmental trust funds

These funds represent departmental trust funds available for spending by divisions with no external restrictions.

h) Student financial support

These funds represent departmental operating funds available to provide scholarships, bursaries, and other student financial assistance.

i) Other funds

These funds are held primarily to support various initiatives to enhance the quality, structure and organization of programs and activities, and to improve the productivity of physical assets.

13. Endowments

Endowments consist of externally restricted donations received by the University and internal resources transferred by Governing Council in the exercise of its discretion. With respect to the latter case, Governing Council may have the right to subsequently decide to remove the designation. The investment income generated from endowments must be used in accordance with the various purposes established by donors or Governing Council. The University ensures, as part of its fiduciary responsibilities, that all funds received with a restricted purpose are expended for the purpose for which they were provided.

University policy has been established with the objective of protecting the real value of the endowments by limiting the amount of income made available for spending and requiring the reinvestment of income not made available for spending. The investment policy has set the real rate of return objective of at least 4% over 10-year periods, net of all investment fees and other expenses, while taking an appropriate amount of risk to achieve this target, but without undue risk of loss. The amount made available for spending must normally fall between a range of 3% and 5% of the fair value per unit of the endowment pool. In any particular year, should net investment income be insufficient to fund the amount to be made available for spending or if the investment return is negative, the amount that is made available for spending is funded by the accumulated reinvested income. However, for endowment funds, where the fair value of the endowment is below the donated

capital and does not have sufficient accumulated reinvestment income, endowment capital is used in the current year as this is deemed prudent by the University. This amount is expected to be recovered by future net investment income. As at April 30, 2026, there are 14 endowments with the original gift value of \$2 million that have a fair value of \$2 million and a deficiency of \$- million. As at April 30, 2025, there were 142 endowments with the original gift value of \$43 million that have a fair value of \$42 million and a deficiency of \$1 million. In fiscal 2026, \$11.06 (2025 - \$10.63) per unit of LTCAP was made available for spending, representing 4% (2025 - 4%) of the five-year average fair value per unit of the endowment pool.

17. Donations

During the year, the University raised pledges, gifts and philanthropic grants of \$206 million (2025 - \$209 million). In 2026, \$145 million (2025 - \$155 million) was recorded as revenue, of which \$106 million (2025 - \$114 million) was received in the current year, \$39 million (2025 - \$41 million) was received and deferred in prior years, and \$100 million (2025 - \$95 million) was recorded as a direct addition to endowments (note 13) and is not recorded as donations revenue.

18. Government and other grants for restricted purposes

During the year, the University received \$620 million (2025 - \$641 million) of government and other grants for research and \$55 million (2025 - \$52 million) for capital infrastructure and other purposes, of which \$577 million (2025 - \$540 million) was recorded as revenue and \$98 million (2025 - \$154 million) was deferred (notes 10 and 11).

19. Financial risks and risk management

The University is exposed to various financial risks through transactions in financial instruments. The majority of these risks are related to investments in the LTCAP. To manage the investment risk of the LTCAP portfolio, the University has set the benchmark Reference Portfolio with an asset mix that reflects its long-term return objectives and risk appetite. The University monitors and limits the active risk, which is defined as the volatility in the actual portfolio minus the volatility in the Reference Portfolio. The University uses risk systems and data management tools to evaluate risk exposures across multiple asset classes, as well as the total portfolio. If the measured risk of the portfolio exceeds the limit, actions will be taken to reduce the portfolio's risks.

Foreign currency risk

The University is exposed to foreign currency risk from direct and indirect (e.g., pooled funds) investments that are denominated in currencies other than the Canadian dollar. Fluctuations caused by changes in the currency rates applied to these investments can result in a positive or negative effect on the fair value of the investments and on the cash flows from these investments. To manage foreign currency risk, the University has established a benchmark currency hedging policy for both the LTCAP and EFIP. In 2026, the benchmark policy for the LTCAP is to hedge 50% (2025 - 50%) of the currency exposure of all the asset classes of the Reference Portfolio, with the exception of emerging markets, which are unhedged. The benchmark policy for EFIP is to hedge 100% (2025 - 100%) of its non-Canadian currency exposure. As at April 30, 2026, the fair value of investments denominated in foreign currencies is \$3.9 billion (2025 - \$3.5 billion), of which \$2.7 billion (2025 - \$2.2 billion) has been hedged.

Credit risk

The University is exposed to credit risk in connection with its fixed-income investments and derivative contracts because of the risk of a financial loss caused by a counterparty's potential

inability or unwillingness to fulfill its contractual obligations. To manage the credit risk exposure from direct fixed-income holdings or from the use of derivatives, limits are established for individual counterparties, and these are monitored regularly. The majority of the University's fixed-income investments are in highly rated securities. As at April 30, 2026, 40% (2025 - 37%) of the University's bond exposure from derivative instruments are either unrated or have market appropriate credit equivalent ratings of A or lower.

Interest rate risk

The University is exposed to interest rate risk with respect to its investments in bonds. As at April 30, 2026, the fair value of total investments in bonds is \$4.7 billion (2025 - \$4.5 billion), composed of \$2.0 billion (2025 - \$1.9 billion) of bonds indirectly held through pooled funds and \$2.7 billion (2025 - \$2.6 billion) of notional bond exposure arising from derivative financial instruments. As at April 30, 2026, the University does not hold bonds directly (2025 - nil) in its portfolios. The interest rate risk of fixed income exposures is managed based on the interest rate risk of the Reference Portfolio in LTCAP and based on the interest rate risk of the target portfolio in EFIP.

The University is also exposed to interest rate risk on its floating interest rate debt. The University mitigates this risk by entering into interest rate swap agreements.

Liquidity risk

The University is exposed to liquidity risk if it does not maintain sufficient liquidity to manage its obligations associated with its derivative financial instruments, the funding of calls from private market funds, long-term debt, and the annual LTCAP distribution for spending. The University has developed a system that models the potential liquidity needs of the LTCAP under stressed market conditions. This helps ensure that adequate cash and other sources of liquidity are available to meet all liquidity needs over a stress-test extended period. The same modelling analysis ensures that the University can, if necessary, rebalance LTCAP's asset mix to match the target asset class weights of the Reference Portfolio. In addition, the University has a voluntary sinking fund that was established for the purpose of accumulating funds to repay the principal of the University's debentures at maturity.

Other price risk

The University is exposed to other price risk through changes in market prices (other than changes arising from interest rates or foreign currencies) with respect to its investments in public equity, private equity, fixed income, real estate, infrastructure and hedge funds. The factors that cause the changes in market prices may affect a specific individual investment, its issuer, or they may affect similar securities traded in the market. This risk is managed by having a benchmark Reference Portfolio, which reflects the University's risk appetite, and by monitoring actual risk against the risk of the Reference Portfolio.

20. Other commitments

- a. The estimated cost to complete construction and renovation projects in progress as at April 30, 2026, which will be funded by operations and donations, is approximately \$1.4 billion (2025 - \$1.7 billion).

21. Contingencies

- a. The University has a program under which it guarantees bank loans to faculty and staff members to assist in the purchase or refinancing of their homes. The University holds mortgages as collateral security against such guarantees. As at April 30, 2026, the amount of loans guaranteed is \$10 million (2025 - \$11 million). The University's estimated exposure under these guarantees is not material.
- b. The University issues irrevocable standby letters of credit for its capital construction projects that guarantee payments to the City of Toronto if it fails to perform certain restorative work at the completion of its capital construction projects. As at April 30, 2026, the amount of outstanding letters of credit issued is \$14 million (2025 - \$23 million).
- c. The members of TRIUMF and the Canadian Nuclear Safety Commission ("CNSC") approved a decommissioning plan that requires all members to be severally responsible for their share of the decommissioning costs as well as provide financial covenants to the CNSC for the amount of these costs. While there are no current intentions of decommissioning the facilities, TRIUMF has put in place a plan for funding the cost of decommissioning that does not require any payments from the joint venture partners.
- d. The University has identified potential asset retirement obligations related to the existence of asbestos in a number of its facilities. Although not a current health hazard, upon renovation or demolition of these facilities, the University may be required to take appropriate remediation procedures to remove the asbestos. As the University has no legal obligation to remove the asbestos in these facilities as long as the asbestos is contained and does not pose a public health risk, the fair value of the obligation cannot be reasonably estimated due to the indeterminate timing and scope of the removal. The asset retirement obligation for these assets will be recorded in the period in which a legal obligation exists or when there is certainty that the capital project will proceed and there is sufficient information to estimate fair value of the obligation.
- e. The nature of the University's activities is such that there are usually claims or potential claims in prospect at any one time. As at April 30, 2026, the University believes that it has valid defences and appropriate insurance coverage in place on certain claims that are not expected to have a material impact on the University's consolidated financial position. There also exist other claims or potential claims where the ultimate outcome cannot be determined at this time. Any additional losses related to claims would be recorded in the year during which the amount of the liability is able to be estimated or adjustments to the amount recorded are required.

- f. On January 1, 2023, the University entered into a membership with a reciprocal exchange of insurance risks, named the Canadian Universities Reciprocal Insurance Exchange (“CURIE”). This self-insurance reciprocal, in association with 78 other Canadian universities, involves a subscriber agreement to share the insurable property and liability risks of member universities for a term of not less than five years. Plan members are required to pay annual deposit premiums, which are actuarially determined and expensed in the year. Plan members are subject to further assessment in proportion to their participation in the event premiums are insufficient to cover losses and expenses. As at December 31, 2025, the date of the latest financial statements available, CURIE was fully funded with surplus of \$134 million (December 31, 2024 - \$130 million).

Purpose of this Supplementary Report

The University of Toronto's financial statements report the University's assets, liabilities, net assets, revenues and expenses on a single column basis. The purpose of this supplementary report is to show the University's financial statement information by fund in a format consistent with how the University manages its finances, that is, by fund. Schedules 1 and 2 show the balance sheet and statement of operations and changes in surplus (deficit) by fund.

The operating fund includes teaching and administrative activities supported mainly by government operating grants, student fees and sales of supplies and services.

Ancillary operations include operations that provide residences, residential housing, food and beverage services, conference services, parking/transportation services, Hart House, real estate services and U of T Press. All ancillary assets, liabilities, net assets, revenues and expenses are recorded in this fund.

The capital fund includes all capital assets – land, land improvements, buildings, furnishings, computers, etc. - except for those of ancillary operations. Contributions to the University for capital assets other than ancillaries are recorded in this fund.

Restricted funds include donations (including endowments), research grants and contracts. Each donation, usually supported by an agreement between the University and the donor, or a collection of small donations with similar purpose, is recorded in its own fund, and managed according to agreed upon terms and conditions. Each research grant or contract is recorded in its own fund and managed in accordance with the terms and conditions required by the sponsor of the funds. There are several thousand individual restricted funds.

The key drivers of financial performance described in the financial highlights affect the various funds as follows:

- Student enrolment growth is mostly reflected in the operating fund and in ancillary operations.
- Growth in research activity is reflected in restricted funds.
- Salaries and benefits growth is mostly reflected in the operating fund.
- Growth in space is reflected in ancillary operations (residences and parking facilities) and the capital fund (all other facilities, including academic teaching and research facilities).
- Donations are mainly reflected in restricted funds.
- Endowments are reflected in restricted funds.
- Investment earnings are reflected in all funds, but predominantly in the operating fund and in restricted funds.

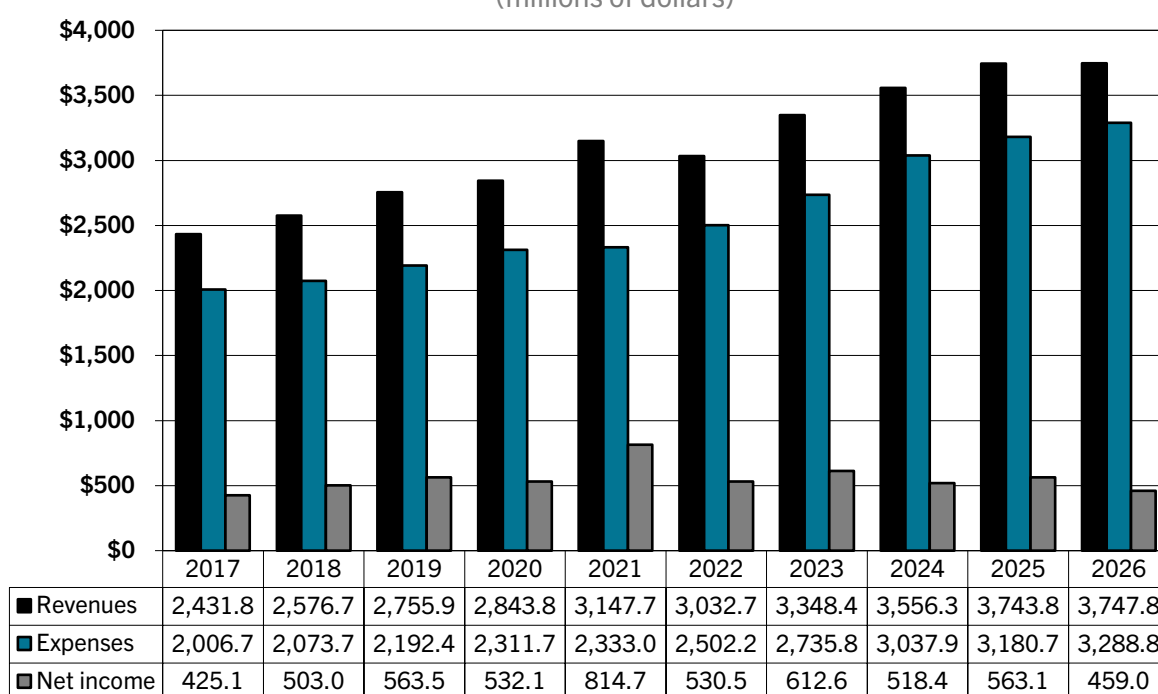
Operating Fund

The **operating fund** includes teaching and administrative activities supported mainly by government operating grants, student fees and sales of supplies and services.

Operating fund revenues for the year were \$3.7 billion; expenses were \$3.3 billion resulting in a net income of \$459 million. Overall operating fund revenues were consistent with prior year, as increases in government grants and sales, services and sundry income were offset by a decrease in investment income. Growth in operating fund expenses primarily reflects increases in compensation for faculty and staff.

The cumulative operating deficit at April 30, 2026 is (\$84) million, whereas the long-range operating budget called for a break-even position.

The 2026 net income in the operating fund is a result of:

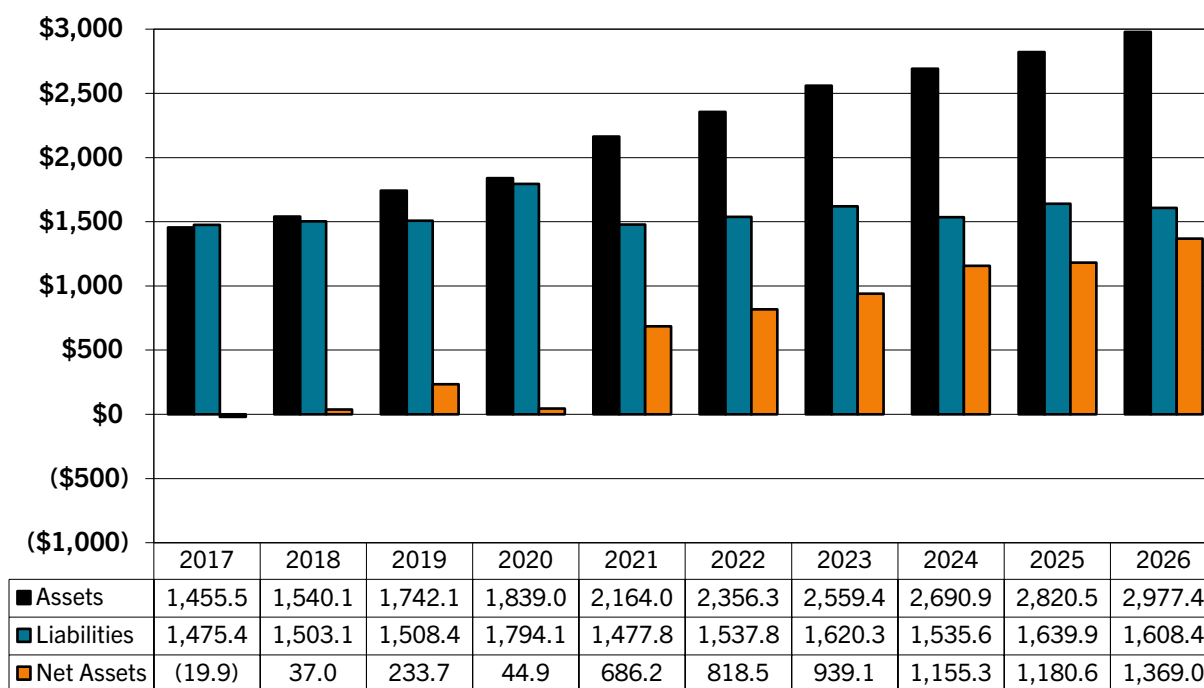

Operating fund assets at April 30, 2026 were \$2.98 billion, liabilities were \$1.61 billion, and net assets were \$1.37 billion.

The University accounts for its employee future benefits (pensions and other employee future benefits) using the immediate recognition approach which has the impact of fully recording its employee future benefit obligations on the balance sheet as a liability offset by a decrease in internally restricted net assets. The increase in net assets since 2017 is mainly a result of increased central and divisional reserves of \$1.4 billion combined and a decrease in net unfunded pension obligations of \$140 million.

The net assets increased from \$1.18 billion in 2025 to \$1.37 billion in 2026 mainly due to the following:

- \$459 million net income for the year.
- (\$269 million) net transfers to other funds.

The transfers to other funds were as follows:

- \$96 million to the capital fund to reflect operating funding of capital asset expenditures recorded as capital assets in the capital fund.
- \$173 million transfer mainly to the capital fund for various projects.

There are two categories of net assets for the operating fund as follows:

- (\$84) million deficit.
- \$1.45 billion of internally restricted net assets.

The (\$84) million deficit is the “cumulative deficit” of the operating fund which is referenced in the University’s Operating Budget Report and internal loans. The cumulative deficit has increased from (\$34) million deficit at April 30, 2025 to (\$84) million deficit at April 30, 2026, mainly due to the following:

- \$459 million net income.
- (\$269 million) net transfers to other funds as noted above.
- (\$240 million) change in internally restricted net assets, mainly due to an increase in divisional reserves and the employee future benefit obligations reserves (excluding remeasurements), offset by a reduction in capital project reserves.

Internally restricted net assets of \$1.45 billion mainly includes divisional reserves of \$1.2 billion, funds set aside for capital projects of \$649 million, funds set aside for pension special payments of \$315 million, and funds set aside for other purposes of \$10 million. These amounts are offset by net unfunded liabilities of \$107 million associated with its supplementary pension plan and \$647 million associated with its employee future benefits other than pensions, that will have to be paid from future years’ operating fund revenues.

Schedule 3 is a summary of operating fund reserves that comprise the \$1.45 billion in internally restricted net assets. Included in this schedule are plans by divisions detailing how reserves carried forward will be spent on a one-time only basis, or in the event of a deficit, a plan for its elimination, using the following categories:

Infrastructure Reserve - This category is intended to capture funds that have been reserved by the division in anticipation of new building construction, renovations to facilities, infrastructure upgrades such as computer networking, equipment replacement, etc.

Research - Funds reserved for research are to be included in this category. This includes funds allocated to Principal Investigators as a result of the expense reimbursement program for Faculty and Librarians, overheads, research allowance or start-up funds. Also included are funds reserved for Canada Research Chairs and any related research allowance.

Student Financial Support - This category captures funds reserved for scholarships, bursaries and other student assistance.

Endowment Matching - This category captures funds reserved to match future external donor contributions. The division must have a written plan that defines what type of contributions it will match (i.e. chairs and professorships, student aid, academic programs and research), with a set limit for the matching.

Operating Contingency - This category is intended to capture divisional operating contingency reserves. Funds in this category include reserves for anticipated budget reductions, voluntary early retirement payouts, increases in university-wide costs, and fluctuations in revenues due to enrolment shortfalls and lower investment returns. The total operating reserve contingency would normally fall in range of 5% to 10% of the division's total operating expense budget. Divisions with greater distributed risk (i.e. large international enrolment, significant growth, high levels of external revenue, etc.) may establish larger operating contingency reserves.

Comparison of the Consolidated Financial Results to the Operating & Consolidated Budget

It is important to compare the year-end results to budget to assess how well the budget has estimated the actual outcome. However, there are differences between the University's operating budget and the year-end consolidated results that must be adjusted before the comparison can occur. These differences are summarized as follows:

- The operating fund is only one, albeit the largest (more than 75% of total revenues), of the four funds included in the financial statements. Budgeted revenues and expenses for the three others - the restricted fund, capital fund and ancillary fund – need to be added to the operating fund to create a consolidated budget.
- The financial statements are prepared on an accrual basis following Canadian generally accepted accounting principles for not-for-profit organizations ("GAAP"), while the operating budget projects cash receipts and expenditures.
- The financial statements include amortization of capital assets while the operating budget includes estimated cash outlays for these assets.
- The financial statements include the costs of pensions and other benefits in accordance with GAAP, while the operating budget includes the projected cash premiums and funding to be paid in the year.

Once these adjustments have been made, it is possible to compare the operating budget with the year-end results and to assess how closely actual results conformed to plan. In summary, the adjustments between the financial statements and the operating budget are as follows:

Consolidated revenues, after GAAP adjustments, were \$4.95 billion, compared to budgeted revenues of \$4.75 billion, resulting in a favourable variance of \$209 million, or 4.4%. This favourable variance was primarily due to strong investment returns from the University's investment portfolios.

Consolidated expenses, after GAAP adjustments, were \$4.52 billion, as compared to budgeted expenses of \$4.57 billion resulting in a favourable variance of \$48 million, primarily due lower than expected operating expenses.

A detailed analysis is shown below.

Ancillary Operations

Ancillary operations include the following:

- *Service ancillaries* include residences (UTM, UTSC, University College, New College, Woodsworth College, and Innis College), conference services (UTSC), food and beverage/hospitality services (UTM, UTSC, and University College), parking/transportation services (UTM and UTSC), and Hart House; and
- *Business ancillaries* including Spaces and Experiences, which is comprised of Real Estate (which includes the University's investment in the Oak House Residence joint venture) and operations that were previously considered service ancillaries: St. George Food and Beverage Services, University Family Housing, Chestnut Residence and Conference Centre, Graduate House Residence, and Transportation Services and the U of T Press.

All ancillary assets, liabilities, net assets, revenues and expenses are recorded in this fund. In the graphs below, we have reported on all current business ancillaries as if they have been business ancillaries throughout the entire period from 2017-2026.

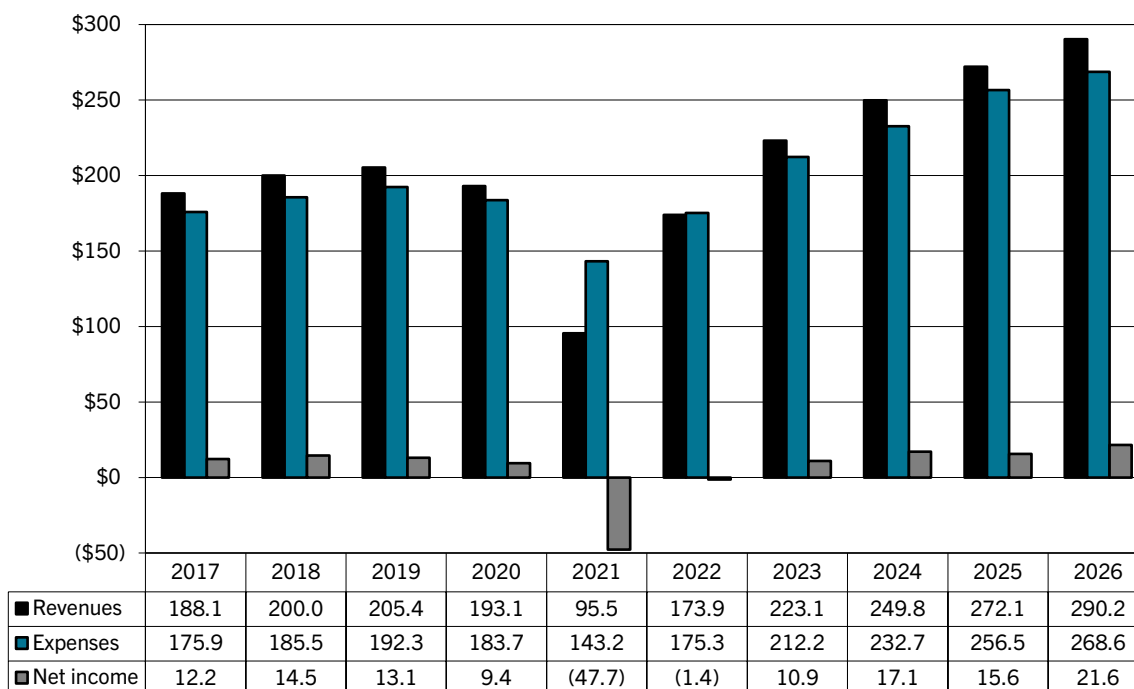
Over the period 2017 to 2020, ancillary revenues grew from \$188 million to \$205 million, expenses grew from \$176 million to \$192 million, and net income increased from \$12 million to \$13 million. Residence fees over the past years have been increased to keep pace with increased expenses, which included large, fixed rate principal and interest payments on borrowing.

Levels of on-campus activity were significantly reduced at the end of 2020 and in 2021 as a result of the COVID-19 pandemic. Ancillary operations saw a decline in net income to \$9 million in 2020 and incurred losses of \$48 million in 2021 as campus services such as residences, food, and parking were particularly hard hit.

Residence operations began to recover in 2022 with higher than anticipated occupancy levels, generating much improved operating results compared to 2021. By the fall of 2023, residence operations returned to full occupancy, as restrictions on capacity relaxed. Ancillary revenues grew from \$96 million in 2021 to \$290 million in 2026. Revenues exceeded \$200 million for the fourth consecutive year, and have grown by 67% since 2022. Expenses also increased from \$143 million in 2021 to \$269 million in 2026. Annual net income increased to \$22 million in 2026 from an annual net loss of \$48 million in 2021. Changes in demand for on-campus services due to flexible work arrangements, increased costs due to a period of high inflation, and rising staffing costs posed challenges for ancillary operations in the first few years post-pandemic, however, an increasing presence of administrative staff across the three campuses is expected to result in higher demand going forward, particularly in food services and parking.

Ancillary Operations Revenues and Expenses

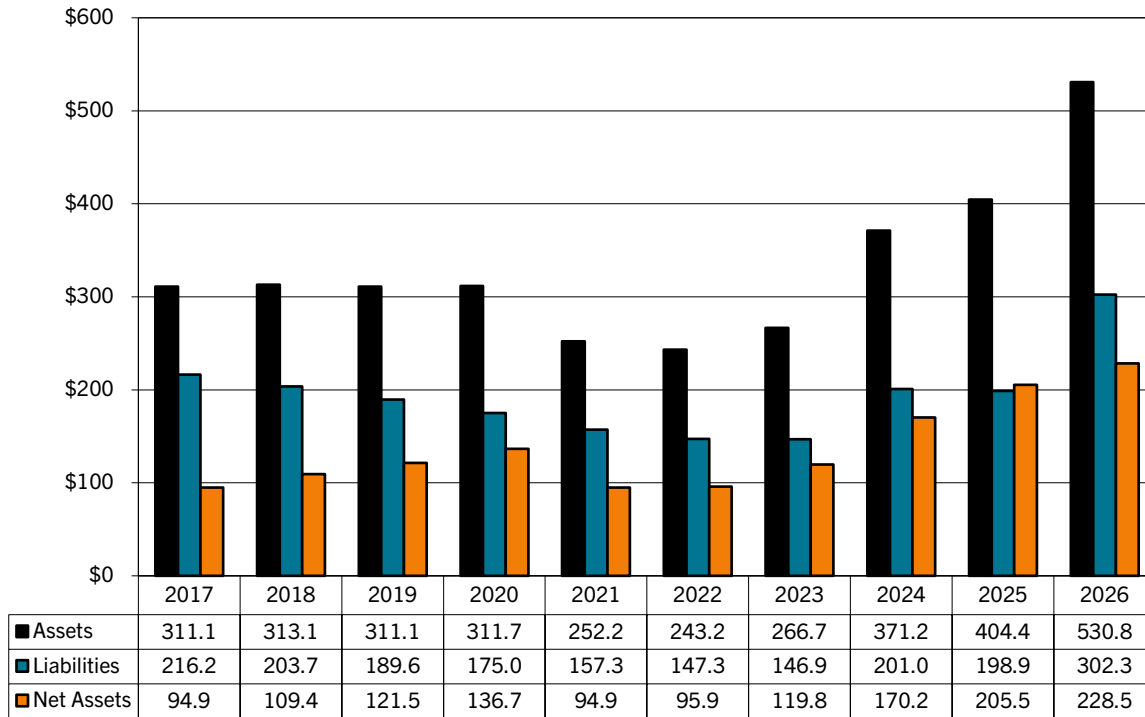
for the year ended April 30

Ancillary assets increased from \$311 million in 2017 to \$312 million in 2020. Assets subsequently fell to \$243 million by 2022 due to the impact of the pandemic. Ancillary operations have now recovered, and assets have steadily increased to \$531 million by the end of 2026. Liabilities decreased from \$216 million in 2017 to \$147 million in 2023 as ancillaries paid down their capital financing. Liabilities increased to \$302 million by 2026, primarily due to capital financing used to acquire residence assets, including the new Oak House Residence joint venture and an equity interest in an off-campus residence facility. Net assets grew from \$94 million in 2017 to \$137 million in 2020, essentially reflecting the continued success of service operations with filling residence and parking spaces, while reducing their debt burden. Net assets fell to \$95 million in 2021 and \$96 million in 2022 due to the pandemic but has since increased to \$229 million in 2026 as ancillary operations recovered from the effects of the pandemic, and an increased presence on campus by administrative staff is driving more demand for food services and parking.

At April 30, 2026, net assets increased by \$23 million from April 30, 2025, mainly due to the following:

- \$22 million net income for the year.
- \$1 million transferred from other funds.

There are three categories of net assets for ancillary operations which together total \$229 million. They are:

- (\$124 million) in deficit.
- \$51 million in internally restricted net assets.
- \$302 million in investment in capital assets.

The investment in capital assets category reflects capital construction of facilities which have been funded by internal borrowing of the University's own funds, resulting in a corresponding increase in deficit. Over time, investment in capital assets will be reduced as the capital assets are amortized, and the deficit will be decreased by the amount of that amortization. The increase in investment in capital assets is primarily the result of the addition of the University's share of the Oak House residence, which was previously included in the capital fund.

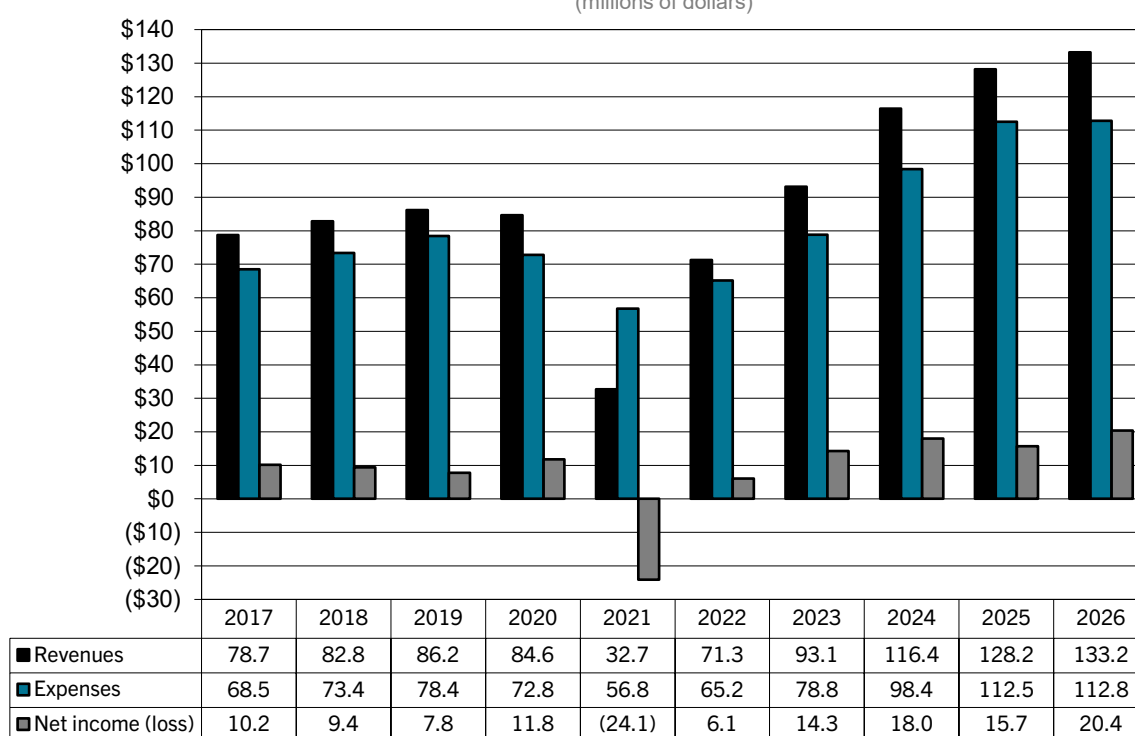
Service Ancillaries

In 2026, service ancillaries had revenues of \$133 million and expenses of \$112.8 million, with a net income of \$20.4 million for the year. Residences continue to operate at full occupancy, and an increased presence of administrative staff across the three campuses is driving higher demand in parking and food services.

In 2026, net income from residence operations increased to \$15 million from \$9 million in 2025. Net income from parking and food services decreased to \$3 million in 2026 compared to \$4 million in 2025. Hart House had a net income of \$3 million in 2026 compared to \$3 million in 2025.

Since 2017, service ancillary revenues have increased primarily due to the expansion of residences to deal with the growth in student enrolment. Residence fees over the past number of years have been increased to keep pace with increased expenses, including large, fixed rate principal and interest payments on borrowing.

The long-term financial health of these operations is dependent upon filling the residence and parking spaces. Growth has largely been financed through long-term debt and through subsidies from their existing ancillary operations resulting in reduced operating margins.

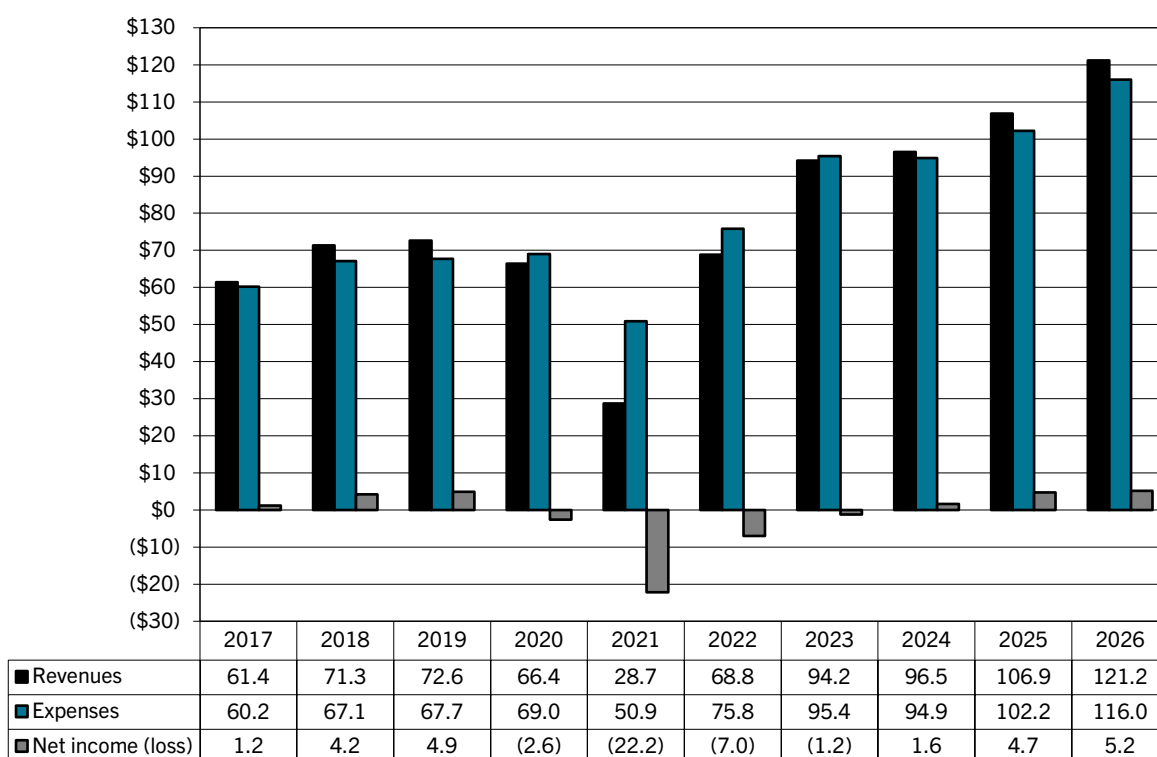
Business Ancillaries

Business ancillaries is comprised of Spaces and Experiences, which includes Real Estate, and operations that were previously considered service ancillaries: St. George Food and Beverage Services, University Family Housing, Chestnut Residence and Conference Centre, Graduate House Residence, and St. George Transportation Services. The University's share of the Oak House Residence joint venture is included in the Real Estate operations. Business ancillaries also includes the University of Toronto Press.

Residences continue to operate at full occupancy, and an increased presence of administrative staff across the three campuses is driving higher demand in food services and parking. U of T Press revenues continue to lag pre-pandemic levels. These operations had combined revenues and expenses of \$157 million each, resulting in a marginal net loss in 2026. Business ancillaries had a net income of \$1 million 2026 as compared to a net loss of \$1 million in 2025.

The net income for Spaces & Experience in 2026 was \$5 million compared to a net income of \$5 million for 2025.

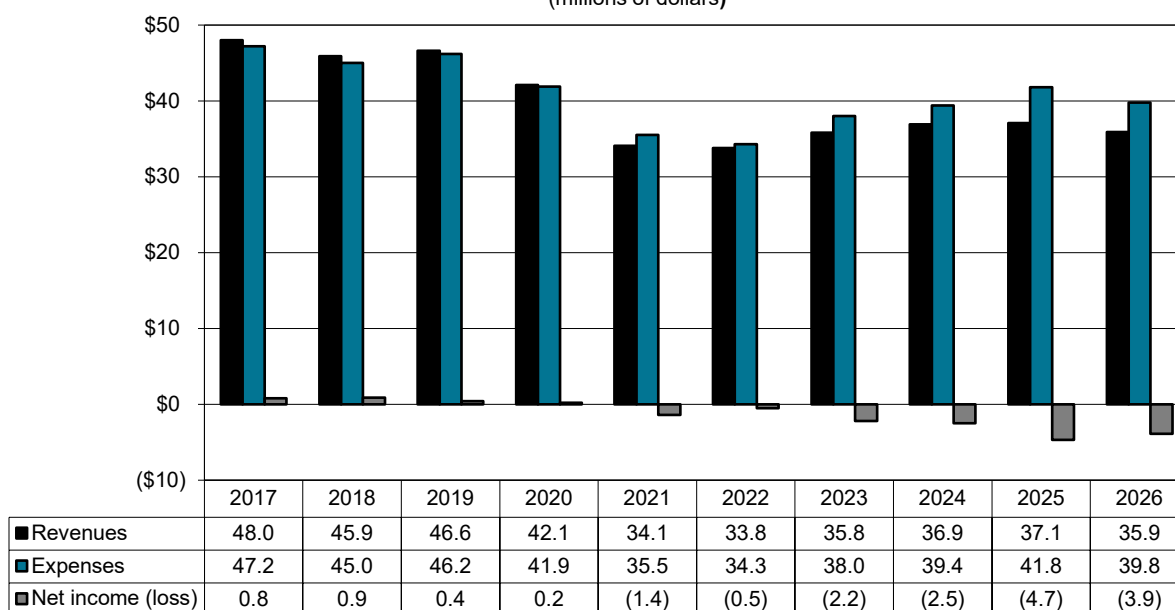
Ancillary operations - Business Ancillaries

U of T Press revenues continue to lag pre-pandemic levels, incurring net losses in each of the last six years. The net loss for U of T Press in 2026 was \$4 million compared to a net loss of \$5 million in 2025.

(millions of dollars)



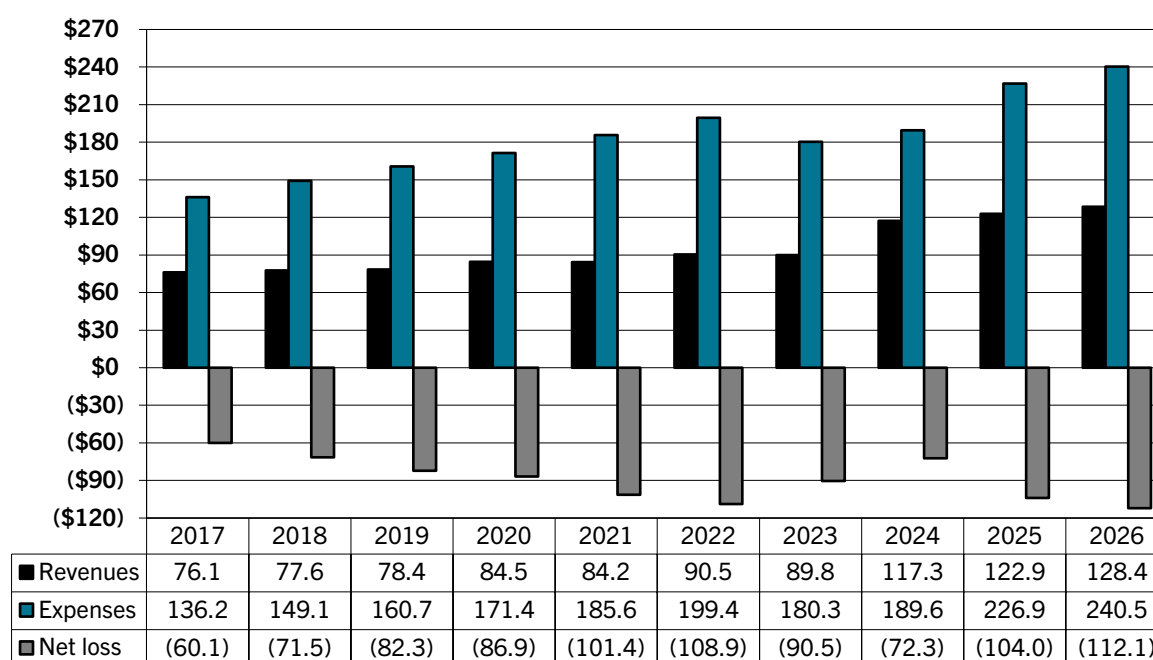
Capital Fund

The capital fund includes all capital assets – land, land improvements, buildings, furnishings, computers, etc. - except for those of the ancillary operations. Contributions to the University for capital assets other than ancillaries are recorded in this fund. This fund also holds the vast majority of the University's debt and in turn lends it out for capital construction and other projects to departments or operations that have the responsibility to repay the loan.

Capital fund revenues for the year were \$128 million and expenses were \$240 million, for a net loss of \$112 million. Revenues include an amount equal to the amortization of capital assets that were financed by grants and donations, while expenses include the amortization of capital assets.

The reason for annual net losses in the capital fund is that a significant share of the revenue funding the amortization of capital assets and funding capital projects is recorded as revenue in the operating fund and transferred to the capital fund as an interfund transfer and therefore is not reported in revenues of the capital fund.

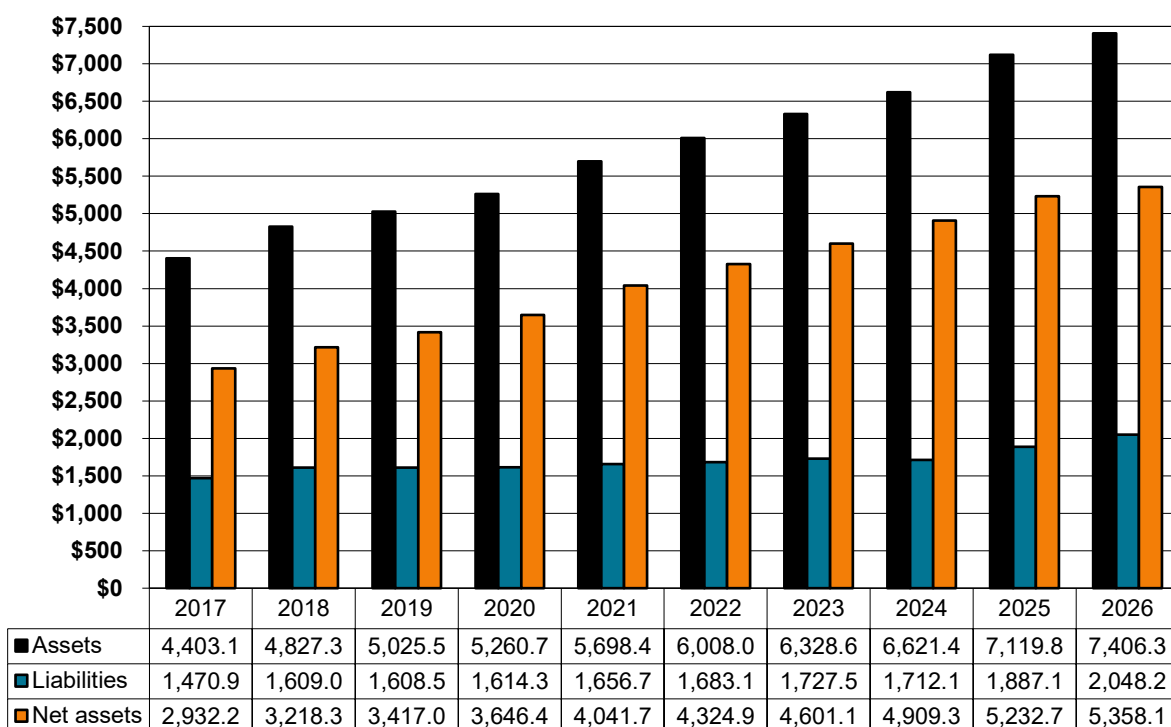
In 2026, a total of \$237 million was transferred to the capital fund. This was made up of \$96 million in capital asset funding from the operating fund that must be transferred to the capital fund (where the assets are capitalized), combined with net transfers of \$141 million, mainly from the operating fund, in support of various capital projects.

In 2026, capital fund assets were \$7.4 billion, liabilities were \$2.0 billion and net assets were \$5.4 billion. Net assets comprised \$5.0 billion investment in capital assets, \$685 million internally restricted funds offset by \$373 million in deficit.

The assets of the capital fund have grown from \$4.4 billion in 2017 to \$7.4 billion in 2026 primarily as a result of the University's large capital construction program over this period. Liabilities have grown from \$1.5 billion in 2017 to \$2.0 billion in 2026. This growth in liabilities reflects the growth in deferred capital contributions to \$1.3 billion and includes long-term borrowings of \$775 million and accounts payable of \$144 million. These liabilities are offset by loans to other funds of \$138 million. All external borrowing of long-term debt is recorded in the capital fund. Loans are provided to departments or operations who have the responsibility to repay the loans. These loans are recorded as a liability in the operating fund or ancillary operations, as appropriate, and are recorded as a receivable in the capital fund.

(millions of dollars)

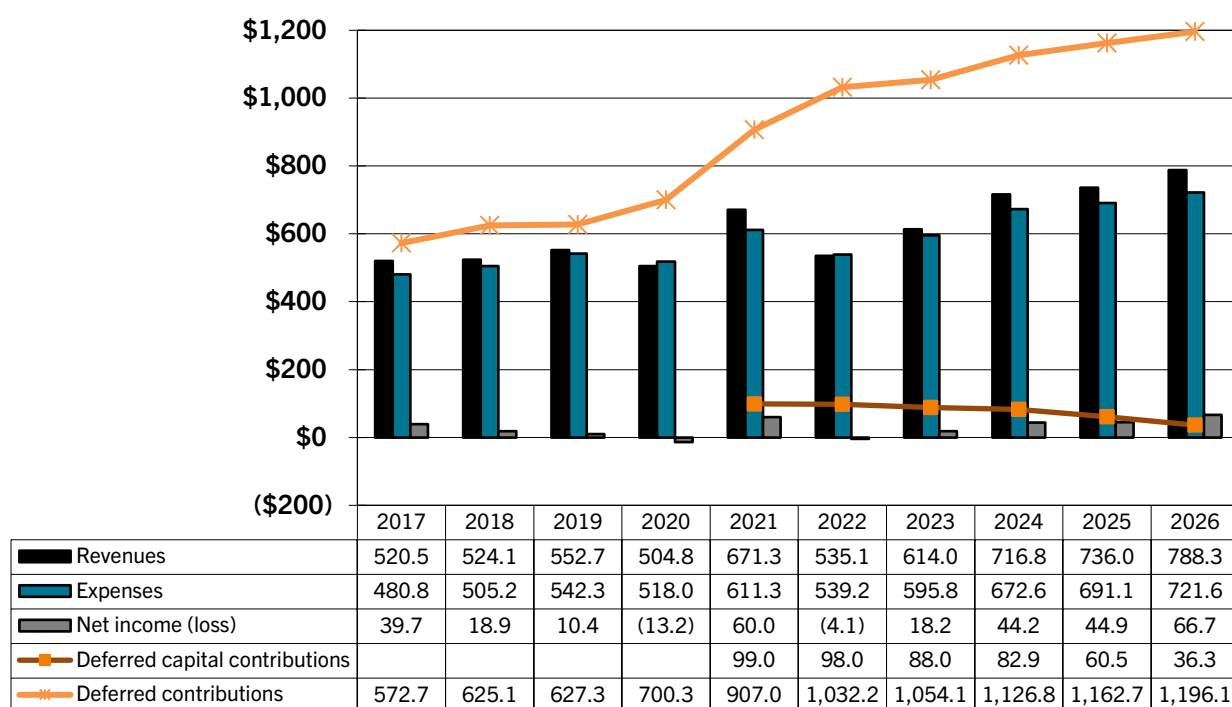


Restricted Funds

Restricted funds include donations (including endowments), research grants and contracts. Each donation, usually supported by an agreement between the University and the donor, or a collection of small donations with similar purpose, is recorded in its own fund, and managed according to agreed upon terms and conditions. Each research grant or contract is also recorded in its own fund and managed in accordance with the terms and conditions required by the sponsor of the fund. There are over 25,000 individual restricted funds.

Restricted funds exclude research grants for capital assets and donations designated for capital assets, both of which are recorded in the capital fund. When restricted funds are provided for, or spent on, capital assets, they are recorded in the capital fund.

Financial reporting for restricted funds follows specific rules with respect to revenue recognition that differ from the rules for unrestricted receipts. They are:

- Restricted grants and expendable donations are recorded as revenue when spent, while unrestricted grants and expendable donations are recorded as revenue when received.
- Unspent restricted grants and donations are recorded as liabilities known as deferred contributions.
- Endowed donations are not recorded as revenue. They are added directly to the balance sheet as net assets.

- Investment earnings on externally restricted endowments that are made available for spending are recorded as revenue and the amount for preservation of capital is added directly to the balance sheet as net assets. In years where earnings are below the amount made available for spending, a drawdown is made from previously re-invested earnings. The amount made available for spending is recorded as revenue, and net assets on the balance sheet are reduced directly by the drawdown. Investment earnings or loss on internally restricted endowments are recorded in the income statement and the amount for preservation of capital or drawdown is recorded as a transfer to or from the endowment balance.

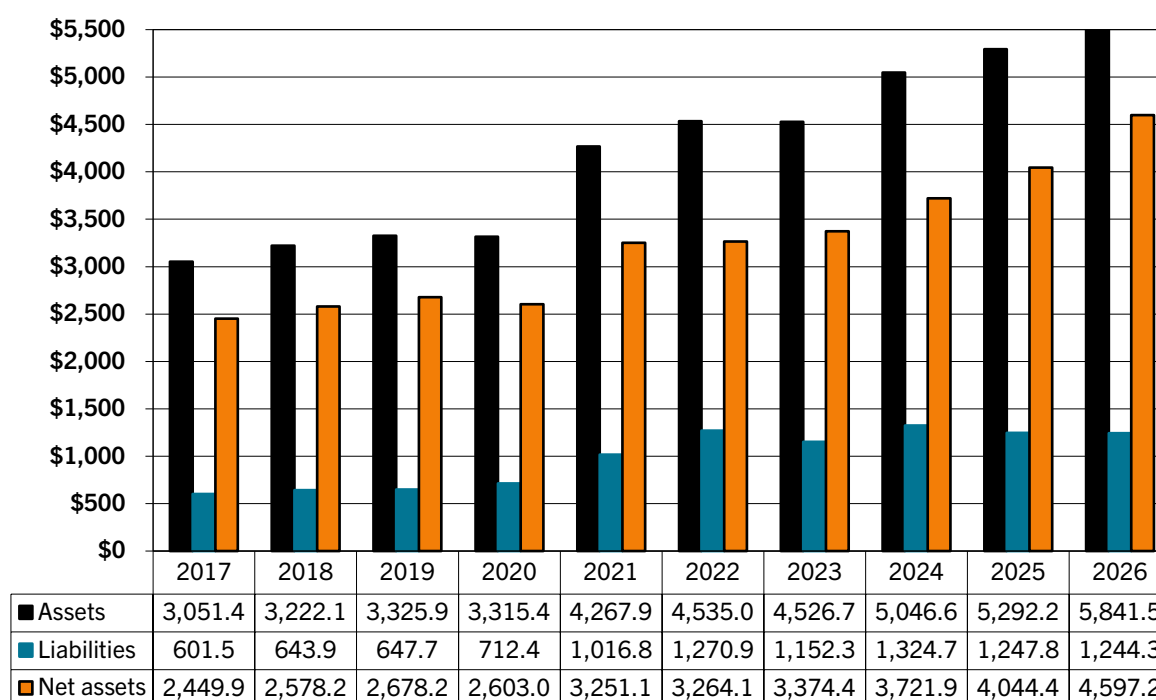
In 2026, restricted funds revenues for the year were \$788 million and expenses were \$721 million, resulting in net income of \$67 million.

Net income in any particular year mainly reflects the recording of unrestricted donations and investment income as revenue that has not yet been offset by expenses. A net loss in any particular year mainly reflects the recording of investment losses on internally restricted endowments funded by a transfer from endowed capital and/or expenses funded by internally restricted net assets.

Restricted funds' assets were \$5.8 billion, liabilities were \$1.2 billion, and net assets were \$4.6 billion. Net assets comprised \$4.5 billion in endowments and \$118 million in internally restricted funds.

Restricted funds' net assets increased by \$553 million between April 30, 2025 and April 30, 2026 as a result of net income of \$66 million and a further \$487 million as follows:

- a) transfers of \$30 million mainly from the operating fund,
- b) endowed contributions and investment gains on externally restricted endowments, which are not recorded as revenue, but are added directly to net assets:
 - \$100 million in endowed donations.
 - \$357 million increase of externally restricted endowments, consisting of an investment income of \$482 million less \$125 million withdrawn for payout.

As noted above, the majority of unspent expendable restricted funds are *not* recorded as net assets, but rather are recorded as deferred contributions in the liabilities section of the balance sheet. Total liabilities have grown from \$602 million in 2017 to \$1.2 billion in 2026 mainly as a result of the growth in research activity and restricted expendable donations that are reflected in deferred contributions until they are spent.

Net assets in restricted funds have grown from \$2.4 billion in 2017 to \$4.6 billion in 2026.
