The Chair stated that since the revision to the constitution of the School of Graduate Studies², a number of divisions had been amending their constitutions to reflect changes to graduate education governance. The terms of reference of the Academic Board called for new or revised divisional constitutions to be considered by the Board and confirmed by the Executive Committee. Because of the current terms of reference, minor revisions to divisional constitutions had to be considered by the full Academic Board. The Chair suggested that approval of such minor revisions might be more appropriately assigned to the Agenda Committee. The Committee agreed that the Chair recommend to the *Towards 2030* Task Force on University Governance that authority for approval of minor revisions to divisional constitutions be delegated to the Agenda Committee by the Academic Board.
