A "Student" is any person registered at the University for full-time or part-time study in a program that leads to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University. The Transitional Year Program and the Millie Rotman Shime Academic Bridging Program have been designated by the Governing Council as programs for the purposes of clause 1 (1) (1) of *The University of Toronto Act*, 1971. An individual who is not registered in such a program will not meet the definition of student under *The University of Toronto Act*, 1971.

Students from the St. George campus and the University of Toronto at Mississauga (UTM) must be registered in the constituency in which he or she was elected during the period September – May in order to hold his or her seat. Students from the University of Toronto at Scarborough (UTSC) must be registered in at least 2 of the 3 semesters between May of the year in which they were elected and April of the following year.

The University of Toronto Act requires that members of Governing Council be Canadian citizens.

"Part-Time Undergraduate Student" means a student registered at the University in a program of part-time study leading to a degree or post-secondary diploma or certificate of the University or in a program designated by the Governing Council as a program of post-secondary study at the University who is not registered in the School of Graduate Studies or the Toronto School of Theology. The status of a student as part-time will be determined by the definition used in the student's academic division.

- For a nomination to be valid, the **signatures of 20 nominators, including nominators' printed full names and student numbers,** <u>must</u> appear in the space provided below
- The nominee and all nominators must be members of the constituency indicated below. A nominator may nominate no more than 2 candidates.
- This form must be accompanied by one of the following, for which photocopies will be acceptable, as **documentary evidence of Canadian citizenship**: certificate of birth in Canada; certificate of citizenship; certificate of naturalization; Canadian certificate of registration of birth abroad; certificate of retention of Canadian citizenship; valid Canadian passport; a notarized statement to the effect that the nominee is a Canadian citizen. (**Note:** The Office of Governing Council will make available such a statement for signature and, if requested sufficiently in advance, will arrange for its notarization. In the absence other than casual of the candidate from Ontario or the Toronto region, the notarized statement may be made on his/her behalf by someone having personal knowledge of the facts where the means of knowledge are stated to the satisfaction of the Chief Returning Officer.)
- It is the Nominee's responsibility to file a bona fide nomination. Errors or irregularities in these papers constitute grounds for rejection of the nomination. Errors or irregularities may be corrected prior to the close of nominations. Please refer to the *Election Guidelines*, 2008 for additional instructions. The Office of Governing Council will attempt to notify candidates of the existence of any errors or irregularities during this period, but is not bound to do so. Candidates are advised to complete and submit their nomination papers early in the nomination period.
- In 2007, the campaign spending limit for candidates in this constituency was \$400. The spending limits for the 2008 election will be announced at the All-Candidates' Meeting. Candidates will be refunded the first \$100 plus 75 percent of any additional spending of amounts above \$100 and less than the spending limit for the constituency. To be eligible for reimbursement, a candidate must obtain at least 25 percent of the votes obtained by the candidate elected in the constituency with the lesser number of votes. Candidates must submit a sworn statement of election expenses, including receipts for all expenses, by 4:00 p.m. on Friday April 4, 2008. (See the Election Guidelines, 2008 for full details.)
- The nominee may submit a **typewritten** biographical statement or other comments, up to a limit of 100 words. The candidate's name will not be counted in the 100-word total if placed at the beginning of the statement. Abbreviations and acronyms will be counted as one word. **This statement will be published in the campus media and linked to the ballot on the web. If a statement exceeds 100 words in length, only the first 100 words will be printed. It is emphasized that the submission of the biographical statement or other comments is voluntary.**
